The appropriation bill was before the House yesterday, and good progress was made on its third reading. The appropriations in the Civil list, the Judiciary and the Interior Department, as far as the items of "buoys and landings," have been approved and passed. Two or three more days of such excellent work as was done yesterday will finish this bill and place it in the hands of the King for approval.

OCCASIONALLY an episode transpires in the Legislature which augurs no good for the peace of the country. Such a scene occurred yesterday, when Representative R. W. Wilcox mounted his war steed, and brandished epithets that fairly startled the coolest heads in the House, and threatened disturbance.

The report on the Post Office was under consideration, when he gave utterance to these words: "If this thing continues there will be a new government before a year, and there will be no King, and I will take a hand in it."

Now if these words of Wilcox mean anything, they mean that it is his purpose to make a disturbance, may more, to dethrone the King and to establish a new government with himself at the head. This is the most rational construction that can be put on the language he uttered.

Again, continuing his speech, he used these words: "In his seven years' residence in Europe, he saw that disputes like that between Messrs. Baldwin and Marques were generally settled outside, at the point of the sword or pistol."

When called to order by President Walker, Wilcox coolly insulted him by saying that "he had very little brains." And when again called to order by Noble Walbridge, he answers him that if he feels injured, he might rub his head.

It is true that he retracted his

language, but followed the retraction with utterances worse than those which preceded, showing that he defied law and order.

We call attention to this matter, as the public should know what is going on, and what the leader of the radical wing defiantly utters before the Legislative Assembly of the nation. It is evidently not meant by him as idle talk to provoke a smile, but as a forecast of his firm determination.

THE ENTERING WEDGE.

Article 20 of the Constitution is one of the mile stones which mark progress in the history of this country.

It is the section which prevents a Government officer from holding a seat in the Legislature. It also further provides that "no member of the Legislature shall, DURING THE TIME FOR WHICH HE IS ELECTED, be appointed to any civil office under the Government, except that of a member of the Cabinet."

In February last, John W. Kalua was elected a Representative to the Legislature. The "time for which he was elected," was two years. The fact that he has resigned, after the lapse of only eight months, does not reduce the "time for which he was elected" to eight months. If this were so the whole virtue of the constitutional provision would be eliminated, for the Devil could most effectually be "whipped around the stump" by any office hungry member resigning as soon as the session was over and filling the office which he had beforehand agreed with the Cabinet he should receive as pay for his support in the House while it was in session.

The constitutional provision does not allow of any such palpable evasion as this.

Apparently, however, the Minister of the Interior has not heard of Article 20 of the Constitution, for although Mr. Kalua is constitutionally prohibited from accepting a Government office for two years from last February, and Mr. Spencer is constitutionally prohibited from making such an appointment, Mr. Kalua has been appointed by Mr. Spencer an Agent to take acknowledgments to Labor Contracts for the District of Waialua.

We suspect, however, that Mr. Spencer may have again been consulting with the Finance Committee as to his rights, powers and duties, and that they have taken him in with another of their "horse-shed" legal opinions.

Whether he has taken bad advice or no advice at all has, however, no bearing upon the rights of the matter.

It makes no difference that the appointment is to a small office. The principle is the same as though Mr. Kalua had been appointed a Judge of the Supreme Court. "It is the first step, the entering wedge, toward breaking down a whole-some constitutional provision.

The only lawful, honorable course for Mr. Spencer to follow is to recall the appointment, if it was made inadvertently. If it has been made willfully and knowingly he is unquestionably liable to impeachment for violation of the Constitution.

THE LEGISLATIVE ASSEMBLY.

One Hundred and First Day. MONDAY, OCT. 13.

The House met at 10 A. M. Prayer by chaplain. Minutes of preceding day read and approved.

Rep. Waipulani resolved that Bill No. 37, relating to the governors, be taken from the table and made a special order for Tuesday. He moved the resolution be adopted.

Minister Brown—It is very necessary that the appropriation bill should be proceeded with. I move the resolution be laid on the table.

The motion to lay on the table carried. The House proceeded to the Order of the Day, further consideration of the majority and minority reports on postal matters.

Noble Crabbe as a member of the Postal Committee said that in the report laid down before this House schedules A. and D. inclusive, also letters received from the rural postmasters, as also affidavits taken from clerks in the General Post Office, were referred to in the majority report, and he considered as they were embodied in the report to the House by reference, that as such belong to that report, and as such belong to the House, and should be paid for by the authorization of this House to have the report printed. Another point was that before the majority report was submitted to this House, the affidavits were shown to the members of the minority and to Noble Baldwin in particular, who said, when he had looked at them, that he would not believe them, the subscribers to the affidavits, because it was evident that if they could not tell the truth when before the committee, they would not do so by affidavit. He contended that all the report was regular, and should be sustained by this House.

Rep. Waipulani—This matter is a very important one. Noble Macfarlane this morning the Printing Committee has no right to print anything not ordered by the House. I would like to ask the chairman if he read the extracts from the affidavits and the remarks on pages 55 and 59 to the House.

At this point, Rep. Kaohokano, on suspension of the rules, presented a report from the Judiciary Committee that they had made a careful examination of the certificate of election and the report of the Interior Office, and found that Patrick Cockett was duly elected as representative for South Waialua, and that he should take his seat accordingly.

The report of the committee was adopted. President Walker appointed Reps. Kaohokano, White and Nawahi a committee of three to wait on the Chief Justice and request him to attend in the House and swear the new members.

The committee returned with Mr. Justice McCully, who administered the oath, the House rising.

The discussion on the Postal Report was then resumed: Rep. Kanae, as a member of the Printing Committee, thinks they have not been treated right by the majority of the Postal Committee. I never heard an extract from affidavits read before the House when the chairman presented his report.

Rep. Rickard said the committee had gone outside of their bounds and requirements, in bringing in such a report as this. It would be unjust and unwise of us as Legislature to accept such a report. The Postmaster-General is at the head of the bureau, and if it was right for the committee to examine the clerks regarding the conduct of the head of the bureau towards them, I fail to see how discipline can be maintained. It was a matter of pay in the bureau that the committee had to investigate. If any of the employees were dissatisfied they were not obliged to remain. The care and responsibility of that important bureau rested on the shoulders of the Postmaster-General. We have not heard of any extreme abuses being practiced on the employees of the bureau by the Postmaster. It is not an easy position to fill to the satisfaction of the members of the kingdom. There has not been a single thing found wrong with the correctness of the accounts and the business transactions in that bureau while the present Postmaster-General has held the position. As long as he is able to conduct the bureau as ably as he has done, a little question of irritable temper means very little.

Noble Baldwin—I think Rep. Rickard is going beyond his bounds. The House should confine its discussion to the report.

Noble Muller—I rise to a point of privilege. If the hon. member looks on page 36 of the Finance report, which the House adopted, he will find grave charges made against the Postal bureau.

Rep. Kaohokano favored reference to a select committee, as these matters require investigation.

Rep. W. Wilcox—I am in favor of reference to a select committee. The members of the minority committee belong to the Reform Party and were elected to come in and protect the interests of their friends whether right or wrong, and at all hazards, they will not let the Reform Party come in to put an end to these things. The Reform Cabinet was put out, but I believe the present Cabinet is just as bad, if not worse, as it keeps these men in office.

Noble Von Tempyky—I rise to a point of order. The Ministers are not before the House.

The President so ruled.

Rep. R. W. Wilcox—The minority of the committee belonged to the Reform Party, and therefore wanted to shield the Postmaster-General. I am surprised to see members of the National Reform Party, who boasted loudly before election of what they were going to do in the House, standing up to defend their officials. If this thing continues there will be a new Government before a year, and there will be no King, and I will take a hand in the business.

President Walker—Such language is entirely out of order.

Rep. Paehaole—I rise to a point of order. The hon. member is way outside of the discussion.

Rep. R. W. Wilcox—I will retract what I have said.

Rep. Paehaole—The habits of some members in talking all around the question is what has protracted this session.

Rep. R. W. Wilcox—The reason the session has been prolonged is all on account of that Cabinet over there. Such differences as those existing between Noble Baldwin and Rep. Marques were settled in Europe with pistols or swords.

President Walker—We don't require any such instruction.

Rep. R. W. Wilcox—The reason the

President does not need instruction is because he has a small amount of brains.

Noble Walbridge—A member who uses such language ought to be reprimanded.

Rep. Wilcox—I withdraw what I have said. If the Noble feels hurt he can rub his head.

Rep. Marques said he did not object to a select committee. He had nothing to lose by such reference, but everything to gain. The more light thrown on the subject the better for him.

Noble Baldwin did not object to a special committee, yet I do not see what is to be gained.

The motion to lay on the table was lost.

The motion to refer to a select committee was lost—24 to 20.

The motion to return the report to the chairman (Rep. Marques) was carried—22 to 9.

Rep. Nawahi and Noble Crabbe both resigned from the committee.

The House then took up the third reading of the appropriation bill.

Rep. Nawahi—I don't know what's the matter with Noble Macfarlane this morning. He is acting like a small boy.

Noble J. M. Horner—We don't want to make these appropriations too large without there is labor to justify it.

Rep. Nawahi opposed the reconsideration. If we want good men we must pay good salaries.

At noon the house took a recess.

Afternoon Session. The House re-assembled at 1:32.

Rep. Marques asked the members to return the copies of the reports on postal matters. He moved that the House give him permission to print, with his report, extracts from the Postmaster's letters and other matter.

Rep. Paehaole did not believe in printing extracts; the letters should be given in full or not at all. He moved that all the evidence and affidavits taken by the majority and minority committees be printed.

Rep. Brown—No such motion as this can be considered. We are on the Appropriation Bill, and it has the preference of everything.

President Walker—The member is a little out of the House ruled the other day that a motion could be entertained while the bill was under consideration.

The matter was deferred until to-morrow.

The item passed at \$62,000. (The President by motions and gestures here gave an illustration of how many of the members voted.)

Band, flags and salutes, \$50,000. Noble McCarthy moved the item read "Band to make a circuit of the islands three times a year and play at the large centers of population, etc."

Noble McCarthy said it was intended to have the band visit the other islands once each quarter.

The item passed as in the bill. Aid to Volunteer Military Companies, \$1,500.

Rep. Nawahi wanted some explanation for the increase. The Minister of Foreign Affairs issued an order for the disbandment of these companies. Some of them will not return their guns.

Noble McCarthy said that most of the guns belonged to the members. They were given to them by citizens in 1887. Those belonging to the Government had been returned.

Minister Cummings said that about eighty guns had been returned.

Minister Brown—This amount is for rent, colonel's salary and tailors' bills, and not for ammunition and guns. These bills were not incurred by the present Ministry. They were an inheritance.

The item passed at \$2,500.

CORRESPONDENCE.

The Tram Cars. Mr. Emron: The street-cars are understood to leave the Oahu College terminus for town at six minutes past the hour, each hour through the day. More than that, they are advertised to do so in the printed time tables. On Saturday last two hours were omitted, the cars stopping at the Beretania street corner. This, of course, seems a very small matter to the company, but one or two cases may be mentioned to prove the contrary. One a quite weary, over-worked woman, engaged in errands down town, errands of mercy, perhaps, takes that particular car, expecting to be carried very near home, but has to walk the extra distance when totally unfitted for the exertion, and becomes still more unfitted for duty.

Another case, a family, with small children in arms, go expecting to meet the same car to go to town. No car; and, moreover, it is too late to go down to the corner to secure passage. These are not imaginary cases. A dozen others might happen. A business man, for instance, might lose his vote at a trustee meeting, a social event might be interfered with, all from the no-car contingency. It is not at all a mere question of walking a few steps; it is a promise on the part of the company deliberately broken.

I know very well the answer that will be made, that the cars were being changed to put on larger ones for the baseball crowd. But the latter is a fortuitous arrangement, the other is regular routine. The public are not all harum-scarum boys, that can as well walk as not, or run for a car. Even for such a word may be said, when we see Sunday after Sunday a crowd hanging on to the two ends of a car like a swarm of bees hanging to the branch of a tree. It is neither decorous nor necessary for regular church-goers to be obliged to return home

IN THAT STYLE, WEEK AFTER WEEK.

Chance crowds are to be expected, and put up with good naturedly; but a known and regular demand should be supplied by those who undertake the business. The street cars are a necessity; they should not become a necessary nuisance. If it is really required, I do not know why a line of street cars should not be wisely subsidized as well as a steamship line. But the service should be given and insisted upon as well as paid for.

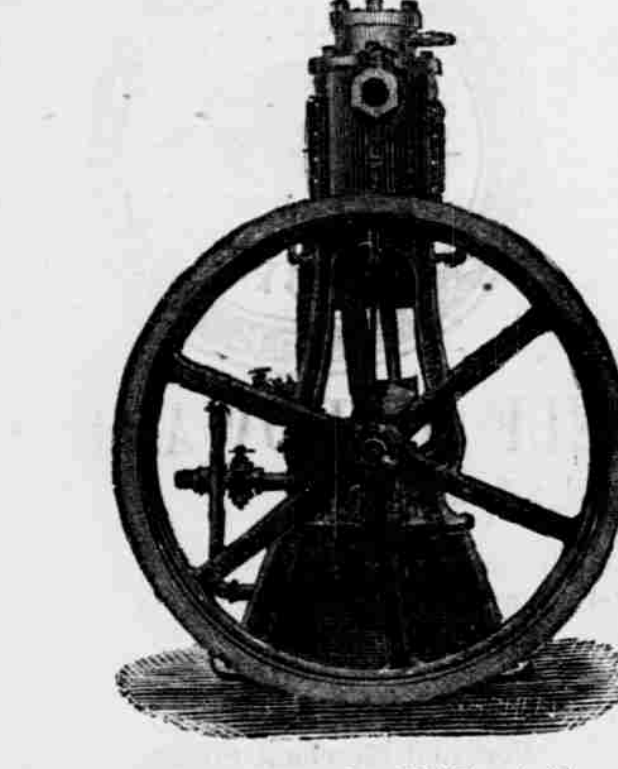
