WHAT BRYAN'S RENOMINATION MEANS.

The Secret of His Sudden Rise to Party Leadership and the Reasons Why He Hopes to Win This Year.

The renomination of William J. Bryan is a notable honor to a remarkable man. This will be the judgment of every intelligent American who examines Mr. Bryan's career in the light of history, and who emancipates himself from all prejudices for or against the candidate and the great party which twice in succession has made him its leader.

Mr. Bryan entered his party's national convention of 1896 as a member of a contesting delegation. As tested by the standards of his organization which prevailed along to that time, he was marked with the taint of partisan heterodoxy. The idea for which he stood—the unlimited coinage of silver at a ratio which would have made the intrinsic value of a silver dollar half that of the gold dollar, and which, consequently, as a large majority of the people of the country believed, and believe still, would drive gold out of circulation, precipitate the country to the silver basis, and disastrously disturb all values—would, if sanctioned by the convention, make a break with the traditions of a hundred years of Democratic history.

Moreover, presented to the same convention were the names of older and (as judged by the canons of that day) greater soldiers of the silver cause. Richard P. Bland, the pioneer of the silver coinage movement in Congress, was urged by a large element of his party for the Presidential nomination. Another faction favored Horace Boies, also a silver champion, who had carried the Republican stronghold of Iowa for Governor, and who had made an efficient and popular official. Senator Joseph S. C. Blackburn, of Kentucky, a veteran fighter on the silver side in both branches of Congress, had some powerful friends in the convention, and received many votes for the nomination. Yet this contesting delegate, who was admitted to a seat by the favor of the convention, but whose name was new to a majority of the delegates at the time, defeated, through the magic of a speech which put the feelings of his hearers into burning phrase, men who had been leaders of his cause long before his name was heard of outside the ward in which he lived, and carried off the convention's prize.

Other men than Mr. Bryan, whose names were not previously coupled with the candidacy, were nominated for President. Nobody thought of Polk or Pierce in connection with the nomination at the time the Democratic conventions of 1844 and 1852, respectively, met. Garfield entered the Republican convention of 1880 as the leader of the Sherman forces, and his speech in favor of the nomination of the man who, while in the Senate, was the leader of the element which passed the gold resumption law of 1875, and who, as Secretary of the Treasury, had put that act in operation in 1879, compares well with Choate's for Webster in the Whig convention of 1852, with Ingersoll's for Blaine in 1876, and with Conkling's for Grant in 1880, in eloquence and power. This speech did much to nominate Garfield, though probably neither he himself nor anybody else at that time thought of him as a Presidential possibility.

Polk, Pierce, and Garfield, however, had served much longer in public station than the four years in which Mr. Bryan was in the House of Representatives. Polk had been Governor of his State as well as speaker of the House in

Washington. Pierce served in both branches of Congress. Garfield was one of the foremost men in the Congresses of his day. Both Pierce and Garfield, too, had military reputations.

Taylor and Grant never served in political office at all until they entered the White House, but each had been the foremost of his country's soldiers of his time. Their record as soldiers gained the Presidency for Jackson and William Henry Harrison, but each of these had a long service in political station before their nomination for President.

The nominations of Hayes and Benjamin Harrison created a little surprise when they occurred, but the names of both had been coupled with the candidacy before the conventions met which put them up; each had been longer in public life than Bryan; each had a military record, although this did not figure with much prominence in the campaigns in which they were elected; and Hayes, in 1875, when he was chosen Governor of Ohio, had led a canvass in which the cause of greenbackism throughout the West had met with a reverse, and this attracted to him the whole country's attention.

The rise of Grover Cleveland was swift, but he, first as mayor of Buffalo and then as Governor of New York, had been conspicuously identified with certain political reforms which began to appeal with especial force to a large and constantly growing element of both the great parties. Garfield's assassination in 1881 by the disappointed and crack-brained Guiteau aroused a demand to "take the offices out of politics," which placed the civil-service law of 1883 upon the national statute-book and put a faction of the Republicans in 1881 in revolt against Blaine, who was believed to be unfavorable toward the reform. Cleveland was a reformer. The anti-Blaine Republicans liked Cleveland. He had the prestige of a plurality of 193,000 votes for Governor of New York in 1882 over the machine-made though personally clean-handed and popular candidate, Secretary of the Treasury Folger, the Republican nominee for Governor that year. These circumstances gave Cleveland a strength which, despite the distrust of the politicians of his party toward him, gave him the nomination in 1884 and the election.

But Mr. Bryan had no military glory, nor was his name, at the time the convention of 1896 met, connected conspicuously with any great reform or cause, for he had made no record during his short service in Congress which could single him out from the roll of ordinary members on the silver side. What, then, was the secret of Mr. Bryan's power over his party? It was this: In his speech to the convention he gave the idea which for years had been struggling for expression in his party more striking expression than had any other of its orators. That party at that time had done with shuffles and straddles. Bryan despised straddlers and shufflers, and made this fact known promptly to his party. His party declared for the "free and unlimited coinage of both silver and gold"—putting silver before gold for emphasis—at the sixteen-to-one ratio, "without waiting for the aid or consent of any other nation." This meant that compromise and equivocation in that party on that issue was ended. Bryan, like John Quincy Adams, refused to compromise with conscience. He was as aggressive and inexorable as Garrison.

Thus Mr. Bryan's proclivities coincided with his party's new

TOPICS OF THE DAY.

Go where you may; talk as you will, a scratched ticket will fill the bill. Good men have been nominated on the several tickets, but there is no individual ticket that meets the wishes of the electorate. A formal fusion is useless. Leave the whole matter to the voters. A campaign of revenge may be disastrous to us all.

The Independents have taken the names of J. O. Carter and E. C. Macfarlane out of their ticket. They have declined to support Mr. S. M. Damon, one of the best friends the Hawaiians ever had. Mr. Damon was approached by the little ring which runs the Independents but declined to accept a nomination if the name of his friend of many years' standing, J. O. Carter, was scratched. The Independents in addition to their Hawaiian nominees have got now on their ticket the names of E. C. Rowe, the painter, John Emmeluth, the plumber, and J. C. Quinn, the hackman. Why hasn't the "iceman" got a place?

Who is this Mr. Frank Berry who figures in the sad tragedy which has resulted in the loss of two lives? The community is entitled to know men of the caliber who arrive here, break up happy families, are the cause of crimes and when the nine days' wonder is over, walk our streets with impunity and later on refer jocosely to that little affair, you know, which ended in that "fool" husband shooting his wife and himself. The Police Department knows the identity of the man Berry, involved in the Steigmann tragedy, and the authorities should at once take steps to place a stigma on the man of that caliber which would forever prevent him from living in this country. The breaking up of homes should not be dealt with in a trifling manner, and wicked as this Christian community may be there ought yet to be decency enough to punish the transgressor.

The Independent called on J. O. Carter this morning to learn from him the facts about the Advertiser's reported interview with that gentleman. Mr. Carter said: "Yesterday afternoon a young man appeared in my office and asked me if I was Mr. Carter. I replied, yes. He then said that Mr. Smith of the Advertiser had sent him to ask me whether it was a fact that the Queen had given the Prince a letter endorsing him as delegate. I replied: Not to my knowledge. He then said that the rumor was current and was believed. I replied, it is extremely improbable."

Out of nine words uttered by Mr. Carter the political trickster of the

Advertiser makes up a quarter of a column of half truths headed "Queen not for David." The Republican campaign must be very weak to require such bolstering.

Clear the Streets.

ED. THE INDEPENDENT:—

Your criticism of the Judge in re the native boy fined 15 and 1 was all right. It is certainly time that this street meeting and singing was ended. They often disturb people who do not like to complain of them on account of the noble work they are engaged in. Now as matter of fact, notwithstanding the merit of their undertaking, what is there in the law that gives special privileges to protestant street exhorting a preference over preaching or exhorting in less laudable undertakings according to some minds viz, Catholicism, Mormonism, paganism or Socialism. Now I for one think the streets should be kept cleared and quiet, and those who wish to teach or be heard "hire a hall." If these meetings are allowed to continue it will be found sooner or later, that they are causing more harm than good. We certainly do not want some dimonite crank preaching socialism. Now if the present style of meetings is allowed to continue, how can we consistently prevent it unless we go into downright treason; but of course a great deal of unnecessary and damaging talk can be made before that class of people can be considered down to the treason point.

SAN FRANCISCO, Oct. 7.—The Shriner steamer Zealandia, which on the 11th inst, will sail for the Hawaiian islands with a large number of the nobles of Islam Temple of the Ancient Arable Order of the Mystic Shrine, and who are all going on a 30 day pilgrimage, accompanied by many of their relatives of the fairer sex, was opened to inspection last night from 8 to 11 o'clock.

Nearly a thousand ladies and gentlemen accepted the invitation of the committee of arrangement to view the vessel that is to be the Shriners' home for a month. Those who had seen her prior to her refitting for this special occasion could hardly recognize the vessel. The emblem of the order, the scimitar crescent and star, is painted in red on the bow and the same emblem adorns the funnel, while on the after quarter is a painting of the Shriners' pet camel crossing the hot sands. During the evening the company was favored with vocal selections by the Corordia quartet.

At 10:30 o'clock the potentate to the shrine, Reuben P. Hurlbut, was escorted to the after part of the promenade deck, where Noble A. F. Gunn, treasurer of the committee of arrangements, in a neat speech introduced him to the audience and after relating in laudatory words what the potentate had done to make the pilgrimage the success that it undoubtedly will be, presented him on behalf of his many friends with a token of recognition of his services. It is in the form of a Shriners' jewel, costing \$500. The

head in the keystone that holds the tiger claws which form the crescent is a moonstone, while from the base of the keystone is a 5 pointed star, pendant, in the center of which there is a magnificent solitaire.

The recipient in a modest speech thanked Noble Gunn, the members of the committee and friends for the magnificent token, and expressed the hope that all on board who were not going on the trip would go to the wharf on Thursday night to say "Au revoir but not good-by," and wish the Shriners a safe journey and a safe return.

Political Potpourri.

There was a Republican meeting at Achi's house last night and the Independent boys were around and shouted for the Republican speakers and drank Achi's gin (paid for at headquarters).

Wm. Auld has been placed in nomination as candidate for senator by the Democrats, in the place of F. J. Testa who has resigned from political honors. Mr. Auld is a very popular Hawaiian, respected by all. He holds a high rank in Masonry belonging to the 32d degree. He is a fluent speaker in the English as well as in the Hawaiian language and is widely known as an upright, honorable and sincere man. Mr. Auld is respected by the "haoles" as highly as he is by the Hawaiians and his financial position in the community makes him a most desirable, conservative Legislator.

In the place of S. K. Pua, who has accepted a nomination on the Independent Senatorial ticket in preference to his Democratic nomination on the Representative ticket, the name of William Holt has been placed. Mr. Holt is a well known Hawaiian, and politically speaking a very strong man. Full of energy and "go" Holt has increased the fortune which he inherited from his grandfather and his generosity towards his countrymen is as well known as his ability in making a shrewd bargain. The Democrats were happy when Holt said "yes" to their request of using his name on their ticket.

To-night the Republicans will exhibit torches against the rain which will pour down and speeches will be delivered to further order at the Orpheum.

The plumbers send us the following item: At a meeting of the Journeyman Plumbers' Association held at their hall on Fort street last Tuesday evening the following resolution was passed:

Resolved, That this Association endorses, as the friends of labor, Mr. Clarence L. Crabbe, candidate for Senator, and Mr. A. F. Gillilan, candidate for Representative, and we bespeak for each of these candidates, the vote of the laboring man.

Fifty prominent young voters signed the roll of the Young Men's Democratic Club last night at the headquarters of the Party where Mr. McClanahan addressed them. The invitation to join the Club reads as follows:

We, the undersigned, hereby associate ourselves together, under the name of the Young Men's Democratic Club of Honolulu.

The purposes of the organization shall be to assist in every way possible the success of the Democratic Party of the Territory of Hawaii.

We also hereby pledge ourselves to promptly respond to every call of our President, at meetings, parades or for any other duty, to which he may call us.

On Monday next there will be a big meeting at the Fish Market where the Democratic orators will speak and tell the voters why David should be elected.

Politics are getting rather warm and even the Hilo papers are taking a hand in the fray. We were "Slackered" when we saw our Hilo friends fighting for Sam Parker. We thought the kickers always wanted to be on the winning side.

ANCIENT AND MODERN.

An Interesting Story in Which a Honolulu Man Figures.

As a preface to the following telegrams it may be stated that the Lycurgus family can trace their descent to the "law giver." The mutability of conditions through the *Eons of the past* have made them "dinner givers" instead of law givers. And yet the shrewdness and tact of the blood remains there, even if transported to Hawaii.

We could say much more, but prefer to take the dispatches as follows:

CHEYENNE, (Wyo.), Oct. 7.—Disguised under an assumed name and a heavy growth of whiskers, D. D. Dare, the defaulting president of the California National Bank of San Diego, Cal., and the Cheyenne National Bank, is now posing as a prominent citizen of Alexandria, Egypt, where he is the president of the principal street railway.

United States detectives have been searching for Dare ever since his flight to Europe in 1891, but until very recently no trace of him could be had. A German traveler, who knows him intimately, discovered him on a recent visit to Alexandria. He did not make himself known to Dare, but instituted a quiet inquiry, and learned that he had been there for several years; that he was the president and principal stockholder in the Alexandria street railway, and was posing as a very prominent citizen. The German said that few people would recognize in the street railway magnate the man who had wrecked two national banks.

Early in 1891 the San Diego bank failed for \$300,000 and the Cheyenne institution followed a few days later for \$250,000. Dare fled to Europe, and it is charged that he took large sums of money belonging to the depositors with him. He was accompanied by his wife, who returned to this country soon after, when the story became current that Dare had attempted to throw her overboard while crossing the Atlantic.

It is believed that secret service men are now en route to Egypt to place Dare under arrest.

SAN FRANCISCO, Oct. 8.—George Lycurgus of Honolulu left his island home in 1895 for a tour of Europe and also with a view of visiting Greece, his native land.

Lycurgus had been told by acquaintances of Dare that the absconder was in Athens and asked to visit him there. He said he found Dare running a concern known as the American Rug Company, with its place of business on the main thoroughfare of the ancient metropolis. While Dare was not talkative on the subject of his sudden departure from America, he said that he had left San Diego solely on account of the climate, which did not agree with him.

When reminded by Lycurgus that the climates of San Diego and Athens were much the same, Dare insisted that the temperature of the Grecian city was much more conducive to his health. He denied that he had taken any funds of the bank, and insisted that he had left San Diego without any money. He had been fairly prosperous in the rug business and said that he expected his family to join him at an early date. Dare said that owing to the climate he did not think he would ever return to America.

mood. His physical traits, more-
over, lent power to his moral at-
tributes. He was as young and aud-
acious as Clay was in 1813 when
Clay, the leader of the young Rep-
ublicans of the U. S. coerced the
peace-loving President Madison and
the rest of the conservative and ma-
jority and of the party which Jef-
ferson and Madison founded, into
resistance of England's outrages on
American commerce and American
sailors, and into the adoption of the
war policy of the West and South.
He was as handsome as Graham of
Claverhouse, as eloquent as Fisher
Ames, as magnetic as Blaine.

Fremont, the pathfinder of the
Rockies and the Sierra Nevadas, the
man who, in the war of 1846-48
against Mexico, aided Stockton and
Kearney in adding the Golden State
to sisterhood of American common-
wealths and planted the stars and
stripes on the verge of the Pacific,
and who was more concretely con-
nected in the popular mind than
either Kearney or Stockton with
that achievement, easily won the
nomination in the first convention of
the present Republican party.
His career was as romantic as an
Arabian tale.

He was daring, chivalrous, self-
reliant, and resourceful, the embodi-
ment of qualities admirably calculat-
ed to captivate the fancy of the
masses of Americans. Moreover, as
he had no partisan antecedents of
any importance, he was especially
agreeable to the ex-Whigs, ex-Free-
Soilers, ex-Abolitionists, ex Demo-
crats and other elements who were then
fusing themselves into the organiza-
tion which had adopted the Repub-
lican name of Jefferson's origi-
nal party of a third of a century
earlier.

Bryan's dramatic advent as a na-
tional leader, when he swept his first
convention like one of his locality's
tornadoes, made him as picturesque
a personality in the new Democracy
of 1896 as Fremont was in the new
Republicanism of 1856. More fortu-
nate, too, than his prototype, he
held this ascendancy in the succeed-
ing canvass.

What are the causes of Mr. Bryan's
hold on the affections of his party
in 1900, aside from those which gave
him the candidacy in 1896? His
robust sincerity, which even his
partisan enemies have never question-
ed; his strength as a campaigner, as
attested by the fact that, in the
most exciting canvass since 1860,
and with hundreds of thousands of
Democrats supporting Palmer or
McKinley, he polled nearly a million
more votes than Cleveland gained
in his tidal wave campaign 4 years
earlier; and the belief of his party,
rank and file, that he is, on the
whole, the best exponent of his
party's position on the issues of the
finances, trusts, and anti-imperial-
ism.

Upon what does Mr. Bryan's party
base its hope of carrying the coun-
try in 1900? Upon analogy, upon
chance, and upon a belief that its
cause is inherently strong with the
people.

In every election for President in
which the same candidates con-
fronted each other twice in suc-
cession the nominee who was beaten
in the first instance won in the
second. Jefferson, was defeated by
John Adams in 1796, defeated
Adams in 1800. Jackson, who was
left behind by John Quincy Adams
in the contest which went to the
House of Representatives in 1824,
was far ahead of Adams in the
electoral college in 1828. William
Henry Harrison, who was easily
beaten by Van Buren in 1836, just
as easily defeated Van Buren in
1840. Cleveland, who was sixty-five
in the minority in the electoral
college of 1888 in the contest
against Benjamin Harrison, had a
majority of more than double that
figure, or 132, over Harrison in 1892.
New York and Indiana have been
swinging alternately from one party
to the other in successive canvasses
for more than a quarter of a cen-
tury, and both were carried by the
Republicans in 1896. Four years

of power for each party has been
the rule for several successive Pre-
sidential terms, and it is the De-
mocracy's "turn" to win in 1900.

These considerations of analogy
and similitude have doubtless im-
pressed themselves on the minds of
the Democratic leaders. Now for
the hopes based upon chance.

The panic of 1837, which began a
few weeks after Van Buren entered
power, was one of the causes of his
defeat in 1840. That of 1873, in the
Republican period, helped to re-
duce the Republican majority in
the electoral college in 1876 to one.
The monetary convulsion of 1893,
which started about a month after
Cleveland went to the White House
a second time, helped to roll up the
majority which was cast against
his party in 1896. The Homestead
strike in the summer of 1892, in
which many persons were killed and
much property destroyed, in the
last year of Harrison's service, was
one of the reasons for the Repub-
lican "apathy" which was noticed
in that campaign, and for the Rep-
ublican defeat which came at the
polls. A panic is decidedly im-
probable this year, but labor
troubles and crop failures are al-
ways among the possibilities, and
any sort of a calamity invariably
hits the party in power.

All of these reasons, coupled with
the conviction which is doubtless
honestly entertained that their
policy will, upon presentation,
appeal with force to the majority
of the people, together with the
fact that it is the American prac-
tice for each side to make an active
fight in every election, whatever
the chances may seem to be, explain
the hope of Mr. Bryan and his sup-
porters that they will carry the
country in 1900.—Charles M. Harvey
