- c. Were any of the 46 individuals released after unfavorable Joint Board action?
- d. Has FBI been notified of the presence of these individuals within the Sixth Service Command? If not, might not this be desirable?
- e. Has WR been informed of the action taken? If not, might not this be desirable?
