**SUPREME COURT--APRIL TERM.**

DOLE, J., PRESIDING.

TUESDAY, April 24.  
The Court opened at 9:30 o'clock, A. M., when the case of the King vs. W. S. Luce was called. About 50 minutes were occupied in empaneling a jury. The following gentlemen finally constituted the jury:

R. J. Lillie, E. J. Spaulding, W. H. McLean, W. Lantz, W. C. Wilder, Jun., P. Opfergelt, T. K. Moore, R. W. Podmore, S. Ephraim, Jas. Nott, J. D. Tucker, and F. W. Wood.

The Attorney-General, assisted by his deputy, prosecuted. Messrs. Hartwell, Hatch, Whiting, and Creighton were counsel for the defence.

Mr. Hartwell moved that the prosecution elect upon which count of the indictment they prosecute. He contended that there were three separate and distinct charges of conspiracy.

The Attorney-General stated that there were not three conspiracies charged, but only one.

The motion was overruled and exception noted.

The first witness called by the prosecution was Mr. W. R. Castle, who testified: I am a member of the Legislature. I had something to do with the investigation of Custom House affairs. I was one of a committee to inquire into the withdrawals of liquors from the Custom House without the payment of duties.

I went to Mr. Luce to learn what I could about goods charged against the Portuguese Consul, Senor Canavaro, and drawn from the Custom House. (Exhibit A, which was an order filled out by Luce, was shown to Castle, and he said that he went to Mr. Luce about this order.)

He (Luce) informed him that the order was handed to me in that shape. I had a piece of paper, a copy of this order, that indicated what it was. Luce said the paper was handed to him by Captain Haley with the erasure on the back.

I asked him who filled in the order. He said he did, and showed me a stub. I asked him who received credit for this, and he said Capt. Hayley. I understood him to say that the Portuguese Consul had no account with him at that time.

There was some other conversation. This occurred at Mr. Luce's place of business. We were alone. He came to the front part of the store and showed me the stub. There was a gentleman there. There was no one there that I knew. He said it was customary to have orders drawn in that way. I think there was other conversation about this matter. I don't remember what was said about the disposition of the liquor, but I know what my impression was. I think it was said that the liquor was not delivered to Capt. Haley, or the Portuguese Consul, but I don't think those were just the words.

Cross examined: I was chairman of the committee to investigate withdrawals from the Custom House. I found a large amount of withdrawals, about \$40,000, was withdrawn from 1st October 1885, to 1st Oct. 1887. Mr. Canavaro withdrew about \$1,200 liquor in that time. I am not sure whether it is \$1,200 or \$2,000. I followed up his withdrawals to a certain extent. We had this talk in November last year, about the middle of the month.

The Attorney-General asked if in following up these withdrawals, did you find any withdrawal credited to a third party as in this instance?

I did not. So far as I examined I did not find any, but did not go into a careful examination.

Mr. Thurston testified: I am Minister of Interior. Know the defendant. I am aware of the nature of this prosecution. I have had conversation with defendant in regard to the matter of this prosecution in my office early in March, in the presence of Hartwell, Whiting and Hatch.

On the 1st of March I read an application from Mr. Luce for a renewal of his license. I received a letter from the Attorney-General asking me to grant the license. I then sent Mr. Luce a letter, the substance of which was that the license could not be granted as an investigation by a committee from the legislature, certain frauds in getting liquors from the Custom House were attributed to him, and the

Government had determined not to grant any more licenses to anybody against whom it could be proved that they were in any way implicated in obtaining goods from the Custom House without payment of duties. On the 3rd of March I received a letter from Mr. Luce, which in substance was a demand to be heard in defence of this alleged violation of Customs, in the presence of his counsel and of the Attorney-General. In reply to that letter I verbally said that I would have an interview. The interview lasted about one hour and a half, and the question was gone over and over again, more particularly in regard to the withdrawal on this order from Mr. Canavaro. A number of questions were asked by myself and the Attorney-General. He said that Haley had a liquor account with him, and Canavaro had not. Haley told Luce that he would bring an order from Canavaro for liquors, the duties on which would amount to \$500. Luce approved of the proposition. Haley did bring such an order, and stated that it was for the amount of \$500. But it did not so state on the order. The order was in blank and was filled by Mr. Luce with such liquor as he chose. Mr. Luce filled it out for over \$500. He then presented the order he had filled out that had been signed in blank by Mr. Canavaro, and drew the liquor from his Custom House, but the liquors so drawn were not delivered to Haley or Canavaro. He then placed \$300 to the credit of Haley and credited the balance of the order to Canavaro, although he (Canavaro) had no account. He (Luce) explained that the reason that he placed this amount to Canavaro's account was, that liquor had been sent to the Hawaiian Hotel Stables for Canavaro by order of Capt. Haley, but never had any account with Canavaro. Luce said he did not see any erasure on this order. He did not see a limitation on the order to one cask of wine. If he had seen that the limitation was for one cask of wine, he would not have filled in the order as he did. He disclaimed any wrong intention. He believed what Haley told him, that Canavaro had authorized Haley to have the order filled in for \$500, but he had no other proof than Haley's word. Haley was an intelligence officer in the Hawaiian Army. He lived here some years. The object of withdrawal was as I before stated. Mr. Luce had an account against Haley and Haley was to produce this order from Canavaro, and the amount would be credited. Mr. Luce did not state the amount of Haley's account at the time.

Cross Examined: Mr. Canavaro said to Luce that he was very much surprised that Haley had done such a thing. If Haley had asked him for an order he would willingly have given him one for \$200 or \$300. I can't say what the attorney said about Canavaro being brought as a witness. There was a great deal of conversation on the matter. There was a question raised whether or not he could be made to testify. I think that Mr. Canavaro was wanted by the Attorney for Mr. Luce. The question was discussed on the charge of perjury. I don't remember any other charge. The main question was in regard to the renewal of license, and a speedy trial of the case.

Luce said he could not recollect that there was any erasure on the order. He stated that at the date of that order he thought there was an account, but that he could not tell without referring to his books, whether anything was due or not by Haley.

Mr. Luce stated that he had a running account with Haley; that Haley proposed to him to obtain an order from Canavaro for liquors upon which duties were to be remitted. He could not tell whether there was a credit to Haley, and that this was a further credit, unless he referred to his books.

Recess until 1:30 p. m.

AFTERNOON.  
On resuming at 1:30 p. m., the Attorney-General read a copy of notice to defendant to produce his books of account, and asked if his books were produced accordingly.

Mr. Hartwell said they were not, and would not be, and quoted the law under which they were withheld.

The Attorney-General was sworn, and testified in regard to the interview in the office of Mr. Thurston. It was on the 5th of March. I was called into the office of the Minister of Interior and there met the defendant with his counsel. The subject of Mr. Luce's license came up, and the first point discussed was the fact that I lodged a formal protest against the issuance of license to Mr. Luce.

There was an intimation in the letter to Mr. Luce, that he was guilty of forgery, in altering the Canavaro order. The objection of myself and Minister of Interior was on the ground of forgery, and not conspiracy. We did not have the original order, but I had a copy. The interview lasted from 11 to 12:30 o'clock, and the matter was discussed by all of us. Mr. Luce wished my objection to his license removed, as being unfounded. He also stated that he was guilty of no wrong, no crime. He stated voluntarily without any threats on the part of either of us, that Haley had a running account with him in 1887. My recollection is that Mr. Luce

stated that Mr. Haley was indebted to him, but he was not sure of the amount, until he examined the books. Mr. Luce stated that as Haley had an account with him, that he (Haley) should get an order from Canavaro on the Custom House, for the withdrawal of liquors. He proposed that Haley should bring an order from Canavaro for \$500, and the examination brought out this explanation, that Haley should secure Canavaro's signature to an order, and that he (Mr. Luce) should fill in the order for liquor, the duties on which should be \$500, and having so filled the order present the same to the Custom House and draw the liquors without payment of duty; to use Canavaro's name to obtain a remission of duties, and a portion of the duties so remitted should be credited to Mr. Haley. It was not made entirely clear to me what amount should be credited to Haley at that time. Mr. Luce stated that in accordance with that agreement, he gave Haley a blank form, and that Haley some time afterward, returned the form to him with Canavaro's indorsement on it. Mr. Luce was not positive whether it was that same day or the next that it was handed to him. After Haley brought the paper back, Mr. Luce filled it in with the list of liquors and signed it with his name. I don't recollect who presented the order at the Custom House, but Mr. Luce stated that he drew the liquors on it. The duties on the liquors so drawn were \$501.15. The disparity between \$500 and \$501.15 was caused by the class of liquors. The order was filled in as near as possible to make \$500 duties. Having secured these liquors he credited the account of Haley with a certain amount and credited the balance to Canavaro. Mr. Luce would not be positive as to the amount of those respective credits but after some deliberation he settled upon \$300 to Haley and \$200 to Canavaro. He was not sure but thought those were the amounts. I examined him at some length in regard to Haley's indebtedness, and my recollection is distinct that he stated that Haley was then indebted to him, but to what amount he would not undertake to say without referring to his books. I put it to him several ways and he was not sure how the balance was without reference to books. He stated that he had no account with Canavaro, but had sent liquor several times to the Hawaiian Stables for Canavaro, but he charged the liquors to Haley, as Haley had ordered them. He said that he had no knowledge of Canavaro receiving that liquor; only what Haley told him.

Mr. Luce did not explain why he credited Canavaro with this amount, although pressed to do so. He stated that that credit was still standing on the books, although he had had no dealings with Canavaro before or since. He stated that the amount was not in the ledger, but was kept in some peculiar way, which I did not understand.

The interview became quite warm, and I asked him if he was using Canavaro's name to pay Jack Haley's whiskey bills.

I do not recollect that he said yes, but he did not deny it. He did assert that he avoided the payment of duties, which had been credited to Haley to pay his liquor bill. He stated distinctly, that what was drawn went into the general stock of his store, and that no portion of it went to Mr. Canavaro, and no portion went to Haley, on that transaction at least. It went into his stock, and customers purchased it. He concluded that at the time of the withdrawal of the liquor he did not suppose that any portion of the liquor was for Mr. Canavaro's use. He stated that such a course was customary. He had done the same thing when with Macfarlane. I think he used the expression "We all do it." He said that he depended upon Haley, and believed he was telling the truth, and stated that he would not have taken the part he did, had he known Mr. Canavaro did not know what was being done. He stated that he saw Mr. Canavaro's signature, but did not see any erasure, nor any limitation on the order. We claim that the original order called for "1 cask, 27 gallons of wine, for my use," the words "27 gallons of wine" were erased, but "for my use" remained. He stated with some warmth that he did not see the erasure, and that he had no knowledge of the endorsement being changed. The interview was long. The counsel made arguments here and there, and I have quoted Mr. Luce's exact words. There were a good many epithets bandied about. I believe I have stated all of any consequence that happened at that interview. There was conversation to the effect that he made nothing from it. I asked him if he did not secure the ready sale of \$500 worth of liquor, and he said yes. I asked him if he did not secure the payment of a whiskey bill from a dead beat, and he said he did not know that Haley was a dead beat. He said that he did not know that there was difficulty in collecting bills from him. I will state that it was expressed by Mr. Luce, and his counsel, that he (Luce) be brought to a speedy trial for perjury, and they were assured that they should have a speedy trial as we could give them. They desired that Canavaro's testimony be procured. But I said that we could not obtain it as it was the rules of the Portuguese diplomatic service for their repre-

sentatives not to testify in a foreign Court of justice, but Canavaro had applied to his Government for permissions to do so, and hoped to receive it soon. I objected to having his testimony taken at his house, as it was unconstitutional.

Cross Examined: I think the interview began about 11 o'clock. My first intimation of it was, when the Minister of Interior notified me. I don't think it was 11:30. I don't think that the counsel for Mr. Luce used any epithets or warm language. I will admit frankly that I used choice language. Mr. Luce stated that the profits went to pay bills.

I characterized Mr. Haley pretty strongly. I believe Mr. Hatch proposed the idea of his being a scab-wag, etc., by stating that he moved in good circles. I recollect Mr. Luce said, that of Capt. Haley was that kind of a man, he did not know it. I used the expression a "man of his reputation." I did not think he knew enough to be a British officer. It takes a man to be a British officer. I will explain my position with Mr. Luce. Mr. Luce secured the possession of a vacant lot between the office of my brother and myself and the entrance to Mr. Cunha's—which perhaps some present in Court may know—and built on it. I had a law suit with him about the building, and I lost the case. I represented to the Minister of Interior the injustice of allowing the building to remain and shut out the light from my office, which was also rented from the Government.

I. Q. Tewksbury, sworn, and testified: I am an officer of the Customs, am store keeper of the Bonded warehouse, have been there 5 1/2 years. I was in that office during the months of Jan. and Feb. last. My duties are to receive goods and deliver them upon orders. I have liquors under my charge, considerable quantities at times. If a dealer wishes to withdraw liquor he comes to me. I collect the duties. I know Mr. Luce. He is a wholesale spirit merchant in Honolulu. He has drawn spirits from the Custom House, (shown an order for liquor). Have seen this before; it is an order for drawing liquors from bond. It is in Mr. Luce's writing. On the 1st day of February 1887 I saw this order in my office at the bonded warehouse. I don't know who

brought the order. Orders of that size were generally brought by Mr. Luce himself. I have had no conversation with Mr. Luce in regard to this order. I don't recollect if Mr. Luce was there in connection with this. The order was connected with getting out liquor. The goods are whiskey, gin, brandy, etc. They are dutiable goods. Nobody paid the duty on those goods. I delivered the goods because the order was endorsed by Canavaro. If an order the same as this was presented without such an endorsement, the duties would have to be paid or a bond given for their payment. The goods were all imported. Either myself or clerk delivered these goods. I noticed this scratch the day it was presented, but it was not as prominent as now. I presume the words on the endorsement were there when it was presented. I don't generally read anything but the name. The endorsement Canavaro is entitled to draw the goods from the Customs. The goods in that bill were in bond when the order was delivered. And were in the custody of the Customs officer. I charge the delivery of goods to the respective accounts, and return the orders to the Collector-General. The endorsement has no account with me. Mr. Luce is the one who has the account. The legal amount of duties was \$501.52, and on the order of Canavaro was remitted. I have no knowledge of the duties being paid to any one. The marks on the margin are by me, and denote the day the goods were delivered and carried into my books.

Cross-examined: The duties were not paid on these liquors. If there is any law to the effect that duties have to be paid before goods are bonded, it has not been carried out. These people, meaning diplomatic agents, have not imported any such goods, but they have been allowed to draw them. Mr. Canavaro has had other orders, but I cannot tell how many. I don't remember if I mentioned to Mr. Luce about the erasure. Other people handle those orders. The erasure may be more prominent to me now, as there has been so much talk about it. I have been sitting here during this trial, have not learned anything while here that I did not know before.

Here the prosecution rested.

Mr. Hatch then addressed the jury and outlined the defence they should offer.

Mr. Luce was called and testified: I filled in that order and signed it. I filled it in to get goods from the Custom House, at the request of Capt. Haley. Haley was a customer of mine. He said that he had spoken to Canavaro about getting goods, and asked me to give him a blank order. I gave him one and in a few days he returned it signed. He said Canavaro offered him the order. I filled the order and drew the goods, and put them in my store. Haley did not owe me anything at that time. They were to replace goods that Haley had taken for Canavaro.

Here the Attorney-General asked the Court to demand the defendant's books.

The Court stated that it had no authority by statute to order the production of the books.

The Attorney-General then moved that the evidence as regards the account of Mr. Haley, be stricken out.

The Court thought it would be wrong to take it out. It does not state anything but that Haley did not owe anything at that date.

The witness was asked, Did you deliver goods previously to the date of that order for Canavaro?

The Attorney-General objected to this question. The Court said it was a business transaction and could see no reason why the question should not be asked.

Mr. Hatch said his question was, have any goods been ordered from you for Mr. Canavaro? To which the witness replied, frequently, Capt. Haley ordered them.

I have known Capt. Haley since shortly after he arrived here. He has acted for other members of the diplomatic corps in getting orders for me, during the time he was here, and when I was in business. The extent of his orders were large for these other people. I had no reason to mistrust his statements. I don't know his financial position. He had an income from home, and a salary for positions he held here. I consider he had a good income. He had credit. I believe he was a man that paid his bills. I don't remember seeing that erasure on the order. It might have been there, but I took no notice of it. I saw Canavaro's name. Capt. Haley dictated the amount of money for duties that the order should represent. The order was filled in, prior to it being sent to the Custom House. Nothing was said to me at that time by Capt. Haley that I have not stated. I had no agreement or no conversation with Haley in regard to these liquors. I had no agreement with him in regard to this transaction. I have drawn liquors for other members of the

diplomatic corps; the procedure was similar to this. Sometimes I filled in the orders before I obtained the signature, and sometimes after. I told the Attorney-General that I did not know how Haley's account stood. This was at the time of the interview. I had no reason to look into his account. I don't remember saying to the Attorney-General at that time that Haley was indebted to me. I have had dealings with Canavaro since the date of this order. I don't think they asked me at the interview if I had any dealings with Canavaro. I don't think I told the Attorney-General that I had no dealings with Canavaro since the date of that order.

At 5 o'clock p. m. the Court adjourned for the day.

WEDNESDAY, April 25.  
Court opened at 9:30 a. m.  
Mr. Hatch called that Mr. Luce be recalled for the defence.  
The Attorney-General objected.  
The Court overruled the objection, and Mr. Luce was recalled.  
Mr. Luce recalled, said, I do not remember ever telling the Attorney-General that no part of that liquor was for Mr. Canavaro's use.  
Cross-examined by the Attorney-General: At the time of this transaction I had an account with Haley. Previous to that transaction I don't remember whether I had an account with Canavaro. If I had an account it would probably have been closed. I think at that time the account would have been promptly paid. I cannot remember whether I had any dealings with Canavaro. Capt. Haley had an account with me from the time I first started in business. I was acquainted with Haley before. I was employed in the house of H. Macfarlane for over 10 years. I can't remember if Haley was a customer of that house, but I think he was. I don't remember what his business amounted to with me. He was a fair customer. Say from \$100 to \$500 a quarter. Haley had his first conversation with me in regard to this order, prior to this date (Jan. 28th, 1887). I can't fix any date. The order might have been brought to me that day or the day after. Haley told me that Canavaro told him that if he (Haley) brought him an order he would endorse it, so that he could get a rebate of duties. Capt. Haley came to me and said that Canavaro told him that if he would bring him an order he would endorse it. He did not say that Canavaro said that he (Haley) would secure a remission of duties by so doing. I have a very fair memory. I don't know whether the conversation was in the office, or in the street. I gave him the order in the office. I don't remember what time elapsed between the time of the conversation and the giving of the order. I stated that I did not know whether Haley was indebted to me or not. I have subsequently found out that Haley was not indebted to me, by the examination of my books. The books are now in my office.

Here the Attorney-General asked the Court for an order for the books, or else have the evidence struck out. The motion was argued by both sides.

The Court ordered that the testimony be stricken out.

By the Court: You said that by examining your books you found that Haley did not owe you; have you anything more to say about it?

At the interview I thought that perhaps Haley might have a balance to his credit, or it might be the other way. I then examined my books and found that he did not owe me anything.

The Court then instructed the jury to ignore that part of the testimony relating to the indebtedness of Haley, to which the attorneys for the defence filed exceptions.

Cross examination resumed by the Attorney-General. I did not know as to Captain Haley's financial standing. He had a good income, and had \$10,000 in the stable company. I did not know that that \$10,000 was in his mother's name. I know J. W. Luning. During the two years I have been in business he has been a frequent visitor to my store. I do not know that Mr. Luning had a number of bills against Haley that he could not collect. He never told me his business. I could not have said that I did not see the erasure, as I might have seen it. I only looked at the signature and took it for granted that it was all right. I never said that I read the signature and the words "for my own use," and did not see the erasure. That was a blank order when I gave it to Haley. I must have filled it in three days after, according to the date. The figures 493 and 501 are mine. I cannot explain those figures. The order explains itself. The duties amount to \$501.

There are 216 gallons of wine and 63 gallons of spirits. I don't remember the cost of dew drop whiskey in bond. I think \$3 a gallon. The quantity in a cask varies.

Century whiskey is more expensive than the other, it is worth about \$4 a gallon.

The Court ruled all this evidence out.

I filled the order in at Capt. Haley's dictation. It was for the amount of \$500 duties. They were

in part for my general stock and part to replace goods taken by Canavaro.

By the Court: the goods that went into general stock were sold to anybody? Yes sir.

I have had dealings with Canavaro since that time. I don't remember the amount. I have probably sold him about \$50 or \$60 a month. He has paid for it. He paid cash. I could not say that the amount was \$37.50. I think the last bill he paid was about \$38.00. I think he has paid more for the quarter previous. I think it was the December quarter. It was after he heard of this row. I think the liquors were purchased before the publicity of this matter. I recognize this bill, it is for \$37.50. It was paid in Jan. 1888. And the liquors were got in October. If Canavaro should say that that was all the transactions he had with me, I should say he was mistaken.

*Doncaster Reporter* of July 6th,  
1887, publishes the following in its  
editorial columns—

less, and taken in a cab by two  
gentlemen to the office of F. W.

was on his way back to his

we all know is a very dreadful  
thing for a poor man with a family

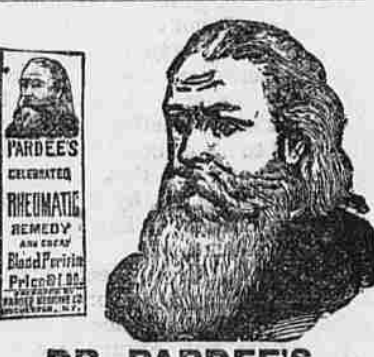
