Yankee Consul Protests When Canton Shelled

Boards Flagship of Sun Yat Sen and Objects to Indiscriminate Bombardment of Chinese City.

(ASSOCIATED PRESS)
 LONDON, June 20—Despatches from Shanghai say that Sun Yat Sen and Wu Ting Fang are aboard a warship en voyage to Shanghai.

PEKING, June 20—Sun Yat Sen's bombardment of Canton damaged three American buildings in the city. The American ambassador asked Admiral Strauss to protect American property.

 PEKING, June 20—A dispatch to the legations here says that 200 foreigners boarded a steamship for Hong Kong when Sun Yat Sen's gunboats started an indiscriminate shelling of Canton on Sunday. The American consul and senior American naval officers boarded Sun Yat Sen's flag ship and protested on the ground that the lives and safety of women and children were being endangered whereupon Sun promised to shell only the barracks and gun emplacements outside the city.

It is reported that Sun is bringing up reinforcements.
 LONDON, June 20—A Times despatch from Hong Kong says that Sun Yat Sen's troops are returning toward Canton and that Chen Chung Ming is also bringing up reinforcements.

Casualties of the Saturday "Bombardment" are estimated at 1000.
 Evidently Sun Yat Sen's men removed the breach blocks of their guns before evacuating their positions.
 HONGKONG, June 19—Dr. Sun Yat Sen's army, consisting of 30,000 troops under the command of Gen. Heo Sheong Chi, arrived today at Mow Hing, in the province of Kwongtung and with the assistance of naval forces, is preparing to make an attack upon the revolutionary army under the command of Gen. Chun Chung-ming now assembled at Canton.

TIENTSIN, China, June 18—Declaration of an armistice between the forces of General Wu Peifu and Marshal Chang Tso-lin is reported from Chinwangto, where the commanders were negotiating. It is reported that the withdrawal of Chang's Fengting troops from Shanhaikwan will be resumed this week.

AMOY, China, June 18—Troops commanded by General Chen Chung-ming have taken the president's residence in Canton. Dr. Sun Yat Sen, president of the Canton republic, is believed to have escaped aboard a gunboat.

Five gunboats under Sun Yat Sen's command shelled Canton Saturday afternoon. Many residents have fled the city. Few casualties are reported, but the invading soldiery did considerable looting.
 Sun Yat Sen's Kiangsi army is reported defeated. He is awaiting the arrival of the defeated army, after which he plans to attempt to recapture Canton.

KIUKIANG, China, June 19—Fighting continued Sunday at some places outside Canton. Sun Yat Sen's soldiers giving battle to the forces of Chen Chung-ming, despite the collapse of the southern government.

Sun Yat Sen, who fled Saturday from Canton, is still at Whampoa.
 Severe fighting continues in Kiangsi province. Last Saturday a junk load of ammunition exploded in the river near Nanchang, killing 50 of Sun Yat Sen's men.
 Wu Peifu and Sun Yat Sen forces are battling around Kianfu. Hundreds of wounded and women are coming into Nanchang, where the hospitals are already full.

Molokai Homes Lots Thought Too Large

 HONOLULU, June 20—Dr. Elwood Mead speaking to the Hawaiian Homes Commission this morning told them of his conclusions after his visit of investigation of the Molokai lands. He said he was generally pleased with the plans except that he considered the tracts that are to be allotted as too large.
 Governor Farrington pointed out to Dr. Mead and the commission that the Hawaiian Homes law provides a minimum size of 20 acres for a lot and such provision cannot be changed by the commission.

COAL SUPPLY LESS

 WASHINGTON, June 20—The department of commerce announces that on June 1 the railroads had 75 days supply of bituminous coal. On May 1 the supply was estimated sufficient for 94 days.

OFFICES FOR WOMEN

 HONOLULU, June 20—Governor Farrington has a telegram from Washington announcing that the house of representatives have passed the bill which makes women eligible to hold office as territorial legislators and delegate to congress.
 The measure transferring the federal leproasarium on Molokai to the Territory has also passed.

Canneries Busy and Rush Draws Closer; Peak About July 15

Maui's pine pack is getting into swing and coming forward fast, according to reports received from the three canneries yesterday. On West Maui the peak will be reached soon after the first of July. D. T. Fleming reports but in East Maui the climax will not be reached until ten days to two weeks later.

The big cannery at Haiku, that of the Haiku Fruit & Packing Company, has been running three lines for several days past and expected today to start up a fourth. Manager A. F. Tavares says the fruit is fine and that the cannery has taken on a real busy air. More help from Honolulu is expected within the next few days and the fruit will come in faster and faster until between the tenth and fifteenth which will be the crest, he expects. His estimate of the pack was given out some time since.

Tavares reports that it is running two lines and its pack is now about 2700 cases daily. It also expects the crest to come shortly before the middle of July. It has ample forces to operate its cannery.
 Over at Lahaina up to the first of the week Baldwin Packers had packed about 13,000 cases, is now putting up something over 2000 cases daily and will add 13,000 to its total this week. Next week the output will be increased to 3000 cases daily. The top of the season will be a little earlier there, about July 1.

A. F. Tavares said that plans for the Hana company are going forward steadily along the lines he had already indicated. Demand for stock in the new company is apparent but the preliminaries to incorporation have not been completed yet.

Cards Out Announcing Dinner to Judge Case

Cards announcing the dinner which the Chamber of Commerce and the Maui County Fair and Racing Association are tendering to Judge D. H. Case the former secretary of the two organizations were mailed out Saturday night to the members of both organizations and replies started coming in to the Grand Hotel yesterday morning. The committee is expecting to meet with the toast master today on general arrangements of the program.

No "stag affair" will this dinner be. There are women members of the Fair and Racing Association and the design of the committee in charge was to make it a "family affair" the members of the families that together go to make up the one big "Maui family." Male members of both organizations may make applications for other members of their families, wives, mothers, sisters or others. Women may make application for friend husband, for other male friends or for members of their families or visiting friends. Primarily however, the dinner is designed for members of the two organizations and their immediate families.

Another point the committee has asked to have brought out is that in formal dress will prevail at the banquet. "Soup and fish" dress is no requisite. Maui is dining "en famille" on this occasion.
 Reservations should reach the Grand Hotel not later than next Monday and the dinner will be held the following Thursday.

Possibility of Rail Strike Looms Bigger

 CLEVELAND, June 20—It is learned that a strike vote of railway clerks and freight handlers on the New York Central road has been authorized.

CINCINNATI, June 19—Chiefs of railway unions have notified the railway labor board of an intended strike if authorized by a million and a quarter workers whose wages were ordered reduced on July 1st.

John L. Lewis, head of the mine workers union stated "Railroad workers have no alternative except to fight." Lewis meets with the railway union leaders Tuesday to consider joint strike action. Lewis pledged the miners aid but did not say in what form. He said the miners would do anything helpful or constructive for the railway men and that the miners were convinced that the rank and file of the railway unions recognized the necessity of making a fight regardless of consequences.

Steamers Booked Full For Fourth

Great Crowds Coming For Foresters' Convention and "Make Happy" Program Is Growing Steadily Bigger.

For "Make Happy" the Kinau will bring 180 Foresters and families and friends and the Kilaua 280. M. G. Paschoal, chairman of the "Make Happy" committee said yesterday and advised that he was advised that others would come up on the Mauna Loa and that if there were a sufficient number to warrant it, as he expects there will be, the Mauna Loa would make Kahului on her trip to Hawaii on June 30. Those who can stay longer than the Fourth of July holidays are arranging to come up earlier in the last week of June, there will be still others on the July 1, Mauna Kea. It will be a great crowd that will be here for the Foresters convention and the carnival in connection with it.

Great Races and Sports
 "It is a big program we are putting on," said Paschoal. "The racing program is a good one and we have promise of a long string of entries but they will not close until Sunday. You can put it down though that the card will be well filled and the class will be high. Maui will live up to the reputation for Fourth of July races it has established during the past 40 years. The track is in fine shape.

"The Japanese wrestling will be a great attraction. We have received definite information that Kaula is sending three mat artists and we will have the beat from Oahu and probably some from Hawaii. This island has some Japanese wrestlers that rank high in the sport and they will be represented."

Asahis Coming Over
 Here Paschoal turned to George Cummings and inquired as to the baseball program. "We shall have a three cornered tournament and a good one," George replied. "There will be strong Foresters team made up from the two Honolulu Courts and we expect the strong Honolulu Asahis. Against them we will put in a strong Maui team. The Honolulu Foresters have some of the best talent of Oahu with them. We have word from Kaula that though they will send a good delegation to the convention they have not been able to get up a ball nine that would show as the Garden Island would want to be represented. We've wanted the Asahis over here for a long time and they will be a big drawing card for the fans."

Shows and Entertainment
 Then Paschoal continued: "There will be shows aplenty, Eddie Fernandez will have a big bunch of attractions. Among them will be, he told me when I was in Honolulu, the "Fire Eater," "Wrestling Bears," a dandy vaudeville and the best bunch of dancers he has ever got together. There will be two rides, the wheel and the merry go round and about two dozen other concessions.

"Each of three courts will put on an evening of entertainment. Court Lunallo will put on the same show it staged in Honolulu last year entitled "Four Nights in Hawaii." The court has been working for weeks in preparation for it.
 "Court Camoes will stage a vaudeville show and without saying too much and giving their plans away Miss Almos will sing and Johnny Noble and Sunny Cunha are on the bill.

"Valley Island will reproduce some of the best numbers of the 'Night in Hawaii' recently produced by the Hawaiian Woman's Club but will add several features which are now being rehearsed."
 "This is just a brief summary of our program, but it shows that "Make Happy" will come through big."

Methodist Mission Breaks Ground For Church at Lahaina

Building of a Methodist chapel has been started in Lahaina and it is reported that plans for a Methodist mission there are quite extensive.

It is some months since the Methodist mission in the Islands secured a tract of land a little Kaanapali from the Pioneer hospital and it is here that ground has been broken for the chapel which is to be a building of some 42 by 26 feet. It is said that a parsonage is also to be erected on the premises and that other plans contemplate the erecting and maintaining of a school.

It is said there are a number of Methodists, especially among the Christian Japanese of Lahaina district.

LABEL SUIT DISMISSED

MAUI GIRL MURDERED

 HONOLULU, June 20—Police are seeking Thomas Mahuka on charges of having murdered his wife, a former Maui girl.
 Mrs. Mahuka was found with her throat cut by razor slashes and died a few minutes later. Her dying statement was "My husband did it."
 Neighbors told the police the couple had had considerable domestic difficulty lately.
 Mahuka was an inmate of the Kalihii receiving station up to a few years ago.

County Library Now Extends Usefulness In Many Directions

From the Maui County Free Library at Wailuku there are 737 individual borrowers, adults and children. This does not include the number of individuals served from the various branches that have been established as to which reports are being compiled. In Wailuku there were 46 new borrowing cards issued in the month of May. Additions to the books for circulation in the month were 126, of which 111 were adult fiction, 13 juveniles and two books of reference.
 During May while there were alterations going on at the entrance of the building and painting later there were a few days the delivery department was closed and thus the number of books loaned in the month at Wailuku was somewhat smaller than it might otherwise have been but 1813 books were taken out in the month.

To the outside branches 176 books were shipped out and 21 were returned, there being outstanding for the branches 1718 volumes. A large number of branches are in the schools and their service will be ended during the summer but community branches are being opened to replace some of them during the summer, as at Kula where Mrs. K. Ching will be librarian. At Hana the branch was opened on the fourteenth and Miss Mitchell wrote that she had a busy day giving out cards to prospective borrowers and that 23 books were taken on the first day. When the cards she gave out are returned she expects to have quite a large list of book users.

Miss Morse, the Librarian made trips to Hana District and to Molokai during the month and made arrangements for the starting of the two branches mentioned, two on Molokai and for several more schools to be served after the summer vacation.

Trout Fry Planted And Game Birds Are Secured For Maui

Trout fry have been placed in three streams on Maui and game birds have been let loose on Molokai and Lanai and are to be turned out on East Maui soon, is good news for Maui sportsmen, disciples of Isaak Walton and nimrod alike. H. L. Kelly of the fish and game commission brought over the trout fry that have been long awaited and Supervisor D. T. Fleming brought in the game birds.

In the upper waters of Waiehe and Iao streams on this side of the Island and in Honokohau stream in West Maui young trout have been released. Kelly attended to the stocking of Iao and Waiehe and Arthur Gordon and Elbert Gillin carried two cases of fry far up Honokohau. They went horseback as far as they could and then walked on two or three miles further. Now the results of the experiments must be watched. They are the first trout the commission has introduced on this Island.

Before leaving Kelly said he expected good results in Waiehe stream but was not so sure of Iao. Gordon and Gillin said they took the trout well above the Honokohau intake and that there were other fish in that vicinity so they hoped all would be well.

As announced last week Supervisor Fleming brought from Honolulu a lot of game birds. Among them are the top knot dove from Australia, some of which had previously been liberated on West Maui and Lanai. Those for Central and East Maui will not be liberated until after the dove shooting season ends. There are also large Nicobar doves to be freed when the season ends.

Yesterday Fleming said there has been sent to Lanai Spinafax pigeons, blue eyed doves and pink eyed doves, the blue eyed being smaller than the doves known here. Nicobar pigeons and 15 pairs of desert quail from Australia were liberated on Lanai. There the birds are safer from molestation than on Maui, he says.

Ambassador's Nephew Charged Conspiring Sends Arms to Ireland

 TRENTON, N. J., June 19—Col. M. H. Thompson, vice-president of the Auto Ordnance Co., of New York, and a son-in-law of Col. George Harvey, the American ambassador to Great Britain, was indicted today by the federal grand jury, together with seven other individuals and the corporation itself, on a charge of conspiracy to ship arms to Ireland in violation of the neutrality laws.
 The indictments are the result of the seizure last June of 459 machine guns which were concealed in the bunkers of the freighter East Side, which was docked at Hoboken. It is believed that the guns were destined for Ireland.

LONDON, June 20—Ambassador Harvey last evening refused to comment on the indictment of his nephew on charges of conspiring to ship arms into Ireland, when shown the dispatches telling of the indictment.

Ship Subsidy Bill To Wait on Tariff

 WASHINGTON, June 20—It was announced from the White House that President Harding informally sanctioned the postponement of consideration of the ship subsidy bill for approximately one month, and that Harding and Postmaster General Work were both in favor of reducing second class postal rates.

The president has abandoned his plans for an Alaskan trip this summer owing to the pressure of public business.
 A conference of senate republicans yesterday voted 30 to 9 against side tracking the tariff bill to consider the soldiers bonus. By a vote of 27 to 11 a resolution was passed to dispose of both the tariff and bonus bills before a recess.

Treaty Favorers Far In Lead In Irish Voting

In Dublin DeValera Succeeds In Putting Only One of His Supporters Across; Seven To One For Treaty.

DUBLIN, June 20—Returns to this afternoon show 44 coalition-pro-treaty members elected to the Dail and 25 coalition-Republicans.
 Dublin returns show that 72,285 electors voted pro-treaty and 10,920 against.

Only one DeValera supporter was elected in Dublin. Countess Markiewicz is among those defeated.

 DUBLIN, June 20—Fragmentary returns up to last night show an unexpectedly heavy vote for the independent candidates in the Irish elections. The pro-treaty candidates are leading those opposed to the treaty and the laborites. The vote has overwhelmingly favored pro-treatyites as second choice on the preferential ballot. However the Republicans claim they do not expect to lose more than 15 seats in the Dail.

 DUBLIN, June 19—The first count of the votes in the Irish parliament elections of last week showed today that the mid-Dublin district had elected Lord Mayor O'Neill, a pro-treaty independent and Alderman Burns, also a pro-treaty candidate. Two more seats are to be decided in this district. Northwest Dublin, elected R. J. Mulcany and Philip Cosgrove, both pro-treaty candidates. Two more seats are to be filled from this district.

Inter-Island Co. Is Reported as Ready to Run Maui Excursion

Honoluluans are being given the opportunity to know the Islands better and at the same time enjoy day outings through the excursions that are being conducted by the Inter-Island Company and Maui can have the same opportunities if it be desired. So reports W. J. Coelho after talks with officials of the company in Honolulu.

The Inter-Island Company has run an excursion around Oahu and one around Molokai with the Kilaua sailing from Honolulu and is announcing a Fourth of July trip around Molokai by another steamer. The two already held are reported to have been much enjoyed and Coelho thought it would be a fine thing if a similar chance for outings were given Maui. He took the matter up with Messrs Stanley Kennedy and Hon. The Inter-Island Company is ready to run an excursion or excursions from Maui, Coelho was told by the officials. All that is necessary is to assure a sufficient party and agree upon the date desired. Some one will have to take the initiative, if any thing is to be done however. Comparatively few persons have sailed completely around Maui and the same is true as Molokai. Either of those trips would be popular, it is believed.

Oahu Chamber Grets Denby and All Party

 HONOLULU, June 19—Guests of the Chamber of Commerce, secretary of the navy Denby and party circled the island of Oahu by automobile Sunday. A stop was made at Haleiwa for luncheon.

After complimenting Simpson and Sumnerall on the splendid cooperation between both branches of the service and the civilian administration and the fine condition of the morale of both branches, Denby spoke as follows in part: "You do not like to think of the possibilities that make armies and navies necessary but we know such possibilities exist and they can not be forgotten by those responsible for the defense of the United States."

Denby in the glass bottomed boat at Haleiwa bay saw the floor of the ocean that his forces guard. Upon the return to Honolulu he made an address at the army and Navy Y. M. C. A. The party left for Japan at 9 o'clock this morning.

Sports Get Walloping From Dusky Chinese; Cummingsites Trim Asahis

Engels' Warriors Tied With Rice Birds For First Place In Major Circuit, Game Featured With Miscues; Sueda's Three Sacker in Seventh Saves Asahi from Shut-out.

While Haiku rested the Chinese played and beat the Sports and the Wacs took their game from the Asahis on Sunday. Now the Haikus and Chinese are tied with three victories and no defeats and the Sports and Asahis are tied for last place with the reverse of the leaders in games won and lost. Next Sunday the leaders will battle it out and the tail enders will struggle with one another to get a head out of the cellar position.

In the first game the Sports lost largely because of ragged work. The fourth was their fatal inning and it was then that Moniz was taken out and Arthur Baldwin put in with two runs scored and only one out in that frame but two more runs came across before Baldwin could stem the tide though he allowed only one hit in that inning. His delivery was found in the seventh and eight, however, and loose team work let in four tallies against him on the single safety against him in the ninth.

For the Chinese young Paschoal, a school boy, made his debut in major league ball as a slab artist and made a highly creditable showing for 5 innings. For four frames he held the Sports hitless and allowed but one in the fifth. In the sixth he began to show the effect of a blistered finger and lost some effectiveness, three hits an inning being made off him in that and the next. Haake relieved him and gave the Sports a single bingle in two frames. For the Sports Caswell's batting was the feature, a home run and a three sacker going to his credit. Clean fielding was one of the pleasing points of the Chinese team's game only two errors being charged them.

Wells Cummings Stars

Though the result was never really in doubt the game between the Wacs and the Asahis was the feature game of the afternoon. Wells Cummings handed them out for Brother George's team and was effective all the way through. In fielding the Wacs showed a decided improvement and blundered only three times. With the stick they hit hard and often and they performed like the Wacs of old. In addition to holding down the opposing batters Cummings laced out a fine double. Ahul Lyons had batting honors, however, with four safe swats one a three bagger. Sueda sent out one for the Asahis that was good for three sacks, also.

First Game

The Chinese opened up in the first with one run across. Silva walked and stole second. Shim fanned. Haake doubled scoring Silva.

The Orientals forced over another counter in the second. Enos popped out. Wadsworth safe on Carrolls error. Ah Leong walked forcing Wadsworth to second. Paschoal fled out. Silva single scoring Wadsworth.

Fatal Fourth

The fourth canto put the game on ice for the Chinese. Four runs crossed the rubber in that frame. Enos started off with a twobagger and took third on Rego's error. Wadsworth doubled. Enos trotting home. Ah Leong fouled out. Paschoal singled scoring Wadsworth. Paschoal stole second. Silva doubled scoring Paschoal and took third on Sequeira's error but was caught attempting to stretch it to the plate. Shim singled stole second, and scored on errors.

Public Boxing Bouts By Women Frowned On in the Philippines

MANILA, P. I. April, 30—(Associated Press Mail)—Public boxing exhibitions by women are objectionable to John W. Green, chief of police of Manila, who would prohibit them for the sake of propriety and for "anatomical and physiological" reasons.

His views are set forth in a letter to the mayor who referred the matter to the city council with a request that an ordinance be passed prohibiting such exhibitions.

Since the passage of a law by the recent legislature, permitting boxing without specifying that it shall be confined to the male sex, a number of bouts in which women were the principals are said to have taken place.

The chief of police in his letter to the mayor on the subject says: "It has come to my notice that on several occasions lately in the city of Manila women have taken part in boxing as principals. For anatomical and physiological reasons, contests of this nature should not be permitted, on the ground that exhibition of this sort can be made very offensive and suggestive and should not be permitted.

"It is requested therefore, that an ordinance be enacted prohibiting females from taking part in any manner in any boxing contests held under the provisions of the act of the legislature authorizing boxing, which appears to be silent on this point."

Hamakuapoko School Leads In Athletics Under Plan on Trial

Hamakuapoko school leads in the grammar school athletics competition which was started this year for the first time on Maui and will be further extended next year. The work was started this year by Alexander House Settlement when no county funds were available for the purpose of introducing physical training and health culture into the schools and it is hoped to extend it considerably next year.

Reports have come in from the 18 schools in which the work was started and reports have been compiled. They will be put in concrete form for the next issue of Maui News.

Work starts in the third grade with "posture work" and grows into athletic games and sports as the pupils advance in the higher grades. A credit is given each child and the averages taken by grades and for the whole school. The work of the teachers, also, is scored in figuring results, according to the interest shown and the way the program is carried out. Totals of the points for the athletic work, for posturing and averaged, by thus averaging the small schools can be fairly compared with the larger ones.

Hamakuapoko leads in four directions; it had the best average for the pupils, the best for posturing, the highest score for any grade and the highest total. Its average is 754.4 points. The pupils average was 496, the highest grade, the fourth, averaged 909.4 and the teachers' average was 235.7.

Keahua comes after Hamakuapoko with 665.3 points, Olowalu third with 552.2 and Haiku fourth with 522.7.

Tennis

Four matches were played in the All-Maui doubles in the past few days and the tournament is now entering on its second round. The play in the first round has been especially well contested most of the matches going into four sets and the survivors are looking for some tough court battles as the tourney proceeds into the later stages.

East Maui has the best of West Maui in the recent play. Deibert and Taylor took their games from Bruss and Walker after losing a first set 3-6, by a score of 6-3, 6-2 and 6-1. Engle and Rietow also won for East Maui, defeating Goto and Tamanaka in straight sets by 6-2, 6-3 and 6-4.

Other matches decided were Walsh and Walsh vs. A. K. Jim and Dr. Ting, the former winning 6-3, 6-2, 6-3. Hansen and Wadsworth defeated Lind say and Rosecrans in a hard fought tilt 6-3 6-3, 3-6 and 9-7.

In the settlement tournament the semi-final match was unfinished because of the late hour into which the play ran. It is scheduled for Saturday.

Movies Popularity Still On Increase In Western States

SAN FRANCISCO, May 27—(Associated Press Mail)—Popularity of the silent drama and comedy in Pacific and Rocky Mountain states is attested by the large increase in the number of motion picture houses, according to latest figures available. There were 1,954 screen houses in those states the first of this year, as compared with 1,692 twelve months before.

This increase of 262 theaters does not fully tell the tale, for theaters that hold 3,000 persons and are equipped with high-grade orchestras and organs have displaced the oldtime nickelodeon with its automatic piano and crashing cymbals. Also many of the new picture theaters have vaudeville acts.

The neighborhood theater, however that runs the best pictures, but a little later than its down-town prototype, has not been injured by the development of the larger theater with its elaborate equipment. Theatrical men say the neighborhood theater will continue to be popular because mother can trot along with father and the children after dinner without bothering to dress up. Besides, the amount saved on the lesser cost of admission and buying a block or two will buy Johnny a ball bat or Mary a tennis racket. Within six months three theaters with an aggregate seating capacity of 8,300 persons have been opened in San Francisco.

PROSPERITY IS APPROACHING

Industrial conditions of the Islands are again on the up-grade and the spirit of optimism is again in the ascendancy. Industrial news in connection with the sugar companies, especially the developments announced the latter part of last week, are all of a highly encouraging nature. Enter the "Joys"; exit the "Glooms".

Recently raw sugar prices both in New York and San Francisco have been hanging about or above 4 1/2 cents and the Honolulu stock market has felt the buoyant effect of the rise in price. On top of those reassuring conditions came the report that Hawaiian Commercial & Sugar Company has resumed the payment of dividends and that news is followed in turn by the announcement of a distribution of \$2,000,000 by the Crockett refinery among the Hawaiian plantations.

Resumption of dividend payments by the Puunene company is taken as a forerunner of similar action by the other sugar plantation companies. From several sources have come the report that some profits may be shown with raws selling at 4 1/2 cents and that lends further strength to the belief that other companies will soon be making dividend announcements.

The distribution of \$2,000,000 from its sales by the California-Hawaiian refinery to the Island plantations is of valuable assistance in furnishing working capital and a relief to the financial institutions of the Islands as well as the plantations. Ownership of the refinery by the plantations is being shown as an advantage. On a rising market it is a guaranty of getting back better than the market price for raws and it has been a rising market for the past several weeks.

Another most encouraging feature is the getting back to or near the normal time for the ending of the grind by three of the Maui plantations in spite of continued shortage of labor. It was necessary somewhat to curtail the area cultivated but it is demonstrated that it is advisable to cultivate a somewhat reduced area adequately rather than to undertake to cultivate the full area with an inadequate labor supply. And in other ways the experience of the plantations during the period of depression will bring some advantages in time to come. Necessity has demanded the introduction of labor and cost saving methods that will without doubt be continued in the future and has stimulated intensive work. Especially in the experiments of selected buddings has great progress been made recently.

Aside from the sugar industry, Maui has cause to be optimistic. The price of pines is higher than last year and the promise of a large crop is good. Expansions of that industry are in order, too. There is to be a cannery built in the Hana district and Pauwela is preparing to cultivate an increased area in the Kahakuloa country. With the sugar industry distinctly on the up grade and the pineapple growing and canning industries in excellent position, all other lines of business on this Island are sure to grow better and better. Traveling men have said for months past that business conditions on Maui were better than anywhere else save Honolulu and now they may be expected to grow even better.

Yet another encouraging feature of the comparatively recent news is the steadily easing condition of the money markets of the nation which made possible the floating of Territorial bonds and enables the going forward of improvements that it was feared would be halted.

All in all, it is evident that optimism is warranted and the sun of prosperity is successfully breaking through the clouds of business depression.

LIQUOR ON SHIPS

As an abstract matter of law, it is hard to see how the United States can permit the sale of liquor on its ships, irrespective of whether the sale or use of intoxicants is right or wrong anywhere.

An American ship, no matter whether within or without the three mile limit of the United States coasts, is American territory. The United States went to the bat on the subject and went into battle with Britain for its contention in 1812 when it successfully resisted search of American ships, they being claimed to be American territory.

So if the contention of the United States was correct then, it is correct today, and if it is correct today than no branch of the government can disregard the application of the Volsted Act to American ships.

That appears to summarize the situation, pretty fairly. The matter of expediency and all matters of morality are left out of consideration. It is the attitude that was taken by the federal court at Galveston where seizure of liquors from Havana was made aboard an American ship. The case is under appeal but appears to have been decided upon the basic law. It is not an instance where the comity of nations enters as in the case of murder or assault or similar acts of violence where international law says they shall be a trial at the first port entered.

There appears to have been a splitting of straws. Because the ship is out of three mile limit she is in neutral waters but her being there in no wise destroys her nationality. Off the coast of Nova Scotia she is as much American as off the coast of Cape Horn or the Cape of Good Hope.

It is doubtful if congress would dare amend the Volsted Act to exempt ships any more than it would dare to exempt the District of Columbia or the Territory of Hawaii, though the phrase "this Act shall not apply to the Territory of Hawaii" has become something of a habit with congress.

As to expediency, it is another matter. The American merchant marine may not be able to popularize its passenger service and maintain it successfully in competition with ships where bars are maintained and wines, beers and liquor served. But expediency is beside the issue. To the law it makes no difference whose ox is gored if an ox is gored. Uncle Sam has no more right to protest against financial losses than had John Doe when he had to close up bar. If the shipping board or any one else can open up a bar on American territory even if that territory happen to be afloat far off from shore,

THE OPTIMISTIC PESSIMIST

John Doe has just as much legal right to open up his bar at the old stand.

To say it is un-American to attack the policy that has prevailed is a mere subterfuge. It is un-American to disregard the laws of the nation whether the law breaker be an individual or the government itself.

There are two courses open as to any law, to enforce or to repeal and there is no righteous or even satisfactory middle course.

DEFICIENT IN ENGLISH

In the Associated Press news from Honolulu that of 138 seniors in McKinley High School 25 have to take special examinations in English, oral and written, before they can obtain diplomas and will not be graduated unless they successfully pass such examinations even if they have sufficient credits to pass otherwise than in English, is disclosed a state of affairs that shows something is radically wrong with educational methods in the Islands.

Nearly 20 percent of the entire class have been permitted to advance through the eight grades of the grammar schools and the high school course with a deficient knowledge of the language of the country that is their's either by birth or adoption, it is to be inferred from the news dispatch. Naturally the question is asked why they were permitted to advance to the senior class of high school under such circumstances.

On the face of the report there is apparent substantiation of the oft repeated assertion that sufficient stress is not laid upon English in the grammar grades. It is insisted there is too much superficiality in the teaching of English and a slurring over of the deficiency in that branch of instruction. Perhaps it may be accounted for by the effort to employ mainland methods of teaching under different conditions in the Islands. Perhaps it is the fault of modern educational methods. The "sight method" of spelling results in students passing through high school without a knowledge of the division of words into syllables as is shown in letters that are typed by high school pupils in business courses where there are improper divisions. Under modern methods, too, inadequate attention is paid to teaching synonyms with a result that the youth of today have a much more limited vocabulary than had their parents at the same age.

But to return to the teaching of English, it is not creditable to educational methods in the Islands to have apparent such a state of affairs as is reported and the fault seems to lie in the earlier school years rather than at the top.

There are strong indications that oke and swipes will be hard to secure on Maui in the near future. Two and three charges on each arrest are discouraging and then later the internal revenue department is likely to come down on the offender for license fees for the still and for the selling.

Twenty years ago the government was constructing roads in Wailuku at \$1.48 a running foot and they were good roads for those days, but they would not stand up long under present transportation methods and usage. Progress has to be paid for and it takes something substantial to stand up under motor vehicle traffic.

Honolulu will give a gay and joyous welcome to the visiting Shriners and a large Maui delegation will be in the capital city to help extend the welcome.

A large part of the Maui population is now marking time and waiting with what patience it has for the advent of "Make Happy," now only ten days off.

The crossing of the stream between Olowalu and Lahaina is almost impassable because of the large boulders that have been washed down.

Dave Meyer of the Wailuku saloon will have Primo on draft and roast goose sandwiches on the lunch counter this noon.

While the regular fall flight of wild geese from the arctic regions to warmer climes seldom extends to Hawaii there is a wild goose that is native to the islands which resembles the brant and is found in large numbers on the island of Hawaii and a few are always to be seen about Haleakala Crater.

Sam Kalama was called to Honolulu yesterday to tell the jury what he knows about Entario Valez' dagger.

The bit of road, some hundreds of feet in length in front of K. F. Hall on Mill street carries with it a lesson. The cost of putting the road in its present condition was about \$1.48 a running foot which means an expenditure of only a few thousands of dollars required to make all the travel roads in Wailuku as well as the road to Kahului handsome thoroughfares.

There is no more beautiful spot in the Islands than upper Iao Valley and yet there is hardly a more difficult place to reach.

ARCHIBALD BELL-CAT

This amusing variation of Blind Man's Buff is founded on the incident in Scottish history which gave the name of Archibald Bell-the-Cat to the chieftain bold enough to give answer in action, to the question, "What'll bell the cat?" the "cat" being a tyrant. 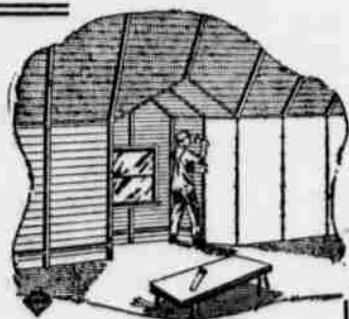

Sayings of Hawaiians Are Being Gathered by Bishop Museum Which Seeks to Secure All Cooperation

The cooperation of all Hawaiians and friends of Hawaiians is being asked by the Bishop Museum in collecting sayings, conundrums and proverbs of the Hawaiians. The Museum requests that these be mailed to them in order that they may select from them the sayings which are best and most truly Hawaiian.

Proverbial Sayings of the Tongans have just been published by the Museum. Here are representative sayings of the Tongans:

Hange ha niu afangia: Like a coconut tree blown by a hurricane. Used especially of a man who sways with laughter. Like a coconut tree swayed by the wind.

Pauki puaka pani fonu: Smeared with pig, smeared with turtle. Pig and the turtle are favorite delicacies and will be found more in the abodes of the chiefs than anywhere else. For anyone to carry about on his person the smell of this rich fare is a sign that he is a person of some consequence.

"Fakaanga i tefito' niu: Criticize at the foot of the coconut tree. One who stays on the ground but is lavish with his advice to the man who has climbed the tree. Generally of the man who stays out of a job but has plenty of talk to offer to the one who has gone into it.

"Moa tangata fie moa taane: Rooster who wants to be breeding cock. The little ordinary person who gives himself the airs of his betters.

"Pikipiki aho: Wings folded by day. Night birds sit with wings folded during the day. The expression is used of those who don't do much by day but who prattle about at night, very often getting into mischief.

"Tau ae lei moe tofuaa: The whale's tooth befits the whale. A big thing becomes a big person.

"Vala kovi fie kofu silika": Bad join cloth wanting to be silk dress. The commoner who wants to act the chief.

"Faka pula matai": Making eye swell. Refers to an angry man.

"Finemotua fie finemur": Old woman wanting to be young woman.

"Tala a fine jii kae ikai mavivi": A little woman saying but not able to do.

Hawaiian Proverbs Sought
A beginning has been made in Hawaiian proverbs. About a hundred have been gathered from Andrews' dictionary and the Hawaiian Annual of 1883. There remain the Fernandez Papers, the meles, and the great literature of Hawaii to be carefully studied and sayings gleaned from them. But the richest field lies in the daily speech and memories of the Hawaiians themselves. If the Museum is to publish a book containing the best sayings of the people, all Hawaiians must write them down as they think of them or as they find them in their reading of Hawaiian and send them to the Bishop Museum, in Honolulu.

Some Hawaiian Sayings
A few of the Hawaiian sayings that have been gathered are:

Aohe loa i ka wai opaa: No skill required in catching shrimp.
Ka lele aau o na manu o kiwaa: The scared flight of the birds of Kiwaa. Applied to a general panic.

Nui kalakalai, manumanu ka toaa: Much hewing, resulting in a lot of chips. Meaning "A lot of work, but nothing done," or "A lot of fuss about a little work."

Aiaalawa na maka o ka: The eyes of a thief look every way.
Ua hele i ke alamaaweiki: He has gone along the untrodden path. When one dies.

Kuipela e ka makani apaa: Knocked flat by the wind apaa. Sudden disaster.
Ehuehu ahiahi: The red sky of evening—applied to old age.

He eleelepi—ka waha o kanaka: 1. Dashing of the waves in different directions. Spoken of men of totally different minds. 2. This was given to us by an Hawaiian as meaning, "The crab, the mouth of a person." That is, a sarcastic remark to the effect that "Your mouth is always opening

and shutting like a crab's; you talk too much."

Pohaku ekeku: A stone easily broken. Hence a good for nothing, cowardly person.
Hawawa ka heenalu, hai ka papa: The awkward surrider breaks the board. Applied to those who undertake something with which they are not familiar.

Hapala ia i ka hawena: Daubed with white. Applied to a grey-headed man who has but little sense. (That is, he is old and has grey hair but he has no sense.)

Mai noho a makamaka ilio, i ka huilo ka ike: Don't be friends with the dog, for the tail will show it. Applied to disreputable acquaintanceships. It has also been given as He makamaka ilio, aia ka i ka huilo. A dog friend, he shows it by his tail. That is, he's a dog of a friend; he doesn't show his friendship by greeting you as a man should; he only shows that he knows you by a darting glance—a wag of the tail.

Kahiki ka puka e ka upena nana: 1. The entrance is stopped with a spider's web. 2. Entangled in the mesh of the spiders web. Applied to a person who is slandered.

He alamakahinu: A greased forehead. Applied to a person who goes frequently to a chief for favors.
He alamakahinu: A greased pathway.

He alamakahinu i ke alii: "Name of a stone at Malua, flat and shining; applied to a disobedient child."
Ke hui nei kale i ka nawaa: The eatable and the worthless taro are mixed; hence, good and evil joined.

Pali ke kua, mahina ke alo: A back straight as a precipice; a front round as the moon. A favorite phrase in praise of a well formed person.
Lila ka maia no e'a; wili ka oka'i: The banana looks withered but it has an excellent flavor. That is, it looks better than it seems.

Lila maia no ka e'a: The withered banana of the banana grove. Refers to a withered person.
Hauamanu e ka ipu inoino e: How full of holes is that dirty calabash. Said of a homely person.

Ka hee o kai uli kapaa ke aiaala: The squid of the deep blue sea has a peculiar bunch. While plumpness is admired, excessive corpulence is ridiculed by such phrases as this.

Ka pui o ke ale, ahu ka olo: That eel from the deep sea is all wrinkled up. Applied to a man with a double chin.
Pii ka ihu o ka naia i ka makani: The porpoise always hold his nose up to the windward. An allusion to the manifestations of rising anger.

Ku ke ehui o na wahi auwaa lilihi: How the spray dashes up before that fleet of little canoes. Applied to an angry person who is fuming around. Similar to our "tempest in a teapot."
Lele lilihi ka lehu o kapuahi: He is scattering the ashes of the fireplace. A hit at a quarrelsome or angry person.

Makaala ke kanaka kuhea manu: Watchful the man who ensnares birds
Mai makemaka wahine, i ka upo ke oia: Beware of a woman's friendship; it lives only with tears.
Me he makani huliua ia, Hui ka manao—hele ka noono—Mele: Like a shifting wind, the mind changes.

Corrections Being Made
Some of these Hawaiian proverbs and sayings may not be correct. They have not been studied as yet. But these together with all that can be got together will be examined carefully and the best ones published. Many of the best sayings are used in every day conversation and have never been written down. These are the ones that the Museum is especially anxious to obtain; together with those that you find in your reading or those that are in the old meles.

Secrecy Surrounds Meetings at Hague
(ASSOCIATED PRESS)
THE HAGUE, June 16—Indignant correspondents representing newspapers of more than 20 nations today sought to ignore the order of the foreign office excluding them even from the gardens surrounding the peace palace where the conferences on Russian affairs are to be held. They forced their way into the building and there demanded an audience from the foreign minister and presented their written protest to him personally. Policemen tried vainly to persuade the correspondents to leave the corridors and finally had to be satisfied with keeping them out of the conference hall.

The action of the correspondents followed the announcement that proceedings at the conferences shall be behind closed doors and under se- crecy.

Merchant Marine for Pacific Is Sought

(ASSOCIATED PRESS)
SPRINGFIELD, Illinois, June 15—Bishop F. B. Fisher of the American Episcopal Church at Calcutta, India, in a speech here advocated a powerful American merchant marine in the Pacific with Manila as a far east base of operations, to rival Liverpool and Hong Kong in size.

He declared the idea of war between the United States and Japan was ridiculous and advocated the permitting of Japan to expand toward Siberia as the only field left for her excess population. He urged America to abandon her policy of isolation as "impracticable in this interdependent age."

Decline of American Government Is Seen

(ASSOCIATED PRESS)
CLEVELAND, June 15—Secretary of War Weeks, in an address which he said he was tempted to entitle "The decline of the American Government," declared the drift of recent years was gradually wrecking the nations governmental structure by undermining the constitution. He said the country had signally failed to improve the constitution by amending it. Weeks declared the direct primary was lowering the standard of congress and the bloc system killing the party and representative government.

German President Is Very Retiring Chief

BERLIN, May 6 — (Associated Press Mail)—In a social sense, President Friedrich Ebert is probably the most retiring chief of any European democracy.

Society, as it is understood in other capitals, is non-existent in Berlin. The great majority of the old Prussian aristocracy have withdrawn to the seclusion of their country estates. They have no desire to mix with the "newly rich," and the new order of things is frankly repugnant to them.

Visitors are few at 73 Wilhelmstrasse and no country cousins stop to gape at the old palace of the erstwhile court marshal which the president of the German republic has made his home.

Rarely is the ex-saddler seen or recognized in public and picture posts of members of the Hohenzollern family are more plentiful in stationery stores than those of Fritz Ebert.

A formal reception at the presidential residence is therefore something of an event in Berlin. For the first time, Herr Ebert the other evening entertained about 100 of the most prominent German citizens who have made their peace with the present regime, or nearly so.

Besides cabinet ministers and chiefs of departments, there were university professors, poets, sculptors, musicians, painters, actors and authors.

President Ebert, welcoming his guests, spoke of his desire to meet personally the present leaders of thought, arts and sciences of the fatherland and dwell on the importance such gatherings would have in fostering culture which he conceived it was the task of the new republican regime sedulously to promote.

Professor doif von Harnack, theologian, delivered a short allocution on the ancient conception of charity, and Konrad Ansoerger, eminent pianist, played Beethoven's Appassionata.

The president is a cheerful host, and his first social evening is said to have been a complete success.

Non-Enforcement Is Only Trouble Seen As To Prohibition

BOSTON, May 22 — (Associated Press Mail)—"The only trouble with prohibition is its lack of enforcement," and the 18th amendment "has resulted in untold good among the thousands of families most likely to suffer severely because of intemperance." John F. Moore, of Boston, president of the Family Welfare Society, told the Unitarian Temperance Society today. As one of the speakers on "Prohibition Results," Mr. Moore gave a description of the findings of his staff of workers in this city. The Volstead act, he said, had decreased the number of new cases in the juvenile court of Boston, had enabled many families to accumulate savings which tided them over periods of unemployment, had decreased the number of applications for aid to the society and had its influence on the industrial situation in keeping irregular workers "who are most subject to the temptations of drinks" from spending their wages for intoxicants. "Prohibition has favorably affected family life among those we visit," said Mr. Moore. "Today many families are better and happier for it. Figures in regard to arrests in Boston must not be misunderstood. To say arrests for drunkenness in 1921 increased almost 100 percent over those for the same period in 1920 is true, but it is equally true that arrests in 1921 were 100 percent less than in 1916, 1917 and 1918. "Considering the effect upon the drinker of some of the liquor now being sold, and the attitude of the police, there is no doubt that a higher percent of drinkers are now arrested than formerly. "There is evidence also that many of those arrested for drink are without family connections and are often persons who are unemployed and who have no residence in the community. "Many men who formerly were constant drinkers now break over occasionally. This means less money wasted in drink and more money invested in the welfare of the family. It means a better home life and better opportunity for the children."

Newspaper Work Easy Under Northcliffe

LONDON, May 12 — (Associated Press Mail)—Lord Northcliffe has announced that hereafter the editors of The Evening News, which include the members of the staff who would be termed "copy readers" on an American newspaper, will work only four days a week instead of five as heretofore. "Since 1894," said Lord Northcliffe when making the announcement, "the pace in evening newspaper production has been intensified and is going to increase still further. Wireless telephony is beginning and is going to affect the publication of news." The occasion was the retirement of W. H. Evans, the editor-in-chief of The Evening News who has been for 28 years on one or another of Lord Northcliffe's papers. Lord Northcliffe gave him a banquet, presented him with a cheque for £10,000 and awarded him a pension of £2,500 a year for the next 10 years and afterwards, for the remainder of his life, a pension of £1,000 a year. According to the testimony of newspaper men who have worked on both New York and London afternoon newspapers, the work on the latter is much the easier. The New York afternoon papers use on an average three as much news as do their London contemporaries and do much harder hustling to get it.
