TELEGRAPHIC ITEMS

The cholera is increasing in Manila.
Another son was born to Mr. and Mrs. Grover Cleveland, July 18.
President Roosevelt has called a special session of Congress to meet October 1.
Severe fighting between the Turks and the revolutionists is reported from Darian.
The members of the Colombian congress are growing more favorable to the canal treaty.
Pope Leo died at 4.04 o'clock, last Monday afternoon, his last words being the Benediction.
The Russian Government has made 850 arrests at Kishineff, holding 250 of the prisoners for trial.
Great Britain and France having agreed on Eastern matters, Russia is provoking Japan into a war.
William Tacker, a white man was lynched by a mob for murder, at Marysville, Kentucky, last week.
A company with a million dollars capital will build an immense beet sugar factory at Blackfoot, Idaho.
The rebel forces at Ciudad Bolivar attacked the Venezuelan troops on Monday morning, but were repulsed.
Fifty houses in Baltimore were unroofed by a furious wind storm, accompanied by a heavy downpour of rain.
Mrs. Harriet Blaine, widow of the late James G. Blaine, died July 15, at the old Blaine homestead, in Augusta, Maine.
Japanese and Mexican laborers on the Santa Fe railroad had a fight in which four men were killed and fifty injured.
Preparations are going forward for the conclave of Cardinals, which will probably begin its session August 1.
It is understood that Col. Oliver, Assistant Secretary of War, will succeed Secretary Root, who is anxious to retire.
Japan is urging Great Britain to join her in an energetic demand upon Russia for the opening of at least six Manchurian ports.
The Irish land bill has passed the third reading in Parliament and it is believed that this measure will settle the Irish land question.
Secretary Hay says that Great Britain has no claim to the islands lying near Bornno, and included in the treaty with Spain.
The Spanish cabinet resigned and Senor Villevord, who has been appointed Premier, will attempt to organize a new cabinet.
King Edward and Queen Alexandra left England on Monday for a visit to Ireland, and received an enthusiastic welcome to Dublin on Tuesday.
Justice Brewer of the Wisconsin Supreme Court in a recent public statement said that every participant in a lynching is a murderer.
The Christian Endeavor convention tent at Denver, Colorado, containing 8,000 people, was blown over, and a score of the delegates were injured.
Delegate Kuhio has received a cablegram from Washington stating that Ellis Lando has successfully passed his final examination for admission to the Annapolis Naval academy.
The Czar of Russia has issued an edict abolishing many of the harsh punishments to which laborers have been subjected for infringements on regulations made by employers.
Hansen, the Russian charge d'affairs has delivered a message to Secretary Hay regarding Manchurian ports which Russia is ready to open, but the Secretary declines to discuss the proposition.
An army of 120,000 Russian troops is mobilizing at Odessa to despatch under emergency orders to Manchuria, and eleven torpedo boats are preparing to re-enforce the Russian Pacific squadron.

A GALA DAY
 In Hospitable Wailuku.

Wailuku has once more proved itself worthy of the claim of being one of the live towns of Hawaii nei, and has firmly established its reputation as the leading town on Maui, not only in business enterprise, but also in the matter of public spirited citizens. And the citizens of Maui generally, from Lahaina to Hamakua poke fairly outrivalled Wailuku itself in the generous and hospitable reception which they united in extending to our distinguished guest, Governor S. B. Dole.

At a meeting of the citizens of Maui, an elaborate program was arranged, and thanks to the committees who had the matter in hand, not a jar or hitch or delay occurred, everything going like clock work from the time the Governor set his foot on Maui soil at Kihai, on Saturday morning, until the last adieu speeches were spoken, and the gallant little tug Iroquois breasted the waves on Sunday morning, bearing away our guests to Hawaii.

The Iroquois arrived at Kihai on schedule time on Saturday morning and was boarded by the all-Maui reception committee who escorted the guests, consisting of Governor Dole, Eben Low, A. G. Hawes, Capt. Rodman, and A. Gartley, to the wharf, where through the courtesy of Supt. Filler of the Kahului R. R. Co., a special train was in waiting. The party boarded the train, and were swiftly whirled through the fat acres of growing cane on central Maui until they reached the Puunene Mill, where they spent an hour, inspecting the workings of the largest sugar mill on earth. Another short run brought them to Kahului, and at 10:25, a warning whistle sounded the note of the arrival of the party at the Wailuku Depot, where a large crowd had gathered to welcome the visitors. And here, the genuine and happy surprise of the day occurred. As the train pulled into the depot, it was greeted by the stirring strains of the Wailuku brass band. It was known that Wailuku had organized a band, but few, even of the citizens of Wailuku knew that the band was prepared to attend public functions. Under the leadership of Mr. Jos. Schumleister, the band has made rapid proficiency, and plays quite a number of pieces with exquisite taste and correctness. The welcoming march as the train arrived, and the sweet notes of the "Aloha Oe" march as the Governor and party drove away in carriages were both finely rendered, and added much to the dignity of the occasion.

At the Wailuku depot, the all-Maui committee surrendered the Governor and party to a Wailuku committee who escorted them to the Maui Hotel which had generously offered them its hospitalities, during the Governor's visit, free of charge, and by the

way this committee deserves special credit for its extreme courtesy and attention to our guests, while in Wailuku. The cortege, from the depot to the Hotel was a brilliant and dazzling affair, led by the carriage containing the Governor and Mr. Carl Waldeyer, chairman of the Wailuku reception committee, and accompanied by a handsomely dressed escort of mounted police.

At the hotel the governor accorded a kindly and informal reception to all who desired to meet and greet him.

The luau in the schoolhouse had been announced for 12:30 sharp, and at the exact minute, the governor and party were received and the doors thrown open, revealing long lines of tables beautifully decorated and groaning beneath the load of well cooked bullocks, pigs, chickens, yams, fish and a complete menu of other luau delicacies so generously provided by the people of Maui. After a bountiful repast speeches were called for and Governor Dole responded in a manner worthy of the occasion. He also pointed out to the people of Maui the serious responsibility which had been imposed on them in the matter of local self government, and urged that all racial lines be wiped out, and that all who possessed the proud right to call themselves American citizens should stand together, for good, economical and honest management of county affairs. Attorney John Richardson of Lahaina also made a brief but eloquent address in Hawaiian, heartily welcoming our guests to the hospitalities of Maui.

As there were many who could not attend the luau at 12:30, the luau committee resolved to keep open doors from noon till 6 P. M., which was done, special viands being reserved for those who came late. By this means all were able to attend, and all were bounteously served, with some to spare.

The governor and party spent the afternoon strolling or driving about town, and at six a formal banquet was spread at the Maui Hotel. At the conclusion of the banquet, the party were driven to the Castle Hall of Aloha Lodge, K. of P., where the Governor extended a formal reception not only to the people of Wailuku, but also to many from up country, who had been brought down on special train, to attend the function. A large crowd was in attendance at the reception, and the scene was a bright and merry one, at which delicious punch flowed like water, the enlivening strains of a Hawaiian band, and violin and piano music courteously furnished by Messrs. Schumleister and Schrader, and the whirl of merry dancers united to make the scene a memorable one.

At nine o'clock the Governor and party excused themselves, and the Governor was driven to Waikapu, where he spent the night as the guest of Mr. and W. H. Cornwell.

On Sunday morning the entire party were driven to Kihai, and at

10:30 they embarked on the Iroquois for Hawaii, followed by the loving "Alohas" of their hosts.

All About the Luau.
 The luau committee have preserved all the data and the finance committee all the vouchers concerning the luau, a study of which will be of much interest to those who wish to give luaus in the future. The total expenses of the luau and reception were a few dollars short of \$400, of which about \$350 were luau expenses. Arrangements were made to feed 500 people. Two bullocks, six grown pigs, four dozen chickens, 6 barrels of poi, 5 barrels of beer, 10 cases of soda water, 7 bags of potatoes, 2 bags of luau, besides opae, ophi, loli, kukui etc in corresponding quantities constituted the menu. Two large imus were built, which consumed 1 1/2 cords of wood. 880 laulau and one whole pig were cooked in the imus. The labor bill alone for preparing the luau was \$63, which included the decoration of the schoolhouse. This might seem a large sum to those inexperienced, but as a matter of fact twenty men were kept busy for two days, besides the extra days and night work, and it is a safe proposition that every man jack of them richly earned his dollar a day.

The finance committee were quite successful in securing funds and all bills will be paid in full. For the information of those who may wish to prepare large brews of punch, it may be stated that the punch for the evening reception cost \$20.

Too much praise cannot be accorded to Jailer David Crowell and Mr. Jos. Welch, who were in charge of the preparation of the luau and also to Mrs. Nua and her young lady assistant who served the feast.

The people of Wailuku and of Maui have cause to feel proud of the reception tendered to Governor Dole and his party, while they were here last Saturday and Sunday. Wailuku needed just such an opportunity to prove that she is worthy of the honor bestowed on her in naming her as the county seat of Maui County and her citizens responded to the occasion in a manner worthy of them. The visit of Governor Dole had nothing whatever of political or business significance but was a purely social function, yet its influence will be a far reaching one, in many directions. It has taught the citizens of Wailuku what can be accomplished by united and harmonious action, and the lesson thus learned will be of value to us when united action in civic affairs is needed. It has also drawn the citizens of Wailuku together in closer bonds of friendship than ever before. Wailuku has a bright future before it and her citizens should ever be ready to stand shoulder to shoulder, as on the present occasion and unite in making our little town one of the crown jewels of Hawaii nei.

Preparations are under way for a big race meeting at Spreckels Park on August 12. Now that the legislature has adjourned, and the Governor has come and gone, the people of Wailuku and of Maui should help along the matter of a grand race meet in August. The Maui Racing Association have offered generous purses, and the indications are that there will be some fast Honolulu and Hawaii horses on the track at Spreckels Park. And as this is probably the last 12th of August race meet on Maui, it should be made a genuine success. Next year, we will hold our big races on the Fourth of July, and the Hilo papers intimate that New Year's Day would suit them better than the Fourth of July as race day. The people of central Maui need such sports as races, polo, baseball and football in their season, to relieve the harshness of our strenuous life and every one should help along all such sports.

The matter of diversified industries finds an earnest supporter in Governor Dole, who in a private conversation with several gentlemen in Wailuku last week expressed it as his abiding faith that the future will see many permanent and paying industries established on the Islands. It does not take a very comprehensive vision to see this, for with a soil so fertile and fruitful as that of the Hawaiian Islands, it is a moral certainty that certain lines of Island productions, other than cane, will be developed into paying propositions. Coffee, sisal, canned pineapples, bananas, castor and vanilla beans and vegetables are on the list of possibilities some of which will become certainties.

A pamphlet has just been issued under the supervision of the Experiment Station at Honolulu, concerning the cultivation of sisal in Hawaii, by Frank E. Conter, Assistant, Hawaii Agricultural Experiment Station. From 600 to 900 plants per acre is the average, according to the soil which yield over ten pounds of fiber, so that one acre will yield from 6000 to 9000 pounds which bring 8 cents a pound f. o. b. at Honolulu, or an average of \$600 per acre, it taking several years to mature and market a crop. From this showing, sisal should pay on the Islands. Owing to the success of the Sisal farm on Oahu, other plantations have been started on Kauai, Hawaii and Maui.

One cannot but admire the brilliant though unscrupulous diplomacy of Russia in her handling of the Manchurian question. The interests of the leading powers are so great and complex in the various quarters of the globe that the whole resembles a great and cumbersome but at the same time a delicate piece of machinery, easily put out of repair. By playing off the mutual interests of Great Britain and France against each other, and by old fashioned, down-right lying to the United States, Russia has managed to leave Japan without allies and at the mercy of Russia. While this may not improve the temper, still it may add to the discretion of the little brown men.

The NEWS takes pleasure in editorially reproducing a local reading ad. in Tuesday's Advertiser, substantially as follows: "For sale. First class vanilla cuttings in six-foot lengths at \$2.50 per 100, F. O. B. Suva, Address W. Livingston, Navua, Fiji." There is no industry, no matter how seemingly unimportant which should not be carefully exploited and the NEWS considers it a sacred duty to encourage such things in all possible ways. An intelligent effort should be made to cultivate the vanilla bean on Maui as a possible source of future revenue.

The study of human nature is a curious and entertaining one and no matter where the book is opened whether in mid-Africa or in the heart of London, whether amid the frozen wastes of the arctic or under the waving mangoes of Wailuku the lines read marvellously alike. Consequently it need surprise no one that a few people at the luau who had not contributed one cent were the biggest kickers when their beer supply was cut off.

From the tone of some of the Honolulu papers it might be imagined that Wailuku is unduly puffed up with pride. Such is not the case however. The citizens of Wailuku have simply come together and are seizing whatever goods the Gods provide, just as good citizens should do.

HARVEST HOME DANCE

At Puunene Mill.

A novelty on Maui is to be offered by the citizens of Puunene on next Saturday evening, August 1, which is nothing less than a harvest home dance to celebrated the close of the Puunene sugar season a record breaking season by the way, for the big mill has been running steadily for the last eighteen months, enriching the world by and output of sixty-four thousand tons of sugar.

Elaborate preparations are being made for the ball and supper, for which several hundred invitations are to be issued. A special orchestra of ten or twelve pieces will be brought from Honolulu, to furnish music for the occasion. Free trains will be run from all points on the road to Puunene as follows: Leaves Paia 6.45; Spreckelsville, 7; Kahului, 7.15; Wailuku, 7; Kihel, 6.45; arriving at Puunene at 7.30 P. M., and will leave again after the ball and supper. All who desire to avail themselves of train service are earnestly requested to make special note of the time of departure of the several trains and be on hand promptly, as it will be necessary to run the trains on close schedule time, in order to reach Puunene by 7.30. The dance will begin at eight o'clock sharp, and supper at 12.

Yesterday at 3.30 p. m. the valve of the steam whistle at Puunene was thrown open and gave vent to a long, loud and triumphant whistle to mark the close of the grinding season, and the end of a steady 18 months run, during which the mill has turned out 64,000 tons of sugar, over 37,000 tons of which are this season's crop.

For the first five innings of the game between the Ilimas and the Lahainas at Wells Park last Sunday, it seemed to be Lahaina's game, the score standing 8 to 8 at the end of the fifth inning. The Lahainas took the lead in the first inning scoring 3 to 2 against their opponents and the score read 5 to 2 in their favor at the end of the second inning. Then the Ilimas made a spurt scoring 1 run in the third and giving the Lahainas a goose egg. In the fourth inning they stacked up 4 runs to one in favor of Lahaina. In the fifth inning 1 run was the best they could do, while Lahaina scored two, tying the score at 8 to 8.

Then the grand stand leaned back to watch hot play which never materialized. The Ilimas chalked up 3 runs in the sixth, and the Lahainas made 1 run and died. The Ilimas came to bat for the seventh inning and were presented with seven runs by their generous opponents, and in the ninth they scored three more runs. The Lahainas batted superbly throughout the game but their fielding was simply rotten. This is to be regretted for the Lahainas have a strong team, if they would get together, practice and train for the games, as the other three teams do.

The score for last Sunday's game stood as follows:

Tomorrow's game will be between the Wailukus and Ilimas, and if both teams have worked up, some fine ball may be expected. The Wailukus have probably lost short stop Wright, who was to have gone to Keanae this week, and this will of course weaken the team.

The Kams scratched out a game against the H. A. C.s at Honolulu last week, scoring seven runs in the ninth inning owing probably to the fact that Barney Joy's arm weakened.

Maui Racing Association.

The M. R. A. recently prepared published a proposed race program for the races on August 12, copies of which were submitted to Honolulu and Hawaii horsemen. A number of letters have been received containing suggestions, and a special meeting of the Association was held on Thursday evening, at which a final program was adopted.

The free for all and the 2.20 trotting races were consolidated into one free for all, best three in five, for a purse of \$450, and the 1 mile free for all purse was increased from \$100 to \$150. This will doubtless result in bringing some of the best horses in Honolulu, and will assure fast racing. Another Japanese race has been added, in answer to a demand from enthusiastic Japanese horsemen. Some horses from the O'Rourke string on Hawaii have been conditionally promised, and strenuous efforts are being made to induce their attendance. Named races were asked for, but the time is too limited to arrange them.

LAHAINA LINES.

Canon Ault preached in Hilo last Sunday. His classmate, Rev. Sidney H. Morgan, is in charge of the Episcopal Mission in that city.

Last Saturday morning Miss Grace Olsen telephoned to her mother from Kihel, saying that she had just seen Governor Dole.

The new turnstile at the entrance to the schoolhouse yard will be a convenience to many.

A handsome flagstaff has been erected on the Joss house lot.

The Hayselden family tomb in Lahaina Cemetery is nearly completed. It has been very carefully constructed, according to plans prepared by Architect Traphagen of Honolulu. Some of the dimensions are as follows: Extreme height, 12 feet; height above the earth line 8 feet; inside measure, 14 feet by 9. There are concrete steps, descending five feet to a landing three feet wide at the bottom. The iron doors are four feet wide, and there is an iron railing around the front. For several weeks past, Mr. Frederick H. Hayselden has superintended the work. He was ably assisted by his son Fred, and a number of Japanese laborers were constantly employed.

The electric pump has been repaired in Honolulu, and came back on Tuesday. Further experiments will be tried with it at the Lahaina Pumping Station.

Special mission services are in progress at the South Sea Island Church.

Mrs. T. J. Hayselden and Mrs. William Ault have been visiting a number of their friends in this town.

It is said that in some place a large number of little white spiders have injured the trees, causing the leaves to fall.

Rev. Father James sailed for Europe about three weeks ago. He is a delegate to the General Chapter of the Society of the Sacred Heart, which will assemble in September. The Chapter meets once in five years.

A hospital has been opened, under the auspices of the Plantation, in the large dwelling house formerly occupied by Chemist Nicholas. Dr. Peters is in charge of the institution, and has an office in one of the front rooms. To begin with, there is only one patient, the Japanese who fell over the pali about three weeks ago. In case of emergency, about twenty patients could be accommodated. A hospital has long been needed in Lahaina.
