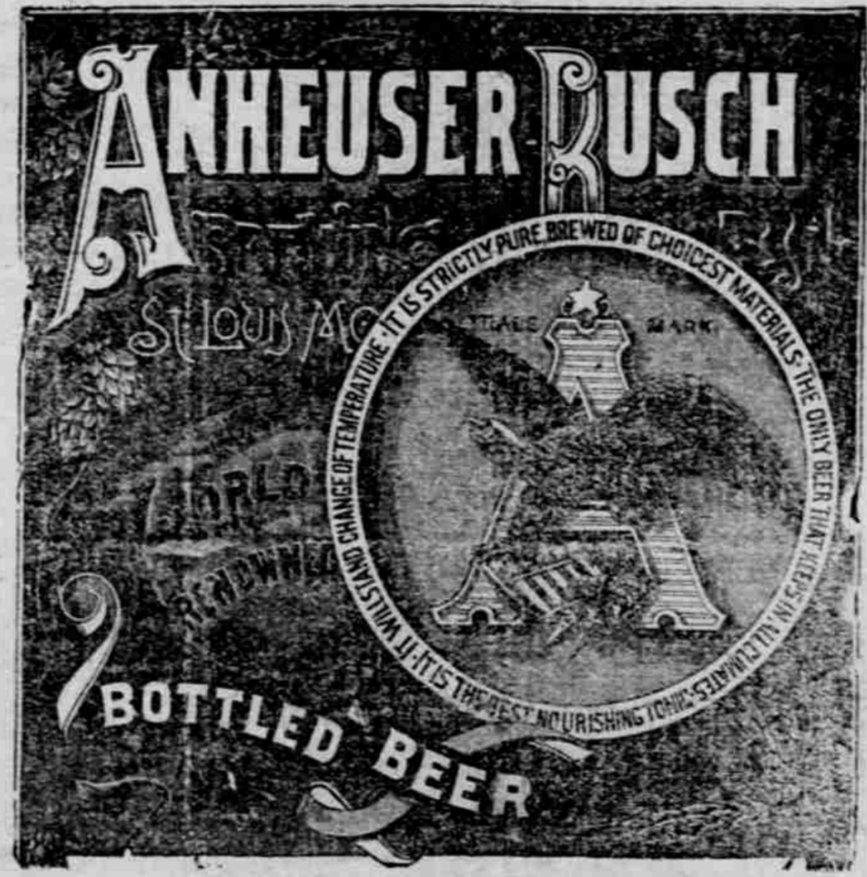

The Life of the Land is Established in Righteousness.

HIS EXCELLENCY.

Our Self-elected President.

In the course of his career as President of the p. g. Mr. S. B. Dole has put forth some very extraordinary public compositions which will furnish wonder and amusement to the future historian of Hawaii. Extraordinary they are, not as models of diplomacy, statesmanship or wisdom, but exactly the reverse. Puerile, verbose egotistical, false, they remind one of Jack Falstaff, Sergeant Bozzfuzz and little Jack Horner.

The analytical student will read between the lines a morbid undercurrent of a mind that has seemingly attained the height of a life long ambition; that while modeling its actions upon the uncivilized lines of South American revolts, fancies itself heaven-inspired; that is so wrapped in a cloudy mantle of oligarchical conceit descends from the medieval church militant, that popular rights and feelings are beneath consideration; that betokens a gratified lust for the empty honors of power and place, and the fulsome comforts of easily acquired government gold.

What Falstaffian humor there was in his bombastic claim for the "brave men" who were the only "earthly authority" he recognized. All the world now knows that Dole's army were merely a lot of mercenary huns, who under Uncle Sam's protection were willing to do a uniform for \$4 a month and "good p. g. grub."

And how he does out-bozzfuzz Bozzfuzz with his pompous vanity and verbose pleading in the cause of the p. g. oligarchy vs. the Hawaiian nation. Unbias your mind, read his pleas and see how vapory, unreal and based on false statements they are.

And what childish glee he displays like little Jack Horner? He exhibits the sweet plums he has pulled out of the Hawaiian pie for himself and his friends. See me now, oh mama missionary! Glory be to Stevens! Now I will be President with a big, big, salary, bigger than most men like I get! and see! there are lot more plums in this January pie that Stevens gave me, which he said I must give around to all the poor missionaries! And mama! these are the same kind of plums the Queen and the bad Royalists used to get and never give us any, but now Stevens says, they will be our own, own own all the time, because the others are heathens, and we are missionaries and we all belong to the "church of the holy hypocrites." And if they try to take it away from us again, we must just hit them.

The latest effusion from the pen and brain of Mr. Dole deserves the severest condemnation for its falsehoods and its insulting innuendoes against the royalists. Dole says, "The monarchy, after a period of decadence which was threatening and prejudicial to all public and private interests came to a logical end—through its own plot to turn back the movement of public progress and to subjugate all national energies and aspirations in the interest of despotism." If those lines had been written as part of the requiem of the p. g. they would have been exceedingly fitting. None but a perverse and biased intellect could have written it against the monarchy. What is the record of fact, which will also be the record of history? The Kingdom of Hawaii held an honored place among the nations, and its ambassadors had often been honored in foreign lands. It surely was not "decadence" that enabled King Kalakaua to secure the Reciprocity Treaty and Treaties that brought laborers from Madeira and Japan, which coupled with the legisla-

tion that fastened the sugar industry and created unexampled wealth and prosperity in Hawaii. Under the monarchy, these islands prospered, and all the people were happy, except, perhaps the conceited and bigoted church clique, who were petulantly worried with an idea to "rule or ruin." The several races of people gathered in Hawaii from the occident and the orient found under the Hawaiian Monarchy, a neutral power that amply protected all their rights and interests, taxed them, but lightly, recognized no international prejudices, or jealousies, and permitted all to enjoy the fruits of their thrift under mild and liberal laws. Dole's assertions that the Queen attempted to "turn back the movement of public progress" he knows to be a base prevarication. The Constitution which the Queen proposed to give the country did not contemplate any idea of despotism, but in fact its provisions were remarkably similar to Dole's proposed new constitution in many essentials, and was intended to free the people from the damnable rotten document of 1887, and to provide for a more truly representative and safe form of government. This cannot be denied and any assertion to the contrary is simply false.

But what have Dole and his filibustering crew done in their brief revel in the palace of Hawaiian Kings. The "decadence" of Hawaii has slid down with rapid strides of depression, and paralyzed industry which is not "threatening" but has absolutely "prejudiced" all public and private interests and has brought Hawaii's financial and business interests to the verge of ruin. The "movement of public progress" has been suddenly checked and the filibusters "plot" has "turned back" the wheels of civilization to a medieval condition of oligarchy, military despotism and insolent dictatorship. Dole has "subjugated" all national energies and aspirations in the interest of despotism, knowing that he and his coterie could never rule by the will of the people, but with a mad conceit that they and they only, were divinely qualified to rule as inspired dictators they have brought Hawaii to a state of social and political anarchy, in which the several nationalities are forming into secret clubs in order to struggle for the dominance. They have created bitter social feuds, so that Hawaii's once peaceful and happy society is at war, and even families are divided as "nasty p. g." and "bad royalist." They have caused distress and poverty among the natives by wholesale dismissals from employ, because "love of country" aloha aina tingled every drop of Hawaiian blood, and caused them to repudiate the pirates oath against their native land.

Yet these are the men whom Minister Willis in denouncing the royalists reports to his government praesid Out with such sycophany and false Auercie n sm.

Again does Dole produce from the clouded abyss of his brain, another rhythm for a p. g. requiem when he writes, "No part of a nation which has made progress in civilization has a right to drag the other part back to barbarism." If the sentiment is correct, by what right has Dole and the infinitely small minority that follow him ended the progressive constitutional government of the people, and dragooned the great majority under an offensive, unpopular and retrogressive military despotism, and still further professes to dragoon them under an aborted Republic?

Another scintillation written by Dole, but inspired by the spirit that is inducing him to write the truth against himself, when he speaks of "success in holding power without abusing it, and in administering government for the benefit of the many by the authority of those whose exercise of political favor is based upon capacity to discharge public duty." Measured by popular feeling the p. g. has not been a success; it has often abused its power; it has been administered for the benefit of the few rather than the many, and they have amply demonstrated their incapacity to discharge

public duty, being bigoted, narrow-minded and prejudiced against all who sale political honor and principles are taken from a higher school.

Mr. Dole's first introduction to the public as a political writer was when he published his "thirty days of Hawaiian history," being his view of the interregnum occurring between the death of Kamehameha V. and the accession of Lunalilo. Looking back at that screech in the light of recent events, it clearly foreshadows the morbid and gloomy revolutionary spirit which suffering from an enforced camp in the background during Kalakaua's reign reached its climax when one week before January 17, 1893, he resigned from the Supreme Bench to join with Stevens and his arch plotters against Hawaiian nationality.

It is perfectly clear that the interests of the Hawaiian people or of the "many" other races here, as against the conceit of few are not safe in the hands of Mr. Dole and his associates. It needs men of broader ideas and more liberal principles who can have the confidence of the people. The royalists can produce such men. Minister Willis to the contrary notwithstanding.

No true Hawaiian who loves his country, home and family, and who cares to leave a peaceful and honorable heritage to posterity, will ever become a party to the spectral republic, which now, meaningly, looms over Hawaii, in comparing with Thurston's partner, the Devil, and gloating over visions of race conflicts and revolutions which elections for a President will bring to unhappy Hawaii.

The Cable Commissioners.

The Colonial Commissioners to the Federal Conference about to be held in Canada, went through on the Arawa which arrived from Sydney about midnight on Saturday. Early on Sunday morning they were met by Ministers Damon and Hatch who courteously entertained the distinguished visitors with a pleasant drive and a visit to the hotel, winding up in the Arawa's saloon. Several Honoluluans who were former residents of the Colonies renewed their acquaintance with the Commissioners. Victoria sends Sir Henry Wrixon, an eminent lawyer and T. B. Sutter, Tasmania is represented N. Fitzgerald, New South Wales sends Simon Frazer and A. J. Thymne represents Queensland. All these men, with the exception of Sir Henry Wrixon, are solid business men who have been elected to their several legislatures by the manhood suffrage vote of the people; so that they may be said to combine the training required for their mission; that of commerce and politics, without being professional politicians in any sense.

Sir Henry Wrixon was seen by a HOLOMUA man and briefly stated, that the primary objects of the conference at Ottawa were to arrive at some plan by which commercial reciprocity between the mother country and all outlying parts of the Empire can be arranged pending the accomplishment of Imperial federation which may not come for some years. In Australia the establishment of a customs line patrol by which each colony keeps out the products of its neighbour, is an anomaly which the delegates will endeavor to abolish.

The question of a cable for the Pacific will be decided on. The Colonies are opposed to the cable being owned by private parties, and it is more than probable that the undertaking will be entirely in the hands of the governments and will only touch at points of British territory.

In regard to Samoa the colonies regretted the intention of the United States to resign its share of control. The vote of the Samoan people to be heard in their own interests would result in union with New Zealand, which was the best thing for Samoa.

Concerning the business depression in Australia—Sir Henry thought the worst days had passed. The banks made advances on land carrying an inflated value. The silver question also had—

as in the United States—much to do with filling the cities with unemployed. Ten years ago less than a thousand men were employed in Australia silver mines; when the late collapse came there was over a hundred thousand silver miners in the several colonies, nearly all of whom were thrown out of work. Men are turning their attention more to agriculture and the governments are assisting with free land, and money help, all who turn their attention to agriculture with the object of founding homes.

Sir Henry did not know much about our local affairs. The Australian press seemed to derive its information of Hawaiian affairs chiefly from the American press, and the provisional government organs, but he would study the new constitution on the trip to Canada. At this point the word was passed "all for the shore" and the levitation swung around with her living cargo of 121 through passengers augmented by 30 from this port.

Puritanism.

When Mr. S. B. Dole can stand up in the constitutional convention and advocate the gagging of the press, the muzzling of speech, it is hardly to be wondered at, that he can become responsible for the retrogressive and absurd move to enforce the ancient and superannated Sunday laws which are yet on the statutes of this highly civilized "Republic." The police have been instructed to shut up everything on Sundays, and to put the community to the greatest possible inconvenience. They have obeyed orders. No shave, no cigars, no cigarettes, no candy, no drinks, no joy in the future. Honolulu on a Sunday is dead to the world, that is, that portion which doesn't swear by the p. g. The preacher can ply his trade and earn his salary by preaching to the select—the cigar dealer is tabooed. The Waikiki resorts can make their money, never mind how, the candy seller cannot. The post office and the government printing shop can be in full blast and the employees deprived of their needed rest and their recreation—the barber cannot shave you, Messrs. Damon and Hatch can "set up" the wine at the hotel for "Inter-Colonial delegates—you cannot buy gingerale. The Portuguese band, the riflemen at Makiki, the target hitters at Kalia can make all the noise they desire, you d—royalist can't even stand and talk quietly on the corner of Emma and Punchbowl streets without some p. g. police officer coming around and disperse the boys—because it is Sunday. Isn't it about time that the p. g. took a reef in their flour-bagged made sails, or does Mr. Dole really want a breeze which will fill his whiskers with sufficient force to blow him and his satellites away from this quarter of the globe? Let all retrogressive moves cease, and let us try, even under Dole, to be civilized and live up to the sentiments of this, the fin de siecle.

An Embezzling Official.

J. P. Silva, deputy tax-assessor for the district of Hana, Maui has been arrested for embezzlement at the instigation of the tax-assessor in chief C. H. Dickey. The accused official is stated to be short about \$1,200 in his accounts. He will be tried at the coming term in Wailuku. He has been in the government service for sometime, and was of course an ardent p. g. politician.

The Advertiser who catches a persons eye usually wins a customer. Many different styles of advertising have been adopted and with more or less success, by the believers in the use of printers ink. The Reciprocity Plantation on Maui is through grinding. The crop is estimated at 900 tons; a great deal less than under former managements.

The target shooting at Makiki yesterday started at 2 o'clock and lasted to 5 o'clock. The residents were, as usually, annoyed—but they have no p. g. protection.

Rev. H. H. Rice will deliver a lecture this evening at the Stone Church. The subject will be the "World's Fair" and will be illustrated by stereopticon views. Mr. Morris formerly with Mrs. Gans will manage the slides. The second lecture on the same subject will take place on the 9th.

The Saturday dinner at the Hawaiian Hotel is now a noteworthy feature. Manager Lewis tempts by his exquisite menu, everybody who "love themselves" to join his festive board. The Quintette Club is furnishing popular music and the tout ensemble is deserving of the patronage of the best citizens of Honolulu.

The Arawa.

The C. A. S. S. Arawa arrived here from Sydney on Saturday night. She left Sydney on May 19th, and arrived at Fiji on the 25th. A large number of passengers were on board her all booked for Victoria. She brought 50 tons of freight for this port, and took away 1300 bunches of bananas and 2000 bags of rice. She left yesterday at 12 o'clock. Captain Hayward of the Mariposa left by her to join his vessel in San Francisco, other passengers from here were Mr. and Mrs. J. N. S. Williams and Mrs. W. L. Green who go to Scotland. Messrs H. THE CONVENTION.

Wise Men Meet

THEIR DOINGS.

Pursuant to adjournment the Constitutional Convention assembled at ten o'clock this morning, President Dole in the chair. After the prayer by the chaplain, the minutes of the last session were read by the Secretary, and approved.

The Committee on the petition of Harry Klemme, that a recount of the ballots between himself and A. K. Kuniaka be taken, reported through Rep. Allen, Chairman of the Committee, that the ballots at the several polling districts had been recounted and a detailed list which he read was appended to the report showing that Rep. Kuniaka polled 3 17-20 votes more than Klemme. On motion of Rep. Rice, the report was unanimously adopted, and Rep. Kuniaka thanked the Committee for their action.

Rep. Baldwin moved that members notify the Secretary of the daily papers they would wish to be supplied with. Carried.

A motion moved by Rep. Carter that the Minister of Interior forthwith furnish the Convention with the details of the voting for delegates at the last election, which was opposed by Rep. Ables, and lost.

Rep. Kalua urged that, as the Hawaiian Version was now ready up to Article 40, the Convention should go on with business.

Rep. Young and the President, thought the rules should be brought up.

Rep. Emmeluth moved, that in all cases a majority vote shall carry, which on the motion of the Attorney General, was referred to the Committee on Rules.

The Attorney General moved that the Committee be instructed to prepare a rule by which the Constitution must be read a second time.

Rep. Emmeluth moved, it be read a third time as a bill in a legislature.

Rep. Carter suggested one reading and one on the final vote. Reps. Hatch and Baldwin held that two readings were enough.

Rep. Emmeluth contended that the importance of the matter should prevent undue haste, and three readings would be proper. Moreover, everyone present was not equally quick to grasp points of moment.

The motion for two readings prevailed.

Rep. Baldwin moved that the Convention resolve itself into committee of the whole and consider the draft constitution submitted, section by section. Carried.

The Secretary then read Section 1, which on motion of Rep. Kalua passed.

Section 2 passed, on the motion of Rep. Waterhouse.

On Section 3 being read, Rep. Carter moved that it should be amended as there was a danger of ambiguity in the draft before them.

After considerable discussion by Rep. Robertson, who opposed any provision for legislation on the occupations of persons after they entered the country; and Reps. Hitchcock, Hatch and Emmeluth, who held out for such restrictive power, Rep. Damon thought it would be dangerous and improper for a republic to start at the outset of its career to restrict anyone.

Rep. Emmeluth moved that the Committee refer the Section to the Convention to have it recommitted; finally the Section was passed by amending line 14 to read "any person or any class or nationality of persons coming into the republic."

Article 3 on motion of Rep. Waterhouse, passed.

Article 3. Freedom of speech and of the press. On being read Rep. Hatch moved to strike out the words "except as hereinafter provided," in the second line, and the rest of the article after the words "such right" in line 6.

The Attorney General warmly opposed his colleague by urging that the whole article should be

retained. If the United States had such a safeguard in its constitution as this, it would have prevented the anarchist trouble in Chicago.

Rep. Carter wanted to pass it *pro forma*, and to be reconsidered on second reading.

Rep. Brown supported the amendment as it was no use bottling up free speech. As to the royalists they should be allowed to get off all the gas they have, as that will be all the good it will do them.

Rep. Damon thought the spirit of the printed section wrong. The intention here should be met by law.

Rep. Ables did not agree with such a provision against free speech.

Rep. Iosepa held there should be such a provision to shut up monarchists. He wanted it maintained as it read.

Rep. Vivas said in his opinion, such a clause as that printed was a blot on the constitution of a republic.

Rep. Robertson thought the wording of the same clause in the constitution of '87 preferable to this, and moved it be adopted *lost*.

The final amendment as moved by Del. Dole carried that the following words stand part of the article in the place of the words agreed to be stricken out on the motion of Rep. Hatch: "Provided however that the legislature may enact such laws as may prevent the utterance or publication of indecent or seditious language."

In speaking to his motion Rep. Dole spoke of lately published language in "newspapers" in this city that could not be uttered on the floor of this house." Rep. Dole spoke also of Chicago and the former strength of the Anarchists.

Article 4 was adopted.

On motion passed to rise, with leave to set again, the committee reported to the Convention and took recess to 1:30.

AN ASSURED SUCCESS.

The 11th of June Will Be Properly Celebrated.

The arrival yesterday of the horses from the Horner-Ballentine stables settled the fear entertained by sportsmen that the race-meeting to be held under the auspices of the Hawaiian Jockey Club on the 11th of June would either fall through or to a certain extent be a failure. The prospects are now that the community will be able to witness one of the finest and most interesting races ever seen here. The track has never been in a better condition. The horses can't help beating their own records when they hear the "go," and get a chance to fly over the track. The horses brought down by the Horners are Amorino, Lolokulani, Kaiulani and Queen L. They are in charge of Carl Leonard, who will ride them. Senator Stanford Leilani and Autonomy of the Gay stables will make it warm for the Maui horses. The trotting and pacing races also promise to be highly interesting. The Club stables have got some excellent horses and some Honolulu records will be broken. Colonel Cornwell brought down a trotter yesterday from Maui, but he has not yet decided if he will enter him. Mr. Giffard is deserving of great credit for the energy with which he has taken charge of the arrangements for the meeting, and it is to be hoped that all Honolulu will turn out in full force as in days of old. There will be all possible conveniences both for the "outer" man as well as for the "inner," and the curtailing of the programme will be appreciated by many who in former years, felt somewhat tired of spending the whole long day on the track.

Fire at Hana.

The residence of Mr. Hanna, a well known attorney-at-law at Hamao, Hana, was burned to the ground last week. The cause of fire is supposed to have been from some children playing with matches. Mr. Hanna had no insurance on his house, and will consequently suffer a serious loss.
