RADICAL TALK BY GRAND JURY CALIFORNIA LEGISLATURE FULL OF REFORM

Thousands Of Chinese Headed For Indignation Meeting This Afternoon

The Chinese mass meeting to be held this afternoon at Aala Park promises to be the biggest meeting of the Chinese ever held here. It was called for the purpose of petitioning for the removal of Consul General Liang Kwo Ying. Those in charge of the meeting say there will be four or five thousand Chinese on the spot, if it doesn't rain.

"We would have hired a theater or a hall," said one of them, "but there is no place in town big enough for the crowd."

The meeting is expected to result in big petitions, addressed both to the imperial government in Peking and the Chinese ambassador in Washington, asking that the Chinese consul

here be recalled. The main cause of agitation against him is that he is said to have transmitted a statement to the Peking government in which many well known local Chinese are denounced as revolutionists. While the fear that families in China may suffer execution for sins of members here is not now so great as it was under former conditions in China, the local people fear some punishment of their relatives and also fear for their own standing if they should ever return to the yellow kingdom.

Chinese business houses have agreed to shut up shop at the time of the meeting, and unless it rains like it did

SUPERVISORS TO DROP THE LADY SINGERS ON PUBLIC BAND AND POSTPONE PLAYERS' SALARY RAISES

The band singers are expected to sing "Aloha Oe" with special feeling the next time they appear, for it will probably be their last chance for some time to come. The rest of the members of the band may play sad music with similar unusual depth of sentiment, for they are going to be turned down for the present at least, in their request for raises of salaries.

The supervisors have practically decided that the band will have to worry along on its present schedule, for the time being, and that the two lady members, singers, shall be cut out. The little money saved by dropping the singers is to be given to the other instrument players. It will be a very small raise, and there is said to be

danger that some of the members of the band will quit, but the municipal fathers say they have to keep down expenses. The band is invited to wait and see what happens after the ideas of March. They may get a raise on April Fool's day.

At the last meeting of the board a petition was received asking that raises be granted all along the line, the total number of increases aggregating nearly \$800 per month. The board has decided that the raises cannot be made at present.

It is understood that Kappelmeister Berger is at work on a new march, to be dedicated to Supervisor Kruger, and entitled "Der Watch on der Rhino."

BIG CUTS IN ROAD WORK, HONOLULU SHARE CUT IN HALF

Under the proposed schedule of city and county expenditures for the next three months, as planned by the new board of supervisors, there will be only about half as much work on roads as during the past six months. The

budget, which will probably be adopted this evening by the board, cuts expenditures from the general fund, on roads, from \$20,400 per month to \$11,350 per month, for the entire county. The road tax fund, which all goes for roads, is slightly larger and expenditures from this fund will therefore be larger. They will be \$3,550 per month, instead of \$3,150. The net decrease in the monthly sum to be spent on road work is \$8,850.

GRAND JURORS COMPLIMENT THE ENLISTED MEN HERE, ROAST THE POLICE COURT FINANCIAL SYSTEM AND DISCUSS LIQUOR PROBLEM

The Territorial Grand Jury submitted its final report for the term to Judge Cooper this morning, shortly after eleven o'clock. Sixty cases were dealt with by the Jury, including two charges of murder, ten of having assaulted with intent to commit murder, ten of having committed assault and battery, and a number of others. There was a deplorably high percentage of charges of immoral acts. Fifty-eight true bills were filed, and only in two instances, were no bills filed. There were twenty-seven convictions and three acquittals. Twenty-eight cases are pending.

After having glanced through the report, Judge Cooper said: "I appreciate your services during the term for which you were sworn in to serve, and will see that the recommendations you have made are conveyed to the proper source, and in discharging you from further service, desire to

thank you for the good and uniform work that you have done. You are excused from further service."

The report is as follows:

"To the Honorable HENRY E. COOPER, First Judge of the above entitled Court:

"Your Grand Jury sitting within and for this Circuit since the month of July, 1910, to this date does now respectfully submit this their final report.

"A synopsis of the work of this Grand Jury during its sessions which commenced on August 3rd 1910 is shown by the schedule attached to this report and marked Exhibit 'A.'

"The personnel of said jury, together with record of attendance is herewith submitted in the form of the roll calls of its several sessions, all had in the Chamber of the Board of Supervisors of the City and County

ACT TO CREATE KILAUEA PARK STATISTICS OF LOCAL POLICE FOR PAST YEAR

Governor Frear this morning stated that he was busy preparing a draft of the bill for submission to Congress in connection with the proposed National Park at Kilauea. So far the descriptions have not been completed, but these are being compiled by Surveyor Wall. As soon as these are ready, the bill will be in order, as far as this end is concerned, and it is hoped that it can be despatched by the P. M. S. Korea tomorrow.

The figures \$50,000 are to be inserted after the words "at a cost not to exceed" It is not anticipated that all this money will be used if it is granted. If there is a balance this will be used for the construction of additional roads and paths to those contained in the proposed scheme to be submitted.

BRUSSELS, January 6.—All doubt as to the fate of the aviator Grace, who disappeared after he started across the English channel two weeks ago, was settled today, when his cap was found in the North Sea. His glasses were also picked up, and it is now regarded as certain that his airship fell into the sea.

BIG CITY IN DARKNESS.
MINNEAPOLIS, January 6.—An explosion caused by a power wire last night wrecked the general electric plant of the city, leaving the city in darkness last night. The loss is estimated at \$200,000.

RECREATION VS. SPORT.

Surgeon General Stokes, U. S. N. condemns specialized athleticism, making particular reference to football, as tending to produce susceptibility to heart and lung trouble in its devotees later in life. He opens up a question that is ripe for right settlement with regard not only to the army and the navy, but colleges and schools, sporting clubs, industrial and mercantile establishments, and in short the youth and the prime manhood generally of this and other countries. Without going into the theories of Dr. Stokes and other investigators, including college professors, which condemn athleticism in its existing phases, it will be generally admitted that the evils pointed out have reached an extreme measure. Manly and womanly sports have too much lost their primal motive of recreation, and become rather a means of producing abnormal championships of teams and individuals. Glory rather than physical good is the incentive. Physical fitness is changed from being the end to being the means, and this of a different end to the original one. Sports are not play any more but war.

In vain is the attempt made to mitigate the fierceness of sports by strict law of segregation of the amateur from the professional. The two things are identical in all save the matter of money prizes. Even in the hiring of outside "talent" the amateur organizations put themselves on the lower plane of professionalism. It is a matter of triumphing over rivals at any price. There is the same abnormal training and excessive specialization in amateur as in professional sports. And if there were merit in specific training and selection of experts for different stations in games, it is only the insignificant few which receive the benefit while the great mass of people, older or younger, whose physical condition would be improved by athletic exercise sit idly upon the grandstand and bleachers. This condition has descended from athletic organizations and colleges to communities and common schools. Those who have attained to places on teams and crews, with a certain proportion of substitutes and understudies, have the fun and the great majority of youth, as well as unsurpassed manhood, merely look on and "root" for their favorites.

To get back to the primitive innocence and blessedness of sport for recreation solely, the prescription should be the elimination of team championships, with all their gawgaws of medals and ribbons and challenge cups, from all colleges, schools and amateur athletic organizations. Let the only training for such be that of correct living, which is the best kind and will not leave a train of susceptibilities of breakdown. It would not be necessary to abolish all rivalry between institutions. They might yet compete for honors as a whole and not vicariously through picked exponents of a particular game. There would be a real test of the average physical condition of an institution's membership. All who played the game or practised the sport, whatever it might be, would thus have the exercise and be ready each, at a moment's notice, to acquit himself creditably in a match with another institution. Absolutely to eradicate the evils of specialization and over-training, the selection of competing teams on all occasions by rotation, or odd and even numeration, or by lot, would be all that was necessary. What is wanted is to get back to play for recreation simply.

This reform would not do away with professional sport, which must always have a place of its own in every virile community. There is a large public of men, women and children which loves to be entertained with athletic sports, and for its money nothing but the high quality of specialized performance would suffice. And there will always be a supply fitting the demand for professionals in field and water sports, just as there is for circus performers and knights of "the squared circle." Much of such professional talent will gravitate from the institutions and clubs that cultivate recreation for its own sake, yet that is no reason why the latter should not be emancipated from the incubus of everything pertaining to professionalism in sport.

MUNICIPAL FINANCES.

There is a financial outlook for the municipality which scarcely justifies the sweeping cut proposed to be made in road works. With exactly the same business to handle as this time last year, the board has practically the same resources in sight and improved ones in prospect.

There is bound to be a large increase of revenue this year, partly from the enhanced value of last year's sugar crop over that of the year before, ensuring more income taxes, and partly from an increase in property taxes which the latest returns show and from which the past year's revenue benefited. With perhaps from five to ten thousand dollars less of cash balance on hand than last year, the present board has more than an equivalent for the deficiency from having no back demands to pay.

In March there will be the bulk of the road taxes collected going directly into the city and county treasury, from which fund the former boards have always found means to relieve the general fund the first quarter of the year. Then half of the income and property taxes will have been collected in May, making ample resources in the Territorial treasury out of which the municipality may obtain advances from its reserve. This reserve, on which a settlement is made in July, will not be less than \$60,000 to \$90,000. Again the bulk of the business license money will be in the first quarter of next half-yearly period, the whole replenishing the treasury by \$50,000 to \$75,000 before the end of the year. Moreover, there is promise that the Legislature will provide better for all the counties at the coming session.

While appropriating money for the first quarter of the year, the board might quite properly discount, to a safe degree, the resources of the remaining three quarters.

A commercial review lately quoted in this paper referred to the apparent anomaly of a decline in copper securities notwithstanding that the consumption of the metal was as great as ever. When the price of copper rose skyward a few years ago, copper mining took on great activity. The result was twofold—copper securities went kiting and there was an over-production of copper. It was only a matter of time when the latter condition should reverse the former. This has happened and the unforeseeing investors bewail the loss of millions. The lesson is the one Franklin long ago taught, but which is seemingly forgotten by present day speculators—"Don't pay too dear for your whistle."

GRAND JURORS

of Honolulu. All of these meetings have been harmonious and without waste of time.

"The many cases presented to the Grand Jury have been disposed of as from time to time reported to the Court after having been recorded in the minutes of the jury.

"This body was organized by the appointment of Mr. R. R. Reidford as foreman, by yourself and the selection of Mr. Ed. Towse as secretary," by Mr. Reidford.

"Mr. John W. Cathcart, as attorney for the Territory and Mr. F. W. Milverton, his Deputy, have diligently, courteously and impartially served the jury in its investigations and deliberations and by their able and conscientious work have been of invaluable assistance in guiding the jury in its effort to serve the people as directed by the Court.

"The cases of malfeasance or embezzlement in the District Court of Honolulu had the attention of this jury. We strongly recommend a monthly audit as prescribed by law of the financial transactions of this Court. The system and practice of handling funds, we find extremely loose. The monies therein have little or no protection in actual practice. Responsibility should be fixed, with exactness and the law so amended that swift and full punishment may follow the theft of public monies.

"We are led to the belief that the law should operate to the end that minor cases of affray, theft, etc. might be finally disposed of in the District Court, fully serving justice, but saving the time and expense of Grand and Petit Juries and Courts.

"Throughout the City and County of Honolulu, the police should be much more alert in the prevention of the carrying of dangerous weapons by individuals. This is pointed out not in the spirit of criticism of the officers involved, but for the obvious reason that many affrays could be avoided were persons suspected of evil designs submitted to search by the police.

"This Grand Jury has endeavored to follow your injunction to investigate the unlicensed selling of liquor. In two cases that were receiving our attention, the suspected persons were arrested, and entering pleas of guilty, were fined. It has been the custom for years to serve liquor with meals in these resorts. We believe that licenses should issue to one or perhaps two restaurants which are resorted to almost entirely by persons of a single nationality in the community.

"We find that several small grocery stores in one section of Honolulu constantly sell liquor without a Territorial license, and that in one place the owner of the premises holding a Federal license has for several years been almost openly an unlicensed retailer. It is also reported to us that in some of the outer districts of the island, liquor is peddled about illegally. We are satisfied that the police and law branches of the County Government are willing to co-operate with the inspector of the Liquor Commission in ferreting out law violations in the places indicated and in certain tenement houses of unsavory reputation. Our suggestion would be to strengthen the Liquor Commission, with funds for the employment of a larger executive force. We believe that by assiduous effort the so-called 'blind pig' can be eradicated. Let the illegal sellers once become convinced that the authorities are constantly and earnestly pursuing them, and such respect or fear of the law will

be engendered that the illegal traffic will be suppressed.

"We believe that the investigation by this body has had a salutary effect. However, every 'blind pig' witness examined by us stated that he (or she) would willingly give facts concerning the issue if called into Court to testify. The chief weakness in enforcement of this law, and perhaps others, is the antiquated system of practice of employing 'spies' or informers, who are harried or badgered into uselessness by defendants' attorneys. This, of course, should not be so, but it is the fact. Sudden and frequent proceedings of various character against the principals themselves, without hesitation in summoning necessary witnesses would certainly tend to make the business perilous and unprofitable.

"Nearly all of your Grand Jurors have been residents of Hawaii for many years and have taken pride in the fact that the people of the Islands were law-abiding. We therefore regret that it has been necessary to return so large a number of indictments for serious crimes, but we accept this situation as probably due to the incident of Hawaii at this time absorbing or receiving large number of new comers—some certainly unacquainted with our manners and customs, even our civilization, and others adventurers.

"We cannot close this report without a brief reference to the exemplary conduct of the very large number of enlisted men of the Army and Navy at present stationed in and about Honolulu. Officers and men are to be complimented and the Territory to be congratulated upon the splendid behavior at all times of the wearers of uniforms upon their visits to the City of Honolulu. Not a single instance of any breach of the peace or other violation of the law by the enlisted men has been brought to our attention.

"All of which is respectfully submitted.

A POLICE COURT RULING AGAINST CHINESE CONSUL

The libel proceedings arising out of the dispute between certain members of the Chinese community and the Chinese Consul-General are creating a great deal of interest in the police court, the court-room being packed this morning when the Consul-General again took the stand. The hearing of evidence has been interrupted several times by the argument of counsel, and late yesterday, questions of the comity of nations, international law, privileged documents and like questions were raised.

Judge W. B. Lymer continued the case until this morning in order to look into the authorities on a point raised by Judge A. S. Humphreys, who requested the production of a certain document then in the possession of the Chinese Consul, Attorney Claudius McBride (assisting the prosecution) objecting to the demand.

When the Court resumed the case at ten-thirty this morning Judge Lymer said:—"The Court desires to make a statement which will prove a surprise to both counsel. In considering this question of comity, international policy and international law which was presented yesterday I have concluded that the only proper ruling for the Court to make at this time is a rule which will probably obviate the necessity of an argument upon whether or not this District

Court has authority or jurisdiction to issue a process of the court compelling the Consul of a foreign country to bring a document which under his instructions, or alleged instructions, he could not properly bring. My view of the entire matter is briefly this: The plaintiff in this case has brought an action for criminal libel against the defendant and has introduced in evidence language which on its face constitutes a libel. Counsel for the plaintiff then very reasonably says, that, the language constituting prima facie libel, the burden is upon the defendant to prove that it is true. But the burden of going forward at this present time is upon the plaintiff, because of this: It certainly is an axiom of law that when the evidence, the controlling evidence, in any case is shown to be in the control and custody of one of the parties to a suit and that party refuses to produce this controlling evidence the law creates a presumption which is hostile to the party by virtue of this fact, and in this case I should say that the Consul, having shown on the stand that the order on which he relies as being his justification for taking this census and which the defendant relies on to show the consul had no authority to take the census, is in his sole custody and possession (he has made that clear by his own admission on the stand) in that case the law takes the presumption that if the Consul refuses to bring that document into court it is because if the document were produced in court the contention of defendant would be found to be true. We must distinguish between the burden of proof and the burden of going forward; the burden of proof is still on the defendant, but the plaintiff having shown that he holds in his possession this document upon which defendant relies the presumption exists that the order if produced would have the effect of supporting the defendant. In my view at the present time, the plaintiff is in this dilemma. If he feels that for patriotic reasons he cannot bring this document into court a presumption has arisen which is hostile to him and the court will have to hold that the contention of the defendant that the charge was true must be accepted. The plaintiff now can bring this document into court and rebut this presumption and then the burden of proof is shown at once to lie on the defendant."

Attorney McBride argued that a privileged communication was exempt from the general rule of presumption and the court had no power to draw any inference from the non-production of a privileged document. He challenged Judge Humphreys, or any other attorney, to prove that the court on the cross-examination of a witness could direct that witness to leave the stand and proceed to get a paper and bring it into court.

Judge Lymer replied that he appreciated the question of privilege but held that the Consul had waived that privilege by bringing the present suit which put at issue at once the existence or non-existence of the order and the nature of the order. He doubted whether the court had power to issue a process to demand the production of the document, but he thought that that was beside the question.

McBride then asked whether the court would hold, even if the consul had acted with or without authority, or in excess of authority, that it would negate that portion of the libel.

Judge Lymer replied in the negative. He held that the presumption existed that the order did not disclose any authority, not that the consul had "forced the census."

McBride wanted to show that the document was privileged and offered to produce authorities, while Humphreys was ready with a pile of books to show there was no privilege, or if there were that it had been waived.

The point was left over for consideration at a later time, Judge Lymer remarking that he would like McBride to submit his authorities, as the question was an interesting one.

The hearing of evidence was then proceeded with.

The Mauna Loa was a veritable stock-yard on her arrival this morning, bringing the following assortment of live stock:—One horse, one donkey, one basket of dogs, two boxes of monkeys, two cows, two calves, seven boxes of pigs, eight boxes of chickens, nine pigs, three dogs and thirty head of cattle from A. J. Paris. She also carried as freight two bags of coin, sixteen bags of beans, twenty-nine bunches of bananas 962 bags of coffee, 5447 bags of sugar (H. A. 1100 and A. H. 4347 bags), seven empty wine barrels and 160 packages of sundries.

The Canadian-Australian steamer Moana is due to arrive off port at seven o'clock tomorrow morning and she will leave for the Commonwealth at noon on the same day. A wireless message was received from the captain to that effect by Theo. H. Davies & Co. this morning.

STOCK SITUATION QUITE CHEERFUL

After the session yesterday 10 and 40 shares of Oahu stock sold on the street at \$26, and this morning on the board 10 shares changed hands at the same figure. At the close \$26 was the general bid for the stock, and it was offered in specified quantities at the same.

There has been quite a run on Ewa in a small way, 10, 10, 125, 15 and 30 shares selling at \$27.50. At the close of the morning's session, however, more was offered at the same, while bidding had sagged to \$27.55. It is believed that very little Ewa could be had for these figures, and that a demand for anything like a large block could not be satisfied at anything like the quotation.

Blocks of 41 and 37 Tanjong Olok rubber sold at \$38, following which \$37.50 was bid, interest in this stock seems to be increasing with the approach of the time when dividends may be forthcoming.

A block of 10 Oloa changed hands at \$3.875, after which the same was bid for more and \$4 asked. Oloa appears to be in considerable demand but at low figures. Another sale of interest was \$1000 O. LAND AND THE WEST'S FINANCES

It is one of the notable changes in the condition of the West that the small bank has become a large factor in financial affairs. For many years the farmer was the one individual to whom the West looked for its prosperity and for management of its business. Upon him everything seemed to depend, but as the small bank developed it placed in a prominent position in Western finance thousands of men whose attention was given entirely to the handling of the farmer's savings. In consequence they have become to a large extent the balance-wheel that maintains a steady condition for the financial situation. It was the banker who called a halt on the land speculation. The farmer himself had no idea in that direction. He was ambitious to extend his properties and acquire new holdings without considering what might be the effect upon business or the supply of money. The banker, however, realized that it would not do to keep up this inflation, and he demanded that the land-buyers use more caution. This feeling on the part of the bankers had a direct, positive effect upon the land movement, and it called a halt in speculative land-buying. It did not, of course, immediately depress prices of real estate nor is it probable that any such effect will take place over the West generally unless there should be a series of crop failures. . . . On the whole, the land movement has assumed a much more substantial and sane basis and one which gives less concern to the banking interests, although it has not yet returned to the complete normal condition that bankers desire. The good prices for crops of all kinds if maintained will rapidly accomplish this, and if the banking interests and the loan companies maintain their present plan of conservative action and discourage speculation in every form there ought soon to be a modification of present financial conditions.—Charles M. Harger, in the December number of the North American Review.

FAST FOOTBALL GAMES IN PROSPECT FOR TO-MORROW

The second half of the Hawaiian Association Football League's program will be entered upon tomorrow afternoon at the league grounds, when the High School team will try conclusions for the second time this season with the Malles and the Iron Works and Punahou will clash.

The two matches set down for play are similar to those played on December 17th when the season opened. Then the Malles won from the High School by the odd goal in three, while the Iron Works and Punahou drew one goal all. Since then, however, there have been several important changes in the teams and the Iron Works team has been greatly strengthened by the inclusion of J. Greig, whose work at outside left is far in advance of that of any other member of the team. This fact has helped the Iron Works players along and since the first draw they have won one match and drawn another, thus escaping defeat up to this point, while each of the other teams have had one set-back. In the case of the High School two.

The Iron Works won from the High School and drew with the Malles and Punahou; the Malles won from the High School, drew with the Iron Works and were beaten by the Punahou; the Punahou won from Malles, drew with the Iron Works and were beaten by the High School; and the High School won from Punahou and were beaten by both the other teams.

Now, what can one make out of results like these? It seems all a matter of luck, and it would not be at all surprising tomorrow if Punahou beat the Iron Works and the High School

beat the Malles, or if the result were the opposite.

The position of the league is a very interesting one. The Iron Works aggregated four points, out of a possible six, the Malles and the Punahou are on the three mark, and the High School has two points. Yet the High School might win the competition, by winning the next three matches in succession, provided that the Iron Works only won one match and drew another out of the three. This is quite a possibility; in fact, those who have followed the fortunes of the High School think it is a probability, but that seems too much to anticipate at that stage, though the High School sprang a surprise by beating Punahou. The championship of the year is at the mercy of any team in the league, or rather it would be better to say any team has a chance of annexing it.

Tomorrow's matches should be interesting, fast and entertaining, and given fine weather there should be a large crowd on the league ground when the match between the Iron Works and Punahou is set in motion at 2:30 o'clock. The second game will commence immediately after the conclusion of the first. The attendance at these games has gradually been growing and it is encouraging to players and league officials alike. The game has not yet been taken up generally by local athletes but all who wish to see an exposition of the game should visit the grounds tomorrow. There is quite enough rough play in soccer at times to satisfy the most exacting on this score, and there are innumerable opportunities for skillful play.

PROTECTION FOR STREET CAR RIDERS

The railway travelling public is to be congratulated upon a recent decision of the appellate division of the New York supreme court. Its gratitude should go back in the first place to the man who had the temerity to take a stand in the matter of what he thought to be his right to protection from the street railway company in whose car he rode, against inconvenience or danger from drunken men. This passenger was finally assaulted by an intoxicated passenger and his appeal to the conductor for relief was unheeded. He brought suit for \$500 against the railway company and refused to accept as final the lower court's ruling that "it was the duty of the passenger to use reasonable common sense and not voluntarily place himself in a position of expected danger," summarily dismissing the case.

Certainly it would be placing an unfair responsibility upon the passengers, that they should be expected to defend themselves from attack by irresponsible persons whom the railway company agent had permitted to come aboard. The reversal of the decision by the higher court is therefore not surprising. The justice rules that he "cannot assent to the doctrine that decent, law-abiding passengers are compelled to flee from the drunk and disorderly or be deemed guilty of contributory negligence;" and the passenger wins his award of damage, while getting also for other riders a more interested protection from street car conductors.

It is fair enough to say that drunken men have no right to the use of the cars. Their presence at such close quarters is offensive to other decent passengers. But it is a kindly service to permit them the help of the car in getting to their homes, if they have wit enough left to make use of it decently. So long as a drunken passenger remains quiet and inoffensive, probably the other people in the car will tolerate him; but at the first sign of anything offensive in his conduct, the conductor should be ready to correct it or put the man off. This is not always easily accomplished and it is not strange that the conductor hesitates to get into a personal encounter with a drunken person; but he should never lose sight of the fact that he stands for the company with the people and they look to him for such protection as they would expect from the company.—New Bedford Standard.

CATS FOR THE PLAGUE.

Rats spread bubonic plague. As a means of getting rid of them, the Municipal Gazette of Shanghai, China, says:

"Although thousands of rats may be killed by traps and poison, no appreciable diminution in the rat population is effected. It is necessary, therefore, to look to nature for some more effectual method of demurization. The cat is well known as the natural enemy of the rat. The utilization of the cat is probably the best means of accomplishing rat destruction as a measure against plague. Every house according to size should possess one or more cats, which should not be too well fed, so as to encourage them to hunt rats and mice. Every place frequented by rats should be accessible to cats, especially the roof space. Kittens should on no account be destroyed, but should, when they are able to live apart from the mother, be given to those not possessing cats or be sent to the health officer, who will make arrangements for their distribution where most required. Cat shows might be held and prizes given for animals of approved ability as ratters.

"When it is found that a trap does not catch rats where they are known to exist, poison may be tried, but very frequently, rats fight shy of a trap which smells of human hands or dead rats. It is therefore necessary to smoke traps frequently with a piece of burning paper to take away this smell. The trap should not be handled after burning it out. Clean gloves may be used in handling the traps. Expert rat catchers are always careful to wear gloves.

"The traps are better stained an inconspicuous color. About once a week traps should be thoroughly boiled in soda, which not only prevents the spring from rusting, but effectually removes smell which may keep rats away."

FIJI BRITISHER OBJECTS TO HAVING CARNEGIE LIBRARY BUILDING

The Western Pacific Herald, published in Fiji, contains the following: To The Editor.

Sir:—Below is a cutting from the "Semi-Weekly Star" of Honolulu, dated September 27, 1910, which speaks for itself.

That a British Crown Colony should cede a few pounds to set up an advertisement in its capital to a money-bag American of the Carnegie class sets one thinking. If the next "blow" don't end the disgrace, it is to be hoped some patriotic citizen will find the dynamite.—I am, etc.

BRITISHER.

That Carnegie library edifice for Honolulu gives me a pain. To think that, with the wealth that this mid-ocean metropolis has brought forth in these latter days, such a selfpauperizing attitude as procured the gift about being received should have been assumed by Honolulu is incredible but for the evidence materializing. What would the little band of now long departed horny-handed mechanics who founded the

Honolulu Library and Reading Room Association have thought if some prophet had told them that the monument to Honolulu's poor but proud intelligence of their day, of which they well and truly erected the pedestal, were thus soon to be razed and a structure reared in its stead to the glory of an outsider with no better motive than to have his name graven upon the structure. For it cannot be viewed otherwise. If Carnegie had investigated the conditions of the request for his bounty in this quarter, he would have ascertained that Honolulu was not in need of a library building at his hands. It is long since alms other than ecclesiastical have come to Hawaii and the soliciting even of such abroad at this day is hardly creditable to its people's self-respect. A country having the largest per capita of commerce in the world in mendicant posture is truly a humiliating sight. It will come high in price of honor, but presumably Honolulu must have its Carnegie library. Yet let boasting of the city's institutions of civilization, self-conferred, forever cease.

TIME WASTED IN THE HOUSE

WASHINGTON, D. C. Dec. 21.—A few days ago I commented on the amount of time passed in the house of representatives discussing trivial affairs relating to the government of the District of Columbia. Only a day later the senate passed a whole day debating the French spoliation claims. Presumably this matter has to be determined some time, but when one considers that the French spoiliations were committed in the year 1810, a little over a century ago, it would seem that there might be some topic in a short session such as this which might better engage the attention of the upper house of the American congress.

But the lower house did not occupy its day to much better purpose. Nearly two hours were passed in determining whether the six bathrooms in the house of representatives office building should be maintained, and in the end no determination had been reached. This is literally the way in which part of the argument was conducted, but only a small part. The proposition was to save about \$4,000 by closing the bathrooms in the house office building.

Mr. Mann (Ill): "Why not cut it off entirely? What is the use of having baths?"

Mr. Morse: "If the gentleman from Chicago can get along without a bath—"

Mr. Mann: "Evidently the gentleman from Wisconsin does."

Mr. Morse: "If the gentleman from Chicago can get along without baths it is perfectly proper to cut them out. The gentleman from Wisconsin cannot, and therefore is not in favor of cutting them out entirely."

Mr. Mann: "The question is, is the next house going to take baths?" (Laughter.)

Mr. Campbell (Kan.): "The great unwashed are in the next congress and will have no use for bathrooms."

Mr. Mann: "There are four men provided for the bathroom over there. There are a large number of bathtubs and they are almost constantly in use. Those members of the house who do not take baths ought not to be too critical of those who do take

them." (Laughter.)

Mr. Campbell: "Some members of the house take baths where they live at reasonable hours of the day."

Mr. Mann: "And at reasonable seasons of the year."

Mr. Rucker (Col.): Gentleman have not forgotten that a number of members on the republican side of the house took a bath when they went up Salt River Nov. 8.

In this merry fashion the house of representatives discussed for more than an hour an item in the sundry civil bill which involved the expenditure of about \$4,000 in the course of a fiscal year. Not all the 291 members were present, but those who were there represent an annual cost to the government of \$10,000 each in salary and perquisites. If that is economy, it would not appeal to any head of a big business house.

To add to the folly of the procedure after they had passed the amendment discharging the bathroom employees and directing the superintendent of the capitol to sell the bathtubs and appurtenances, the members reconsidered their action and let the subject stand where it was at the very beginning.

FILIPINO NEWSPAPER MEN HIT FOR LIBEL.

MANILA, P. I., Dec. 22.—The Supreme court today disposed of the Manila Renacimiento prosecution by sentencing Theodore Kalaw, formerly editor of the paper and now a member of the Philippine assembly, to one year's imprisonment and a fine of \$2,000, and Martin Ocampo, formerly the manager, to six months' imprisonment and a fine of \$2,000 for having criminally libelled Commissioner Dean C. Worcester.

The case has been in the courts a long time. Ocampo was convicted in December, 1910, and sentenced in the following month. Kalaw was found guilty and sentenced in the spring of 1909. In January of the present year Mr. Worcester was awarded \$50,000 damages against the paper. Delays and appeals to the higher court stayed the execution of the sentences.

MONEY ASKED FOR MILITARY

WASHINGTON, January 6.—The interest of congress was centered yesterday on military matters, when the question of defenses for the country again came before the representatives in a report from Secretary War Dickinson, who asked that congress make immediately available \$770,000 for supplying field artillery for the militia.

This request is in line with the proposal by the federal government to properly supervise the training of the militia and provide suitable equipment on a plane with the regular army, that in time of necessity there may be a body of citizen soldiery ready to call to arms.

Ask for Submarines.
Members of the Pacific Coast delegation to congress visited President Taft and called his attention to the practically undefended condition of the Pacific slope. Congressman McLachlan, of the seventh congressional district of California, accentuated the conditions in the southern part of his State, pending the erection of proposed fortifications, and the entire delegation asked that more submarines be stationed at the harbors on the Coast.

Another communication from the war department asks congress to provide \$1,750,000 for the relocation of the Panama railroad over a new right of way, which was originally planned to pass through the Culebra Cut.

Worcester Testifies.
The investigation into matters concerning the disposition of lands in the Philippines, known as the Friar lands, was continued and Dean C. Worcester, secretary of the interior for the Philippine government, testified at length.

The United States senate has adjourned out of respect to the memory of late United States Senator Stephen E. Elkins, and a delegation representing the senate will attend the funeral tomorrow.

WEAPON FOR CRUSADE.

SACRAMENTO, January 6.—State Senator Wolfe introduced a bill yesterday which will be a powerful weapon in the hands of the State authorities in their crusade against the white slave traffic. It proposes to make it a felony for anyone to procure women for immoral purposes or to subsist upon their earnings.

MYSTERIOUS MURDER.

SPOKANE, January 6.—One of the most mysterious murders which has ever startled the Northwest occurred here late last night, when Police Captain Sullivan, of this city, was shot at his home and instantly killed by one or more unknown men.

RACE SUICIDE IN GERMANY.

Berlin, Germany, Dec. 21.—As a result of computations recently completed it is found that the birth rate in Germany is decreasing, and sociologists are anxiously drawing attention to the menace of race suicide. Last year's birth rate for every 1,000 of population throughout the empire was only thirty-three, as against thirty-six for the decade ending with 1890, and forty-two per 1,000 in 1875.

The decline is attributed partly to the increasing reluctance of prosperous persons, especially in the cities, to accept the burden of raising large families. The unfavorable showing is causing some concern among the statisticians, who point out that a continuance of this rapid decline in the birth rate would bring Germany ere long to the condition of France, where the population has ceased to grow.

MODESTY FATAL TO YOUNG WOMAN.

NEW YORK, Dec. 21.—Because she was too modest to allow the fastening of a tourniquet about her leg Helen Gerschen, 18 years old, died at St. Vincent's hospital today. The young woman accidentally stabbed herself in the leg with a pair of scissors while at work in a clothing factory. Fellow employes rushed to her assistance, but she refused to permit anyone to bind the wound. Soon she fainted from loss of blood and was hurried to the hospital. It was too late, however, to save her life, although the surgeon said she would have recovered had a tourniquet been applied immediately.

JOHN BIGELOW WORKING AT 93.

NEW YORK, Dec. 21.—John Bigelow, one of the leading writers and publicists of America for the last fifty years, who celebrated his ninety-third birthday the day after Thanksgiving, is planning to enjoy Christmas and New Year's day, not as a worn-out old man, but as an active worker. Mr. Bigelow, who published a two-volume biography of Samuel J. Tilden only two years ago, is busy on another great work, despite his years. Mr. Bigelow came to New York as a young lawyer and began to write of political subjects. In 1849 he became a partner with William Cullen Bryant in the conduct of the New York Evening Post. One of his best biographies is that of Benjamin Franklin. He is president of the board of trustees of the New York public library.

ITALIAN HAS POCKET WIRELESS RECEIVER.

PARIS, France, Dec. 22.—Prof. Cerbotani, a well-known physicist of Rome, exhibited today before Parisian engineers and members of the ministry of posts and telegraphs a pocket wireless receiver. The instrument can be carried in a leather case in the pocket. It receives messages from considerable distances and promises to be exceedingly useful to the army.

The Italian also explained an invention which he believed solved the problem of insuring the secrecy of wireless messages so that only those for whom they were intended could receive them.

The Sierra, en route to San Francisco, made 340 miles in the twenty-

four hours ended eight o'clock last night, according to a wireless message received by C. Brewer & Company. She was then 400 miles out, and was in the midst of an easterly gale. The sea was rough and the weather dark and gloomy. The barometer stood at 36.12 and the thermometer showed 70 degrees.

Reconciliation ended the case in the police court this morning against G. Bradley, which has been dragging on since December 21 last. Bradley was charged with using threatening language to his wife and he retained Attorney Atkinson for his defense, Attorney Chillingworth assisting the prosecution. Chillingworth explained to the court this morning that the parties were living together again. Bradley had been charged with threatening his wife with a revolver, a twenty-two caliber weapon. This Bradley denied emphatically. Since the trouble arose Mrs. Bradley's father had died and Bradley paid the funeral expenses. The bereavement had brought the parties together and the wife did not want to prosecute further. Chillingworth stated he tried to prevent the woman from prosecuting in the first place as he expected it to end up amicably. Judge Lymer granted a nolle prosequi.

The American schooner Nokomis, 482 tons, arrived in port this morning with a general cargo from Tacoma consigned to Bishop and Company. She took twenty-eight days to make the trip.

Deputy United States Marshal Harry Holt will leave for the Claudine tonight for Maui to serve the necessary condemnation papers in the case of the United States vs. H. P. Baldwin, et al. This is the suit to acquire land at Hae Point as a site for a lighthouse. Deputy Marshal David K. Sherwood left last night on the W. G. Hall to serve papers in connection with the suit brought by the United States against Augustus Knudsen, et al. This is also in connection with condemnation proceedings for the acquisition of land at Lae o Kokole, Kaula, for a lighthouse site.

KOREA ARRIVES, GOES TOMORROW

The Pacific Mail steamer Korea arrived at the Alakea-street wharf a few minutes before two o'clock this afternoon, after being off Barber's Point shortly after eleven o'clock. She had altogether 363 passengers on board, 43 in the first saloon, 41 in the second and 279 in the steerage. Of this number 329 were Asiatics, of whom 113 were for Honolulu. Among those for Honolulu are 44 Filipinos who will no doubt be put under rigid examination before they are permitted to land here. There were also 21 Chinese and 48 Japanese for Honolulu. There were six saloon passengers for this port, as follows:—Mr. and Mrs. C. M. Lovested, Mrs. L. F. Willson, Mr. and Mrs. R. Arakawa and Lau Ah Leong.

The Korea had 1810 tons of general Oriental freight to unload here and the work of discharging was commenced immediately the vessel drew alongside the wharf. It is anticipated that she will be ready to sail for the coast at noon tomorrow.

INDICTMENTS FOUND.

The Territorial Grand Jury this morning returned true bills against Yasugi Nagana, for having committed an assault with intent to commit murder, and against Silvester Cullen for assault and battery with a weapon obviously and imminently dangerous to life. Deputy City and County Attorney Milverton said that the arraignments could go over until Monday morning. Judge Cooper ordered that the warrants be issued, returnable on Monday morning next.

The deck passengers were:—Thirty Hawaiians, thirteen Japanese, five Chinese, four Porto Ricans, and one other.

CAPTAIN HAS FEAR OF MUTINY

"Yes, I am afraid of him," said Captain Klocking of the German ship Erna, in the police court this morning, when asked by Attorney Straus whether he was afraid of Manuel Rodrigues, who was charged with having used threatening language towards the captain. Rodrigues was signed on at Tacoma for Port Said for orders, but when he got to Honolulu he left the ship and wanted to be paid off, but the captain refused to accede to his demand. In consequence of this refusal Rodrigues got mad and according to the captain he used vile and threatening language against Captain Klocking in particular and the German community in general.

Fireworks started in the court as soon as the case was called on this morning. Straus asking for a continuance in order to get certain witnesses and Deputy City and County Attorney A. M. Brown objecting to the application.

Seizing the complaint Straus read out "I'll get even with you before I leave here!" the words complained of as being used by Rodrigues against Captain Klocking. "The captain wants to get Rodrigues in jail and keep him there until the ship sails so that he will be able to evade paying him off," whereupon Brown jumped to his feet with another objection. Straus continued that he proposed to call the American shipping commissioner, the Portuguese consul and a witness from Hackfeld & Co. to explain defendant's position. He contended that even if the words were used as charged all that was meant was that the ship would be libelled unless the captain paid off defendant.

The request for a continuance was not pressed when Brown suggested that he was willing to agree if the prosecuting witnesses were called this morning, and Straus accepted the suggestion.

Captain Klocking, a tall well-built German, declared he was afraid of the defendant, who had threatened to finish him. "If a man says he is going to finish me in two minutes, I am afraid of him," he said. He said that defendant had deserted from the ship and he met him in the street and refused to pay him off because he had signed for Port Said for orders. When he met defendant in the German Consulate the defendant called him several names and made two attempts to jump at him.

"I cannot take him back to the ship, because I am afraid there will be a mutiny if I do," he said. Captain Klocking gave his evidence in rather a noisy manner and was rebuked by the court for interrupting counsel, Judge Lymer remarking "if you keep on talking I shall certainly fine you for contempt of court."

The hearing of the case was adjourned until tomorrow to allow defendant to secure the attendance of his witnesses.

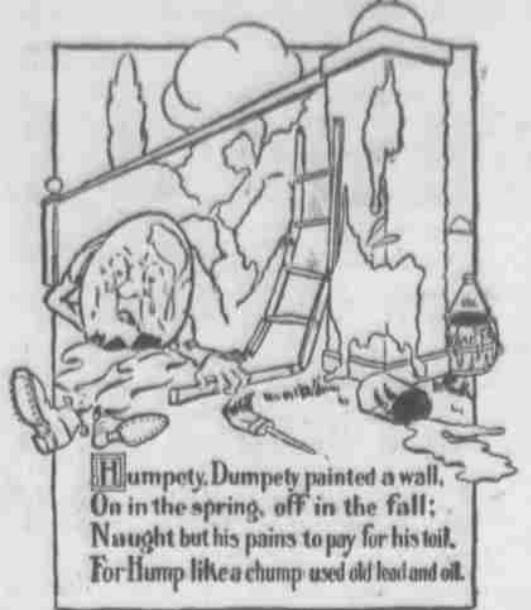
A meeting of Chinese was held today at the offices of the United Chinese Society. MUCH SPOILED WHEAT.

The work of separating the saleable wheat from that that has been damaged beyond sale in the German steamer Erna is proceeding rapidly. This vessel brought about three thousand tons of excellent north-west wheat, but on the way over she met with violent weather, and much water found its way into the hold where the wheat was stored. On arrival here an investigation was made as to the state of the cereal, which is now being emptied into lighters. Out of the total consignment it is feared that only twenty-five per cent of it will be found saleable, and even that will have to be disposed of as in a damaged condition. The other three quarters or whatever amount is found to be useless, will be taken out to sea and dumped overboard.
