# Gov't losing out in military beer scam

THEILLEGAL re-sale of untaxed beer at the US military commissary on Saipan has become a major concern among private businesses as well as the government due to lost tax revenues, it was learned yesterday.

Some four to eight 40-foot containers of beer are brought into the CNMI from Guam on a monthly basis, one of which can accommodate 1,600 to 2,000 cases of beer, depending on whether they are in cans, bottles or pallets.

The beverage sells at the Army Air Force Exchange Service (AAFES) Troop Store tax-free and at a lower price for the benefit of U.S. military personnel.

Appalled by the large volume

of "military beer" supply in the CNMI, the Department of Commerce (DOC) wants to put a limit on the number of containers coming in.

It added the large volume of military beer here has prompted some military personnel and their families to rake in profits by reselling them at a higher price.

Andrew Salas, director of DOC's Alcohol, Beverage and Tobacco Control, disclosed there has been rampant re-selling of the beverage in the CNMI, and announced that the government wants both the Guam and CNMI military supply offices to "rectify" the problem.

"That's illegal, and they know it's illegal. The military guys have the privilege to buy a case of beer that's so inexpensive... and

to turn it around and sell it is illegal but it is happening and it is saturating our market," Salas said.

Some 300 to 1,000 military personnel and veterans, and their families have the privilege of buying products at the AAFES Troop Store at a lower price, provided they are for their own consumption, and not to be re-sold.

CNMI wholesalers like Marpac and Pacific Trading are required to pay \$6.20 for every case of beer they bring in here regardless of the total volume of these items.

Military beers (including Miller Lite, Budweiser and Bud Light), on the other hand, are untaxed yet they are currently being re-sold.

#### 2 dead in Palau boat accident

KOROR (Palau Horizon) —

Two persons died while several others suffered serious injuries when a boat, ferrying some 20 people, crashed against a rock island somewhere at the Kekerel Toi channel in Palau over the weekend.

The accident was described by Health Minister Masao Ueda, who was on call at the time of emergency, as "very serious."

"When (responding medical workers) came, two were dead; four in a very critical situation; and several others sustaining cuts, lacerations, bruises, broken arms, dislocated arms and hips; and some are heavily crushed internally," Ueda said.

Ueda said a 13-year old girl had to be medically evacuated due to serious injuries to the head and lungs.

The patient was referred to Guam Memorial Hospital last Sunday morning but she arrived there the same day at around 3 p.m.

Unfortunately, the hospital does not have a specialist to attend to the girl, so she was flown about four hours later to St. Luke's Medical Center in the Philippines. According to Ueda, the girl is now in stable condition. "She's okay," he said.

According to the minister, the hospital got a distress call at around 2:30 to 3 p.m. on Saturday, and majority of the doctors, nurses and hosppital personnel came in, putting the health ministry's "Blue Code" to a test.

In a matter of 30 minutes to one hour, medical personnel, including the visiting doctors and nurses, rushed to the hospital upon hearing the emergency call.

## Sting operations yield tobacco sale violators

THE MOST recent multi-government agency tobacco sting operations resulted to some 50 to 60 licensed business establishments being cited for violating current laws against selling tobacco products to minors, the Division of Mental Health and Social Services (DMHSS) disclosed during a press conference yesterday.

Gloria Cabrera, DMHSS' Substance Abuse Program director, said that in a week-anda-half period in August, the government was able to inspect some 185 to 200 establishments out of the total 338 businesses that have licenses to sell tobacco products.

"Out of the 338, we were able to randomly select between 53 and 55 percent of the list, which is somewhere around 185 to 200 businesses.

"Of that figure, we found out that a little less than 30 percent





## Lawmakers drop hate-crime bill

WASHINGTON (AP) — Lawmakers working on a compromise spending bill dropped provisions Monday that would have expanded federal hate crimes to include those motivated by a victim's sexual orientation, gender or disability.

House-Senate bargainers crafting a compromise version of the wide-ranging bill - a process dominated by majority Republicans jettisoned the hate-crimes provi-

"That was one elephant too much for this boa constrictor." said Sen. Judd Gregg, R-N.H.

In July, the Senate without debate included hate-crimes legislation in a \$35 billion measure financing the departments of Commerce, Justice and State for fiscal 2000. The House version of the spending bill did not contain the provisions.

Asked if he had assumed in

July that the hate-crime provisions would be dropped in negotiations with the House, Gregg said, "I was trying to get a bill off the floor. ... Sometimes you presume certain things will happen and let it go.'

The overall bill faces a likely veto by President Clinton because of disputes with Republicans over spending for hiring police offic-

House seems unlikely to demand a restoration of the hate-crimes language as a condition for signing the measure, said Democrats who spoke on condition of anonymity.

Critics of proposals to expand the scope of hate-crimes laws including many conservatives have said such legislation creates special classes of citizens who are already protected by state laws

Gregg said the issue was dropped because it should be considered by Congress' Judiciary committees. He also said it had become "extremely complex" to resolve differences between two hate-crimes bills that were included in the spending measure: one by Sen. Orrin Hatch, R-Utah, and a second, stronger version supported by the Clinton admin-

#### Saddam vows to fight 'evil powers'

BAGHDAD, Iraq (AP) — In a meeting with Iraqi army commanders, President Saddam Hussein pledged to fight "evil powers" that he said are threatening his country.

Saddam's comments in a speech Sunday appeared to refer to the United States and Britain, whose planes have been patrolling no-fly zones over northern and southern Iraq since the end of the 1991 Persian Gulf War. Iraq calls the zones a violation of international law and has frequently challenged the allied planes, which have been bombing the area since December.

"We shall fight evil powers with knives, we shall fight them with light weapons if they attempt to harm our land," Saddam said during his speech.

#### Gunmen open fire on RP gov't office

MANILA, Philippines (AP) — Gunmen opened fire on the offices of the local government in metropolitan Manila before dawn Sunday, police said. No one was injured and damage was minor.

Police said the attackers apparently fired aboard a car while traveling on an elevated bridge in front of the Department of Interior and Local Governments building in suburban Quezon City.

The shots shattered glass windows and damaged walls and ceilings in at least two offices on two floors, which were unoccupied during the shooting. No one has claimed responsibility for the attack.

The offices belong to a department that has jurisdiction over the

national police and municipal governments.

The department is also being considered to lead a government campaign to promote President Joseph Estrada's proposal to amend the country's constitution, a move opposed by many left-wing and Catholic Church groups.

#### GE recalls 3.1M dishwashers

WASHINGTON (AP) — General Electric is recalling 3.1 million dishwashers that might catch fire because of a faulty switch.

The Consumer Product Safety Commission said Monday the recall includes GE and Hotpoint brand dishwashers with the model numbers GSD500D, GSD500G, GSD540, HDA467, HDA477 or HDA487. The recalled models also have a serial number that has a second letter of A, M, R, S, T, V or Z.

The model and serial numbers can be found on a rectangular label on either the right or left of the inner tub's front edge, the CPSC said. GE and the CPSC are aware of 50 incidents in which the slide switch, which selects the heat drying and energy save functions, melted and ignited fires. Seven of the fires spread beyond the dishwashers and three caused damage to homes.

#### Court asked to save Honolulu Star-Bulletin

SAN FRANCISCO (AP) — A group of Honolulu newspaper readers asked a federal appeals court Monday to uphold a judge's order keeping the Honolulu Star-Bulletin alive past its scheduled

Owners of the 117-year-old afternoon newspaper agreed last month with Gannett Co., owner of the morning Honolulu Advertiser, to end their joint operating agreement and close the Star-Bulletin. Liberty Newspapers, owner of the Star-Bulletin, is to receive \$26.5 million in exchange.

The state of Hawaii filed an antitrust suit and won an injunction last Wednesday from U.S. District Judge Alan Kay blocking the closure until the suit is resolved.

#### F. Lee Bailey faces ethics charges

TALLAHASSEE, Fla. (AP) — The Florida Bar filed ethics charges Monday against famed attorney F. Lee Bailey related to a dispute over millions in stock that he claimed he received for legal fees.

In 1996, Bailey spent 43 days in jail for contempt of court stemming from a dispute over \$16 million in stock owned by a client and for withdrawing \$3 million from a Swiss bank account established with the stock without court permission.

The stock belonged to Bailey's client, Claude Duboc, who was convicted in a drug case and ordered to forfeit his assets to the

Bailey claimed he was given the stock as his fee, while the government contended it was part of the forfeiture.

#### Vietnam fire leaves 500 homeless

HANOI, Vietnam (AP) — More than 500 people were left homeless after a fire tore through the slums of the central Vietnamese coastal city of Khanh Hoa, a local government official said Monday.

Thirty-two thatched houses were destroyed and 10 others were damaged Saturday when the fire, triggered by a short circuit, spread through the area, he said. Another 40 homes were dismantled to prevent the blaze from spreading.

No casualties were reported in the fire, which took nearly two

Some people were housed temporarily in schools and pagodas, while others were staying with relatives, the official said. Each family was given 110 pounds of rice and will get \$150 in aid next

#### SoKor will welcome all NoKor defectors

SEOUL (Reuters) - South Korea will welcome all North Korean defectors in third countries seeking political asylum in the South. Unification Minister Lim Dong-won was quoted on Monday as

Lim, who was speaking at a parliamentary session on Saturday, said diplomatic issues with the country or countries where the North Koreans have been hiding should be resolved first, ministry officials said.

"There are several hundred North Korean defectors who have expressed their intention to come into (South) Korea through our diplomatic missions," a ministry spokesman quoted Lim as saying at the National Assembly.





#### Two lawyers accused by AGO of violating NMI Gov't Ethics law

THE ATTORNEY General's Office has accused former CNMI Supreme Court Associate Justice Pedro M. Atalig of violating the Government Ethics Act for serving as counsel for Juan S. Demapan in the lawsuit filed against acting Attorney General Maya Kara.

At the same time, the AGO claimed that lawyer Joseph Arriola also violated the Act for representing Demapan's co-plaintiff, Cheung Ping Yin, in the same lawsuit against Kara.

Former Senate President Demapan and businessman Yin filed the \$3-million lawsuit against Kara, Public Safety Commissioner Charles W. Ingram Jr. and others over an alleged illegal arrest durng a raid at their legitimate gamoling establishment in Garapan. Lawyers Atalig and Arriola repesented Demapan and Yin repectively in the lawsuit that also questioned Kara's alleged illegal olding the position of acting Atorney General.

In defendants' motion, Assistant Attorney General L. David Sosebee

explained that under the Act, "a public official or public employee shall not appear as an attorney for another person before a Commonwealth governmental entity.'

The Act, according to Sosebee, defines a "public official" as "any appointed, non-employee member of the Commonwealth government, including members of the boards, commissions, and task forces."

Sosebee said Atalig currently serves on the Board of Public Lands (BPL) as an appointed non-employee member.

"As amember of BPL, Mr. Atalig is a public official as that term is defined in the Act. The Act further defines the Commonwealth Government to include the judiciary,"

Under exceptions listed in the statute, the government lawyer said, Atalig would be able to represent himself before the court without violation of the Act "as he is doing in a 1996 civil action where he is a defendant accused of land fraud in Rota."

"Mr. Atalig would also be able to represent members of his immediate family. Mr. Atalig could also represent BPL if that agency were his principal employer," Sosebee said. He stated that Atalig would be able to appear before the court on purely ministerial matters where no discretion is required on the part of the Commonwealth gov-

ernmental entity. In addition, the AGO cited that Atalig serves as a special master in the ongoing Larry Hillblom's probate case.

As the special master, Sosebee said, Atalig is a public employee as Commonwealth law defines

He stressed that a public employee is "an individual who is an appointed employee of the Commonwealth government, whether part-time or full-time."

As a public employee, Sosebee said, Atalig is also prohibited from appearing as an attorney in the Commonwealth courts.

Sosebee said the defendants hope that as a former Justice, Atalig would understand the importance of government ethics and withdraw from the case without the necessity of an order from the

Citing past criticisms by the Office of Insular Affairs regarding unused funds provided under Section 702 of the Covenant, Tenorio said it's about time serious work is done to ensure that all CIP money is utilized.

"We like to see that we use the money to improve the CNMI," said the governor.

For his part, the CDA Chair said government should follow plans drawn up on how to spend the CIP money, saying a deviation from this could result to future prob-

"It is all up to the administration and the Legislature on to how to spend it," said the CDA Chair, stressing that government should ensure that the money is "strictly 100-percent CIP."

"While the Probation officers administering the test initially agreed to provide the test results, separate Probation Officers decided not to release my client's report after her results turned up negative," said Phillips in the letter dated Oct. 14.

Cepeda in response to Phillips' request said he has forwarded the letter to the court's administrative director for review and action.

"The court's practice for requests pursuant to the Sunshine Act is to refer the matter to the administrative director for his action. I expect that you will receive a response from him shortly," said Cepeda in Monday's letter to Abayari's counsel.

#### Radar faulted in KAL crash on Guam in '97

WASHINGTON (AP) — A radar system that is supposed to warn low-flying planes of nearby obstacles was plagued with problems and fixed nationwide only after a 1997 fatal airplane crash in Guam, according to a published report.

errors caused the Minimum Safe-Altitude Warning system not to operate over wide areas, including near busy airports such as those in Chicago and Dallas-Ft. Worth. In other cases, false alarms were so numerous that air traffic controllers put cardpoard over warning speakers to silence the noise.

The Federal Aviation Adminstration was warned about the rouble after a business jet crashed outside Washington in 1994, but it did not take decisive action to resolve it until after a Korean Air jumbo jet slammed nto a hill on approach to Guam n August 1997, killing 228, said





#### Mum on the deficit

WE HAVE yet to hear what the administration and the Legislature intend to do about the government's \$68 million deficit. Nor is there any public statement regarding how Capitol Hill will spend the revenues that will be "available" now that the government will use money from its loan from Bank of Guam for capital improvement projects.

As we've said before, because the government runs on money we taxpayers shell out, the \$68 million deficit is actually our debt. Which is why taxpayers should be nagging the government about this issue before legislators begin appropriating this "extra" money for the construction of, well, more basketball courts.

Yet even the non-incumbent candidates for House and Senate seats are mum on this issue. Indeed, it seems that every one is talking about how he or she will spend more public funds. Have these candidates discovered a way to finance all these generous and beneficial programs they're promising to implement without using the voters' and taxpayers' money?

Voters should remember that every time a candidate vows to push for legislation that would, say, expand the scholarship program, that candidate should also be asked where he would get the money for it, particularly now that 1) the government is saddled with a \$68 million deficit; and, 2) the CNMI Constitution says the deficit has to be retired in two


To be sure, there is no law to enforce this provision, but the deficit still has to be reduced somehow, soon, because, as we've said before, its current size will only tarnish the government's credit rating at a time when the CNMI's only available source of finances lies in borrowing money.

We repeat. The government cannot not do anything about a deficit this large—more than one-third of the fiscal year 2000 budget outlay—without risking a shutdown.

As our elected officials know, there are three ways to tackle this debt: reduce the size of government, reduce spending on public services and raise taxes. These are unpopular measures even in a non-election year. So, right now, the government has no choice but to seek more way of cutting its expenses. Legislators, for their part, should be urged to support spending cuts even it they involve their own ac-

But after the November elections, the administration and the Legislature should be prepared to discuss measures that would identify new sources of revenues—that is, new taxes, be it of the "one-time" variety or those with sunset provisions—and those that, at the very least, would somehow cut the size of government, beginning with the composition of

Incidentally, elected officials cannot afford to be silent on these issues if the people who they supposedly serve are not.

#### Air Force Two's bagel-bar security

DOUGLAS COHN, ABOARD AIR FORCE TWO — My partner, Jack Anderson, once took a gun past security at the Senate Office Building and laid it on Sen. Bob Dole's desk. I could have done the same thing on Air Force

Security was not sufficiently enhanced after the Senate episode, and on July 25, 1998, a real gunman did enter the building, killing two policemen. An even more costly tragedy could occur on Air Force One or Air Force Two, the planes designated to transport the president and vice president, respectively.

Our story begins on the night of October 13, 1999, at the Westin Hotel in Seattle, Washington. I check in and contact Vice President Al Gore's staff for instructions. A staffer says all non-carry-on baggage must be brought to the staff room by 5:30 a.m. the following morning. It will be inspected and held for loading. Nothing is said about carry-on bag-

On the morning of the 14th, the press corps - fewer than a dozen strong because the They look at picture IDs and check the manicoveted seats are at a premium - congregates at the hotel's bagel bar, carry-on luggage in tow. This luggage is haphazardly parked as it would be in an airport terminal, some of it together, some of it apart, some of it watched, some of it not. Secret Service agents, obvious by their ear pieces and appearances, are stationed at various points in the lobby, but they pay no heed to the lug-

The bagel bar is filled with people, some of them vice-presidential staffers, some of them members of the press, most of them other hotel guests. The agents are looking for suspicious characters, for people matching certain profiles. The press corps isn't a match; neither are the other hotel guests. The luggage and various jackets draped over chairs, attended and unattended, go unnoticed. After all, the bagel bar is not the airport.

A staffer tells a couple of reporters it is time to go, and the rest of us follow them out the door. Some of the reporters are known to the staffers, some are not. Indeed, anyone could walk out that door with us and load into the waiting press van or the overflow van. No roll is taken; no credentials are checked. Shortly thereafter the vice president's limousines emerge from the hotel, and the convoy drives to Boeing Field, escorted by a large contingent of motorcycle policemen, who block the traffic. Lights are flashing; motorcycles are rushing past. All appears

I did not know it then, but we had just left the terminal — the bagel bar — because the next stop is alongside Air Force Two. No instructions are given, but logic tells us to board the plane by the stairs near the tail, rather than the one near the cockpit. At the base of the stairs is an Air Force officer and another man, probably a Secret Service agent fest. At this point, any unauthorized person who had joined the convoy back at the bagel bar would be rejected. No one is rejected.

But where is the machine to scan our carryon luggage? Where is the walk-through scanner to check us? I am stunned. There is less security involved to board Air Force Two than there is to board an ordinary commercial plane. In fairness, however, passengers on commercial flights do not undergo security clearances as guests of the president or vice president do. But people are not the concern. It is their previously unattended carry-on luggage and jackets. No one planted an explosive device in those unattended items back at the bagel bar, but it was possible very possible.

We have notified the Secret Service about these deficiencies.

#### Pakistan's new ruler yet to soothe India

ISLAMABAD (Reuters) — Pakistan's new military ruler has struck the right conciliatory tone towards India but must now work to prove his sincerity, political analysts said on Monday.

General Pervez Musharraf's weekend remarks heartened a worried West but India, an old foe and fellow nuclear-capable power, has reason to be suspicious, they said.

Only a few months ago, Musharraf was said to have directed a bold incursion into Indian territory in the disputed Himalayan region of Kashmir, bringing the nations to the brink of war.

"I don't think that any side is going to drop its guard. There will be a standoff for the next few months," said one Western defense attaché in New Delhi.

Musharraf's call for "results-oriented" dialogue on Kashmir, cause of two of the three Indo-Pakistani wars, was in line with the position taken by previous Pakistani governments - a stance that has only seen deadlock in talks with India.

Musharraf, Pakistan's self-appointed chief executive, restated Islamabad's bottom line: India must agree to a U.N.backed referendum in Kashmir to determine its future.

India rejects a referendum out of hand.

The United States welcomed Musharraf's offer to renew dialogue with India, stalled since the Kashmir infiltration which New Delhi says Musharraf helped mastermind.

"I was heartened by his offer of dialogue with India and the unilateral concession he offered to make... We would like it to go further," said U.S. ambassador to Pakistan William Milam.

"We hope both sides will get into a serious unconditional dialogue as soon as they can," said Milam, adding he hoped the new military-civilian regime Musharraf named would extend the withdrawal to the military Line of Control dividing Kash-

There was no applause from India, only doubts and statements that nothing had changed since Musharraf overthrew Prime Minister Nawaz Sharif's government six days ago. New Delhi experts played down the troop withdrawal offer.

"It's not a very substantial remark. It assumes that they had put extra troops on the border, so the status quo of last April is simply maintained," the Western military attaché told Reuters.

"It was just a gesture that sounded good for those who don't know the situation," he said. "Reading it in detail, it doesn't

The attaché, echoing U.S. and European Union views, said Musharraf should extend the withdrawal to the military Line of Control, a de facto border dividing Indian and Pakistani Kash-

"Both sides should be looking at de-escalation along the Line of Control and so far they have shown very little willingness to do that," the attaché said.

The attaché said his mission believed Musharraf was the driving force behind the Kashmir incursion. The Pakistan military has denied involvement, but few Western states believe it.

One former Indian diplomat said Musharraf's comments were aimed more at the West than India.

"He is trying to project as a virtue something that is a routine... In the process he can project himself to the international community as a very reasonable man," said J.N. Dixit, former Indian foreign secretary and envoy to Pakistan.

Dixit said Musharraf had referred only to the international border and not to the Line of Control, the site of frequent shelling and raids from both sides.

Musharraf also referred to Kashmir in the same terms as the Sharif government - as the "core issue" between the two countries, he said.

#### Substance abuse prevention: The role of parents

DURING Child Health Month the focus is on substance abuse. I recently wrote about inhalant abuse. But there is a lot more to preventing substance abuse in our children. And it starts with us, the parents.

While nothing can guarantee that our children will not start to use and abuse drugs, we parents (and teachers, doctors and other involved adult members of our community) can make a difference. How?

• By not using drugs ourselves;

• By giving our children clear rules and guidance about not using drugs;

• By spending time with our children, sharing both their good times as well as their not so good times;

You might want to start by asking yourself some questions prepared by the American Academy of Pediatrics. Since our children learn so much from their parents, both the good and the bad, it is important to realize that our behavior really does make a difference. These questions look at what we do, not what we say.

• Do you usually offer alcoholic beverages to

friends and family when they come to your home? • Do you frequently take medicines for minor

aches and pains or if you are feeling sad or nervous? • Do you take sleeping pills to fall asleep?

• Do you use alcohol or any other drug in a way that you would not want your child to?

• Do you smoke cigarettes?

• Do you make jokes about using drugs or about getting drunk?

• Are you proud of how much you can drink?

• Do you go to parties that involve a lot of drinking? • Do you drink and drive or ride with drivers who have been drinking?

• Has your child ever seen you drunk?

• Do you let minors drink alcohol in your home? Think about your answers to these questions. You do make a difference, probably the biggest difference anyone can make.

#### Meet the blood guy

BOLING, Texas (AP) — Halloween is two weeks away, but 72-year-old Sylvan Miori is already wearing a tuxedo, cape and plastic Dracula fangs.

"Hey, it's the blood guy!" a teen-ager says as the silver-haired vampire sweeps onto the campus of Boling High School, 45 miles from

He founded a program called Teens Are People Savers, or TAPS, which encourages young people to donate blood by providing schools with gift certificates that can be applied toward student activities, such as graduation parties. Certificates worth up to \$1,000 at stores such as Wal-Mart are awarded.

Since its inception five years ago at nearby Wharton High School, the blood program has spread across 10 Texas counties, producing more than 22,000 units of roughly a pint each.

"What you're getting with these kids is our future - a generation of new givers," Miori said. "If we can keep that going, you'll always have a brand new bunch of people turning 17 years old."

TAPS may be one solution to what some experts fear is an emerging national crisis. A study by the National Blood Data Resource Center predicted that demand for blood in the United States could outstrip supply as soon as next year. Those concerns have reached Washington, where a House subcommittee is to hold the last of three hearings Tuesday on the severity of the shortage.

Experts cite numerous pressures on the blood supply, including tougher donor-screening restrictions, an aging population that is becoming too ill to give blood, and the proliferation of medical advances that require substantial amounts of blood, such as organ transplants.

There is also a generation gap among donors: A poll Oct. 11 by America's Blood Centers, the national network that supplies about 45 percent of the nation's blood, found that 68 percent of people ages 18 to 24 have never donated blood to a blood bank. By comparison, only 22 percent of Americans 55 and over have never donated.

"Individuals in the age group of 55 and up are more sensitive to the need for blood because of their experiences in World War II. Regrettably, as these folks age they become more susceptible to the diseases that preclude giving blood," said Bill T. Teague, president of Houston's Gulf Coast Regional Blood Cen-

"That's why it's so important younger people understand the need for blood, be educated about the donation process, get their fears addressed and get the opportunity to donate," he added. "And that's why TAPS is such a success."

The former auto parts dealer and beer distributor spoke to students at Wharton High, offering \$1,000 toward their graduation party. He got 107 donations. Since then, Miori has spent thousands of his own dollars promoting the pro-

On the day of his visit to Boling High, the school earned \$500 for its graduation festivities. Many students said the incentives helped get them in the door to donate, but they left with the satisfaction of knowing they may

"It just feels good, knowing you're helping people," said Julie Walker, 17, student blood drive chairman.

With financial support from foundations and corporate sponsors, TAPS has now donated more than \$250,000 to about 50 schools.

"Hell, I'm going to die," Miori said. "They're going to lose a good blood donor when I die. So we need to get these young people started now."

## GEDA nixes drydock loan

THE GUAM Economic Development Authority (GEDA) board has turned down a request for GEDA to take out a \$7 million loan that would cover the repair costs of the huge AFDB-8 drydock donated to Guam by the federal government.

The loan request was submitted to GEDA yesterday by the Government of Guam's Base Realignment and Closure (BRAC) Steering Committee Director Joe T. San Agustin.

The drydock, which arrived on Guam more than a month ago, needs to be towed to the Philippines for underwater repairs. But with GovGuam's budget crisis, financing to tow and repair the drydock might fall short.

The drydock was originally scheduled to be towed to the Philippines last Aug. 21. This was then moved to Oct. 5 but until now the drydock has not yet been transported to the Philippines.

The GovGuam-BRAC Steering Committee wanted GEDA to bor-

row money to finance the towing and the repair of the drydock.

According to San Agustin, the U.S. Rural and Development Administration had indicated that GEDA is eligible to participate under its Business and Industry Loan Guarantee Program.

However, GEDA Board Chairman Chris Murphy said that unless GovGuam can demonstrate a future revenue stream from the shipyard where the drydock will be placed, private banks and the Federal government would not

Instead of a loan, GEDA and the GovGuam-BRAC Steering Committee agreed to look at other alternatives such as Cabras Marine's offer to tow the huge AFDB-8 drydock to the Philipnines

In return, Cabras Marine wants to receive title to GovGuam's AFDM-5, a smaller drydock that is already obsolete.

Upon receipt of the notice of title transfer, Cabras Marine will initiate AFDM-5 towage seaworthiness preparations and reserve an ocean tug to tow the bigger drydock to the Philippines.

The big AFDB-8 drydock will

then be towed from Guam to Subic Bay and back to Guam under a "towcon" agreement with all-risk insurance (environmental/third party liability and partial/total loss) for a total insured value of \$4 million.

Northwest revises policies on shipment of dangerous goods

NORTHWEST Airlines announced yesterday that effective Nov. 1 it will no longer accept commercially tendered hazardous goods, identified as "dangerous goods" in the industry, for transport aboard its fleet of 410 passenger aircraft.

The airline will continue to carry such materials when properly prepared for shipment aboard its fleet of Boeing 747 freighters.

Northwest Airlines operates dedicated cargo aircraft from its Guam office with cargo accepted for daily flights in and out of Guam.

From Guam, incoming and outgoing cargo is coursed through Narita for eventual distribution throughout the airline's route system which includes Los Angeles, Manila, San Francisco,

Seattle, Anchorage, Chicago, New York, Hong Kong, Singapore, Bangkok, Taipei, Osaka, Tokyo, Manila and Shangboi

The category "dangerous goods" includes such items commonly used in industry as oilbased paints; paint thinners; insecticides and garden chemicals; lithium batteries; magnetized material; camping stoves; chainsaws and other motors not purged of fuel; automobile batteries; vehicles; infectious substance shipments; any compound, liquid or gas that has toxic/poisonous characteristics; any adhesives that are flammable; and industrial solvents, bleach or acids.

Certain hazardous materials in small quantities for personal use are permitted by national and international rules to be brought aboard by passengers and aircraft

crew members without regula-

Some of these items are: 11 pounds or less of sporting ammunition per passenger in checked luggage only; matches or lighters when carried on a passenger's person (but not in luggage); electric wheelchairs; medical or toiletry articles so long as no single item exceeds 1 pound or 1 pint and the total of all such items is less than 4.4 pounds or 2 quarts, and; 5 liters or less of alcoholic beverages defined as those beverages with an alcohol content of more than 24 percent (48 proof) and less than 70 percent (140 proof).

When packaged and handled correctly Northwest said such materials are not hazardous to normal aircraft operations and are routinely carried.

## NMI youths join Hawaii meet







Air Marshal Doug Riding, vice chief of the Australian Defence Force, said the security situation in East Timor was steadily improving and the majority of the militias blamed for waging a campaign of terror now appeared to be open to the idea of an independent East Timor.

"We expect that the INTERFET operation...will conclude no later than the end of March 2000,"Riding told reporters after talks with Philippine Defence Secretary Orlando Mercado.

"We would like to see it sooner than that and indeed we are planning for it to commence, the transition, sooner than that, preferrably in January."

INTERFET, dominated by Australian troops, is to be replaced by a special U.N. peace-

He said a vote by the Indonesian People's Consultative Assembly (MPR) accepting the August 30 ballot, in which the overwhelming majority of East Timorese voted to end 23 years of Indonesian rule, was crucial to the process.

"All expectations are that the MPR will vote to accede to the independence of East Timor. That is our expectation, but only time will tell.

Riding said the security environment in East Timor "is improving all the time.'

"There are increasing numbers of militia who are handing in their arms and accepting the invitation to become involved in the political process of an independent East Timor rather than to fight...the clear will of the East Timorese people," he



## S. Korea monks quarrel

SEOUL, South Korea (AP) — South Korea's main Buddhist temple resembles less a spiritual sanctuary than a fortified camp these days.

Coils of barbed wire line the tile-topped walls, trailers block the entrances to ward off intruders and guards with iron bars and piles of rocks at their feet watch warily from the bell tower.

South Korea's largest Buddhist order is once again in turmoil over leadership, and the thuggish tactics of some monks - hardly in line with the path to eternal enlighten-



ment - have scarred the religion's image nationwide.

The dispute illustrates Buddhism's often uncomfortable role in secular South Korea, where some faction leaders vie for control of tax-free properties and donations from worshippers.

There also is suspicion among some Buddhists that Christians. who dominate the government, are trying to manipulate the conflict to marginalize Buddhism's 1,700 years of influence.

The Chogye order, which pro-

At the temple last week, monks brandished sticks and smashed collapsible metal chairs on the shaved heads of rival monks. At least 10 monks and lay people were injured.

The clash recalled events of a year ago, when dissident monks took control of the temple, where the order's administrative headquarters is located. Police expelled them several weeks later.

On Monday, about 100 dissident monks and supporters protested peacefully outside the temple in downtown Seoul.

The squabble revolves around matters unabashedly material: who gets to handle an annual budget in the millions of dollars, control land, buildings and assets worth millions more, and appoint 1,700 monks to various duties.

After last year's showdown, mainstream monks elected a new leader for the order. But a Seoul administrative court, acting on a. lawsuit by the dissidents, cited procedural flaws and ruled against the vote on Oct. 1.

In defiance, the mainstream monks barricaded themselves in Chogye, named for a Chinese mountain where an ancient Buddhist patriarch once lived. The temple was built at the end of the 14th century, burned down and reconstructed, replete with lotus lamps, a pagoda and an iron gong.

"If we had procedural problems in electing our own leader, we can take care of that," said Woonkwang, a spokesman for mainstream monks. "Mundane courts or judges have no say in



#### Vietnam fire leaves 500 homeless

HANOI, Vietnam (AP) — More than 500 people were left homeless after a fire tore through the slums of the central Vietnamese coastal city of Khanh Hoa, a local government official said Monday.

Thirty-two thatched houses were destroyed and 10 others were damaged Saturday when the fire, triggered by a short circuit, spread through the area, he said. Another 40 homes were dismantled to prevent the blaze from spreading.

Some people were housed temporarily in schools and pagodas, while others were staying with relatives, the official said. Each family was given 110 pounds of rice and will get \$150 in aid next week, he said.

No casualties were reported in the fire, which took nearly two hours to extinguish, he said.

22 and begin a two-day visit to Portugal on Oct. 26.

Chinese officials said Jiang would discuss China's desire for WTO membership with leaders of Britain, France and Portugal. Trade Minister Shi Guangsheng, who recently resumed WTO negotiations with the European Union, was traveling with Jiang, but China was not expecting to seal a deal during the visit.

The EU, the United States and Canada are pressing China to open its markets wider before it can join the trade rules-making body.

China broke off WTO talks with the EU and the United States after NATO bombed the Chinese Embassy in Yugoslavia on May 7. Talks with the United States resumed recently.

Alexander Downer began a two-day visit to Thailand on Monday amid a climate of strained relations between the two countries over the handling of the East Timor crisis.

Downer said in a statement he would discuss East Timor with Thai Prime Minister Chuan Leekpai and other government figures before going to Singapore on Wednesday for the East Asian Economic Summit.

Relations between Australia and many Southeast Asian nations came under pressure last month after Canberra took the principal role in organising and leading the multinational intervention force now quelling militia violence in East Timor.

Australian Prime Minister John Howard was accused by Asian leaders of "aggressive" behaviour in trying to assert white, Anglo-Saxon values in the region through his more assertive foreign policy stance.

Indonesia and Malaysia led the attack, but Thai defence officials also criticised the behaviour of Australian troops in the INTERFET force, accusing them of "provocative" behaviour towards pro-Jakarta militiamen and Indonesian

Thailand's Major-General Songkitti Jaggabatara is second in command of INTERFET, which is led by Australian Major-General Peter Cosgrove.

But Downer's statement praised the Thai commitment to the 14-nation force.

"Australia has welcomed the strong commitment made by the Deputy Commander...and members of the significant Thai contingent," he said. At the annual East Asia Eco-



## Judge says Anwar has to answer sodomy charge

**KUALA LUMPUR (Reuters)**  A Malaysian judge on Monday ruled that jailed former finance minister Anwar Ibrahim has a case to answer on a sodomy charge and ordered his landmark trial to continue with the calling of defence witnesses.

Anwar's lawyers told the capital's High Court after the ruling that he would subpoena Prime Minister Mahathir Mohamad to take the stand in the 4-1/2-month trial, which has split Malaysia and exposed a rift in the nation's dominant political party.

'We'll also be calling several ministers as witnesses," lead counsel Christopher Fernando told Reuters after judge Arifin Jaka granted a two-day adjournment for the defence to prepare its case. Anwar's lawyers said the ex-minister would be their first witness when the case resumes on Thursday.

The prosecution closed its case in August and has turned over 22 witnesses to the defence for possible further examination.

Anwar and his adopted brother, Sukma Darmawan, are jointly accused of sodomising the Anwar family's former driver between January and March 1993. They both deny the charge, which carries a maximum punishment of

20 years in jail and whipping. The defence has venemently criticised the charge, amended twice before the trial after the driver said he could not remember exactly when the alleged sexual act took place.

But judge Arifin said he was convinced by the prosecution's case. "Aftermaximum evaluation of all the evidence adduced, I'm satisfied that the prosecution has made up a case beyondreasonabledoubt, and I therefore order both the accused, one and two, to enter their defence on both charges," he said.

Fernando said the defence was "absolutely dumbfounded, flabbergasted" by the ruling "which went beyond our wildest expectations." Anwar, however, said he was

not startled by the decision. "What

## Population is biggest problem

nese President Jiang Zemin vowed on Monday to focus on economic development and open China wider to the outside world, but said his biggest problem was the country's large population.

Jiang was answering written and verbal questions from the London Times newspaper ahead of his visit to Britain this week - the first by a Chinese head of state.

He spoke of more positive relations with the United States since they hit a low over NATO's bombing of the Chinese embassy in Belgrade and said Beijing would enter talks with the Dalai Lama, subject to his acceptance of conditions including Tibet being a permanent part of China.

Jiang said China would ultimately resolve the question of Taiwan by adhering to the policy of "peaceful reunification and one country, two systems" used to secure the return of Hong Kong and Macau.

"We do not undertake to renounce the use of force, but this is by no means directed at our compatriots in Taiwan. It is directed at those foreign forces trying to interfere in China's reunification," he

He signalled that he saw the economic development of communist China in a very long-term way.

"In the past 50 years, since the founding of the People's Republic of China, we have made a lot of achievements," he said.

"But when you divide these achievements by our 1.25 billion population, the figure becomes really small... The biggest problem I'm facing at the moment is the large population of China.

Jiang stressed the importance of China's transition from a planned to a market economy. "China will follow the rules of a market economy," he said.

He said key objectives for next century were to "achieve modernisation by and large" and to become a strong, prosperous, democratic and culturally advanced socialist

"We will continue to focus on economic development, deepen reform, open the country wider to the outside world and develop a socialist market economy...," he said.

Jiang said the NATO attack on the Chinese embassy in Belgrade during the Kosovo war had caused "grave damage" to relations between Beijing and Washington but he had had a "positive and

U.S. President Bill Clinton last month that was very important in improving ties.

He said China had done much to modernise Tibet, saying: "We put in two billion yuan (\$241.6 million) every

He believed many young people in Tibet were more interested in such developments than old causes.

Jiang said China would enter talks with the Dalai Lama on two conditions - his acceptance of Tibet as a permanent part of China and that Taiwan was also part of the country.

Nervous British officials describe Jiang's visit as having "little margin for error" because of the competing priorities of British business interests, the human rights issue and Chinese pride and dignity The tone of his visit, which includes the rare honour of a bedroom at Buckingham Palace, will be set by his first public appearance on Tuesday, when he travels with Queen Elizabeth through central Lon-

Protesters demanding a free Tibet and the release of jailed Chinese dissidents have vowed to hold demonstrations during the visit, which lasts from Monday to Friday.

Britain is the biggest European investor in China and Beijing exports twice as much to Britain as it buys from it.

#### E. Timor leader won't share power

DILI, East Timor (AP) — East Timor's top independence leader on Monday rejected sharing power with the militiamen who devastated the territory after it voted to break away from Indonesia.

A vote by a special Indonesian assembly on whether to accept East Timor's Aug. 30 independence referendum could come as. early as Tuesday, and Indonesian officials predicted the body would ratify secession.

"Most of the factions have expressed support to let East Timor go," said Erna Witoelar, vice chairwoman of a commission charged with drafting a decree acceptable to the People's Consultative Assembly's 700 members.

One key question about East Timor's future has been how proindependence backers will be able to reconcile with the militias.

An Indonesian government task force is holding talks in Dili on the handover of administration to a transitional authority created by the United Nations to steer East Timor to eventual independence.

Peacekeeping head Maj. Gen. Peter Cosgrove has urged the delegation to pressure leaders of the

anti-independence militias to participate in the transitional administration.

But Jose Alexandre "Xanana" Gusmao, who spent seven years in prison or under house arrest in Jakarta for his independence activities before his release last month, said they would not be welcome in East Timor's future government.

Australia, Gusmao said the militiamen would be free to return to East Timor, but he ruled out sharing power with them or granting any amnesty for crimes committed during their rampage.

"Amnesty is only a very empty political act. The real amnesty will be from our people," he said.

Gusmao, who plans to return to his homeland later this week, said he is receiving daily reports that Indonesian troops are killing people in Oecussi, an East Timor enclave surrounded by Indonesian-held West Timor.

"The (multinational) forces plan to go in the first week in November. I think that it is very, very late

to save more lives," Gusmao said. Col. Mark Kelly, chief of staff of the Australian-led peacekeeping

Lawmakers vote this week for a new president and whether to accept East Timor's overwhelming vote for independence - key steps in Indonesia's difficult transition to democracy.

The 700-member People's Consultative Assembly decides Wednesday who will be Indonesia's leader for the next five years, but embattled President B.J. Habibie may not make it that far.

His political future hinges on a parliamentary vote Tuesday on whether to accept a recent "accountability" speech about his administration's successes and failures. If they don't, Habibie's Golkar Party may replace him as its presidential nominee - a last-minute move that could change the vote's

Also Tuesday, the assembly will be asked to accept East Timor's overwhelming Aug. 30 vote for independence, or delay a decision until certain conditions are met.

Lawmakers could demand that Portugal, East Timor's colonial power, remove all claims to the territory from its constitution. They could also demand that international peacekeepers guarantee the safety of all East Timorese, including those who reject independence.

Habibie has urged lawmakers to accept East Timor breaking away. Many Indonesians, however, are furious that an Australian-led peacekeeping force was sent to the province to stop a rampage by antiindependence militants and their Indonesian backers after the vote.

Habibie is one of three candidates for the presidency. Appointed, not elected, he took over 16 months ago when authoritarian President Suharto, his mentor, stepped down after 32 years of iron-fisted rule.

In an emotional speech on Monday, Habibie urged Indonesians to let him stay in office to continue democratic reforms - a plea he has repeated for several days.

"I don't want to say goodbye. I don't want to bid farewell," he told several hundred soldiers and police at a national monument in central Jakarta.

Soon afterward, about 5,000 students demanding the election of Habibie's main rival, opposition leader Megawati Sukarnoputri, filled a major traffic circle with a noisy protest.

"We will be here until Mega becomes president. If she isn't elected, we will start a revolution," said student Zaenal Surrahman, who wore red, the color of Megawati's party.

In a separate demonstration in the city's business district, about 1,000 white-collar workers rejected Habibie's candidacy.

Atathirdsite, 500 soldiers closed Jakarta's main road, pushing about 100 protesters near Atmajaya University down a side street. Last week, fighting between students and security forces went on for hours there. But on Monday it was clear the armed forces were far less

Habibie introduced some basic democratic changes, but his popularity has sunk because of his close ties to Suharto and his inability to end human rights abuses and cor-

He also has been criticized for the East Timor crisis, a banking corruption scandal linked to his inner circle and Indonesia's huge economic problems.

Twice last week, police and soldiers had to fire tear gas and plastic bullets to disperse large, anti-Habibie demonstrations outside parliament and in the city's business district. Dozens of people were hospitalized or arrested.


But protests since Saturday have been peaceful.

In addition to Megawati - daughter of Sukarno, the country's first president - Habibie is expected to face presidential candidate Abdurrahman Wahid, founder of the Muslim-oriented National Awakening Party and leader of Indonesia's largest Islamic group.

Gen. Wiranto, Indonesia's powerful defense chief and army chief, continued to be coy about whether he would accept Habibie's offer to be his vice presidential running mate, saying Monday he would do whatever the people need.

#### Survey cites absence of dominant campaign issue

WASHINGTON (AP) -Americans say the issues they most want to hear discussed during the 2000 presidential campaign are health insurance, the proper use of U.S. troops and the future of Social Security and Medicare, a new poll said Monday.

The absence of one dominant issue gives the personal qualities of the candidates increased importance in the 2000 presidential campaign, the poll suggests.

That appears to have hampered Al Gore in head-to-head matchups with GOP front-runner George W. Bush, who had been running 11 to 15 points ahead of the vice president. Gore narrowed that gap to 7 points, 51-44, in the poll by the Pew Research Center for the People & the Press.

The vice president benefits from increased support from women: 50 percent of women would vote for Gore today compared to 40 percent in September, while 45 percent of women in this poll said they back Bush. Support for Gore remains unchanged among men at 37 percent.

A majority in the poll, 56 percent, said they're very interested in hearing about whether U.S. troops should be sent into countries to stop the killing of innocent civilians in a civil war. Those most likely to want to hear more about those issues were men and those with some college

Half said their top priority for campaign discussion was keeping Medicare financially sound, and almost that many, 46 percent, said they wanted to hear discussion of investing Social Security funds in the stock market.

Those most likely to want to hear about Medicare were women, those with a high school education or less, and those who make less than \$30,000 a year and not surprisingly, older Americans.

While the poll "does show a little progress for Gore, there's still a lot of uncertainty here," said Kohut, noting the election was more than a year away. "We will see a lot of ups and downs. People don't have a lot of conviction about this."

#### Clinton not offended by Gore's moves

WASHINGTON (AP) — President Clinton said today he is not offended that Vice President Al Gore doesn't want his help in seeking to win the White House. "No one can help anyone else in a campaign beyond a certain point," Clinton said.

The president told reporters he agrees with Gore, who told The Washington Post last week that his bid for the Democratic nomination is a "very personal quest" and that he might ask Clinton not to help his campaign.

"I think that's a decision he ought to make at an appropriate time," Clinton said following a meeting with his economic advisers. "I agree with what he said about it. It won't matter who said it as much as it matters what is said. I just want the American people to make this judgment



based on what's best for them.' Gore said while he has not decided whether he would turn down Clinton's help, "I may do that."

Clinton said that is fine. "The candidates will be the major players. Everybody else, to a greater or lesser degree, is in a subordinate role," he said.

## Ray formally replaces Starr

WASHINGTON (AP) — Career prosecutor Robert Ray was sworn in today to replace Independent Counsel Kenneth Starr and wrap up the wideranging investigation of President Clinton and the first lady. One of the appointing judges pleaded with him to act with "deliberate speed."

Ray appeared on the federal courthouse shortly after taking the oath as independent counsel, vowing to finish the five-year, \$40 million-plus investigation in a "prompt, responsible and cost-effective manner."

The new special prosecutor thanked Starr for his personal sacrifice and said his office would carry on the investigation with the same professionalism. "We should do our best to be thorough and fair," Ray

Starr, who is returning to private law practice, oversaw an investigation that prompted Clinton's impeachment but which lost much public support in the face of incessant criticism from presidential supporters.

One member of the threejudge panel that appointed Ray hinted at the public fatigue. calling for a speedy conclu-

"There can be no more vital consideration now than closure with all deliberate speed. Senior Circuit Judge Richard Cudahy wrote. "Our selection of Robert Ray carries much

The two other judges made no reference to a speedy wrapup in their order.

Ray must decide whether to bring additional prosecutions and must write a final report on the wide-ranging investigation that has delved into fraudulent land deals in Arkansas and alleged presidential perjury and obstruction in the Monica Lewinsky scandal.

The contents of a final report - which will deal in part with a fraudulent Arkansas land deal for which Mrs. Clinton performed some legal work -could cause political problems for the first lady if she decides to run for the U.S. Senate from New York.

The special prosecutor's office has pending investigations into two matters:

-An alleged attempt by Maryland developer Nathan Landow and Democratic Party supporter to influence the testimony of presidential accuser Kathleen Willey.



Starr's investigation of the Lewinsky scandal, the president's affair and subsequent cover-up, led to the first presidential impeachment since 1868.

On Friday, the Clinton White House suggested Ray is a politically motivated prosecutor, noting that before going to Starr's office, he spent several years working for Independent Counsel Donald Smaltz in the investigation of former Agriculture Secretary Mike Espy.

Ray's family disputed the White House suggestion over

"Bob believes strongly in public service, he believes that people should be held accountable, but he is not politically motivated in his job; that's simply not true," said Ray's father, a retired Army colonel who served two tours of duty in the Vietnam War.

Until January 1998, Ray was a registered Democrat in New York City. Ray ran twice for the school board in New York City in non-partisan elections, losing both times. He now is a registered voter in New Jersey unaffiliated with any political party.

Ray in recent years made four donations totaling \$90 in support of Republicans - three to then-Sen. Alfonse D'Amato and one to the Republican National Committee.

While at Princeton University in 1982, young Ray chose the Kennedy administration's Peace Corps as the topic for his senior history thesis. offering extensive praise for the late president.

## Clinton axes foreign aid bill

WASHINGTON (AP) - President Clinton today vetoed a \$12.6 billion foreign aid bill as inadequate and called on Republican congressional leaders to join the administration in seeking a solution to the budget impasse.

"We need to sit down and do it together," the president told reporters in the Cabinet Room. He said he would sign another emergency spending measure to keep the government running beyond Thursday, but that it should be a short-term measure.

"We have to put politics aside and seek common ground," Clinton said.

"We're going to have to make tough choices and we're going to have to make them together," Clinton said. "Inaction is not an option."

The president said Republicans were shortchanging spending needs on education, the environment and foreign policy affairs, including U.S. obligations under the Wye River Mideast peace ac-

White House spokesman Joe Lockhart said Clinton will refuse to sign other spending bills passed by Republicans, but instead has invited congressional leaders to a White House meeting Tuesday.

"If the congressional leadership will join me," the president said, "we can make this a season of real progress for our people."

Republican leaders said they would attend the session, but they emphasized they would not consider using Social Security surpluses to help pay for spending

"We will not agree to a summit that would try to find secret ways to spend the Social Security surplus," House Speaker Dennis Hastert, R-Ill, said in a statement.


The foreign aid bill passed over loud opposition from Democrats and the White House, who claim it shortchanges important American foreign policy interests.

"It doesn't meet the president's priorities," Lockhart said. "Wye River is certainly an important element to that, and it is an important part of continuing to exercise U.S. leadership around the world. We can't expect nations in troubled parts of the world, like the Middle East, to move forward with their peace process when we won't meet the commitments we've made."

Lockhart said a veto of the defense spending bill may be on the way. "That is under consideration," he said.

"The bill is beyond what the president requested, and there are also a number of gimmicks in it. They make operations and maintenance an emergency. The Pentagon is a pretty big building, but I don't know if you can go over there ... and find one person who considers the operations and maintenance of armed forces an emergency," Lockhart said.

Clinton's foreign aid veto, the 28th of his presidency, will likely stand. The bill only narrowly cleared the House with a vote of 214-211, and the Senate with a

vote of 51-49. A two-thirds vote in both houses is needed to override a presidential veto.

House Speaker Dennis Hastert, in a statement prepared in anticipation of Clinton's veto, said that

the extra money Clinton wants can only be obtained by raiding the Social Security trust fund. He

"Congress will not use Social Security as a pot of gold to fund foreign aid," Hastert said.

Rep. Sonny Callahan, chairman of the House Foreign Operations subcommittee, said Republicans Congress have sent a consistent message that "we will not raid Social Security, nor will we agree to raise taxes, to pay for increased foreign aid spending.'

As passed by Congress, the aid bill provides \$2 billion less than Clinton sought and none of the \$500 million down payment he had sought to help Israel and the Palestinians carry out the peace accord negotiated last year at Wye River, Md. In all, Clinton has pledged \$1.8 billion in U.S. support for the Mideast peace effort.

The bill also provides significantly less money than Clinton requested for international debt relief, the Peace Corps and for efforts to reduce the nuclear threat from North Korea and other coun-

## Helms may block Moseley-Braun

WASHINGTON (AP) — Sen. Jesse Helms, whose opposition has sunk both treaties and nominations, took aim Monday at former colleague Carol Moselev-Braun's bid to be ambassador to New Zealand.

An Illinois Democrat who was the nation's first black female senator, Moseley-Braun comes to the Senate for confirmation under "an ethical cloud," asserted Helms, R-N.C., chairman of the Foreign Relations Committee.

Helms clashed with Moseley-Braun during her one term in Congress, most memorably on the Senate floor over use of the Confederate Flag. She later accused Helms of taunting her in an elevator by singing "Dixie."

The conservative, combative committee chairman suggested his panel would scrutinize allegations raised in Moseley-Braun's 1998 re-election campaign, including never-proved ones that she used 1993 campaign funds to pay for personal luxuries.

Democrats suggested Helms was giving Moseley-Braun a hard time to settle an old score.



"I hope he won't do that," President Clinton told reporters.

Clinton called it yet another sign of "a new isolationism in this country, that we don't really care whether we have ambassadors in some of these places."

The president made similar "isolationism" accusations last week when the Senate turned down a nuclear test ban treaty that he had championed. That Senate action drew condemnation from around the world.

Helms was a leading foe of the test ban treaty and contributed to



its defeat by refusing to hold hearings for two years. He also torpedoed the 1997 nomination of former Massachusetts Gov. William Weld to be ambassador to Mexico by refusing to hold hear-

This time, Helms announced in a statement that he would hold hearings on Moseley-Braun to "examine serious charges of ethical misconduct in her past."

"Charges of ethical lapses led the voters of Illinois to determine she was not fit to represent them in the U.S. Senate," Helms said.

"If it turns out in the course of those hearings that all these reports are false, the committee will

#### Census mulls poverty formula

NEW YORK, (Reuters) - The U.S. Census Bureau has begun to revise its definition of what constitutes poverty, and is looking at a formula that would drop millions more families below the poverty line, the New York Times reported on Monday.

The new approach would raise the income threshold for living above poverty to \$19,500 for a family of four from \$16,600, the paper said.

Such a change would mean that 46 million Americans, or 17 percent of the population, would be officially below the poverty line, not the 12.7 percent announced last month, which was the lowest

level of the decade, the Times said Sociologists and economists who study what people must earn to escape poverty in the United States put the line even higher than what the Census Bureau is considering, the Times said.

They put the threshold for a family of four at between \$21,000 and \$28,000, partly because the bureau's figures do not allow for extra cash for emergencies, such as fixing a car, the paper said.

A higher threshold would mean that government spending for benefits for the poor, such as food stamps and Head Start programmes, would have to rise, the paper said.

#### Russian forces said to have hit civilians

MOSCOW (AP) — Russian bombs and artillery are indiscriminately wiping out peaceful Chechen villages, killing hundreds of civilians and stoking fury against Moscow, human rights activists said Monday.

Russian officials have denied killing civilians, saying the attacks are aimed solely at Islamic militants who twice invaded the neighboring republic of Dagestan this summer and who are blamed for apartment bombings in Russia that killed 300 people.

But several Chechen villages that appear to have no connection with the militants have been bombed by Russia, and scores of civilians reportedly have been killed.

"Our military has never said what it considers a rebel base," said Andrei Mironov, a member of the respected human rights group Memorial, who traveled to Chechnyaearlier this month. "This vague term can cover just about anything.

Russian forces were badly defeated in a 1994-96 war in the republic, eventually withdrawing and giving Chechnya de facto independence. But Russian military commanders think their chances are better this time.

Unlike the previous war, when most Chechens fiercely opposed Russian troops, military officials claim they are welcomed by ordinary Chechens weary of lawless-

But Mironov said the indiscriminate Russian strikes were threatening any support and creating "a real natred (of Russians)" that could lead to a violent backlash. "People feel certain that they

are being killed, eliminated," he said. "This war will inevitably be even bloodier than the previous

In Elistanzhi, a village in the mountains near Chechnya's southern border, Russian jets staged a surprise bombing raid during midday Muslim prayers on Oct. 7, leaving dozens killed and injured.

Villagers denied there were militants in Elistanzhi. Mironov said he also found no evidence of rebel activity and accused the Russian military of attacking peaceful villages to keep them from sheltering militants.

"It is certainly easier for the Russian military to advance in Chechnya if militants have no place to stop and rest. This way, any village can be considered a terrorist base," he said. "And this is the only way the bombing of Elistanzhi can be explained."

The 20 injured from Elistanzhi, 30 miles southeast of Grozny, included only one adult man, while the rest were children and women, Mironov said.

Chechen officials said a Russian tank fired on a bus carrying refugees on Oct. 5, killing 41 people. Video footage showed rescue workers removing bloodied bodies from the bus, while children and old men sat dazed, with blood covering their faces.

Russian officials from Prime Minister Vladimir Putin to the military s top commanders have denied attacking civilians.

Russia's Col. Gen. Vladimir Kulakov said Monday that "not a single Russian plane, not a single rocket launcher, not a single gun is firing on residential areas," the ITAR-Tass news agency reported. "All statements that Russian troops are killing the civilian population are lies," he said.

Russia's top military commander in Chechnya, Col. Gen. Viktor Kazantsev, said Chechens were bombing their own villages, according to ITAR-Tass.

Chechen officials say hundreds of civilians have been killed in the conflict. Moscow confirms the number of casualties but says they were all rebels.

"One can dispute the actual number (of casualties) ... but one can state that the majority of the victims are civilians," said another Memorial member, Alexander Cherkasov.

Russian troops are stationed along Chechnya's borders in the east and west, and control the northern third of the republic, above the Terek River. The forces shelled several Chechen positions overnight, but the fighting eased later Monday.

Russian troops are located along a mountain ridge north of Grozny about 10 miles from the city. So far, they have not advanced on the capital, but the militants were building concrete fortifications and digging trenches to rebuff a possible assault.

Russian and Chechen forces clashed Monday at two villages along the Terek River, killing one Chechen and injuring two, Chechen commander Isa Munavey told the Interfax news

The fighting has forced more than 150,000 Chechens to flee to the neighboring republic of Ingushetia.

In Moscow, President Boris Yeltsin, who is still recovering from a bout of flu, met with Putin on Monday to review the military operation and efforts to accommodate the refugees. Moscow has been criticized for being slow to

The guerrillas seized 13 hostages in August after invading the former Soviet republic of Kyrgyzstan from neighboring Tajikistan. Their aims have been vague, although Kyrgyz officials said they want to carve out an Islamic state on territories now belonging to three Central Asian nations, Kyrgyzstan, Tajikistan and Uzbekistan.

## Russia fears new arms race

MOSCOW (AP) — Russia is warning that the world could be pushed into a new nuclear arms race because the United States wants to change a key agreement that has helped control nuclear weapons for the past 25 years.

The U.S. proposal has alarmed and outraged Russian political and military leaders, who claim that Washington wants to acquire nuclear invincibility at a time when Russia's nuclear forces are in shambles. Moscow may have to build new atomic weapons to counter what it sees as a major threat, they say.

If Washington persists with its proposal, Russian officials say, it could endanger the whole framework of nuclear agreements on limiting or scrapping nuclear weapons that took decades to con-

"All agreements that have been

At the heart of the Russian fears

amend the ABM treaty so that denouncing both countries can defend themselves against nuclear attacks by rogue nations such as North Korea. It has tried to allay Moscow's fears by offering to help build a Russian defense system - a proposal Moscow has yet to respond

> Moscow says the United States is exaggerating the threat from minor nuclear states. Instead, Russian officials fear, Washington wants to develop an ABM defense that could defeat a major missile attack. This would make Moscow's nuclear arsenal useless and leave Russia vulnerable because it does not have the resources to build a defense system

Russian may be forced to abandon arm control pacts to ensure their nuclear forces remain effective, officials say. One option is rebuilding multi-warhead landbased ballistic missiles, which have been banned by arms control deals.

## Israeli spy admits to passing secrets to KGB

JERUSALEM (AP) — An immigrant from the former Soviet Union who worked as a technician at an Israeli air force base pleaded guilty Monday to passing military secrets to the KGB.

Aspart of a plea bargain, Valery Kaminsky, 54, pleaded guilty in exchange for a six-year prison term, said Justice Ministry spokesman Ido Baum. Convictions in such cases often bring 20vear sentences.

Prosecutors said the KGB recruited Kaminsky in 1975 in Riga, Latvia, and taught him how to encode and transmit information. Kaminsky spied on the Jewish

#### Israel gives Mandela hero's welcome

JERUSALEM (AP) — Hectoring his Israeli hosts in mild tones for their past alliances, Nelson Mandela elicited nothing darker than smiles and cheers Monday from statesmen and schoolchildren alike during his first visit to Israel.

The former South African president's trip brought a belated end to the enmity between the Jewish state and the movement Mandela headed for decades from a jail cell.

While Israel provided the apartheid regime with arms and training, Mandela's African National Congress forged alliances with the Arab radicals Israel once regarded as mortal enemies.

"Israel worked very closely with the apartheid regime," Mandela reminded President Ezer Weizman.

But he was quick to add that he was in Israel on a mission of reconciliation.

"I say Israel cooperated with apartheid but they did not get involved in the atrocities," he said. On a day when starstruck poli-

ticians and schoolchildren jostled for photo opportunities, the 81year-old Mandela chided his hosts for taking so long to ask him over. Imprisoned for 27 years under the former apartheid government, Mandela was released in 1990.

"I took so long to come here firstly because when I came out of prison I was invited by almost every country in the world except Israel." he said.

Earlier Monday, Israeli Foreign Ministry spokesman Aviv Shiron said previous attempts to bring Mandela to Israel while he was in office failed because of technical

The hard-line Israeli government at the time wanted little to do with Mandela, wary of his alliances with Palestinian leader Yasser Arafat and Libyan leader Moammar Gadhafi.

Israel's reconciliation with the Palestinians, launched with the Oslopeace deal in 1993, and South Africa's emergence from apartheid softened the relationship.

On Monday, such considerations seemed distant.

"I like President Mandela very much," Weizman said. In a statement, Prime Minister Ehud Barak called his guest "deeply coura-

Mandela returned the compliment, congratulating him for reviving the peace process since assuming office in July.

"This is a man who has aroused our hopes that somebody is going to guide people in this region to make peace," Mandela said.

Mandela left office this summer, but continues to dabble in affairs of state. Before coming to Israel he traveled to Syria, technically at war with Israel.

"Syria is your neighbor ... They are seeking a peaceful resolution." he told the Israelis. Mandela also has met with Iran's leadership, and said he was "convinced" Israel's most implacable foe wants

Mandela brought his easy charm to the street, stopping at every crowd of stunned tourists, suddenly aware they were sharing pavement with a 20th century icon.

Mandela refused to be rushed while touring Yad Vashem, Israel's Holocaust memorial, pausing to read the caption of each exhibit.

He was especially captivated by the rare efforts at rescue during 1939-45, when Nazis and their allies murdered 6 million Jews in Nazi-occupied Europe. "They tried," he said emphatically of attempts to save Jews.

He emerged from the dark museum into a brilliant Jerusalem day, and encountered a group of schoolgirls from northern Israel touring the memorial. He called out to them, "Where are you from!"

The Israeli teens turned and stood awestruck for a moment. and then erupted into cheers.

"This memorial is very important to prick our conscience and to know to what extent humanity can sink," he told them. "Because the greatest matter is to improve yourself - not so much others, but to improve yourself."





At the same time, Cabrera made a pitch on the CNMI's low tobacco sales violation rate.

While the CNMI targets violation rate to go down to 20 percent until Year 2004, it has already seen a rate within the 20 percentile range.

"We are two to three years ahead of what were scheduled in our compliance rate. Currently we are targeted to decrease the tobacco violation rate of 20 percent in year 2004. But it's only 1999 and we are already in the 20 percentile range. The CNMI has been doing a lot in addressing problems of tobacco sales to minors," said Cabrera.

With the passage of Public Law 11-75 in March, the CNMI government now has more power to enforce tobacco sale regulations and impose sanctions.

Cabrera said DMHSS, which is under the Department of Public Health, together with the Department of Commerce and other government agencies can now hold tobaccosting operations on a quarterly basis as opposed to previous years when this can only be done once a year.

Moreover, the government was able to inspect more than 50 percent of the establishments on DOC's lists of licensed businesses. The government could only inspect 15 percent of the firms on DOC's list in the past.

"We have progressed much in addressing the problem of selling tobacco products to minors. We have a more comprehensive law which is not even true to other states. In most cases, certain states

Military beers can also be distinguished through the dates in their labels. Salas said distributors are bringing in beers that have August and September dates, while military beers have October and November dates in their labels.




