The Legislative Assembly meets on the 29th of April.

The receipts of sugar for the past week amounted to 15,856 pkgs.

The Iwalani leaves for Maalaea, Kona and Kau this afternoon at 4 o'clock.

A meeting of the Honolulu Athletic Association will be held at the Lyceum this evening at 7:30.

During the late election no less than 51,750 ballots were printed at the DAILY BULLETIN Printing Office.

The regular monthly meeting of the Protection Hook & Ladder Co. No. 1 will be held this evening at 7 1-2 o'clock.

The Reformatory School buildings are undergoing a general overhauling, being thoroughly renovated and painted.

About 100 pkgs of sugar were damaged while transferring it from the Waimanalo to the Mokolihi last Saturday night.

The schr Claus Spreckels was at Kahului last Saturday, loading for San Francisco. She would sail about the 7th inst.

The schr Julia sails for the island of Peru next Wednesday. She takes down between 60 and 70 South Sea Islanders, whose contract term have expired.

The C. R. Bishop for Nawiliwili, Koloa, Eleele, and Waimea, this day at 5 P.M.

The schr Luka was at Ookala last Wednesday, discharging her up freight; if the fine weather continued, she would have a full return load.

Charters have been granted to the "Hilo and Hamakua Telephone and Telegraph Company"; and the "Young Men's Christian Association" of Honolulu.

The tract of land, Maawaa, at Puna, Hawaii, containing 55 1-2 acres, was sold at auction last Saturday. It was knocked down to Mr. F. M. Hatch for \$50.

A mail for the Marshall and Gilbert Islands will be forwarded by the schr Julia on Wednesday the 8th inst. All letters and packages may be left at the office of the Hawaiian Board, in the Sailors' Home building.

The stmr Waimanalo went ashore on the east side of the spar buoy while entering the harbor last Saturday evening. The stmr Mokolihi went to her assistance and took off part of her cargo of sugar which lightened her sufficiently to enable her to float, and towed her into port.

The Kilauea Hou leaves to-morrow.
The receipts of sugar this morning amount to 2,167 pkgs.

The W. H. Diamond leaves for San Francisco to-morrow.

The Likelike will not leave for Windward ports until Thursday of this week.

The Kilauea Hou towed the schr Ida Schauer down from Kahului last Saturday.
