MRS. JAMES KULA TO BE PRINCESS

Mrs. Lipi Keoloha Kula, of Koloa, will be the Kauai Princess in the Floral Parade at Honolulu.

This was definitely decided at a meeting of the special committee of the Chamber of Commerce, on Floral Parade matters, held in the office of President H. Rohrig last Friday morning.

Mrs. Kula is a full Hawaiian, young woman and is the wife of the well known garage man of Koloa. She is a rider of skill and grace, and will undoubtedly be a striking figure in the parade.

At the meeting there were present with Mr. Rohrig: Rev. J. M. Lydgate, E. E. Mahlum, J. H. Coney and Mr. Hale, the scenic artist who has been engaged to paint the Spouting Horn for the Kauai float.

Mr. Hale displayed a pretty water color sketch of the Spouting Horn, from which the large painting will be made. Everyone present was highly pleased with the sketch.

It was decided to have 2,000 "promotion" pamphlets printed, to be made up into the shape of fish. These will presumably be caught from the water pooled at the base of the Spouting Horn and will be thrown out into the crowds along the streets as the float passes by. Each of the fish pamphlets will be bound around with a string of small Niihau shells, to give the package weight in throwing. It was also decided to order a large number of leis for elaborating decorations on the float.

An effort will be made to secure a horse from Francis Gav for a ula to ride.

Next matter taken up by committee was that of the promotion of Mr. Baker, with his views, taken over here some time ago. It was decided to have Mr. Baker come over next week and display the views one night each in Lihue, Koloa and Waimea. He has a new machine for the purpose. The Chamber of Commerce makes a guaranty of a sufficient amount to cover expenses, so that an admission fee will be charged.

Secretary Desha Writes

In a personal letter, dated January 12, to the editor of THE GARDEN ISLAND, John R. Desha, secretary to Delegate Kuhio, at Washington, included the following remarks of local interest:

"The Nawiliwili harbor bill is with the Rivers and Harbors Committee, and undoubtedly will receive attention soon. In the case of the Lihue Electric Light bill, the committee on Territories cannot act at present, as the Alaska Railroad bill has the attention of the committee. Perhaps in a month or so, when it is expected that the Alaska bill will be out of the way, the electric light matter will be taken up."

Robert W. Shingle, president of The Henry Waterhouse Trust Company, came up on the last Kinau to spend a few days with his old friend, Charles A. Rice. He returned home by the same steamer, sailing Saturday afternoon.

While here, Mr. Shingle was on the "go" most of the time, Wednesday was given over to a hunting trip over Koloa way, resulting in a bunch of pheasants. (It was rumored that Shingle and Rice sat under a lauhala tree and talked politics, while a native boy killed the pheasants; but the boy could not be located to confirm the report.)

On Thursday the two gentlemen left for Makaweli, calling upon Manager B. D. Baldwin and other prominent men over on that side. Friday was spent around Kealia and Kapaa, the host that day being Mr. Gaylord P. Wilcox. On Saturday a trip was made to Kilauea, where the hospitable home of Mr. J. R. Myers was thrown open to the visitors. The return to Lihue was made in time to catch the steamer for Honolulu.

Mr. Shingle is chairman of the Republican Territorial Committee and Mr. Rice is Republican National Committeeman for Hawaii. Naturally, that throws an element of doubt on the lauhala tree story.

FOOTBALL GAME RESULTS IN TIE

The football contest Sunday afternoon between the Makaweli and All American teams on the Lihue grounds was probably the hardest fought battle of the season. Both sides went into the game in a weakened condition. Makaweli was minus several good players, and had to play substitutes; while the All Americans were short in the same way and had to add the same number of men to make up their team. This knowledge of weakness, however, as sometimes happens, caused the men to play with unusual determination, so that there was real ginger in every part of the game.

RICHARDSON HURT

In the first period Richardson, of the Makawelis, and Hill of the home team collided, and the former was laid out by a nasty cut across the shin, inflicted by Hill's shoe. The accident was unavoidable, as could be plainly seen; and no one manifested more regret for it than Mr. Hill himself. Dr. Putman hastily dressed the wound and the injured man was removed beyond the side-lines in order that the game might proceed.

THE GAME

With the loss of Richardson, the Makaweli team was so weakened that defeat seemed easily possible. It was then that the soccer spirit of the visitors showed itself. Every man from the smallest up to big Hayselden fought like a tiger for points of vantage. Joe Fassoth, although with one hand still tied up as a result of his recent injury, never played with more determination, while Murdoch and others of the team gave the homers all they could handle. In one side kick the Makawelis struck the post and only missed a goal by the ball bounding the wrong way.

Undoubtedly the All Americans played the heaviest game they have yet put on. An unusual amount of head work was displayed, while the speed was excellent. When the game ended, honors were exactly even, and the ball was almost on the spot from which it originally started.

NOMINATIONS TO CONVENTION

Meetings were held in the various precincts of the island last night for the purpose of nominating candidates to be voted upon next Saturday evening for election to a convention to be held in Honolulu on the 24th, inst. for the purpose of revising the Rules and Regulations of the R. publican party.

The Lihue meeting was held in the court house, and nominations were held open between the hours of 7 and 8 o'clock. H. D. Wishard presided and A. G. Kaulukou officiated as secretary. The latter stated the objects of the meeting, and read the official call.

Nominations were then called for, and C. H. Rice presented the following names: H. D. Wishard, J. H. Coney and W. H. Rice Jr. No other nominations being forthcoming, these men will undoubtedly receive their credentials, as the precinct is entitled to just three delegates.

Mr. C. A. Rice produced and distributed copies of the proposed new rules, in both English and Hawaiian; and discussion thereon was had at considerable length. Numerous questions were asked, and were answered, for the most part, by Mr. Rice.

As was to be expected, a question mark was introduced after the provision that one-fourth of county collections should go to the Central Committee, and attention was also directed to the provision that 75 per cent of the Central Committees collections should be paid over to the counties, unless specifically prescribed by the donor that any particular subscription be paid to some designated county committee. Ideas as to how this complex system would work out seemed to be hazy.

Mr. Wishard wondered if the rules were not a sort of cut-and-dried proposition anyway, and the work of the convention be largely matter of form.

Mr. C. H. Rice replied that just the opposite would likely be the case. He knew of one thing that was sure to bring on a "scrap", and that was in regard to the Central Committee's position in the primaries. He knew of one very prominent Republican leader at Honolulu (whose name he mentioned) who intended to fight for the actual domination of the primaries by the Central Committee. Personally, he was opposed to any such thing, and believed a majority felt as he did, but

A. Hanneberg, auditor for Hackfeld & Company, arrived per the W. G. Hall for the purpose of going over the accounts and annual statements of Lihue, Koloa and Kekaha plantations and stores. Lihue was prepared for the visit, but delays elsewhere on the island may keep Mr. Hanneberg over here for ten days or more.

MR. BRIDGEWATER TO FACE CHARGES

E. B. Bridgewater, who returned to Honolulu by the Kinau Saturday night, was arrested upon the arrival of the steamer there Sunday morning on a charge of gross cheat. On Monday he was released on bail in the sum of \$100.00, the case being set over to a future date. The Honolulu Star-Bulletin, yesterday afternoon, had the following to say of the matter:

"E. B. Bridgewater, publisher of the defunct 'Sentinel,' arrested Sunday on a charge of gross cheat based upon his representations while publishing the paper, was released from the jail this morning on bail, a cash bail set at \$100 and furnished by Harry Gregson.

"The prosecution of the charge against him is to be made on a warrant sworn to by H. S. Canario, a street car conductor, who competed for a prize in the contest undertaken by Bridgewater for subscriptions to his weekly paper. Canario maintains that he was entitled to a motorcycle because of his success in the contest. He says that Bridgewater gave him a motorcycle. It is here that the charge of gross cheat enters. The conductor says that not long after the motor was returned to him, it was taken away from him by the real owners, who proved to him that Bridgewater had never had title to it, but had only been allowed to use it for a test ride.

"Prosecuting officers say there is a possibility of other charges, falling under the head of gross cheat also, being made against the editor. So far Bridgewater only has one warrant against him."

Mr. Bridgewater had been over here for a week or ten days, spending most of his time around Hanalei and Lihue. He was aware of the charges (it being reported that others will follow the one made by Canario) being worked up against him at Honolulu, but expressed confidence that he would be able to explain matters to the satisfaction of everyone.

Before leaving for Honolulu, Mr. Bridgewater, at the request of THE GARDEN ISLAND, wrote out the following statement of his case as he then understood it, for the information of his friends on Kauai:

"Concerning that which the Honolulu press has had considerable to say relative to my business affairs in Honolulu, I will state that unforeseen circumstances which included non-receipt of sufficient subscription money with which to pay for prizes offered in the cause of my present difficulties. There has been not the least intent nor attempt to defraud anyone and I am returning to Honolulu this afternoon where I intend to face the charges whatever they may be. At all events, every paid-up subscriber will receive his dollar back. This will probably take sometime, but those who know me, must also know that though I've failed to make good in this instance, I am equal to the occasion. Being down and out doesn't mean "pan" by a jug full. I have a position offered me, and as soon as I get this matter off my hands will accept it and hope soon to catch up again."

The Chamber of Commerce

Is it not easily possible that the Kauai Chamber of Commerce has failed to gain ground as rapidly as it might on account of the infrequency of its sessions? To keep up enthusiasm in, and promote the effectiveness of, such bodies as Chambers of Commerce and Merchants' Associations, it has been found necessary, in other communities, to maintain a degree of activity constantly. This cannot be left entirely to committees; for the secret of success of the organization lies in a steady glow of enthusiasm throughout the entire membership. And that interest can only be attained, in a desirable ratio, by the frequent touching of shoulders, as it were, by and of the members themselves.

There are no two ways about this. At first an organization of the character of the Chamber of Commerce may start out with a big whoop, a brass band and a big and enthusiastic membership roll. Everybody predicts a brilliant future for it. But when it begins on a program of "occasional" meetings, leaving such routine as may come up to the judgment of committees (however good those committees)—it right then and there transfers its sun from the brilliant orient sky to the western horizon. Unconsciously, imperceptibly, the work and value of the organization will lessen under such circumstances, until finally its influence and effectiveness in the community are nil.

Let the Chamber of Commerce hold its regular sessions as now provided for in its rules, in Lihue. In the meanwhile, let it be known that invitations for intermediate meetings, once each odd month (to take partly the nature of "social sessions"), will be in order from Waiimea, Koloa, Hanalei, Kapaa, Elele and other places, the dates of such outside sessions to be fixed by the executive committee. A program for monthly meetings for a whole year in advance might easily be made in this way.

The effect of this arrangement would be to bring the Chamber of Commerce directly to the attention of the people residing in the different communities of Kauai, and to distribute enthusiasm in regard to it all over. And as enthusiasm begets enthusiasm, and rebounds and enthralls the enthralled, the effect upon the original members of the Chamber would be all to the good. On the other hand, unless something of that sort is done (however distasteful the idea may be), history will repeat itself for the millionth time in similar cases, and the organization will eventually (although may be not soon) literally go to seed.

Mr. Wm. G. Irwin

ALTHOUGH not a resident of Hawaii for some years, Wm. G. Irwin, who died in San Francisco last Wednesday had the right, by virtue of interests here, to be still considered an Island man. Some of his best friends are in the group—not a few being here on Kauai. By those who knew him best, the death of Mr. Irwin will be sincerely regretted.

In business, Mr. Irwin was a pupil of the late Claus Spreckels, and was probably one of the best friends the Sugar King ever had. He began his career in Honolulu as desk clerk on a small salary, from which he advanced rapidly to position after position of responsibility. Mr. Spreckels said many years ago that he intended to make a millionaire of W. G. Irwin; and his influence probably had much to do with bringing that state of affairs about.

Mr. Irwin developed into a business man of considerable foresight, but, most of all, possessed in a marked degree that faculty of accumulating wealth to be noted in financial leaders of the world at this day. His bull-dog tenacity in business elicited the admiration of friends and caused no little worry, betimes, to his competitors.

Room Badly Needed.

A most unfortunate state of affairs, in the matter of room, exists in the school house at Koloa. The school there long ago outgrew its home, and for quite a time the rooms have been too small for the comfort of the classes. Matters now, however, are even worse; for the rooms are no longer able to hold the crowds of children, and a class is bunched on the outside. During the wet, cold spell through which the island has just passed, conditions in the school were exceedingly bad, and another such weather visitation is apprehended by the teachers with dread.

It would probably not cost a large sum to supply housing facilities adequate to requirements for some time to come. Of course, everybody knows that the Supervisors are hard pressed for the wherewithal to meet necessary expenses for the present, but it is to be hoped that enough may be spared to meet this small but pressing requirement.

Very Poor Economy

TERRITORIAL Treasurer Conkling has announced his intention of "economizing" by slashing off from \$250,000 to \$600,000 of the money appropriated for carrying on the work of the departments. As seems to be a sort of habit in the Islands, he starts out by proposing a big cut in the appropriation for public schools. This is just the opposite to what should be done. The schools (particularly those in the country districts) are now down to bone and marrow, and to submit them to a policy of further economy would be extremely unfortunate. It is to be hoped that in dealing with this matter, a number of other things may be considered before the public schools are placed in the way of the economy axe.

The Kaiser's Birthday

GERMANS the world over foregathered, at one hour or another, last Tuesday in honor of the fifty-fifth anniversary of their Emperor. The present ruler of the German Empire, although a less strenuous character than in his earlier life, is really a more important and conspicuous world figure today than ever before. He has "ripened," so to speak, with his years; and with his sound judgment, and the wisdom of his policies, must be credited much of the prosperity and progress of the Fatherland in the past decade. Not the Germans alone, but this is one instance in which the whole world joins in the sentiment: "Long live the Emperor!"

Helping Hand Needed

MR. DESHA, secretary to Delegate Kuhio, states elsewhere in this issue that the Nawiliwili harbor matter will be considered by the Committee in Congress in "a month or so." This does not mean that the item will be recommended. In the meanwhile, Delegate Kuhio is speeding to San Francisco and it is to be hoped that he will be in Washington in time to appear before the Committee, and succeed in landing the appropriation. Without all the pressure that can be brought to bear from Hawaii, the item is likely to again fail and Kauai be minus an harbor for a long time.

THE selection of Mrs. Lipi Keoloha Kula, of Koloa to be the Kauai princess in the coming Floral Parade at Honolulu will meet with general satisfaction. It seemed to be the island's desire that the princess this time be a native Hawaiian, and it is doubtful that a more graceful rider could have been selected than the lady who has been chosen by the committee. It now seems that Koloa is to supply both the princess and the basic feature of Kauai's float, which may well cause the old town to throw her chest out.

THE rate of \$8.00 fixed by the Inter Island S. N. Company for the round trip to Honolulu during the Carnival is quite satisfactory; but it is extremely doubtful that sufficient passenger accommodations have been provided. An unusually large number of Kauai people had already planned to go to Honolulu, before the low rate of fare had been taken into consideration, and now that the expense of the trip is to be so light, the number of those going over will be greatly increased. It is to be hoped that the Steamship Company has carefully figured out this matter, and that the low rate of fare may not be offset by the discomforts of overcrowding.

BASS ("Dutch Standard" Bass, as he calls himself) is flooding the plantation offices of the Islands with literature on the sugar situation, much of it bordering closely on what may be termed an effort at blackmail. The idea of Bass seems to be to induce the planters of Hawaii to jangle up for his campaign at Washington; but if the man has no more brains than are manifested in his circular letters, his help would probably be more harmful than his enmity. A recent attack on J. P. Cooke and another on the Battelle process of refining are the champion specimens of asininity reaching this office in a great while.

It does seem that not enough support is received from Honolulu in Kauai's fight for an harbor. This matter interests the capital city greatly. Let the Honolulu Chamber of Commerce, the Merchants' Association and the Honolulu Ad. Club get busy and help us out. Resolutions urging the appropriation by Congress would carry weight just now, inasmuch as the matter is to be seriously considered by the committee in a short time.

FOREMAN Morse, of the Harbor Commission, has recommended at Honolulu that \$3,000 to \$4,000 be expended for improvements to Nawiliwili wharf. All users of the wharf know that it has been in bad shape for a long time, and it is to be hoped that the expenditure will be authorized without delay. Concrete pillars, in place of piles, as now proposed, will make the foundation permanent, which will be very great economy in the long run. Let the work begin at once.

SCHOOL Inspector Raymond states that if Lihue will supply the building, he will see that the high school is established and maintained. That is an advance in a favorable direction, and gives the people of Lihue something of a tangible character to work on.

HAWAII with her volcano scene and Maui with her silver sword display will attract lots of attention in the Floral Parade at Honolulu. But just wait until Kauai's Spouting Horn turns the corner! It will be something new—and that is what the people will be looking for.

DELEGATE Kuhio actually got away from Honolulu last week, and from all accounts was headed toward Washington. Now, if someone does not spring a luau or two in San Francisco, there is still a chance that he may beat adjournment to his seat in Congress by a neck.

PROMOTER E. N. Payne announces that he will "save the stockholders" in Humama Oil Company. We feel no hesitancy in assuring the gentleman that quite a number of Kauai investors in his company will not object to being "saved."

THE REPUBLICAN CENTRAL COMMITTEE has asked for suggestions in regard to its proposed rules and regulations, and we modestly arise to present one which we think, if carried out, will be of value to both the committee and the public. Our suggestion is that the rules, as they now stand, be handed over to some cub reporter at Honolulu with the simple instruction: "Condense them". The cub will be gone about one hour and fifteen minutes, and will then return with a set of rules and regulations one-fourth as long as the committee's draft; covering completely every point in the original, and expressed in such ways that the average citizen will understand what is meant.

FRIENDS of E. B. Bridgewater on Kauai (and there are many, we feel assured) will sincerely regret the embarrassment into which he has drifted (or, perhaps, "plunged" would be the better word) at Honolulu. The whole trouble arose, apparently, out of a subscription contest—a species of those freak "splurges" of newspaper men, or papers, which are undignified, in the first place, and are so fruitful of dissatisfaction and criticism in the second. Well wishers of Mr. Bridgewater will hope that he may satisfactorily explain matters. Some good may come to the community as a whole out of the case, however, if it serves to re-emphasize to newspapers generally in the Islands that subscription contests do not improve at all the otherwise fairly clean atmosphere of Hawaii-nee, and might well be eliminated from future programs.

Subscription Contracts

ALTHOUGH not feeling itself legally responsible for the business acts of E. B. Bridgewater as lessee of THE GARDEN ISLAND newspaper (the lease agreement expiring with each year and being finally terminated December 31, 1914), THE GARDEN ISLAND PUBLISHING CO. recognizes the fact that quite a few people may have, without a distinct knowledge of the facts, and in perfectly good faith, negotiated long term subscription contracts with Mr. Bridgewater during a recent contest carried on by him, and for which money was paid over to the promoter thereof. To recognize such contracts and assume responsibility for their fulfillment, would, as the public may readily see, mean a considerable loss to the stockholders of this company. At the same time, THE GARDEN ISLAND PUBLISHING CO. covets the friendship and confidence of every person on Kauai; and, if necessary, is willing to shoulder what seems to be an unusual and unfair burden in order to perpetuate the esteem held for the paper in our island community.

Therefore, after going over as carefully as the records would permit, the subscription contracts entered into by Mr. Bridgewater during the progress of the contest above referred to, we have decided to assume responsibility for the fulfillment of the same; hoping that our friends will recognize now, and continue to recognize, the fact that THE GARDEN ISLAND PUBLISHING CO. has been innocently drawn into the matter, and is to be the sufferer for the errors of a person acting in an independent capacity and on his own behalf. To use a vulgarism, this Company has been "stung"; but it would rather have it that way than to have its friends unfairly treated by a person temporarily in charge of its property.

When the notice hitherto published, disavowing these contracts, was written some three weeks ago, certain facts in connection with the ability (or inability) of Bridgewater to protect the persons who had contracted with him for subscriptions ranging over a long period were not clearly understood in this office. Mr. Bridgewater had announced his intention of starting another paper on this island, and stated in this connection that he would fulfill these old contracts with his new publication. Circumstances have since come to light which indicate the impossibility of any such paper being started, and would seem to bring the matter of the subscription contracts back to the starting point.

To summarize, therefore, the position of THE GARDEN ISLAND PUBLISHING CO. in the matter is as follows: (1) It never has, and does not now admit any legal responsibility for long-term subscription contracts entered into by E. B. Bridgewater during the life of his temporary lease of THE GARDEN ISLAND newspaper. (2) Bridgewater was, and is, responsible personally for all such contracts, but seems to be unable to fulfill the same. (3) For the protection of its friends, and in order that it may retain the full measure of their confidence and esteem in the future, this Company assumes and takes over the subscription contracts referred to, and will endeavor to fulfill them in the same good faith as was probably felt by the subscribers when they negotiated the same with Mr. Bridgewater.

All persons holding receipts for subscription money paid to Mr. Bridgewater during the contest referred to, the same being paid for a newspaper to be delivered over and from January 1, 1914, are requested to show the same at this office in order that their names and terms of subscription may be duly entered in the books of THE GARDEN ISLAND PUBLISHING CO., and proper receipts of this Company for the unexpired period of such subscriptions may be given.

TRANSFERS OF HOMESTEADS

Governor L. E. Pinkham, upon the recommendation of Joshua D. Tucker, commissioner of public lands, has approved of three homestead transfers on Kauai. Other land office work relating to the Garden Island is now awaiting the sanction of the governor and it is expected that this will be cleared up within a short time. The location of the homesteads and the parties figuring in them are as follows:

Kalaheo, Kauai—Francisco Callego to Francisco Fernandez; Simao Moito to Juan Cascale; Philip K. Palama to Ramon Bagliot.

Lawai, Kauai—Tom to Manuel Jacintho Martins; Joe Silva to Antero Tavares.

Wahiawa, Kauai—Manuwa Pule to Lorenzo Ruiz; Lono Keawe to William Rowan.

No little favorable comment is being heard in Honolulu regarding the speedy action of Sheriff William Rice and Circuit Judge Lyle A. Dickey of Kauai in securing and presenting to Attorney-general Wade Warren Thayer the facts concerning a tale of woe which a Portuguese girl named Glory Paris, whose parents reside on the Garden Island, told the latter the

other day. Claiming that she was but 19 years old, that she had four children to support, and that the husband has been wrongfully cast into jail, Glory Paris' story was taken by the attorney-general to have some meaning to it.

The attorney-general communicated with the Kauai officials, who immediately visited the girl's parents, only to learn that Glory Paris' had no children and that her story was otherwise a gigantic frame-up. This evidence was immediately forwarded attorney-general and the matter straightened out just in time to prevent a number of charitable people of the metropolis coming to the aid of one whom they believed to be a destitute mother with four children.

The campaign which Dr. John W. Wadman, recently appointed superintendent of the Anti-Saloon League with headquarters at Honolulu, is now carrying on throughout Kauai is the forerunner of a great movement which is to permeate every section of Hawaii.

Doctor Wadman is out in earnest to fight the saloon and has the staunch support of Jeff McCarn, United States district attorney, in his undertaking. Mr. McCarn has stirred the people of Honolulu with the many forceful, straight-to-the-point addresses on the temperance question.

Next Football

The game of football on the Lihue grounds next Sunday afternoon will be between the Makaweli and German teams. A hard-fought battle is anticipated.

GERMANS HONOR GREAT EMPEROR

Function of Kegel Club Elaborate And Successful Affair

The Kegel Club had a royal time of it last Tuesday evening, the occasion being the "celebration" in honor of the anniversary of Emperor Wilhelm, of Germany.

The formal part of the "session" was in charge of President Rice, although Mr. C. Maser is to be credited with the arrangement of the splendid program. The good-time started at 7:30 and lasted until near midnight.

A long extra table had been arranged in the middle of the room for the purposes of the banquet; and on it was a feast gotten up in regulation German style. There were salads of various kinds, German cheese and sausage and numerous other things common to the Fatherland.

The piano from the Fairview Hotel had been brought over, so that there was good music and plenty of it during the evening. Mr. Maser had decorated the hall in fine style, ferns being used around a large portrait of the Emperor, which was conspicuously displayed.

Rev. Hans Isenberg responded in a patriotic, though happy, vein to the toast "The Emperor." His remarks frequently drew forth rounds of applause, and at the close all present joined in singing "Hock, Sol er leben."

Wilcox, Thurtell, Hill, C. S. Dole, Hannes, Vincent, Robinson, Morgan, Wisner, Wishard, Philip Rice, F. Mahn, and D. W. Dean. Joviality reigned throughout the evening, there not being a single dull moment; and the affair was unanimously voted one of the most successful and pleasant ever pulled off by the Kegel Club.

It's Number Is 142

Manager Rohrig, of the Lihue Store, bought the handsome truck brought to Kauai a couple of weeks ago by Mr. Humphreys, of the Von Hamm-Young Company. Its number is 142, as is also a department of the Lihue Store and thereby hangs a tale:

Mr. Rohrig was telling Mr. E. H. W. Broadbent about his purchase. It so happens that the latter's auto number is 142.

"Yes," said the manager of Grove Farm; "and I suppose you want my auto number, too, to correspond with your telephone number."

Mr. Rohrig admitted that he would like to have it, and Mr. Broadbent inquired how much he would give for it. "A box of good cigars," replied the merchant. "It's a go!"—the sugar man.

And that is how the fine, new truck gets 142 as its number, while Mr. Broadbent will have to secure another number for his flier.

EXEMPTIONS IN INCOME TAX LAW

The following are the special exemptions mentioned in the new Federal income law:

For the past year 1913 the specific exemptions will be \$2,500, or \$3,333.33 in a case of a married person, and in future years \$3,000 and \$4,000, respectively. Where the tax has been withheld on part of the income at the source, or where part of the income comes as dividends upon stock of a corporation which is taxable under the corporation tax section of the law, the regulations set forth that such income shall be deducted from the individual's total net income when computing the amount on which he is taxable.

The law imposes a tax of 1 per cent and provides that individuals who have an income over \$20,000 and not more than \$50,000 shall pay an additional tax of 1 per cent on such amount; on all over \$50,000, and not over \$75,000, 2 per cent; on all over \$75,000 and not over \$100,000, 3 per cent; on all over \$100,000 and not over \$250,000, 4 per cent; all over \$250,000 and not over \$500,000, 5 per cent, and all over \$500,000, 6 per cent.

Lights Wrongly Placed.

Editor GARDEN ISLAND:—

There is a law which states in effect that vehicles using the public highways during the hours of darkness shall carry a burning lamp.

It does not specifically state that the light shall be placed in such a position as to be seen by others using the same highway. Common sense interpretation of this law, however, would indicate that its intent is to protect public life and property and therefore, the light should be placed in a conspicuous position.

On almost any evening, one may observe wagons travelling the public highways without any light showing until closely approached, these lights either being placed in the bed of the wagon or attached to the dark directly back of the horse. Even when seen, many times the direction of travel cannot with certainty be determined at a distance.

Being at times really dangerous, particularly on very dark nights it appears as though some effort should be made toward the improvement of these conditions.

Rice To College

Philip L. Rice will leave early in April for Ann Arbor where he will take an advanced law course, extending over a period of two years. He goes in the Spring in order to engage in work preliminary to the opening of the regular term in September.

School Officials Here

Inspector Raymond and Superintendent H. H. Brodie spent last Tuesday night at the Hotel Fairview, and on Wednesday visited the schools around Lihue, returning to Hanapepe Wednesday night. While here they had a look at the old court house, which has been spoken of as a possibility for use as a high school.

Is Havelock Foy Present

Governor Pinkham has requested THE GARDEN ISLAND to inquire if Havelock Foy, formerly of Linsadill, Armagh, Ireland, is on the island of Kauai. He is described as 5 ft. 9 in. in height, dark hair and eyes, strong face, fresh complexion, probably clean shaven, unusual figure and age 28. The father of the young man wrote to President Wilson about the matter, and stated that when last heard from Havelock Foy was in the Hawaiian Islands. Any authentic information concerning the young man, if on Kauai, or otherwise, will be appreciated.

 were finally gotten aboard. Tom
 was very sore about something
 which he had no control over
 when he left. It appears that of
 the \$1,000.00 guaranteed him by
 the promoters down Hanapepe way,
 \$100.00 had been held back for some
 claim which the promoters had
 against the aviator. This made
 Thomas sore; and he went away
 vowing that he would roast Kauai
 in general and the promoters in
 particular in the papers at Hono-
 lulu.

Gunn said, before leaving, that
 he had enjoyed his visit to Kauai
 and had been treated nicely by
 many people. He held out to the
 last that unfavorable wind (not
 "cold feet") and circumstances
 over which he had no control were
 responsible for his failure to put on
 a satisfactory program here.

The aviator will have only a
 short time in Honolulu before sail-
 ing for the Orient, in consequence
 of which, he said, he would prob-
 ably not fly again in the Islands.

I. I. S. N. Investigation
