\$5,000,000 PLANTATION

EWA WILL QUINTUPLE ITS CAPITAL STOCK.

Will ask the Government for Increase of Charter Rights so as to Raise Capital to Adequate Amount.

The Ewa Plantation Company met this morning and decided to increase the stock up to \$2,000,000. Up to the present the capital stock of the plantation has been \$1,000,000 with privilege, according to the present charter, to raise it to the amount decided on.

J. B. Atherton, on being interviewed, stated that this was no watering of the stock. The increase was on the actual value of the property. It has been an exceptionally successful plantation and the value of the real estate and the many rights belonging to it as well as the natural improvements have increased the value to the present amount. As a mere matter of fact the plantation has been assessed for taxation purposes far ahead of even its present value.

It is the intention of the company, and the directors have been instructed to make the application, to raise the present capitalization to \$5,000,000, and there will be ample cause for doing so.

Ewa plantation is among the most successful that has ever been organized here. In its early days it had some serious ups and downs and it came near wrecking some of the most solid of Hawaiian fortunes, but it has weathered all storms and is now one of the most prosperous of all our commercial enterprises, the original shares commanding \$400 for \$100 shares.

GARNISHEES ARE IGNORED

WEEPING AND WAILING AMONG BILL COLLECTORS.

Government Refuses to Recognize and Claims Under the Old Garnishee Act—Test Case to be Brought.

There is trouble in the camp of the bill collectors today. Salary warrants have been paid in full to the incumbents and no notice whatever has been paid to garnishee judgments, even though they accrued six or eight months ago.

The garnishee law provides that 25 per cent of the salary of a government employe may be sequestered for the benefit of his creditors and the person paying out the money is directed by an order of court to pay this 25 per cent over to the creditor named in the order.

It has been customary for a garnishee to run in this way for several months, before being entirely satisfied.

A prominent bill collector said this morning: "The government has not only refused to recognize garnishees obtained since the passage of the Audit Act, but in two instances to my own knowledge has refused to recognize garnishees obtained six and eight months ago. One of these is in the Interior Office and the other in the Marshal's. In both of these cases it will take the men several months to pay what they owe under the judgments I hold, but today both of them have been paid in full and the men have laughed at me when I demanded payment of the monthly profits for which I hold judgments and orders of court directing the Minister of Interior and the Marshal to pay to me and hold back out of the salaries. These officials say that they have nothing to do with the salaries now. If this is not a clear case of retroactive legislation then I am badly fooled. At any rate we shall test the matter in the courts."

HILO REPUBLICAN CLUB

DECLARES FOR FULL AND EQUAL SUFFRAGE.

First Organization in the Islands on the Lines of American National Parties—Much Enthusiasm Shown.

Hilo, July 27.
Hilo has a fully organized Republican club. It was formed last Monday evening at a largely attended meeting at the Court House. The meeting was in response to a call issued by a number of citizens. The band was in attendance and there was much enthusiasm.

William Vanatta was made temporary chairman and J. T. Stacker of the Hawaii Herald temporary secretary. A permanent organization was effected by the adoption of the report of the committee on permanent organization, consisting of G. F. Little, W. S. Wise, C. H. Brown, L. A. Andrews and H. C. Austin. The officers of the permanent organization are: President, R. B. Williams; vice presidents, William Vanatta, E. N. Holmes and C. C. Kennedy; secretary, J. T. Stacker; treasurer, Walter A. Hardy; executive committee, W. W. Goodale, John A. Scott, Gilbert F. Little, C. H. Brown, Joseph Vierra, G. F. Alfonso, W. S. Wise, B. H. Brown and William Nalimu.

The constitution and by laws presented by the committee in English, Portuguese and Hawaiian versions, were adopted. This constitution pledges the organization to the principles of the Republican party.

On the subject of suffrage the club thus declares itself:

"The members of the Hilo Republican club recognize the full and equal right of Hawaiians, Hawaiian born Americans and Hawaiian born Europeans to the full privileges of franchise with the citizen of the United States and by this section declare themselves as unequivocally in favor of such franchise and inalterably opposed to curtailment in the right of such persons to the slightest degree. We believe the aliens who voted under the Constitutions of 1857 and 1894, should have the rights of citizenship upon taking the oath of allegiance to the United States."

As to the political action in local matters the club declares:
"Each member pledges himself to assist in keeping the ballot pure and in the selection of candidates for city, county and territorial office, to confine himself to such men of the party as he believes will administer the affairs to the best interests of the masses."

Over 100 have already enrolled themselves as members of the club, and it is expected that this number will be more than doubled within a short time.

A BANKRUPTCY SETTLEMENT.
C. Bosse, assignee of the bankrupt estate of S. Kasamatsu, has filed a release, signed by all the creditors, for the first and final dividend. The debts foot up \$25,088.07. The total of the dividend is \$2,025.68, or about 9 per cent of the claims.

BEFORE JUDGE PERRY.
The Kahului Railroad and Hawaiian Commercial controversy was before Judge Perry in a new phase this morning, which has reference to the application made by the Kahului Company to the Minister of the Interior for a contract, noted in yesterday's issue.

A father 90 years of age is not what many men can boast of, but John Nott can, for his father passed his ninetieth birthday on July 26th. When Mr. Nott heard from the old gentleman by last mail he was hale and hearty and trotting round, taking an interest in all that was going on, and required no one to look after him.

Mr. Nott, senior, was born in Bristol, England, in 1808. He is a freeman of that city, though he has been a resident of New York since 1852. Mr. Nott, Jr., our Mr. Nott, says he remembers seeing his father walk in the Bristol procession in honor of Queen Victoria's coronation. He was a very small boy then, but his Sunday school went to see the sight and had an excellent position.

HELP FOR THE RED CROSS

HOW MANY CAN ASSIST THE BOYS IN BLUE.

What Style of Articles are Needed by the Nurses for Their Patients and Where to Send Them.

The Red Cross Society has three representatives on board the transports in port. At the head of them is Dr. F. J. Hart. This gentleman was for five years in the government service in Arizona, attending, as he says, to "soldiers and Indians," and has had altogether fifteen years in that sub-tropical climate. Moreover, he has a thorough knowledge of Spanish, which he can speak and write with fluency. The other members of the Red Cross that have been sent out with this expedition are Eugene Rosenthal and Leon A. Crowther, who are accredited nurses of the society.

The two nurses are men of experience. Rosenthal has been out in Russia, Greece, Turkey and India, on behalf of the society. He was on the ship Cowper that took provisions to the starving people of Hindoostan a year or so ago. He has certificates from many parts of the world where he has worked. Crowther is a medical student and an experienced nurse. He has been with Dr. Hart for many years and thoroughly understands the practical part of his work. All the gentlemen give their services gratis to the cause.

In future, if there is a future and peace is not proclaimed, a member of the Red Cross will accompany each transport. The Red Cross man in charge carries a certain amount of stores for the sick soldiers. Besides the stores he carries with him the various State societies will forward stores to be used when the hospital is started in Manila.

The following is the list of stores started with on the Peru, and will enable people here to judge what the Red Cross people need. Dr. Hart says no one can know how useful the lime juice and the clam juice are to the seafaring soldiers. Of this everything has been used up, and the other stores have been seriously drawn upon. The ladies of Honolulu have promised to help as much as they can, and there is no doubt but that when the list is understood there are plenty of people who will send something to aid it. Contributions should be sent to Eugene Rosenthal, care of the Red Cross Headquarters, Nuuanu street. The following is the list:

Two cases cocoa, 1 case condensed milk, 4 cases lime juice, 6 hospital size malted milk (cases), 1 case alcohol, 10 pounds permanganate potash, 1 gallon Jamaica ginger, 6 cases clam juice, 2 pails anchovies, 100 pounds of steamed oatmeal (2 cases), 2 cases of whiskey, 1 keg insect powder, 3 bottles brandy (1 case), 1 case claret, 5 cases jelly, 6 cases canned fruit, 120 pounds oranges (2 cases), 1 case figs, 100 pounds dried fruit (14 cases), 100 pounds (3 cases), 50 pounds farina (1 case), 24 pounds chipped beef (1 case), 2 boxes unsweetened chocolate, 5 pounds tea, 3 gallons bay rum, 3 Arab tents, 1 gallon sherry, 12 bottles, Bisterine, 1 large bag emergency pillows.

W. O. ATWATER.
Leaves Government Employ After Twenty-two Years Service.

Today may be said to end the career of W. O. Atwater as an employe of the government, although he has consented to exercise supervision of the office he has lately held for a couple of weeks yet.

It was in 1876 that Mr. Atwater first entered government employ as clerk of the circuit court for the Second district, which in those days comprised the Island of Maui. In this capacity he served until January 1st, 1884, when he resigned to take the office of secretary of the Board of Immigration, which he held till March, 1887. He then entered the employ of the Honolulu Iron Works, remaining with that firm four years and a half. From 1892 to 1895, Mr. Atwater was away from the Islands, but on the 28th of February, 1894, he again entered the service of the Postal Department, succeeding John G. Rothwell. During the time he was with the Iron Works, Mr. Atwater was also agent to grant marriage licenses, so he can almost look back on a continuous and honorable career as a public servant lasting for over twenty-two years.

FLAG RAISING AT WAILUKU

OVER TWO THOUSAND PEOPLE WERE PRESENT.

Plantations and Mills all Closed for the Day—Speeches, Music and a Luau were Features.

Maui, July 28.
On Monday last Wailuku celebrated the greatest event in Hawaii's history and formally raised the Stars and Stripes over the court house. Those in charge of the affair had worked hard for days before to make it a success, and it went even beyond their expectations. A beautiful day, a large, good natured crowd, a sumptuous feast, fine music and good speaking made the affair one to be long remembered.

Throughout the whole of Wailuku district the day was observed as a general holiday, and the Wailuku Sugar Company, from Waikapu to Wailue, the Kahului Railroad Company, and the Hawaiian Commercial and Sugar Company, in all their branches were shut down to allow each and all to enjoy the event. A free train was run in the morning from Paia to Wailuku, bringing seven carloads of people from the villages on the way, and returned with them about sundown. Then at midnight the train made the trip again, taking people home from the dance. This was very greatly appreciated, and the thanks of the community are extended to the Kahului Railroad Company for their courtesy.

The events of the day began with the raising of the flag at noon. From a platform, draped with flags and bunting, erected in front of the court house, Miss Emma Kupieha and Miss Laura Wells, two little misses, representing Hawaii and the United States, together raised the Starry Banner and floated it to the breeze over the court house, while the band stationed on the upper verandah of the school house adjoining, played the Star Spangled Banner and Hawaii Pono, and the crowd cheered. The Wailuku police in full uniform, presented arms and a salute of twenty-one bombs was fired. W. G. Taylor of Spreckelsville, the orator of the day, gave a most stirring and patriotic address, which was often interrupted by bursts of applause. He spoke with much feeling of Old Glory, gone up over Hawaii, to remain, and the blessings accruing therefrom; of the American arms in the present war, and the glory and honor of being a citizen of the great republic, under the protection of the eagle's wings. He paid a high tribute to the Hawaiian race, and trusted that they would benefit by the opportunities and blessings now placed within their grasp.

A. N. Kepolikai spoke to the Hawaiians in their own language, and made a very forcible address, giving them much good advice and sound reasoning. Upon the platform beside the speakers and the little flag raisers were Sheriff L. M. Baldwin, United States Consular Agent A. G. Dickens and J. Dow of Wailuku.

Next in order was the luau, which was held in a luau, the shape of an L, 100 feet each way and 30 feet wide, in the native church yard, where about 800 people were seated at a time and a bounteous feast spread. Among the good things consumed were 1,200 pounds of beef, 1,200 pounds of pork, 24 dozen chickens and 150 dozen bottles of soda water.

During the balance of the afternoon music by the band was enjoyed, and a good time had generally.

C. B. Wells, George Hons, W. F. Robinson and others received with lavish hospitality during the day. It is estimated that over 2,000 people were present.

The dance in the school house in the evening was a most enjoyable one. The room was prettily decorated with flags, bunting and ropes of fern, and the music was furnished by the Wailuku string band. E. R. Vander Nalieu managed the floor, and the large number present enjoyed themselves until after midnight. Light refreshments were served.

The day throughout was a great success, and fully justified the eight hundred odd dollars expended. The money was raised by popular subscription.

THE WRONG UNIFORM.
About half a dozen men of the Montana regiment went into a Chinese restaurant on Hotel street last night and after eating all they could hold refused to pay, claiming they had no money. The Chinese proprietor raised a row about it, but seeing that the money was not forthcoming let them go, saying, "You fellows all are same thieves. You no business with that uniform on. More better you go put on Spanish uniform." The shamfaced men slunk off without a word.

HOUSE CLEANING TODAY

THE HOSE INSTEAD OF THE BAND IS PLAYING.

Nearly all the Troops Taken From the Transports While a General Scrubbing Goes On.

The streets have been martial this morning with marching troops and drilling companies. From all three of the transports in the harbor all the men who could possibly be spared were taken off in companies and marched up and down the streets, partly for exercise and partly for drill.

A great many of the company commanders devoted a large part of the time to practicing their men in the manual of arms. All along King street and Alakea street, along the water front, and even on Beretania street, companies were drilling, and every company had a crowd of interested spectators watching it.

While the troops were thus away the ships were all given a thorough scrubbing and cleaning from hold to quarter deck. The hose played instead of the band, and the melody of cleanliness it rendered was as inspiring as the bugle call to action.

On none of the ships were visitors allowed except on business. All the serious sick were removed to hospitals in the city. As compared with the usual conditions the transports looked deserted today.

This afternoon there was little drilling, but general shore leave was given the men.

Tomorrow being the last day of the month there will be general muster of all the regiments and change of quarters among the men so far as possible.

On the Pennsylvania a large number of additional bunks have been placed between decks so as to leave free the smoking room which up to now has been used as quarters for the men.

A large number of dinner invitations have been received by the boys in blue today.

The Rebekahs, assisted by the Odd Fellows, will entertain visiting Odd Fellows among the soldiers tonight at Harmony hall.

WITH COMPANY D.
Company D had a short drill last night, followed by high links, for the benefit of a number of invited guests. About 200 were present, a special musical and variety program being part of the entertainment. A general good time was had and the visitors heartily enjoyed themselves.

THE HAWAIIAN FLAG.
The Hawaii Herald Makes a Suggestion Regarding It.

Citizens are called together at the court house tonight for the purpose of determining the course to be taken in officially raising the Stars and Stripes in Hilo. Beside this is another matter of equal import—the ceremony attending the official lowering of the Hawaiian flag. If sentiment exists anywhere it is in the breast of the Hawaiian for the flag under which he was born. The Herald suggests that the flag be lowered with fitting ceremony and that it passed over into the keeping of John T. Baker, a representative Hawaiian and the last governor of Hawaii under the monarchy, as custodian, for Hawaiians in Hilo district. Under the broad constitution of the United States it will not be treason for the Hawaiians to form a society, and this flag should be kept among its treasures.—Hawaii Herald.

The question as to who shall be governor of the Islands has probably been settled by this time, so it is no use chewing the rag over it. The American Union party, through its central committee, made its choice quickly and sent on its endorsement of Mr. Sewall. Other people who had candidates should have been up and doing just as quickly. Whatever appointment the President makes will be satisfactory to the people of the Islands, and The Star has every reason to believe that when the appointment arrives it will be found to contain the name of Harold M. Sewall.

It looks very much as if the morning grandmother was becoming the morning grandmother weeping over the good old times. Cheer up, old lady, progress is the order of the day and you can't stay among the scenes of your remote youth forever. Because we are annexed there is a dark hint that office holders with bowie knives will be ascending into editorial sanctums. Don't be alarmed, even the wielders of bowie knives will not harm a lady, and especially one who sits bathed in tears and dreaming of the dear departed—monarchy.

The number of foreign residents in Yokohama is not nearly so large as one would be led to think. The total amount is 4,728, but of these 2,743 are Chinese, leaving a little less than 2,000 to be divided among European and American nationalities. The British stand at the head of the list with 869, Americans come next with 369, Germans, 198, and the French, 187. The rest are each less than 100. Among the list are 13 Hawaiians. As trade relations between the United States and Japan increase, the number of American residents will increase, for new business houses are bound to open out in Yokohama during the next year or so.

FOOD INSPECTION.

The last Legislature passed a bill creating the office of food inspector and appropriated a salary for the position. A great deal of time was spent both in committee and by the Senate and House in putting the bill in good shape. Pure food, pure drink and pure medicine were provided for. It was stated at the time many articles sold in the stores were adulterated, and that the public, especially the poorer portion of it, suffered in consequence. Cases of adulteration were cited both in food and in drugs, and the law, when passed, was quite a stringent one.

But it is no earthly use having laws on the statute books unless they are enforced. They might just as well have gone into the waste basket as to remain a dead letter. The pure food law will never be enforced until we have a food inspector appointed. Why there should be hesitation about the matter does not appear. It is not an appointment that will be effected by annexation. Hundreds of cities in the States have their food inspectors and we shall continue to have ours if we can only once get him appointed.

Certain of the milk dealers are especially anxious that the appointment should be made, because, as they put it, though they are perfectly willing to meet ordinary competition they cannot compete against Nuuanu stream in the milk cans. The Board of Health killed a number of their cattle on account of tuberculosis, but it does not give them protection against the competition of adulterated and impure milk. It looks very much as if these milk sellers had a clear grievance.

But it is not a matter that the milk sellers are interested in alone; it is one in which the general public is also much interested. If impure milk is being sold, it is the buyers of the milk that suffer most. If milk is only watered the harm done may not be great. There is no doubt that in spite of the law a great deal of oleomargarine is sold as butter. There is no great harm in this, but if a person asks for butter he should have it. Ground coffee is largely adulterated, and the adulteration is done in this city. Again the adulterant may not be harmful, but the article should not be sold as coffee, it should be sold as coffee and chicory, or whatever the mixture may be.

It is quite clear that there is urgent necessity for making the ap-

pointment of a food inspector. Already seven months of the biennial period have elapsed. It will take a man some time to get familiarized with the duties, to lay plans and to fully understand his powers under the law. In the interests of the public then, the appointment should be made at once. There are several candidates for the position and there should be no difficulty in choosing a capable and fit man to carry out the law. It will require a man of judgment, and one in whom the people can have perfect confidence, but such a man can be found. There are men enough if the appointing power will only bestir itself.

A DIFFICULT PROBLEM.

The Summer School is over and Colonel and Mrs. Parker can congratulate themselves on having conducted it most successfully. Considerable enthusiasm has been aroused among the teachers, and this will be carried into the remotest districts of the Islands. The educational work of the Hawaiian schools will have to go on industrial lines, if we are ever going to improve and not remain stationary. At present, the ideas upon such a change are somewhat nebulous, but we shall reach the practical solution some day.

The problem is how to make a day school run satisfactorily on industrial lines. The problem of how to run a boarding school on such lines has long ago been solved, and no better example is to be found than Hampton, though that is by no means unique, and almost every country in Europe has institutions running on similar industrial methods, but the day school with its limited hours, and its limited area of land, presents difficulties which have never yet been satisfactorily solved. There is no doubt that to succeed we shall have to retrain many of our teachers, drop a good many more and remodel the course of study in the Normal school. But success will come.

FRENCH SAILORS LANDED

MEN FROM THE CRUISER ECLAIR-REUR IN SHANGHAI.

Ning Po on the War Path and Fiercely Resisting French Invasion—The Shops in the City Closed.

SHANGHAI, July 17.—The Chinese having refused to accept an offer of money by the French and the promise of a new site to replace the Ning Po joss house, the repository for the French corpses, pending their final burial, the French object being the removal of the nuisance and the improvement of the road, eighty sailors were landed from the French cruiser Eclairneur on Saturday and commenced pulling down the wall of the cemetery. Later some stone throwing was indulged in by the population, but the sailors and the French police maintained order. It is said that one native rowdy was bayoneted today.

It is reported that the Ning Po head men have declared a general boycott against Shanghai. None of the Ning Po shops are open and no Ning Po are at work. The head men's orders have been posted.

The volunteers paraded this afternoon and are kept in readiness in case of need. Three natives are reported to have been shot. The bridges between the French and English settlements are closely guarded.

GENERAL COURT MARTIAL.

A general court martial has been in session on the hurricane deck of the Pennsylvania all forenoon. The members of the court are Major Potter of the Fourth Cavalry, Majors Jas. M. Dennon, Byron H. Cook, and John R. Miller, and Captains Geo. W. Rief, Charles Gardner, William L. Hill, E. W. Wynne, John E. Moran and Thomas S. Dillon of the First Montana, Captains V. H. Bridgeman and A. B. Dyer of the Sixth Artillery, and Lieutenant H. L. Hawthorn of the Sixth Artillery, Judge Advocate.

The court is sitting in review on a number of cases from garrison courts martial as well as hearing a number brought directly before it.

The findings in none of the cases will be made public until published in a general order.

THE TAX COMMISSION.

Judge Robertson stated this morning that the tax commission would probably meet and organize as soon as Senator Baldwin arrived but that nothing further would be done before the flag raising. Much will depend as to the view the Hawaiian commissioners take of the matter.

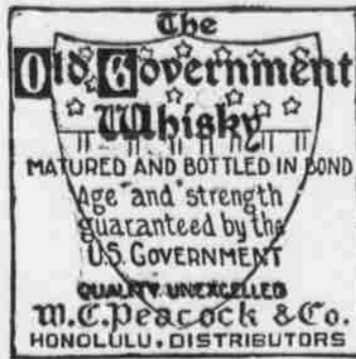

SOAPY SMITH CASHES IN

**KING OF SKAGUAY DIES
WITH HIS BOOTS ON.**

The Gambler and Desperado Who
Has Terrorized Southwestern
Alaska Killed by a Citizens.

VICTORIA (B. C.), July 15.—
"Soapy" Smith, the "King of
Skaguay" and one of the most des-
perate border gamblers the West has
ever known, is dead in the town of
which he has been practically the
ruler. His followers are dispersed
and there is none to bespeak for
him so much as a Christian burial.

When the Cottage City, arriving
here this evening, left the North,
Smith's body still lay in a slab in
the Skaguay Moirgue, while City
Surveyor Frank Reid, whose bullet
ended "Soapy's" checkered career,
was recovering at the Red Cross
Hospital from a return bullet fired
from Smith's Winchester. A jury of
the best citizens had meantime "sat
upon the body of the deceased" and
returned to Deputy Commissioner
Schlbrede a verdict completely ex-
onerating the City Surveyor from
all blame.

Smith's death was due to an out-
burst of indignation at the fleecing
of a returned miner by some of
Smith's gang. A citizens' commit-
tee demanded that Smith make res-
titution which he promised but
failed to do. A meeting was called
to consider the best means to deal
with him. Smith approached the
place of meeting with a loaded
Winchester. He struck Reid who
was acting as sentinel and fired at
him. Reid drew his revolver and
killed Smith.

Although there was not a person
in Skaguay who appeared to do
honor to the man, yet there are
those who deeply mourn his untimely
end. Smith had received in his
last mail photographs of his wife
and six children, who are living in
St. Louis. He was born at Camilla
Ga., forty-eight years ago, and
has a brother who is one of the
editors of the "Evening Star,"
Washington D. C. He had a large
correspondence with leading politi-
cians, and by the last mail received
a letter from the Secretary of War,
declining the tender of a volunteer
company which he had organized,
on account of the cost of transport-
ation, but the Secretary accompan-
ied his declination with warm ex-
pressions of the Government's ap-
preciation of Smith's patriotism.

Jefferson Randolph Smith, better
known as "Soapy," was the terror
of Southwestern Alaska. While
not at all like a typical border ruffian
in appearance, he never hesitated at
anything to accomplish his ends.
Suave of manner, debonair in ap-
pearance, he was often mistaken by
his victims for a well-to-do business
man, but rarely indeed did the
guileless tenderfoot when once
within his clutches escape.

VICTORIA, July 18.—Word
was received from the north by the
steamer Tees tonight that the body
of "Soapy" Smith was interred a
week ago last Sunday. Friends
of the deceased had planned to have
the body embalmed and taken
East, but the vigilance committee
at Skaguay had the body removed
in an express wagon to the little
cemetery back of town and there
consigned to mother earth. No re-
ligious service was conducted.

LONG LIVED VIRULENCE.

Some remarkable observations on
the longevity of germs in dust have
been recorded by Dr. Miquel, a
French biologist. In 1881 some
earth was taken from a depth of ten
inches in Montsouris Park, dried
for two days at 30 degrees C., and
then yuc away in a corner of the
laboratory, first being hermetically
sealed in talc. After sixteen years
it was found that the dust still con-
tained 3,500,000 microbes per
gramme, the original number in the
soil having been but 6,000,500 per
gramme, which the drying reduced to
rather less than 4,000,000. From
the surviving bacteria the tetanus
microbe was isolated, and so won-
derful was its vitality that it caused
death in guinea pigs after an incu-
pation period of two days.
