Work of One of the Art League Exhibitors. It is always refreshing to turn from an oil painting to a water color painting. Not that one is in any way more forcible than the other, but simply that the material gives a greater simplicity of effect, which is always charming. These remarks are in no way intended as an invidious comparison between the king of oil and the queen of water, but rather to do full justice to an often slighted branch of art. That many of the greatest masters have chosen oil as their medium to convey their thoughts is simply because the material is more lasting and permanent. They have, however, in doing so, conquered difficulties which the material will ever give in their efforts to obtain that freshness and breadth which comes so readily in water color. Material is a matter of selection, sometimes an accident. The same imagination and hand which controls the brush in one controls it in the other, but there may be, and is, a suitability of style which would make the work of a certain individual more effective in the one than in the other. This may be said to apply forcibly regarding Annie H. Parke's studies in water color. What is always essential in every branch of art and the foundation of all that is to follow is accuracy of drawing; this Miss Parke shows. Her work, No. 16 in the catalogue, "Stranded," is a fair instance of her simplicity of treatment, every line and brush mark and they are few - have their value. Miss Parke seems to have that judgment which enabled her to leave off before unimportant lines and detail have detracted from the value of the crucial points. No. 9, "Fath Through the Pines," should be noticed. It has a distinct atmosphere about it, but perhaps of all the many charming sketches No. 18, "New England Field," is the most happy. Perhaps this is owing to the selection, for it is a most charming piece of composition; none the less so for its almost severe simplicity. There is a breadth of touch and delicacy of tone throughout all her work which would give her consideration anywhere. Hawaiian Opinion. A Cluster of Wooden Buildings Destroyed—Origin a Mystery.

A destructive fire occurred at 9 o'clock yesterday morning on King, between Fort and Bethel streets. How the fire originated or where it started is a matter of conjecture. The Portuguese barber in the rear of E. S. Cunha's saloon says that when he first saw the blaze, it seemed to him to be alongside the partition in S. Kuby's cigar store. J. Spencer, operator in the Bell Telephone office, was the first notified of the fire and he promptly turned in the alarm. When he looked out of the central office window he saw the fire was in the rear of Kuby's store, close to the partition between the store and W. W. Wright's carriage factory. The fire gained rapidly and before the fire department arrived the two buildings were a mass of flames.

Minister King, who was among the first to arrive on the scene, took the men in hand and assisted in taking some of the carriages and tools taken out of the burning buildings. When it was found that the buildings on fire could not be saved, the firemen were set to work to prevent the flames from spreading to adjoining buildings. Although strenuous efforts were made the fire reached and destroyed a Portuguese shoemaker's stand, G. W. Lincoln's carpenter shop, also the storeroom of the Honolulu Furniture Co., Molteni's barber shop, and part of Young Nap's cigar store. Molteni managed to save his goods from the flames. The Honolulu Furniture Co. was more unfortunate. The members are recent arrivals from the Coast. They brought a quantity of household furniture with them for disposal here. The furniture was moved in on Friday and Saturday. The entire stock was burnt.

A large quantity from twenty to thirty men were lauded from the Japanese cruiser Takahiko to aid in subduing the flames. The men worked hard and materially assisted in keeping the fire under control.

The Union Saloon barber shop was sooted, but otherwise escaped. Mr. Wright's loss in stock and finished work will amount to about \$5000. He has an insurance of \$2000 on the stock, \$1000 in the Hartford Fire Insurance Co., C. O. Berger, agent, and \$500 each in the London & Lancashire and Alliance Fire Insurance Companies, J. S. Walker, agent. There is an insurance of \$1000 on the building with the Hamburg, Magdeburg Fire Insurance Co., E. A. Schaefer & Co., agents. The building is the property of E. S. Cunha.

The other buildings burnt belong to the Von Holt estate and are uninsured. An interesting feature of the battle with the flames was the way in which some of the old war horses of the volunteer fire department rushed in to assist the paid brigade. They said they could not help it when they saw the fire getting the advantage, and they displayed no mean courage and skill in their efforts.

There was a good deal of criticism heard about No. 1 engine's passing the hydrant at Hall's corner, and again going by the eastern at Bishop's Bank. Time was lost in the first place, and afterward efficiency weakened by the engine's attachment to an inadequate main on King street.

Fred Harrison, who had been doing paving work in the locality, lost some of his kit. He did not get three barrels of lime out of the way, as if they had got a new fire might have started from them.

Repos were stretched at the outset to keep back the crowd from impeding the workers. There was a great crowd gathered, a large portion of which hung around all the forenoon.

The people here vary in their ideas of the proper way to observe the first day of the week. "One man's meat is another man's poison." If the law against Sabbath breaking is to be enforced, let it include the entire statute or drop it entirely.
