THE CHINESE.

The Chinaman quietly pockets the proceeds of his infamous business and thereby lays the foundation of what to him will be a comfortable competence, while the poor Hawaiian goes down to infamy and death, a victim to Mongolian greed.

Late Foreign News.

AMERICAN.

New York, September 19th.—The "Sun's" Washington special of September 18th says: To-morrow the Board, consisting of Chief Engineer Melville, Captain Brown, Chief Constructor Wilson and Assistant Constructors Bowles and Nixon, which has been studying the probable cost of two 6,000-ton armor-clads authorized by Congress, will report to Secretary Whitney that they cannot be built for \$2,000,000 each, which that body appropriated.

Dubuque, Sept. 18.—A horrible accident on the Chicago, Milwaukee and St. Paul Railway, two miles north of this city, took place about 5:30 this morning.

New York, Sept. 18.—District Assembly, No. 49 K. of L., passed resolutions to-day asking Governor Oglesby of Illinois to commute the sentence of the seven Chicago Anarchists.

Belfast, Sept. 18.—A party of Orangemen, while passing through Greenacres last night, had an encounter with Nationalist residents.

London, Sept. 20.—Flourens, Minister of Foreign Affairs, has submitted to the Budget Committee a statement of the Tonquin business. It shows a deficit of 20,000,000.

Frankfort, Sept. 19.—The "Papal Romans" learns that England urges Abyssinia to give Italy satisfaction, and proposes a settlement of frontiers which will remove all pretext for collision.

Rome, Sept. 20.—The Prefect of Messina has succumbed to the cholera and there were 114 new

cases of cholera and fifty deaths in Messina during the past twenty-four hours. Cholera is reported at Trapani and Reggio di Calabria.

London, Sept. 21.—The artillerymen stationed at Hilsa, India, being ordered to prepare to move abroad, mutinied, and, after wrecking the sutler's shop, went about smashing widows and spreading terror among the inhabitants of the town.

London, Sept. 21.—At yesterday's hearing in the Mitchellstown inquiry, Constable Doran was sworn. He fired four times at the crowd, twice with buck-shot and twice with ball.

Sergeant Rider deposed that he fired three charges of ball from the window of the barracks. He declined to say whether he murdered any one. He simply did his duty, he said.

Mr. Harrington (interposing)—Listen to me, you villain! Witness replied warmly that he was no villain, and asked the Coroner's protection.

A spirited altercation ensued, the spectators taking Harrington's side. The inquiry finally had to be adjourned. It is certain that a verdict of murder will be rendered against certain policemen.

a wind bag. Then Cayford thumped
Wier, tore his coat and catching him
by the throat knocked him down and
held him there until friends inter-
fered. The petition, which had then
about 20 signatures, was to the
Minister of Interior begging for the
removal Chas. B. Wilson from office.
Cayford was found guilty as charged
and fined \$7.
Kashu, assault and battery on a
wahine, 5 days at hard labor.

AURORA IN ALASKA.

Lieutenant Ray, in his report to
the Government on the International
Polar Expedition to Point Barrow,
Alaska, says: "Every clear night
the sky was illuminated by the most
beautiful displays of aurora it has
ever been my fortune to witness.
They always commenced in the
northeast and the northwest, and
seemed to spring from a dark, low
bank of clouds. The lights were
never stationary for a single second,
neither did they take the form of
bows or arches so often seen in other
latitudes, but great curtains of
light, flashing with all prismatic
colors, seemed to be drawn across
the heavens, ever rising and chang-
ing, and often culminating in a coro-
na at the zenith, and falling like a
meteoric fire. As the winter ad-
vanced these displays were more
brilliant, and were always of a char-
acter that defies description either
by pen or pencil, as they were never
for two seconds alike. They were
unaccompanied by any sound so far
as we were able to observe, and the
deadly stillness that always prevails
in this region when the sea is
closed gave us an excellent opportu-
nity to detect any sound had there
been any."

A final estimate of the victims of
the burning of the Opera Comique
Theatre, in Paris, places the number
at 130, including the remains of 40
persons which were found in the
ruins, but which were so badly
burned as to be unrecognizable.

Wine-drinkers, who prefer the
foreign article on account of its
supposed finer quality, will be in-
terested to learn that there is a
movement in Spain against Ameri-
can alcohol, large quantities of which
are employed in that country and
France in "fortifying" the finer
brands.

The Army and Navy Act!

OPINION OF THE JUDI-
CIARY.

DEPARTMENT OF THE JUDICIARY,
HONOLULU, H. I., Sept. 30, 1887.
His Excellency Clarence W.
Ashford, Attorney-General—SIR:
The Justices of the Supreme Court
have had the honor to receive from
your Excellency a letter dated the
27th instant, requesting, on behalf
of His Majesty's Cabinet, by virtue
of the provisions of Article 70 of the
Constitution, the opinion of the Jus-
tices on the following questions, to
wit:
First—"Does the Act of the Leg-
islature, entitled 'An Act to Organi-
ze the Military Forces of the King-
dom,' approved the first day of
October, 1886, and being Chapter
XXII. of the Session Laws of 1886,
contravene the Constitution of this
Kingdom, and is said Act or any
part thereof, unconstitutional, for
any reason, especially for any of the
reasons hereinafter enumerated"—
mentioning four.

We discuss the second alleged
reason first. It reads:
"Section 2 of said Act ex-
pressly purports to make the Chief
of Staff, under the title of Lieuten-
ant-General, the Commander-in-
Chief of all the armed forces of the
Kingdom, under the supreme com-
mand of His Majesty as Generalis-
simo, whereas Article 26 of the
Constitution provides that 'the King
is the Commander-in-Chief of the
Army and Navy, and of all other
military forces of the Kingdom by
sea and land.'
The Section of the Act reads as
follows:
"Section 2. There shall be a
Staff, the Chief of which shall hold
the rank and title of Lieutenant-
General, appointed and commis-
sioned by His Majesty the King, to
hold office during His Majesty's
pleasure. This officer shall be Com-
mander-in-Chief of all the armed
forces of the Kingdom, under the
supreme command of His Majesty
as Generalissimo."

We notice the incongruity of the
"Chief of Staff" being the "Com-
mander-in-Chief," positions which
would seem to be incompatible. For
the "Staff" is composed of subordi-
nate officers about a superior officer,
who execute his commands, and
their head is the Chief of Staff. It
is impossible to see how one person
can be the "Commander-in-Chief"
and also the "Chief" of his own
"Staff." But the incompatibility
of two offices, one of which is sub-
ordinate to the other, being held by the
same person, is a matter of construc-
tion, and does not affect the graver
question of the constitutionality of
the Act. We put it in this way:
His Majesty is, by Article 26 of the
Constitution, the Commander-in-
Chief of the army and navy and of
all other military forces of the King-
dom. The Act in question author-
izes His Majesty to appoint a Com-
mander-in-Chief of all the armed
forces of the Kingdom, under the
supreme command of His Majesty
as Generalissimo. We are of opin-
ion that a function which the Con-
stitution has conferred upon His
Majesty, he cannot delegate to an-
other, unless the warrant for the de-
legation of authority is provided for
in the Constitution. And what His
Majesty cannot do in this respect,
the Legislature cannot do by enact-
ment. There certainly cannot be
two Commanders-in-Chief of the
same army at the same time. The
section of the Act under considera-
tion is, in our opinion, repugnant to
Article 26 of the Constitution. Being
of this opinion, the appointment
by the King of a Commander-
in-Chief of all the armed forces
would be without warrant of law.
The duties therefore devolved upon
such an officer by the Act, cannot
be performed. The conclusion at
which we have arrived would make
it unnecessary to consider the other
reasons put forth by other parts of
the Act as unconstitutional; but as
our opinions are asked upon them,
we will give them.

The first one stated is:
"That Section 1 of said Act,
while making the Minister of For-
eign Affairs Secretary of War and
of the Navy and responsible to ac-
count for all disbursements made
on account of the military or naval or-
ganization, does not, nor does any
other section of said Act invert
either the said Minister or any other
Cabinet Minister with any direct
control over such expenditures."
In Section 1 the duties of the Min-
ister of Foreign Affairs as Secretary
of War and of the Navy are "to
account for all monies disbursed by
the Military and Naval Depart-
ment and to accept and approve all
drafts upon the Treasury therefor."
This means that he is to keep the
accounts of the Department of War
and of the Navy and that his ap-
proval of drafts upon the Treasury
is essential, if they cannot be paid.
We notice that this section does not
confer upon the Minister the
authority to draw or sign the drafts
upon the Treasury. And it would
seem by the latter part of Section 8
of the Act that this authority was
conferred upon the "Chief of
Staff." This reads, "All drafts up-
on the military, volunteer and naval
appropriations shall be made through
the Chief of Staff," etc. If it
read "by" and not "through" the
difficulty would be cleared up. But
the section goes on to say that the
Chief of Staff (who it must be re-
membered is the Commander-in-
Chief) "shall submit the same to

the Secretary of War and of the
Navy for approval." The power to
approve implies the power to dis-
approve. But the section says
further, "provided that no liability
or expenditure shall be incurred
without the approval in writing of
the Commander-in-Chief" etc. This
confers the authority to incur ex-
penditure solely on the Commander-
in-Chief, and it is nowhere expressly
given to the Secretary. The Com-
mander-in-Chief is further required
to "cause proper vouchers for the
same (the expenditure) to accom-
pany each requisition for a draft
upon the Public Treasury, which
voucher shall be retained by the
Secretary." This would imply that
the Commander-in-Chief is to send
a requisition for a draft to the
Secretary who is to make the draft
on the Treasury. But it is incon-
sistent with the previous part of
this section and with section 1,
which, as we have seen, confer the
power on the Secretary merely of
approving the drafts, and not of
drawing them.

It is difficult to make sense out
of this law. It is absurd to require
the "acceptance and approval" by
the Secretary of a draft which he is
himself to draw, and it is equally
absurd to make the written approval
of the Commander-in-Chief the only
authority for the expenditure of
money or incurring of liability and
at the same time to require the ap-
proval of the Secretary upon drafts
for their payment. If the Com-
mander-in-Chief has authorized the
incurring of any liability the law is
satisfied and the Secretary must
"approve."

In our opinion the Act does not
invest the Secretary of War and of
the Navy or any other Cabinet Min-
ister with any control of the dis-
bursements for account of the mili-
tary or naval organization. But a
law which places the responsibility
for the disbursement of public mo-
nies beyond the control of any re-
sponsible Minister of the Crown, is
not by that fact unconstitutional. It
may be unwise to do so and the
Legislature may not have intended
it in this case. Still it is not un-
precedented. By the terms of Sec-
tion 49 of the Act regulating the
Bureau of Public Instruction (Com-
piled Laws p. 213) the Board of
Education is "invested with full
power to apportion and disburse the
various monies and avails devoted
to the promotion of public educa-
tion."

By Section 9 of the Auditor-Gen-
eral's Act (page 671 Compiled
Laws) "every account shall be con-
sidered duly authorized that is in
accordance with any existing law
or regulation, or has been directly
sanctioned by one or other of the
responsible Ministers of the Crown,
and covered by any Appropriation
Act in force at the time of pay-
ment."

The latter part of Section 4 of the
Act under consideration reads that
"appropriations for defraying the
cost of the King's Guard, volunteer
or other military or naval organiza-
tion, under and by virtue of any law
or enactment in force in this King-
dom, shall be expended and ac-
counted for as provided for by this
Act." If the Act be considered as
unconstitutional and inoperative in
respect to the disbursement of the
military and naval appropriations
by reason of there being no legal
Commander-in-Chief to incur liabil-
ity and disburse the funds, there
will be no difficulty in resorting then
to the Appropriation Bill. The
items for military are included in
this Act in the Department of the
Minister of Foreign Affairs, who
can draw upon these appropriations
on his ministerial responsibility.

The third reason alleged is thus
stated, "That Section 4 of said Act
in the second paragraph thereof pur-
ports to appropriate for the purposes
of carrying this Act into effect the
sum of twenty-one thousand dollars
for each biennial period, thus pur-
porting in effect to bind succeeding
Legislatures to the support of the
purposes set forth in the Act."

The paragraph referred to reads,
"There shall be appropriated and
applied to such purpose from monies
in the Public Treasury not otherwise
appropriated, the sum of twenty-
one thousand dollars for each biennial
period."

We take it that the words "not
otherwise appropriated" mean not
appropriated by the general Approp-
riation Bill which is authorized by
the 75th Article of the Constitution.
"The Legislature votes the approp-
riations biennially" &c. And there
is force in the view that monies ap-
propriated by a law, the item for
which is not in the Appropriation
Bill, cannot be drawn except from a
surplus in the Treasury after all the
items in the Appropriation Bill have
been met. In this country this con-
dition of the Treasury could not be
ascertained until the close of the
biennial period. But the fourth
of the Appropriation Bill for 1886-8
reads, "The Minister of Finance
shall not cause or allow to be paid
from the Treasury any money for
objects not authorized by this law"—
except under the provisions of this
general enactment controlled.

We are of opinion that one Legis-
lature cannot bind its successor to
the voting of appropriations where
no legal rights of third parties are
involved. But the item for the section
military and naval organization ap-
pearing in the Appropriation Bill as
well as in the Act under considera-
tion, further discussion of it is
unnecessary.

The fourth reason as suggested in
your letter is:

Fourth—"That Section 5 of the
said Act provides for the making
and promulgation by a body or au-
thority other than the Legislature of
this Kingdom of a code of rules and
regulations to be entitled the "Reg-
ulations of the Army and Navy"
which rules and regulations are by
said Act (Section 7) invested in ad-
vance with the force and effect of
law, and violations of the same are
made penal."

Says Cooley on Constitutional Li-
mitations p. 116, "One of the set-
tled maxims on constitutional law is,
that the power conferred upon the
Legislature to make laws cannot be
delegated by that department to
any other body or authority."

But there are some matters of
mere regulation the authority to
make which can be delegated by the
Legislature without an infringement
on the Constitution.
An instance of this is that given
by Section 668 of the Civil Code to
the Minister of Finance to make
regulations for the collection of du-
ties and the transaction of the busi-
ness of custom houses &c., and the
power given by Section 833 of the
Civil Code to the Supreme Court to
make rules for regulating the
practice in the Courts. Until we
should be shown the "Rules and
Regulations" promulgated by the
Chief of Staff under the authority of
Section 5 of the Act, it would be
impossible to say whether they
amounted to an attempt to exercise
powers of legislation, or infringed
upon the functions of the Legisla-
ture. If, however, these "Rules
and Regulations" imposed penalties
they would be inoperative and void
as repugnant to the Constitution.

The second question asked is,
"Whether laws or parts of laws if any
are repealed by Section 12 of this
Act."
If the Legislature should intend
to repeal any specific law it would
be better to indicate it, for it cannot
be known what laws are repealed by
implication or by general words, as
used in Section 12 of this Act, until
there has been a judicial decision to
that effect.

From such investigation as we are
able to give to the matter, we find
only one law which would be re-
pealed by the Act under discussion.
It is the Act of the 1st of August,
1874, being chapter xxxix. of the
Session Laws of 1874. This Act
abolished the office of Secretary of
War and of the Navy and author-
ized His Majesty by special commis-
sion to a Commander-in-Chief. This
appointment was never made, as
we have been informed, owing to
the belief that the law authorizing
the appointment of a Commander-
in-Chief was repugnant to the 26th
Article of the Constitution then in

THE LOUISIANA SUGAR INDUSTRY.

It is becoming evident that the sugar industry of this State needs new methods instilled into it to meet with success and bring profit to those engaged with it. The sugar planters of Louisiana are among the most energetic and progressive of its citizens, but they have found it no easy matter to make money at raising sugar. The overproduction of this article has forced down the price to the minimum figure, and, moreover, other countries have improved the machinery and methods used in the manufacture of sugar and obtained better results. Louisiana must do the same if she wishes to hold on to this industry, which was once her greatest source of profit.

The following facts are now universally recognized by those who know anything of the manufacture of sugar:

(1) The ordinary three-roller mill and open kettle, or steam train apparatus, is not obtaining from a ton of sugar cane more than an average of 100 pounds per ton. With the price of sugar ranging about three and one-half to four cents per pound for centrifugal, the business does not pay. Take a series of years, good, bad and indifferent, it is doubtful whether the planter can make both ends meet. It is generally conceded that unless the price of sugar advances the planter, with the ordinary apparatus in use, is bound to cease the culture of sugar cane.

(2) From the enormous quantity of beet sugar thrown on the markets of the world, through the operation of the bounty system of Germany and France, and from the economical methods adopted in other countries, it is to be feared that the price will not advance.

(3) The question then with the sugar interests is abandonment or change of method of manufacture, taking for granted that our method of agriculture, if imperfect, is sufficiently advanced to produce profitable results if not hampered by inefficient manufacture of the raw material.

There are not 5 per cent of the sugar planters who have adopted the recent improvements whereby larger yields of sugar per ton are obtained at less cost. There is not a single central factory in the State. The few planters who purchase cane by the ton merely supplement their own crops with small outside purchases.

The co-operative system, involving a union among contiguous planters, and embracing two departments, the manufacturing and agricultural, is nowhere in Louisiana a fact as yet. The planters of St. Mary and a number of citizens not planters have initiated a movement looking towards such co-operative action.

The adoption of this system is a matter of vital necessity. The sugar trade is one of the bases of the commercial prosperity of New Orleans. The people of St. Mary are doing their best to establish this new system of sugar cultivation and manufacture in Louisiana. They should have the assistance of all the sugar districts and particularly of New Orleans, so interested in the revival and encouragement of this industry. The enterprise has more than a local interest and bearing, for its success will place the sugar interest on a substantial basis. We hope, therefore, that the new movement will receive the cordial support and assistance it deserves.—New Orleans Times-Democrat.

JEFF DAVIS' CABINET MINISTERS.

The death of R. M. T. Hunter of Virginia, who was a member of the Confederate Cabinet, leaves but three of the entire number still surviving. There were fourteen in all who held Cabinet positions under Mr. Davis during the existence of the Confederate Government. There survive Congressman Reagan, who was Postmaster-General of the Confederacy from first to last; Thomas H. Watts of Alabama, who was Attorney-General for a short time, and George E. Davis of North Carolina, who also filled that position for a few months. Mr. Reagan lives at Palestine, Texas, and has been a member of the House for many years, and is now elected to the Senate. Mr. Watts lives at Montgomery, Ala., is a very active man, still engaged in the practice of law. Mr. Davis of North Carolina still lives at Washington, practicing law. It seems a little curious that of the fourteen that served with Jeff Davis eleven should have died before him. Perhaps he may outlive all of them, for he seems to be active, both physically and mentally, if we are to judge from the frequency with which he is heard from on the current topics of the day. He is now in his eightieth year, having been born June 3, 1808. The eleven deceased members of the Confederate Cabinet are: Benjamin, Bragg, Breckinridge, Hunter, Mallory, Memminger, Randolph, Selden, Tombs, Trenholm and Walker. Reagan is the only member of the original Cabinet left. Tombs, the first Secretary of State; Memminger, the first Secretary of the Treasury; Mallory, the first Secretary of the Navy; and Walker, the first Secretary of War, having all passed away.—[N. O. Item.]

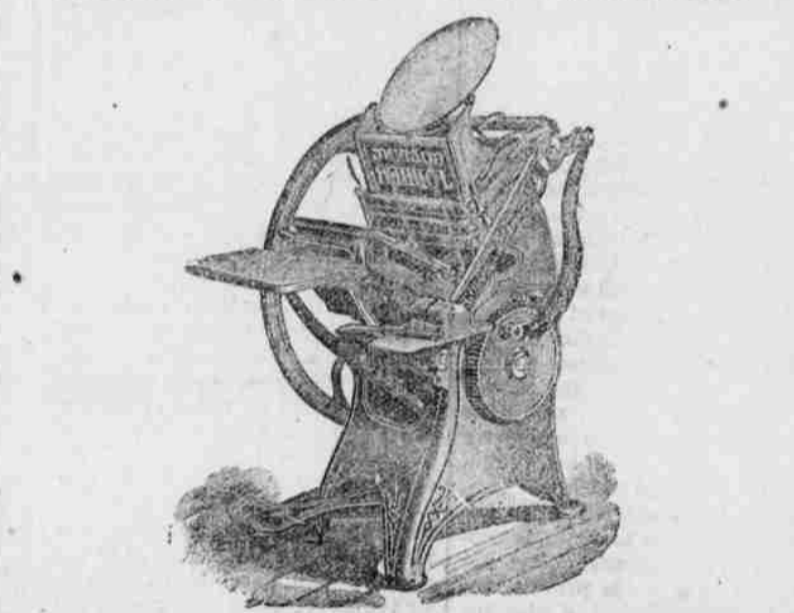

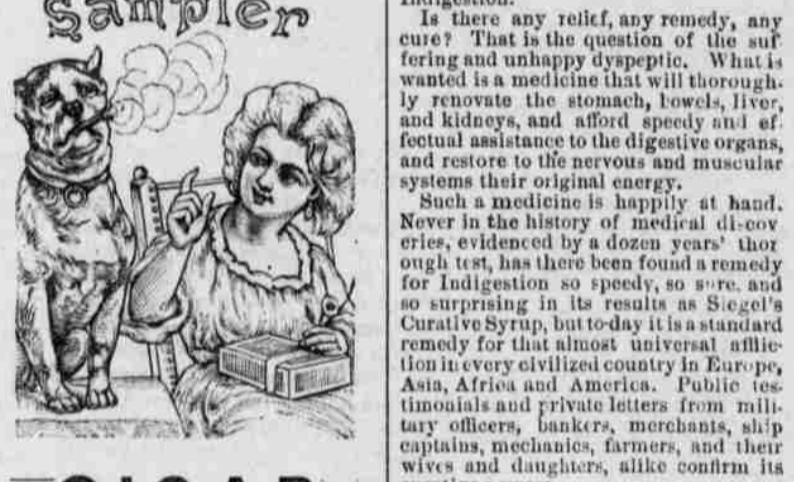
