PAGTA TI KALON

We, the members of the United Communities of the Cordillera, who are hereby gathered here today in Tiempo, Tubo, Abra for two days from January 25-26, 1979, witness and stand these agreements of the people called 'PAGTA' :

1. All members of this federation are prohibited from working in CRC and other companies which destroy the means of livelihood of the members of the said federation.
2. Any member of the federation who guides CRC is strictly prohibited.
3. Nobody is allowed to make transactions with CRC and other companies like mining without first consulting the peace pact holder and the residents of the place.
4. Anyone who is discovered bribed by CRC and other companies will be punished.
5. The federation will work as one to support any person who is put to court due to CRC opposition.
6. Any member of the federation who violates these promulgated rules will be punished accordingly.
7. There is an annual meeting of the federation except when there are emergency cases.

7. Adda regular meeting daguiti Council ti federation mamin-san iti makatawen kalaksidan iti emergency.
