## Republicans Meet To Plan For Campaign Work

The first meeting of the Republican Central Committee for serious campaign business will be held at the headquarters on Fort street tonight. The purpose of the meeting is to thoroughly canvass the situation and plan the campaign. Chairman Robertson said this morning that no definite plans had been settled upon but that the entire business would be rounded up tonight. It is probable that a big meeting will be arranged to be held at the Orpheum next Saturday night. It is expected that Kuhio will be back from Hawaii and ready to occupy the center of the stage on Oahu for a while.

The executive committee of the Fourth District also meets tonight to talk over plans for the campaign in that district. The meeting will be held at the district headquarters just opened up in the Podmore building at the corner of Alakea and Merchant streets. The headquarters of the Fourth District are admirably arranged for business and campaign work.

There is a private office for the president and the secretary, a general office and reception room and an assembly room capable of seating 250 people. This headquarters will be a storm center for Republicanism during the next six weeks.

Tonight the executive committee of the Fourth, among other matters will consider that of having a formal banner raising for the district at an early date, probably this week. The banner will be thrown across Alakea street and it is hoped to make the occasion an enthusiastic one for the good of the party. Tonight, the committee will also arrange a schedule of meetings to be held in the Fourth and make out a list of the campaign speakers available. Regular meeting nights at Fourth District headquarters will be Thursday of each week.

The Fifth District Republican executive committee will meet tomorrow night at Fifth District headquarters to outline the campaign work in that section. Chairman Vida requests that all members be present.

## Democrats Look For Legislature

The Legislative ticket to be put in the field on this island by the Democrats is now absorbing the attention of Democratic leaders. There has been no little difficulty in finding good men who will consent to go on the ticket. Both the Fourth and Fifth District Democrats will hold caucuses tomorrow night and give the bushes a good heating in the hope of securing enough material to fill the lists.

Democrats of all types wanted W. A. Kinney to run for the Senate but it is stated that Mr. Kinney refuses to seek office of any kind and will not allow the name to go before the Democratic convention.

So far the list of candidates discussed among Democrats as possibilities contain the following names: Frank Harvey, S. M. Damon, J. O. Carter, J. W. Erving, R. H. Trent and Manasse. Until his recent illness, August Drier was considered a strong Senatorial possibility.

The timber for the House is said to contain such names as J. K. Prendergast, Shanks Mossman, Nauakana, Hlyases Jones, Phillip and Damien. In the Fourth the men talked of in Democratic circles for the House are Kiasina, Chas. McCarthy, A. Wilder, Maka Wai and Sam Kaloa.

## Sen Palmer Woods Predicts Democratic Success

Senator Palmer Woods of Kohala is in the city, and speaking of the political situation in Kohala and on the island of Hawaii generally, he said: "I am confident of Democratic success on Hawaii. I have not been around enough to form a definite opinion on the Delegate fight, but we are going to make things hum for our legislative ticket. Kuhio was through our district last week and reported that the Waipio valley people had gone over in a body to our party. He said there were only six Home Rulers left in that valley."

"In Kohala, Kuhio's canvass was poorly managed by the Republican leaders and he had small audiences.

"We will hold our district convention at Kohala Wednesday. I expect to see my brother, Frank Woods, nominated for the Senate. J. Burgess and Makahalana are in the lead for the House. With O. T. Shipman to strengthen us in East Hawaii, I think you can count on a Democratic Senatorial delegation in the next Legislature. The people up our way are getting tired of the political methods of 'Strenuous George' and 'Ambitious Jack' and this feeling will show in the vote. It's all because they have made so many promises that they couldn't carry them out."

## Dietz And Norton Swear To Cross Complaints

Gerhart Dietz, the watchmaker, and George P. Norton, a Rapid Transit employe, this afternoon each swore to a general summons against the other. The trouble between the two arose on account of a watch belonging to Norton which Dietz was repairing. Norton alleges that on September 10 Dietz pulled a loaded revolver on him while Dietz in his turn alleges that Norton committed an assault and battery on him on Fort street today.

Norton says that Dietz had been repairing a watch for him but had failed to put the watch in order and that a dispute arose between them on account of this fact, which ended in Dietz's threatening him with a gun. Dietz says that Norton refused to pay for the repairs. He denies that he pulled a gun on Norton.

## Gear Says Gambling In Honolulu Is Conducted Openly

"Gambling games are being run openly in Honolulu every day," declared Judge Gear from the bench in criminal court this morning. "but, of course, that is no reason, why, having been found guilty of a jury, sentence should not be passed on this defendant."

Chew It, convicted of having lottery (che fa) tickets in his possession, was up for sentence this morning and the court found occasion to make a few timely remarks on the general condition of the city as to gambling. "One can walk along the city streets, in certain quarters," continued His Honor, "and observe gambling operations under way in the broad light of day; men can be seen opening the envelopes containing che fa tickets, making no secret of it."

"When the police do go after the gamblers and convictions are secured, this court will pass sentence."

"Chew It's daughter has called on the court to plead for her father, but I fail to see that there is much cause for leniency here."

"I understand that for some fifteen years the defendant has been engaged in gambling and that there are sixty-seven or eighty gambling establishments in Honolulu. It seems that this man has perjured himself on the witness stand. The mere fact that gambling is conducted openly does not excuse this defendant. He is old! This fact the court will take into consideration and sentence Chew It to thirty days' imprisonment."

Chew It, who had asked the court to pardon him, was strongly affected when the sentence was interpreted.

When the case of the Territory against Dan Kamai Kahili, alleged manslaughter, was called, both Attorneys J. J. Dunne and S. F. Chillingworth, on the calendar as representing the accused, arose to explain that they were no longer retained in the case. Dunne had been informed by defendant's relatives that his services were not required and Chillingworth, who had appeared for defense in Police Court, receiving only a small fee, had also been "discontinued" by the relatives of the accused.

Prosper stated that Dunne and Chillingworth had been passing the case up to each other, as senior counsel, since the beginning of the term.

Dunne declared that he knew nothing of the case.

"What is the court to do?" asked Judge Gear.

"I would suggest that some young and vigorous member of the bar be appointed by the court to defend this man," said Dunne.

The court replied: "I know of no more vigorous member of the bar than J. J. Dunne."

The subject of this remark claimed strenuous business engagements in the Federal Court and mentioned the name of J. W. Cathcart as being that of a young and vigorous attorney.

Cathcart, who has a reputation for philanthropy, confined his comment to a patient laugh.

Judge Gear was forced to call for volunteers. To his beechment there was no response until S. F. Chillingworth, who had said the defendant's friends had dismissed him, came forward with an offer to be ready in the case this afternoon.

Both Judge Gear and Deputy Attorney General M. F. Prosser thanked Mr. Chillingworth for his accommodation.

## INDICTED FOR HARRIS MURDER

Grand Jury Returns 25 True Bills For a Starter

ASKS TWO WEEKS REST PENDING FURTHER TOIL

GEAR MAY HAVE A CHARGE TO MAKE TOMORROW — THREE PRESENTMENTS ON OPEN FILE.

Territorial Grand Jury processed before Judge Gear's bench at 10:40 o'clock this morning, headed by Foreman J. D. Tucker and Deputy Attorney General E. C. Peters and flanked by Bailiff Eugene Buffandeau, and handed up a bunch of indictments to the number of twenty-five.

Peters, speaking for the inquisition, asked that all cases in which the defendants were already in custody be placed on the open file and that all cases in which accused persons were at large be placed on the secret file.

In accordance with this request twenty-two matters were veiled in mystery and a humble trio of true bills received the light of publicity.

It is understood that the secret affairs include gambling, burglary, larceny, headless driving and liquor charges, to say nothing of one or two matters of a more serious nature.

Of the three open file indictments one names as defendant E. Geneau, charged with murder in the first degree. Geneau is alleged to have, with intent and malice aforethought, etc., intended to kill one Amos Kinnard but, while intending to send Amos to kingdom-come, (Continued on Page 4.)

## Many Restaurant Keepers Arrested

Ab Yong, Hop Kee, Lum Sun Yuen, You Lee, W. A. Chun, Tam Hon, Hop Sing Lung and Chee Won appeared before Judge Lindsay this morning, charged with keeping restaurants without having the required license. On June 9 of this year Judge Gear in his decision in the case of the Territory vs. Frank Lucewoko, charged with keeping a lodging house without a license, declared this section of the Penal Code unconstitutional. The police are endeavoring to get the matter before the Supreme Court for a decision, hence the arrests mentioned. The cases of all the defendants were continued until next Wednesday.

## Cecil Brown Will Run For Senate As Independent Republican

"I shall run as an independent Republican candidate for the Territorial Senate." Cecil Brown thus announced his intentions to Attorney General Lorrin Andrews, who is chairman of the Fourth District Committee at the Capitol this morning.

Mr. Brown's position is that his defeat by the Republican Senatorial convention was encompassed by the manipulation of the Attorney General and office holders of the administration. He believes that left to the unhampered vote of the people, he would have secured the nomination and consequently is convinced that in a straight appeal to the voters of the island he will be successful.

Mr. Brown's decision will make a very complex situation on this island. He has led every Republican ticket and is considered one of the strongest vote getters on the island. Hitherto independent candidates have had a mighty hard row to hoe, but none of

those who have tried it have possessed the popularity of Brown. Mr. Brown states that he has been assured of the support of independent men on all sides, notwithstanding other friends who are sticklers for party regularity have urged him not to make the fight.

SEAL POACHER CAUGHT.

Vladivostok, Sept. 18.—An English seal poacher has been captured at the Pribyloff Islands. The crew was imprisoned and the schooner sunk.

ITALIAN SOCIALISTS.

Genoa, Sept. 18.—The situation in Italy, from the aggressive conduct of the Socialists, has become serious.

HERBERT BISMARCK DEAD.

Friedrichshagen, Sept. 18.—Herbert von Bismarck is dead.

PORT ARTHUR CONDITIONS.

Chefoo, Sept. 18.—Prince Radzivil has arrived from Port Arthur with dispatches for General Kuropatkin. He says that the combatants are merciless. JAPAN WANTS CAPITAL.

Tokyo, Sept. 18.—A movement is growing here for the removing of all obstacles to the introduction of foreign capital into Japan.

JAPANESE CAPTURE STORES.

Washington, Sept. 18, 1904. To Miki Saito, Japanese Consul, Honolulu. Field Marshal Oyama reports as follows:

The trophies we secured through the occupation of Liaoyang greatly exceeded our expectations and, although all of the stores have not yet been assorted and counted, our captures, as far as we can ascertain, up to September 17th, not mentioning a great quantity of minor trophies, were as follows:

Three thousand five hundred and seventy-eight (3,578) rifles, 1,638,730 rounds of rifle ammunition, 10,056 shells, 129 ammunition carts, 15,255 shovels, 5639 plows, 2560 axes, three electric signalling machines and three reflecting mirrors; six field telephones, 18,915 barrels of preserved beef, 2500 timbers, each one and one-half feet in diameter; 100,256 bushels rice, 69,897 bushels grain, 50,128 bushels flour and 6400 army overcoats.

In addition to this we captured large quantities of spare railway material and coal mining machinery. Other items in great quantity consisted of telephone and telegraph wire and kerosene oil.

As prisoners we took thirteen Russian non-commissioned officers and men.

Socialism is stirring Italy. It will be interesting to know how far this so-called socialism is promoted by Italian immigrants returned from the United States and anxious to have the same thing at home.

St. Petersburg does not expect the Japanese to attack immediately because Kuropatkin has received reinforcements. The unexpected has been happening to the Russians since the campaign opened.

Japan is assuming a more lenient attitude toward foreign capital. The necessities of war are opening the door which foreign business men from Japan represent as closely guarded by "cocky" self-sufficient citizens.

Some day, Republican voters will learn that the primaries furnish the place to make party fights. Whining over the result after the conventions are held creates the nucleus of party bolters and party defeat.

### THURSTON'S KNIFE OUT.

Republican nominations for the Representatives of the Fifth District are no sooner made than the organ of frenzied hypocrisy calls upon the wrath of God and man to strike the combination if it possesses the first scintilla of capacity or law-making ability can by any means known to man be squeezed out of the bunch.

Wise men whose forethoughts come afterwards are things of beauty. The dust they kick up to mislead thoughtless humanity as to the responsibility for what they class as political errors, doesn't fool anyone but themselves.

If the Fifth District Republican ticket is not sufficiently aristocratic to suit the frenzied hypocrites, who is at fault?

Delegates to the Fifth District convention were elected at primaries held only a few weeks ago. We trust it is not necessary to explain at this late date the purpose of a primary, though to hear the comment now offered one might think that the first intimation that a primary election was ever held dawned on the dull brain of the critics the morning after the convention.

Take the Ninth Precinct of the Fifth District as a fair sample, it being the home of Governor Carter, P. C. Jones, W. O. Smith, L. A. Thurston and numerous other representatives of sense and nonsense as well as Jim Shaw, one of the candidates whose nomination Thurston's organ now bewails. The quintessence of political wisdom ought to come out of this precinct. Going back over recent political history we find that Thurston, for instance, was very active in this precinct to defeat a resolution endorsing county government. The Republican convention state was made up. It seemed to suit everybody, or at least no one was sufficiently interested to raise a contest. The precinct nominations, the primary election, the oceanous and the place for contests in behalf of the representation for which Thurston's paper now cries out were passed along as quietly, peacefully and as overflowing with brotherly love and political affection as a Quaker camp meeting. We do not recall that there was any extraordinary howl about Candidate Shaw at that time, though every citizen not a knave or an idiot knows that the primary election is the proper place to pave the way for legislative representatives.

Precinct to aspire for representation, the Ninth picked one of its favorite sons from the ranks of business men and slated him for the Senate. Possibly the House was beneath its dignity. This was done when the Senatorial ticket was already well looked out for, from the business standpoint in the candidates of the Fourth District, and every principle of fair dealing pointed the justice of the laboring classes having some representation. When the Ninth Precinct's candidate for the Senate was beaten in the district caucus, the Ninth laid down. From the ticket-critic's present viewpoint the Ninth allowed the Representative ticket to go to the demitition bowwows and then cursed fate when it went. So far as Jim Shaw is concerned we have no doubt that for honesty of purpose and desire to answer the demand of the people he is head and shoulders above the organ that bunches him in its sneers at the ticket finally produced.

What the Bulletin would like to know of these political Rip Van Winkles who now arise to complain, is why this array of might-have-been candidates was not trotted out before the primaries, or during the primaries, before the convention or during the convention.

Believing Fifth District Republicans to be men of average intelligence the Bulletin and party men generally, have taken it for granted that the result of the primaries and conventions would be to place before the people such men as the Fifth District Republicans deemed capable of properly representing them. There is no sign that the "better men" were manipulated out of the game. They were never put up. Delegates did not have the opportunity to vote them in or out. Their names are not mentioned till the nominations are made.

Another fact to be taken into consideration is that a paper that has cheered Birbeism and all the profane rowdyism it stood for—till the decent men of the Fifth District wiped it out—is playing a part of frenzied hypocrisy when it bewails about the Fifth District Representative ticket. When the Thurstonian tin gods explain why they used Birbe as a political Sunday school teacher, then the people may be able to discern why the men who helped make the Fifth District ticket and watched its development without a murmur, now rise up and declare it to be an aggregation of men "whose duplicates" it says "you can see any day sprawled at a luau listening, half asleep, to the taro-patch fiddle or calling obstreperously for gin."

There are increasing evidences that Mr. Thurston and his paper have no love for the Carter administration and would gladly accomplish the defeat of the Republican Congressional and Legislative ticket in the coming campaign.

### TEACHER-POLICEMAN

Editor Evening Bulletin:—I wish to make public the manner in which the Kawahae school is conducted. I have received complaints from parents of pupils on this head. The present teacher barely knows a word of English and certainly not enough to teach. He has sent away (home) pupils from the school, giving them no reasons and no explanation to parents, although they are of a proper age to attend the school. Instead of spending the greater part of their time in the school the children are made to do dirty work in the yard, such as carrying stones in their clean clothes and sweeping the yard, also to clean up the teacher's own apartments and carrying washing water for his family and guest's use.

He continually makes use of the school house for holding prayer meetings, which he makes the pupils attend in the interest of the church he is a member of—which is violating the general rule of the government schools. The most serious charge is that the children are refused the use of the toilet part of the school premises and sent out into the wilds, while he reserves it for his own family use and that of his guests who are continually there.

Although the parents are dissatisfied with all these matters they are afraid to remonstrate with him about it because he is a policeman. They have been obliged to send their children to other schools, away from home. We really want a more competent teacher in Kawahae and these are plentiful in the Normal school, Honolulu.

### INDICTED FOR MURDER

put a bullet into one U. S. Harris, from the effects of which bullet Harris died. The killing of the negro, Harris, is a matter of recent history. He was shot in the Pantheon Saloon on Hotel street.

Geneau was a seaman aboard the U. S. gunboat Wheeling, then in port. He is supposed to have had some quarrel with a shipmate, Amos Kinnard, and was said to be looking for Amos with a gun. Going into the Pantheon, in his search, his eyes fell upon Harris at the bar. Some say he mistook Harris for Amos; others say that when, upon seeing Geneau enter with a drawn gun,

bystanders attempted to wrest the weapon from the marine, the pistol was discharged, accidentally or otherwise, and a ball entered the left side of the abdomen and death resulted at the Queen's Hospital within a few days.

Amos Kinnard, a negro, was one of the witnesses before the Grand Jury. It is understood that he was anything but a willing witness; that he was most circumspect in regard to his testimony.

The indictment does not allege intent to kill Harris; it is charged that Geneau intended to murder Kinnard but that Harris proved the victim. Fujimoto is indicted for burglary, first degree. He is charged with entering the store of Benjo Hayashi on August 5th.

J. Borgeo is indicted, with Tom Larkin, for first degree burglary, being charged with forcing the Kalihl Grocery Store.

After filing the true bills, Peters stated that the Grand Jury, having completed all work on hand, desired to be excused until October 3rd, when further work would probably be ready for handling.

Judge Gear, however, excused the inquisitioners until 10 o'clock tomorrow morning when he will consider excusing them further. Possibly the court has some charge to make.

### DEMOCRATS FOR CRAWFORD

The Chinese Republican Club will hold a meeting at its quarters on King street tomorrow night. The purpose is said to be to consider the failure of Wm. Crawford to get nominated as Representative.

Crawford states he has been offered a nomination on the Democratic ticket by prominent Democrats. He is at present considering the matter.

### MOB ASSAULTS TANAKA

High Sheriff Brown today received a letter from Sheriff Coney of Kauai which gives the details of the mobbing of a Japanese officer at Kilauea, a partial report of which was published in the Bulletin last week. It turns out that the officer in question was Tanaka, who some time ago distinguished himself by doing valuable work in connection with the arrest of the Japanese who blew up Mr. Glennau with giant powder. An excerpt from Sheriff Coney's letter follows:

"I beg to report to you that on the 13th inst. I sent Officer Tanaka to Kilauea to look for an escaped prisoner and while there and in the house of Officer Gomez, at about 10 o'clock at night, the house was surrounded by 250 to 300 Japs, who demanded that Tanaka come out of the house and threatened to do up Gomez if he did not surrender Tanaka to them. Manager Moore was telephoned for. He arrived on the scene and tried to persuade the Japs to go back to their houses, but the Japs refused to do so and insisted that Tanaka be turned over to them.

"After a great deal of talking they finally agreed to let Tanaka get to the Government road. On reaching the road he found it blocked in front and back of him by the mob which immediately began to assault him with sticks and stones by the aid of lights from bonfires built by them on the road, all the while yelling, 'Kill him, he is a Jap policeman.'

"Tanaka fired several shots in the air, which checked the mob for a while. At that time he made a break for liberty but his horse got caught in a rope which they had stretched across the road and finally threw him to the ground. He saw his chance to escape through the cane field and was found by the officers very much bruised up, his horse in the same condition and his saddle destroyed.

"I can not speak too highly of Tanaka's level head and pluck in handling the situation as an officer against the cowardly mob of Japs. I have not made any arrests as yet as the mobbing was done at night and it is almost impossible to identify any of the mob but I hope to be able to make an arrest before long as I do not intend to let up until I have the guilty parties behind the bars.

"The Japs have it in for Tanaka and are laying for him on account of the recent liquor arrests. Kilauea has an unusually bad lot of Japs. Any help or advice you can give me in this matter will be highly appreciated by me."

The American schooner James Tuft arrived from Hakodate yesterday with a part cargo of 1450 tons of sulphur. She was stopped several times by Japanese war vessels but had no trouble with them.

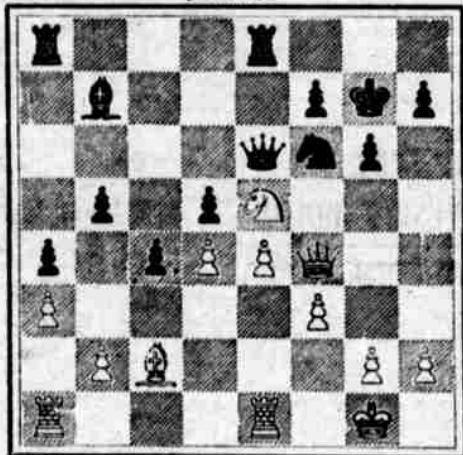

Lindsay of Honokaa has rented Frank Johnson's Waimea place. She and her children will make quite a stay in the neighborhood. The Misses Verre and Louise Greenfield are staying with her. The telephone (South Kohala-Hanalei) system has been so busy lately sending telegrams and repeating them and correcting mistakes, that the new telegraph land line would be a great relief to the telephone subscribers, even if it proved a loss or unnecessary to the wireless company. Mrs. S. M. Spencer entertained some friends at an afternoon tea on the 12th inst. Those present were Mrs. David Forbes of Kukunahale, Mrs. A. B. Lindsay, Miss Vere and Miss Louise Greenfield, all of Honokaa, and Miss Margaret Kaunauau. Samuel Parker and E. P. Low arrived at Kawaihae by the Kinau on the morning of the 14th inst. They continued their journey to Manu through Waimea. It is quite six months since Mr. Parker paid his last visit to the ranch. He returns to Honolulu tonight by the same boat. Mrs. A. B. Lindsay gave an afternoon tea on the 16th inst. Among those present were Mrs. S. M. Spencer, Mrs. David Forbes, Miss Margaret Kaunauau, Miss Jeanette Spencer, Miss Vere and Miss Louise Greenfield. Samuel Parker Jr. of the Humuhu sheep ranch will ship a large flock of sheep by the Kinau from Kawaihae tonight, Friday, Sept. 16th. The Hon. Wm. N. Purdy of Honokaa has again taken up the fish business, purveying fish from Kawaihae to Hanalei. Prince Cupid, accompanied by John Wise and A. S. Mahaulu, arrived in Waimea from Waipio on the night of Sept. 10th. They were guests at the Akona hotel during their stay. LAUNCH RACE TALK Clarence Macfarlane, who was the original promoter of the launch race Regatta Day and who won the race with his launch Julie, is not pleased with the insinuations that he fixed the race for himself with his influence with the handicapping committee. On this subject, Mr. Macfarlane said to a Bulletin reporter: "There has been a lot of talk about the launch handicaps Saturday, and it has been said that I was a party to the handicapping. I wish to say to the public at large that I was the one who introduced launch racing, being interested in power boats. In response to a request I received from the American Power Boat Co., their rules and regulations for handicapping in launch racing. It was decided that Alex. Lytle should take the measurements of the different launches and turned over to him the book of rules and regulations. I was told by Mr. Lytle, the day before the race, when he showed me the handicap list that the launch owners were satisfied with it. I said that I also was willing to abide by the handicaps he had set down according to the rules. "In the race I was more than satisfied with the way the engine in my boat performed its work from start to finish. I think that every bit of power that could be gotten out of an engine was accomplished in this case. If any of the launch owners have the idea that they can beat my boat in a race according to the rules of the American Power Boat Association, from the Waterwitch down, I am ready to make a match. I will also be willing to name their own party to do the handicapping. "I do not wish to appear anxious to get into the racing business, but I am anxious to clear myself of the accusations of the past few days and demonstrate also the superiority of my engines."

## Books, Bookish People and Things

We get so good by being ungenerous even to a book.

E. B. Browning.

The following from "Here and There," by H. T. Peck, is too good to enjoy alone, so the Bulletin Bookman copies it for the pleasure of our readers:

"We have always recognized and admired the devotion of the English to fair play. It is indeed, a commodity of which they are so fond as to keep it mainly for home consumption. For foreigners, including Americans, seldom have a chance to see it. Englishmen are good losers—to other Englishmen. If they happen to be vanquished by opponents of a different nationality, then instead of yielding gracefully and admitting that they have been fairly beaten, they are very apt to raise the cry of 'Foul!' just as a French army, when defeated by superior numbers and abler strategy, breaks into the sinister shriek of 'Treason!'"

"As Englishmen in their own eyes are the perfect flower of the human race, it is inconceivable by them that in a fair field and with no favor they can ever be surpassed. If they are surpassed, then the field was not fair, and the adversary enjoyed illicit favor."

"Thus when the schooner yacht 'America' went over to England in 1851, and costily out sailed all the English boats and won the famous cup, the first thought that entered the English mind was that the whole thing was a 'Yankee trick.'"

"It was asserted and believed that the 'America' had some kind of engine concealed in her stern, and this belief became so general that the owners of the 'America' allowed their vessel to be searched. It never occurred to the Englishmen that searched it that their action was an insult and the grossest violation of the most elementary rules of courtesy and hospitality. They did it just because their rivals were Americans and not fellow-Englishmen."

"The fact that no British boat has yet succeeded in bringing back the cup is evidence to many Englishmen that the conditions here for racing are so craftily arranged as to favor the defender and defeat the challenger."

"The English papers used to be full of complaints that the excursion boats got in the way of the British skipper and tried to make him lose the race. Of course, it was obvious enough that it was only the losing yacht which could possibly be hampered by the excursion fleet, but this made no difference."

"When Lord Dunraven made his most unmanly and unmanly exit several years ago, he did so after implying that the American yachtsmen had secretly and by night shifted the ballast of the defender. Lord Dunraven would never have thought of making such a charge against any kind of Englishman. He would not have believed them capable of fraud, and had he expressed a suspicion of the sort he would have been ostracised as a cad."

"But here it was different. His attitude was extremely significant of that which makes his countrymen so impossible. No Englishman in his heart of hearts thinks that any one save an Englishman can be a gentleman in the full English sense of that fine word. As a facon de parler he will speak of an American gentleman, or a French gentleman, or a Spanish gentleman, but he will always mentally class them as a different category and as constituting a different species from that which is represented by a gentleman of England. He will never ascribe to any foreigner the same high standards of good faith and honor which he himself professes to maintain."

"We can see no justification against the American rifle team which won the Palma Trophy. It was understood that the competing teams were to shoot with the regular service arm of their respective countries. Now the United States troops were at that time actually using the Krag-Jorgensen rifle which the Government had officially adopted the new Springfield model."

"Not unnaturally, therefore, the team representing the National Rifle Association of America took with them to England both the type of rifle with which our army was at the time equipped and also the other type of rifle which was presently to be issued. The Americans asked the captains of the competing teams whether there was any objection to the use of the new model, and finding that no objection was made, they employed that model and won the match. Had they been wise, and skilled in the ways of Englishmen, they would have had the whole thing down in writing; but they were unsuspecting souls and thought that a verbal agreement between sportsmen was quite as good as any bond."

"Now long after the event is over, the Rifle Association of Great Britain has discovered that the trophy was won by fraud and that the Americans used one form of rifle while professing to use another."

"Apparently, it is denied that the English understood about the two different models and so the British press is thundering over the alleged dishonorable conduct of the American riflemen and saying that no reputable sportsmen will ever again attempt to win the Palma Trophy."

"We are inclined to think that a good deal of the misunderstanding is due to the fact that General Spencer, who represents the American Association, cannot write a lucid letter. . . . He might have put the case in half a sheet of letter paper; but instead of

that he seems to have written a long, verbose and clumsy screed which gave the Englishmen the impression that he had something to cover up, and that he was covering it up with ponderous sentences and a flux of words."

"Which shows how necessary it is for every man to be able to write plain English. He may be able to hit the mark with his rifle, but if he flops all around the thing at which he aims his words he may not get credit for any of the balls he puts in the bull's-eye."

"Your trail runs to the westward, And mine to my own place; There is water between our lodges, And I have not seen your face."

"But since I have read your verses 'Tis easy to guess the rest, Because in the hearts of the children There is neither east or west."

"Born to a thousand fortunes Of good or evil hap, Once they were kings together Throned in a mother's lap."

"Surely, they know that secret, Yellow and black and white, When they meet as kings together In innocent dreams at night."

"With a moon they all can play with, Grubby and grimed and unshod, Very happy together, And very near to God."

In re-reading "Pamela, or Virtue Rewarded," by good old Samuel Richardson, just issued in the English Comedie Humaine series of English masterpieces, a reader of forty years or thereabout is annoyed by the heroine's unrelent (and, I am thankful to say,) unnatural prudishness. It is a good thing for a child to go to its mother with its doubts and unfounded suspicions, but for a marriageable girl to write such tiresome details as Pamela did to her parents is enough to make a reader wish for her undoing."

Pamela's master shows her some kindnesses and she forthwith writes her parents that she is afraid he has designs upon her, and when he kisses her she nearly faints and declares she is "undone"—but finally she marries the good, kind master."

Of the two, in this case, an unbiased person will be apt to think the apparently modest, shrinking girl the more inherently immoral. But with Pamela it did not happen, as it does now-a-days, to the very proper, mother-watched, prudish maid, for the "Master" was fool enough to marry her. To her old drinking song does not apply:

"Here's to the girl that gets a kiss And runs to tell her mother; She's the one that will die an old maid And never get another."

One fear is that when women To the ballot box shall flock The home will be forgotten And the cradle cease to rock. —Gorham (N. H.) Mountaineer.

Of course, for when the women To the ballot box shall flock The cradle will stop rocking— There'll be nothing there to rock. —N. Y. Star.

More likely 'tis the woman Will say, "When I am gone, Just rock the baby darling, And put the kettle on."

There is a revival of Charles Reade and his novels are being issued in all sorts of popular editions.

Early in his literary career, a "friend" of Reade's taking exception to something he had published, wrote him a rather saucy letter of remonstrance, advising him with high assurance and impudence, to resume the practice of law, and lock his "literary propensities" up in a "well-secured iron chest."

This acquaintance of only a few years' duration had presumed much upon his friendship, for Reade had already received the favorable opinion of well-known literary persons, while the critic was not only not in a position to judge of literary values—he was a business man occupied with matters of an entirely different nature. Reade's letter is well worth reading.

"Dear Sir:—I have always supposed that the choice of a vocation in life, like the choice of a wife, was a man's own prerogative, or, in stretched cases, that of his parents. But you who have known me in a far from intimate way for a few years, being displeased with my conduct in some particular, have taken upon yourself to advise me in language not even friendly, as to a matter upon which your judgment is not at all to be trusted. Men of my own calling in law and literature whose opinions I have some reason to respect, are strong in their approval of what you contemptuously call my 'literary propensities.'"

"Besides having been given a mind of my own and liberty to follow my particular calling in life, I do not feel that it is exactly the place of a wine-merchant who occasionally comes into

personal relations with me, to do indelicately what my most intimate friends might fear to undertake.

"The best thing you can do is to mind your own business; to taste your own wine—not to pass upon the bouquet of a vintage you were never intended to sample."

This is the sincere, outspoken word of an author about his own books, in pleasing contrast to the affected inuference of some or the pseudo-modesty of others. Mr. Garland has written good novels and he knows it as well as his readers. They are books, too, to be remembered because they grew out of conditions and experiences; because they were not manufactured at so much a page nor built upon far-away information.

Mr. Garland is lecturing under the James B. Pond Lyceum management. He has appeared before the English Graduate Club at Columbia, Dr. Henry Van Dyke's Monday Club, and has been re-engaged at the Chicago University. He has been asked to deliver "The Joys of the Trail" before the National Geographical Society, the Yale "Smoker," the West Point Military Academy and elsewhere. If Honolulu were not so far away we should have him here.

Mr. Lafcadio Hearn, whose "Kwaidan" we reviewed in these columns a few weeks ago, will publish very shortly a book of over 500 pages, entitled "Japan: An Attempt at Interpretation."

This Fall seems rich in books on art. CANOE RACE EXCITING

PAIR-OARED EVENTS CAPTURED BY MYRTLE S

IRISH WINS THE FIRST DIVISION YACHT RACE—GLADYS OUT-BAILS HAWAIIAN AND SPRAY.

The latter part of the Regatta Day program was considerably altered. As no boats showed up for the sampan tug-of-war this event was cut out. The whaleboat race was started next. As only the Kanaloan and the Kaploian showed up at first these were started alone together. This made practically a repetition of the first race, only the course was shorter. The Lawenhi and the Hawaii showed up a little later on and were started together as a separate race.

The Kanaloan got a better start than the Kaploian and led well. The Kanaloan kept her lead and on the return was far ahead of her rival. In the last part of the channel Harris boat made a wonderful start but it was of no avail; the Kanaloan won the race with comparative ease. Time: Kanaloan, 13:32 2-5; Kaploian, 12:49 5-5.

The Lawenhi and the Homa got off well together. The Lawenhi kept gaining throughout the race and finished a great distance ahead of her opponent. Time: Lawenhi, 12:19.

In the Junior six-oared sliding seat races the Myrtles redeemed their former defeats and the backers of this club picked up fresh spirits. The Healanis took the lead from the start, passing the lighthouse a length to the good, and maintained their lead throughout, gaining especially on the homeward stretch. SOLD TO RUSSIA.

New York, Sept. 7.—From a trustworthy source The Call has received information that two of the biggest steam vessels ever built on this side of the Atlantic—the Minnesota and the Dakota—had been sold by J. J. Hill to the Russian Government.

Samuel Holmes, the well known ship-builder, is said to have received a commission of \$35,000 for conducting the sale. He admitted as much tonight, although Hill made a denial.

Rivers of Mud In Kuropatkin's Retreat

St. Petersburg, Sept. 8.—The lack of news from the front, either official or newspaper dispatches, is very trying to the public. In spite of the assurances that General Kuropatkin's army is out of danger, no word from Kuropatkin has been given out for 26 hours and not a single newspaper dispatch later than September 6 has been received. The Emperor has received some additional details showing the tremendous difficulties encountered in accomplishing the retreat over the Maudarin road to Mukden, from which it is easy to imagine the horrible picture of the army and the baggage and transport trains floundering northward over a road converted by torrents of rain into a river of mud. An instance is given where the wheels of a gun drawn by six horses sank up to the breech. Four additional horses were harnessed to the piece, but the ten horses were unable to budge it.

The Russian rear guard is considerably above Yental, but there is no exact information in regard to the location of General Kuropatkin's main army, the left wing of which has been engaged in a more or less continuous duel with the Russian batteries which are covering the retreat and no particulars have been received of the extent or character of this fighting. The General Staff, however, is of the opinion that Kuropatkin's troops must be experiencing almost as great difficulties as the Russians and that they are too exhausted to create a serious menace at present.

While the public impression is that Kuropatkin's army is continuing north from Mukden, no official admission to this effect is now obtainable. The General Staff, while declaring that it has no specific information on this point does not deny the possibility that owing to the difficulties of the retreat some transport and some guns may have been abandoned.

Knight Commander Log \*Told Whole Story

Vladivostok, Siberia, Aug. 7.—The evidence on which the British steamer Knight Commander, sunk by the Vladivostok squadron, was condemned by the Prize Court, was contained in a letter-copying book taken from a press in the captain's cabin by Midshipman Baron Ert after the officers and crew had left the vessel. This book was not delivered when the captain surrendered the other documents, and it proved conclusively to the Russians that the cargo of railway material carried by the Knight Commander was destined for Chemulpo and not for private firms in Japan.

The captain was not compelled to take an oath, the President of the court saying he would accept his word of honor as a gentleman and a subject of a friendly power. The captain testified that neither he nor the owners of the Knight Commander knew that the cargo was contraband of war, and that they believed it was not destined to be used as war material. He was then confronted with his own letter book and was dazed for a moment. He then exclaimed: "Heavens, I thought that book was at the bottom of the sea!"

Iaukea Listened To By Hilo Populace

Hilo, Sept. 13.—There was a fairly representative audience of men, women and children gathered to hear the band concert Thursday night and incidentally to listen to the Democratic oratory as rendered by Curtis P. Iaukea, candidate for Congress, and local Democratic leaders. Interspersed between music and song the flow of oratory continued both in Hawaiian and English until a late hour.

Hon. C. M. LeBlond kept the crowd in good humor by his fund of jokes and ridicule of Republican ideas as represented by "genial Jack" Atkinson and other statesmen in the Young Men's Republican Club. He claimed that this body was being used as a weapon to make laborers who desired work, join the Republican ranks. He gave no instances of such being the case but relied upon a speaker's license to say what he pleased without contradiction.

Candidate Iaukea arrived by the Kinau Thursday afternoon and was more or less fatigued by the trip. He spoke, however, briefly to the crowd, which listened to his remarks attentively and without interruption. His main argument was an appeal to the voter to abandon the Republican party and administration and vote for a new regime, which he promised would be just as good if not better.

He stated that the governing power was still maintained in the hands of the few, and that Governor Carter was no less than an autocrat, assuming the right to demand resignations of the heads of departments in advance of their appointment. He claimed this was un-American, unwise and contrary to either Republican or Democratic doctrine. He charged this as being political chicanery and not possible on the mainland. He said the effort of the administration officials to compel self-respecting citizens to become Republicans in order to secure a dollar for a day's labor on the public improvements of the Territory as something unheard of. This he called "dirty politics."

He made a strong appeal to the Home Rulers to join the Democratic party, where he said they would have an equal right in the government of the party and of the country. He extolled the advantages to be gained from being in the party opposed to the administration, and assured his auditors that if the Democrats failed of election this November, their fight was not without its results. "If we succeed," he said, "in getting the Home Rulers to join the Democratic party, then we will have done something which the Republicans never could have accomplished. It remains now for the Democratic party being organized within the Territory, to take its proper place as a political factor in the affairs of the islands. If there ever was a time in the history of this country when citizens should stand up for their rights and see that the Territory was not mismanaged, it is now." He urged all good Democrats, Home Rulers and even Republicans who do not approve of the Governor's actions, to rise up and overthrow the remnants of the oligarchy and its misrule.

Japan's Alliance And Korean Protectorate

London, Sept. 5.—No official representation will be made by the British Government in regard to the Japanese-Korean agreement, the text of which was cabled from Tokio last night, but the authorities are taking a lively interest in the extent of the intervention of Japan in the affairs of the hermit kingdom. Under the Anglo-Japanese alliance both powers agreed to respect the independence and integrity of Korea and the agreement between Japan and Korea is regarded as an infringement of Korean independence. But it had been expected that if Japan were successful in the war she would establish a protectorate over Korea.

HERALD PREDICTION

DEMOCRATIC ORGAN HAS FIGURED OUT THE HOUSE

THINKS THE DEMOCRATS HAVE CHANCE OF CARRYING HOUSE THOUGH THEY LOSE THE NATIONAL TICKET.

New York, Aug. 27.—The Herald will say tomorrow: "There is a rather strong possibility that the election returns on the night of November 8 will show a Democratic House of Representatives for the Forty-ninth Congress."

"Under the peculiar conditions which are prevailing in various parts of the country it is possible that the Republicans may elect their national ticket and still lose the House by a large majority."

"The Herald has made an investigation of this subject and is able to present a few hard facts, based on careful inquiry and reliable information."

"Put briefly, the situation is that the Democrats have rather the better of it at the outset of the campaign. There are 386 members of the House of Representatives. In the present House there are 298 Republicans, 172 Democrats, two Union Labor delegates and four vacancies. The Republicans thus have a majority of 24."

"Investigation shows that in the United States there are 159 districts that can be counted safely Democratic. There are 156 districts that can be counted safely Republican. There are 71 doubtful districts, which may be carried by either side, and in these the great battle for the control of the House of Representatives must be fought."

"In order to obtain a bare majority, it is necessary for the Democrats to carry 35 of the 71 doubtful districts. It is necessary for the Republicans to carry thirty-six of them."

"The doubtful districts are now represented in Congress as follows:

New York, Aug. 30.—Thomas N. McCauley, organizer and former president of the alleged bankrupt International Mercantile Agency of this city, which is now in the hands of a receiver, was arrested today upon the request of the Hamilton, Ontario, authorities, who informed the local officials that McCauley was wanted there on the charge of larceny of \$4500, made by a former stockholder. McCauley says that his arrest is the result of spite on the part of a present official of the company because of McCauley's action in bringing suit against the agency for \$54,000, which amount he says he loaned to the company.

### PROGRESS OF GOVERNOR

#### GREAT ENTHUSIASM ON HIS TOUR THROUGH MAUI

LUAU IN PLENTY AND PEOPLE TURN OUT IN CROWDS—HAWAIIAN LAND POLICY.

Waikuku, Maui, Sept. 17.—The Governor and his party are following out the route mapped out by the Republican District Committee, and are everywhere meeting with a great deal of enthusiasm and being treated to luau.

After a good day's rest at Kulamau, Mr. Cook's beautiful mountain residence, the Governor, accompanied by Secretary Atkinson, Forester Hosmer and Manager von Tempisky, started out early Monday morning, breakfasted at Mrs. Dora von Tempisky's, and climbed the steep sides of Haleakala. Thru and a half hours' laborious climbing brought them to the famous Polopoli Spring. There Dr. Raymond joined the party and on the descent to Ulupalakua, Mr. von Tempisky turned back towards Makawao.

Meanwhile the Governor's wife, accompanied by Mrs. von Tempisky, Miss Coleman and Miss Magowan, Commissioner Pratt and Aiken, left Erewhon for Ulupalakua.

The Ulupalakua Preenet Club spread themselves quite a good deal. The luau, which was a sumptuous affair, was served in the school house, and it seemed that every one turned out to greet the chief magistrate and his party. Questions of local interest were freely discussed, and the natives greatly appreciated the fact that he is making a personal canvass of the situation to get into closer contact with them. They applauded time and again his remarks concerning subjects of vital interest to that district.

Monday night was spent by the Governor at Edgar Morton's, while his wife and party were accommodated at Ulupalakua Ranch.

The return through Kula was a triumphant procession. First the whole police force of Makawao met him beyond Keokea school house, then the school children at Keokea with flag flying greeted him with a few songs. The crowd at Keokea heard him speak, and then the procession, headed by the Keokea string band, which accompanied him to the Kealahou school house.

At the latter place was prepared a luau under the management of David Morton, which surpassed anything of the kind heretofore given. The table was just loaded with good things to eat. There must have been between 600 and 700 people present when the Governor started in to address them, and the enthusiasm was great.

The usual amount of petitions were presented and duly discussed. An old time legislator stated his desire that the homestead act should be so arranged that any one could get hold of a piece of land as in olden days. He was greatly surprised when informed that any system which gave the native the land so he could sell it again was condemned. When informed that it was the policy of the Administration to settle only on lands which would yield a living and in such a way that one could not part with them, the natives saw the good points in that and cheered him again. The night was spent at Erewhon.

Wednesday was rather a light day for the Governor; breakfast at Kulamau, address to the school children at Makawao whose little hearts he delighted by giving them a half-holiday; luncheon at Mrs. Dowsett's address to the Maunaloa girls, reception at Man-
