DONE UP BY DAVIS

VINDICATION IS WHAT HE SEEKS

Captain Frazier Late Master of The Transport Sherman to His Way to The States to Make Things Hot.

Among the passengers on the Hong Kong Maru bound for San Francisco is Captain Frazier. He is going back for the purpose of stirring up things in the army transport service.

He was the commander of the transport Sherman at the time that the vessel went aground on an uncharted rock off of the Philippines. The vessel was subsequently floated and was repaired at one of the Chinese dry docks.

Captain Frazier appeared before a court of inquiry and was completely exonerated from all blame in the matter. This finding did not apparently suit General Davis the commander in chief of the American forces in the Philippines. Davis is understood to have refused to approve the findings and to have removed or caused Frazier to be removed, from the command of the vessel.

Frazier considers that he has been very shabbily treated. He proposes to have the affair taken up when he reaches home. It is said by sea faring men, that Davis was not actuated by the best interests of the service in causing Frazier's removal.

The Hong Kong Maru landed about 1,000 tons of freight at this port. She has not a very large list of passengers. The vessel got away promptly at 10 o'clock this morning for San Francisco. A number of passengers were late in reaching the vessel and there was a rush and hurry before the gang plank was finally lowered and the vessel backed out of the Bishop slip. She expects to make San Francisco early next Monday morning. Among the passengers from this port, was Mrs. Ella Harrison.

DIMOND BILL PASSED.

The House yesterday passed the W. W. Dimond gas franchise bill on third reading, and it now goes to the Governor for signatures. There was only one vote against the bill in the House.

GALIC MAKES COAST TODAY.

SA FRANCISCO, April 7.—The S. S. Gaelic arrived at 7 a. m. today from the Orient via Honolulu. As the result of the thorough fumigating given the vessel at Honolulu, she was not put into quarantine at this port. The vessel was fumigated at Honolulu for a case of varioloid.

MANY VESSELS WERE SIGHTED

BARK ANDROMEDA BOUND FROM HONOLULU TO ABERDEEN WAS SIGHTED BY ALICE COOKE.

The death of sailing vessels in the harbor was relieved considerably yesterday by the arrival of four of the fleet from various ports.

The schooner Rosamond arrived from San Francisco after an average passage of 19 days. This is much better time than most of the sailing fleet have been making from that port. The Rosamond encountered very disagreeable weather. On the third day after leaving San Francisco, she carried away her jib-stay, and three days off Oahu, she carried away her fore-sail.

The schooner Alice Cooke arrived yesterday morning, 22 days from Port Wamble with lumber. This is quite a good record, especially when vessels from San Francisco have been making longer passages. The Alice Cooke sighted two vessels that left this port last month. Both were sighted on March 25. The first vessel seen was the schooner Forest Home bound to San Francisco and the other was the old Andromeda bound under a jury rig to Aberdeen to undergo further repairs for the lumber trade to Australia. The Andromeda was sighted in Lat. 44:13 north, Long. 140 west. She left here March 5.

The barkentine Fullerton got away yesterday afternoon for San Francisco in water ballast. The wreckage that the vessel sighted on her way down was seen in Lat. 25:18 north, Long. 140 west. It consisted of a lower mast with top attached. The spar appeared to be bright. The wreckage passed within 150 yards of the vessel. The mast was evidently not attached to anything, for it was floating flat in the water.

The bark W. B. Flint arrived off the harbor yesterday afternoon, 26 days from San Francisco. She has a general cargo of supplies for Makawell. She will probably sail for Makawell this afternoon. She will load a return cargo of sugar for San Francisco.

The schooner Admiral, 56 days from Newcastle, arrived yesterday morning with coal.

ESTEE'S TERM NEXT WEEK

FEDERAL COURT JURY TERM WITH SHORT CRIMINAL CALENDAR—THREE HILO CASES.

The April term of the United States District court will be opened next Monday, according to the provisions of the Organic Act. Grand and trial juries have been summoned, but in both cases it will be necessary to summon more talesmen, as a large proportion of those whose names were drawn are not American citizens and must be excused.

The calendar for the term is not a large one this time. Deputy Marshal Handy was sent to Hilo today by Marshal Hendry to bring back three Japanese who are charged with illicit distilling. Their cases represent three different stills raided on the island of Hilo. Owing to the absence from Hilo of United States Commissioner Carl Smith, the defendants will have their preliminary hearing in Honolulu, before Commissioner Gill. The examinations will take place on Saturday, after the arrival of the Kinau. Handy will bring the witnesses as well as the defendants.

On the term calendar are also thirteen cases of the United States vs. H. Hackfeld & Company, the charges being of allowing Japs who were not entitled to land to escape from steamers here. One of the cases will probably be tried and will serve as a test for the others.

The other cases are that of First Mate Neilson, charged with assault and battery on the high seas. I. Miami and Hirota, charged with feloniously importing women into the country for immoral purposes.

ENGLISH IS SHUT OUT

MEMBERS OF THE HOUSE PREFER THE HAWAIIAN LANGUAGE AND HAVE TAKEN TO DEBATING IN THAT TONGUE WITHOUT ANY INTERPRETATION—LONG DISCUSSION MEANINGLESS TO THE ENGLISH-SPEAKING PUBLIC.

The House oral proceedings this morning were nearly all in Hawaiian. Since the opening of the session there has been a gradual movement toward less and less interpretation, and today the speeches of the native members, who did most of the talking, were not given in English at all, and there was a long debate which no one in the house or lobby who did not understand Hawaiian could know anything about.

Interpreter Coelho stood close to the stenographer and whispered into his ear the English of the native speeches. This got them on the record and saved time, for Coelho got through with the speeches at the same time as the speakers, but it made the proceedings all native.

The new rule made little difference as far as the members of the House are concerned. All the members understand the Hawaiian language and all but one understand English at least fairly,

PLANNING FOR AN EXTRA SESSION

A GENERAL FEELING IS GROWING THAT THINGS ARE SHAPING THEMSELVES OR ARE BEING SHAPED SO THAT AN EXTENSION OF THE PRESENT SESSION OR A SPECIAL ONE WILL SEEM NECESSARY.

Talk of a special or extended session of the legislature is beginning to be very general among those who are watching the proceedings of both houses and it appears as if a majority of the members had decided that such a session, or an extension of the present session, would be necessary.

So far there has been no disposition shown to take up the appropriation bills, and in the event that such bills are not disposed of the governor will have to extend the session or call an extra session. Both houses have scores of bills in program which the members are anxious to act upon. Progress of work is much more rapid now than during the early days of the session.

but the English-speaking public of the Territory is shut out from the debates of the representatives under such a system.

The measure on which the new method was adopted was the bill to provide that anyone may gather mail, fens, etc., on the public lands. The debate was quite lively, Chillingworth leading the opposition to the bill by an address in which he predicted great destruction of forests if the existing restrictions were removed. Knudsen took the same view, mentioning cases of wanton destruction of ferns and trees, tending to affect the rainfall and water supply. Kanho, Aylett, Pali, Kealawa and Kumalae supported the bill. Greenwell rose to question Kumalae about a statement he said the latter had made, but Kumalae disavowed it, and the vote was taken. The bill passed second reading by a general vote of natives.

Under the law the governor may extend the present session for not more than thirty days, or he may call an extra session after adjournment, or he may call an extra session for the sole purpose of considering appropriations. In the latter case the legislators would have to confine themselves to appropriation bills.

BEETS AND BOUNTIES

OXNARD SAYS THAT THE BOUNTY SYSTEM HAS STIMULATED AN IMMENSE OVERPRODUCTION OF SUGAR IN EUROPE—AMERICAN BEET SUGAR CO. OF NEW YORK RE-ELECTS ITS DIRECTORS.

NEW ARCHBISHOP OF MANILA

ROME, April 7.—The announcement has just been made that Archbishop Montgomery, who was only lately made the coadjutor of Archbishop Riordan of San Francisco has been made Archbishop of Manila. This announcement comes as a great surprise as showing an unexpected extent of the Pope's consideration for the new conditions in the Philippines, and the assumption on the part of the Vatican that the Philippines are now American and are to remain American and be more and more Americanized.

Archbishop George Montgomery was born in California and served important parishes in San Francisco. He was for many years the Catholic Bishop of Southern California.

REPATRIATION AND DEATH

PROTEST IN AUSTRALIA OVER THE OPERATION OF THE PACIFIC ISLANDS' LABORERS ACT—SAID THAT IT WILL RESULT IN GREAT HARDSHIPS AND DANGER TO MANY POLYNESIANS DEPORTED FROM THE COMMONWEALTH.

SYDNEY, March 23.—The enforcement of the law recently passed by the commonwealth Parliament excluding Chinese, Hindoos and Polynesians, and deporting those already in the country who do not voluntarily leave, is creating a good deal of outcry and protest. The Sydney Morning Herald today publishes a dispatch from Brisbane which is typical of dispatches published almost every day. It is as follows:

"A number of kanakas resident near Rockhampton held a demonstration yesterday and presented the Governor with an address, a portion of which expressed thanks for the reply of Mr. Chamberlain to the petition sent through the Governor from the islanders in Queensland assuring the islanders that the British officers in the islands would help to settle those who returned in safe places. A desire was expressed that a way be found by which they would be permitted to lead a quiet and peaceful life in Queensland where most had resided for many years.

"A kanaka girl then read clearly another address regretting that under section 8 of the Pacific Islander Laborers Act it was provided that all kanakas found in Australia after the end of December, 1906, must be deported, and pleading that they might not be separated from their parents.

"The Governor in reply, promised to forward both petitions to the Governor-General.

"A kanaka named Peterson, speaking good English then addressed the Governor, pointing out that the Government allowed them to settle down and buy land without saying anything. They did not want to break up their little homes. They had made up their minds to settle in Queensland, and remain there till they died.

"The government on the other hand is combating this idea as is shown by the following dispatch from Melbourne published in the same issue as the other:

"Fears have been expressed that the wholesale deportation of kanakas, owing to the operation of the Pacific Islands' Laborers Act, will result in the islanders being starved on their islands or being killed by the natives. Sir Edmund Barton stated on Saturday night that there was a possibility of wholesale deportation. The act allowed several years for the return of kanakas to their islands. The government would do nothing without the fullest consideration, and the islands would not be allowed to suffer in any way.

"That this optimistic view of the government is not shared by everybody is shown by the following leading editorial in the Sydney Morning Herald, under the heading 'Returning the Kanakas.'

"Drawing the color-line in the Commonwealth is not altogether the easy task that might be supposed. We know the difficulties raised by the sugar planters, and the partial embarrassment to the Federal Government in consequence, though Sir William Lyne assures us that this is being rapidly overcome. But there are other responsibilities besides those claimed as due to the planters, and Captain Rason, the British Commissioner resident in the New Hebrides has something to tell us on that side of the subject. It con-

cerns our treatment of those kanakas who have been taken from their island homes to work on our plantations, and who are now to be repatriated. There are, he says, about 3000 laborers from the New Hebrides now in Queensland, and these are to be returned to their homes within two years. That will mean a rather sudden addition to the population of the group. Under the kanaka labor conditions any such step was avoided. We took 350 colored laborers from these islands each year, but then we returned 250 in the same period, so that there was no violent interference with the normal level of population. Obviously, as Captain Rason puts it, the comparatively sudden deportation of 3000 adult males would under any circumstances, have a marked effect. We have to consider these people, and we have also to consider the conditions in the New Hebrides. It is not open to us to select a group of islands like this in the Pacific, and make it the scene of ill-considered experiments among the native population, and the Resident Commissioner is quite within his rights in bringing the matter under notice.

"There is a question of humanity here, apart from the political one. We owe something to the men we have half civilized, although we place them beyond the color line. It would not be altogether creditable to the Commonwealth if it began its career by doing something calculated to expedite that extinction of the native races in the Pacific which we are accustomed to associate with the advance of civilization. We could not fairly say that the destructive side of civilization in these islands is only that represented by the adventurer and the beachcomber, if one of the first acts of the federal authority was to precipitate such a state of things as Captain Rason describes. If these 3000 kanakas are thus thrown among a savage and kindred population it is not difficult to predict that, in the first instance, their own partial redemption from savage conditions will be sacrificed. They will relapse into barbarism as a matter of course, and the fact would be recorded against us in history as a reproach. We owe a certain moral obligation to the rest of civilization, howsoever awkward it may prove to discharge it. Captain Rason has done no more than his duty in making us see this clearly, and it may be hoped, in time. Then there is the question of food supplies. If the male adults of the New Hebrides be suddenly increased by one-fourth, and no provision is made to feed the increased population, we have here at once the primal elements of quarrel and dissension, especially when the contact of semi-civilized and barbarism is considered. Can it be said that the federal authority discards no imperative moral obligation here? Captain Rason says that 'some arrangements will have to be made to get food supplied, and also to permit of these returned kanakas who have been leading a civilized life in Queensland being placed in some position where they will be enabled to live in a manner similar to the lives they have lived in Queensland, apart from their fellows,' thus ensuring their security.

INVESTIGATE BALDWIN LEASES.

Vice-Speaker Knudsen of the House this morning appointed the special committee called for by resolution of Kupihua's yesterday to investigate some leases of land to Baldwin of Maui. Kupihua, Andrade and Hala constitute the committee.

THE DOGS OF WAR ARE LET LOOSE

THE MACEDONIANS CALLED TO RISE AGAINST THE TURKS--AID FROM THE POWERS HOPED FOR.

Associated Press, Morning Service. CONSTANTINOPLE, April 6.--The Macedonian general committee has issued a proclamation calling for a general insurrection against the Turk. The day set for the uprising is April 20th. This action is based on the ultimatum of the three powers which was made public yesterday and the news has had the effect of creating a feeling that the spring will bring events of the gravest importance.

The proclamation calls upon all the Macedonians to fly to arms, gives hope of aid from without and promises that the leaders of bands now operating in the mountains, will rendezvous at a point which will be made known later, evidence as to who are to be mobilized. The committee is most sanguine in its declarations. It is believed here that this call, coming when the people are told that the three great powers will intervene in the event of the Porte being unable to bring out an army of not less than 100,000 men. This will tax the energies of the Turkish commanders now in the field, and it is reported that there will be issued an order sending 100,000 more men to the western frontier.

SOFIA, April 6.--After three days of heavy fighting about Salonica the Turkish forces have been able to drive back the Macedonian army. The roving bands of Macedonians combined for the struggle, and gave battle before the city, which called out a great percentage of the defending forces of the Turks, the garrison of the seaport having recently received heavy reinforcements. The Macedonians lost heavily and were compelled to fall back. Albanian bands descended upon the town of Okhrida, situated on the east banks of the lake of that name, captured it and proceeded to put to the sword all the Christians. There was a terrible slaughter, the people defending themselves as best they could. The revolutionists sacked the town and finally burned the Christian section. The proclamation of the Macedonian committee was issued from Sofia which is the headquarters of that body. The present president of the committee is Mikhailovsky, by profession a schoolmaster, who took the office two years ago when Sarafoff left the place. General Tsoncheff is a major general in the reserve of the Bulgarian army. Maj. Yankoff recently led a raid into Bulgaria, but was again at the front operating about Salonica. The activity in the region of Salonica is due to the fact that the rebels would like to secure that port, so as to prevent the landing of troops and their being dispatched into the interior by the railroad. This would cut off the principal means of distribution of men that is in command of Turkey, as the other railroad line is extremely vulnerable.

LORENZ WILL VISIT AMERICA. Associated Press, Morning Service. VIENNA, April 6.--Doctor Lorenz, who made a sensation when he went to Chicago for the purpose of treating the daughter of Ogden Armour for malformation of the lower limbs, has been summoned to the United States again, and soon will leave for a hurried visit.

SWISS MASONS STRIKE. Associated Press, Morning Service. BASEL, April 6.--A general strike of the masons of the city was declared yesterday, and now more than 2,500 men are out. There have been several collisions between the strikers and the police and troops have been called out to keep the peace.

BIG REPUBLICAN MAJORITY. Associated Press, Morning Service. DETROIT, Michigan, April 6.--For an off year Michigan today rolled up one of the biggest Republican majorities of recent years. The fight was for justices of the supreme court and regents of the state university. In each instance the Republican candidate was successful.

JONES WINS AGAIN. Associated Press, Morning Service. TOLEDO, O., April 6.--Mayor Jones was re-elected today after a campaign full of interest. He failed of nomination so ran independently. Samuel M. Jones, who has been re-elected Mayor of Toledo, was born in Wales in 1846, and his parents came to America three years later. His early was one of poverty and at eighteen he secured his first employment in the oil fields of Pennsylvania and has been interested in that industry ever since. He granted the "eight-hour" day to the men in the oil fields that he controlled and made a big "eight-hour" fight in Toledo. Four years ago a deadlock occurred in a Republican convention in Toledo. Jones' name was mentioned, and he went through like a whirlwind, being later elected mayor, although opposed by the corporations and saloons. His platform in running for office has been one favoring municipal ownership of all public utilities and no grant of new or extension of existing franchises.

FLEISCHMANN AGAIN ELECTED. Associated Press, Morning Service. CINCINNATI, O., April 6.--Mayor Fleischmann was re-elected today, though by a greatly decreased plurality. Mayor Fleischmann had to put up a big fight against M. E. Ingalls, railway president and capitalist, who ran for office on a Citizen's Ticket. His election insures the control of city politics by Cox.

MACEDONIA.

Macedonia is the storm center just now, as Bulgaria was before the Russo-Turkish war, and as the vicinity of the Pruth was at the time of the Crimean war, and the difficulties in Macedonia are as likely to be followed by a great war, as the previous difficulties have been.

It has been a long struggle and though the Crescent had the best of it at the outset, the Cross has had much the best of it for a century and a half. The Roman and Greco-Roman world were overwhelmed by the Moslem, and later by the Moslem Turk.

We have a way of speaking of the unspeakable Turk, and talk of his being turned out bag and baggage out of Europe, but it is not so easy to turn him out. He came with sword and lance, he will only retire before superior arms and quick-firing cannon.

The immense sympathy shown by the Bulgarians towards the Macedonians is not based merely upon the likeness of religious creed, but is based on racial lines. Of the three millions of inhabitants in Macedonia more than 2,500,000 are Bulgarians, talking the same language, having the same national aspirations, and believing the same creed.

It must be quite plain that the Bulgarians of the practically free Bulgaria must sympathize with their enslaved or dominated brethren in Macedonia. The Macedonian revolutionary committees have found ready aid and have been helped in their organization by the Bulgarians of Bulgaria.

It may be perfectly true that Macedonia is in a state of anarchy, and that the Turk has lost the capacity for government, but it is also perfectly true that given the complete dominance in government the orthodox Greek Christian will oppress woefully a section of the population which is now by no means oppressed.

There is some talk of the partition of Turkey between Austria, Russia and England. This was what the Emperor Nicholas proposed before the Crimean war under the celebrated parable of "the sick man," but partitions do not prove satisfactory, and only lay up future trouble.

Rebellion in St. Domingo, insurrection in the Balkans, riots in Serbia and Spain, possible war in Central America, floods on the Mississippi and strikers all over the mainland and in Holland, make a budget of news which is exciting enough, but does not show a very peaceful world.

Committees of the Senate and House visited the Leper Settlement Sunday, returning Sunday evening. Complaints of various kinds were heard and there seemed to be a unanimous attack upon Dr. Goodhue.

New York on May 24 will celebrate the two hundred and fiftieth anniversary of its existence as a municipality. For three days, May 24, 25 and 26, there are to be exercises in honor of the event. There will be an historical address in the Chamber of the Board of Aldermen, special exercises in the schools and illustrated lectures showing the development of the city.

Whatever happens the Chinese fund seems to be a source of trouble. At one time it was too easily got at, and every one, who had charge of it, except H. E. Cooper seemed to consider that it was a small gold mine. Now it is so tied up that it cannot be got at at all, and a large number of Chinese who ought to get \$36 apiece are unable to collect.

The balance of the Post Office Savings Bank fund still remains to be distributed. Fortunately no one has had a nibble at this, and it remains intact for Pain to collect his ten cents, and others to get their magnificent share of the interest.

THE ALL-BRITISH PACIFIC CABLE

IS SAID NOT TO BE GETTING THE BUSINESS AND THE PATRIOTS KICK.

The ultra-patriots of Australia seem to be raising a protest because the all-British Pacific cable does not receive the patronage they think it should, the private concern, the Eastern Extension Company, getting more business than the empire-owned cable. The issue is pretty clearly shown in the following communication published in the Sydney Morning Herald:

Why the public do not use the Pacific cable as much as the Eastern Extension Company's one is a question which is easily answered. As one who has occasional cable business with England and elsewhere, I would prefer as a patriotic Australian to use the Pacific line, but experience has shown me that the private line is better and cheaper.

As to cheapness, the government makes a number of small charges which in the course of the year, amount up, viz. 1s for a book of forms, 1d for a receipt for the telegram, and 10s 6d a year to register your code address. The only way to send a message "via Pacific" is through the post office, and the government insists on these charges whereas, if I take a message to the Eastern Company's office, a book of forms and receipt are given free, and no charge is made to register a code address. Naturally, therefore, one prefers to save this expense when possible. As to quickness, if I take a message to the Eastern Company's office I know it will be forwarded by their direct line to Adelaide, and is not likely to be blocked by either departmental or private, state and inter-state messages, as may possibly happen if a cable message be sent "via Pacific" on to Brisbane.

If the government will abolish all these small charges, and give a special line to Brisbane for cable business only no doubt the Pacific cable will be able to compete with its rivals. Until then I, as well as no doubt many others, will prefer the Cape route.

CHARGED WITH EXTORTION.
Loo Joe was arrested yesterday on a charge of extortion. It is claimed by some Chinese that Loo induced them to visit his rooms and play fan tan. While the game was in progress, a white man entered, levelled a revolver at the Chinese, displayed a star and took all the money away from them. The money amounted to \$147.50. Loo, it was claimed, had called on the white man to aid him in collecting some money which had been won from him by fraud some nights previous.

YESTERDAY IN SENATE.

Number of Bills Passed Third Reading In Afternoon.

At the afternoon session of the Senate yesterday, Senator C. Brown succeeded in having Bill No. 46 which enlarges the powers of banking institutions, passed second reading. The bill had been adversely reported on by the Public Expenditures committee, but Senator Brown said he was ready with amendments to eliminate the objectionable features. Section 1 was stricken out; Section two was amended so that banks could not hold real estate for a longer period than five years. An amendment was inserted, permitting banks to hold real estate. Another amendment prohibited the banks from carrying on agricultural, commercial, common carrier or manufacturing business. The bill will be read a third time Wednesday.

The bill prohibiting the adulteration of foods and drugs passed third reading.

The other bills that passed third reading were, bill making change in partnership laws; bill providing for publication of United States decisions; bill for quarantining of animals; bill relating to Hilo fire department; bill

for appointment and pay of commission to pass on political claims of 1895; bill amending law relating to sale of kerosene; bill repealing law for importation of foreign goods, and a bill amending law for protection of birds. The House Bill for the purchase of the Pauoa Valley springs passed first reading.

Senator McCandless introduced a joint resolution providing that the total amount of bonds to be issued within the coming biennial period, should be limited to \$1,000,000. After some discussion, the measure was tabled to be considered with the Loan Bill.

LOUISE GETS A NEW TITLE

NEW YORK, March 23.—A cable to the Herald from Vienna says: It is learned from an authoritative source that the former Crown Princess Louise of Tuscany will in future be known officially by the title, Princess Louise of Tuscany, with honors due her royal highness. Her father, as Grand Duke of Tuscany, has the prerogative of granting titles, and has conferred this one upon his daughter with the consent of the emperor. The King of Saxony's manifesto caused an unpleasant sensation at the grand ducal court, and a reply, formally protesting against some expressions, has been drawn up and is now on the way to Dresden. The Allegemeine Zeitung announces that Princess Louise is about to publish a reply to the manifesto.

COURT NOTES.

The final accounts of W. O. Smith in the J. H. Wood trust have been approved by the circuit court. Petitions for approval of accounts and discharge have been filed by Cecil Brown in the estates of A. F. Gilliland and D. B. Smith. Keahi has brought a suit in partition against Niau Lauke and others. Suit has been brought by Louis Marks against F. W. Makinney for \$350 alleged to be due on a note. Manena Castino has brought suit for divorce from Joseph Castino. She alleges that he married her in 1878 and has failed to provide for her since 1891.

TOM JOHNSON VICTORIOUS.

CLEVELAND, O., April 6.—Tom Johnson was re-elected mayor today by a fair majority. His campaign was as sensational as that he made for governor last year. Thomas Loftin Johnson, better known as 'Tom' Johnson, mayor of Cleveland, has had a unique career in the Ohio city. He has a national reputation. He is a manufacturer of steel rails, yet advocates free trade. He has made a barrel of money out of the building of street railways and operating them, yet he thinks the municipalities should own such enterprises. He has amassed a fortune doing what he thinks no private citizen should be allowed to do if a city was run as a model. He is counted as a possibility for the Democratic nomination for President for 1904.

STRIKE IN HOLLAND

Associated Press, Morning Service. AMSTERDAM, Holland, April 6.—The strikers' committee has proclaimed a general strike all over Holland and as a result today all water and land transportation is tied up. There have been minor disturbances all over the country and numerous riots and fights with the troops which are trying to cope with the strikers. The streets of Amsterdam are in the hands of cavalry and marines. Over seventeen thousand employees of the Netherlands state railways are on strike and in sympathy with them men and women employed in mines and on canal and channel steamers, have come out today so that the strikers now number over fifty thousand. The mails are now being carried on motor cars. It is impossible to proceed by rail and travel from Holland ports to England has been interrupted, owing to the crews of many vessels plying across the channel joining the strikers. Crews of vessels at Flushing today refused to sail on any steamer carrying passengers which arrived at that port by train. THE HAGUE, Holland, April 6.—Queen Wilhelmina today called out the Netherlands reserves who are to be used at once in suppressing the strike on the state railways. Soldiers have been placed on trains in order to move the transcontinental mails arriving at Holland ports. The present great strike in Holland started through a difference of laboring men with a Dock company. It spread to the railway because the latter would not refuse to haul freight from the dock where the men were on strike. Now the water transportation laborers have joined in the strike in an effort to further cripple the railways. Troops have been moved from point to point by boats recently to cope with the strikers owing to the fact that trains could not be operated, but now that sailors are on strike also it is likely that the soldiers will have to march. In addition to the railways the tramways are also tied up and both of these tie up the coal mines, so that there is likely to be much distress unless the strike is settled quickly.

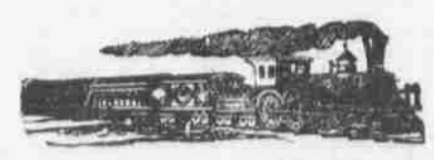

WHAT JOE FOUND IN SOUTH AFRICA

CHAMBERLAIN DISCOVERED A BITTER FEUD BETWEEN BOER AND BRITAIN.

Mr. Chamberlain has reached home, having successfully accomplished an important part of his mission, for he now knows much more about South Africa than he ever did before. As a search for information and first-hand impressions the tour very likely has been a triumph. He visited every colony except Rhodesia, met scores of deputations, held numerous conferences and made countless speeches. In its educational effect upon himself the trip must have been admirable, and the only regret that can be felt by anybody is that Mr. Chamberlain did not visit the country before the war.

As for the effect of the tour upon South Africa, that is another question. We cannot trust English newspapers entirely in their accounts of the situation, since their correspondents have naturally felt the inclination to represent the mission as a great triumph of conciliation, statesmanship, firmness, or whatever may be essential to the colonial secretary's own victorious march in the blackened and devastated wake of Buller, Roberts and Kloofner. It is impossible to know whether Mr. Chamberlain has done much good or not. In dealing with the business questions awaiting settlement he has been very successful doubtless. The question of how much the Boer mine owners should pay for the cost of the war was speedily determined, and much to the financial advantage of England. Mr. Chamberlain was at his best in squeezing the mining, millowners, and the British taxpayer is correspondingly grateful. The labor problem was much more difficult, and could not be settled at once. Mr. Chamberlain carries that home with him for further consideration, but with the prospect that the mining interest will finally succeed in having established a system of forced native labor. Some of Mr. Chamberlain's speeches indicated that he was quite taken with the idea that it would be a blessing to the Kaffir to be compelled to work, whether he needed it or not.

But important as those questions are in the future of South Africa, they hardly can take precedence of the question of reconciliation between the races. It is doubtful if Mr. Chamberlain's tour at this point exercised a beneficial effect, or did more than reveal the intense and bitter racial antagonism that exists among the white people. Before the war ended Mr. Chamberlain was accustomed to assure the British taxpayers that South Africa would coalesce into a homogeneous country under the British flag about as easily as the North and South did after the American civil war. He was very fond of that precedent, ignoring the important fact that in America the war left no race problem between white men of different language and even distinct antecedent nationality. The civil war left us a race problem based solely on the color line. But the Boer war has left to England in South Africa a Dutch-English problem as well as a negro problem of great magnitude. One of Mr. Chamberlain's most painful discoveries the past two months, according to his own public confession, has been the racial animosity between Dutch and English, now inflamed many fold compared with its intensity before the Jameson raid and the war.

It is a curious yet easily explained fact that this race hatred between the English and Dutch inhabitants is least in the Transvaal, is stronger in the Orange River colony than north of the Vaal river, and is most ferocious and rampant in Cape Colony. Outside of Johannesburg the Transvaal population is so preponderantly Dutch that the internal race feud does not have the chance to exist to such an extent as it does farther south. There was less real civil war in the Transvaal than anywhere else. In Orange River colony, however, the Dutch and English were more evenly divided and the war was not a little internecine in character. In Cape Colony, of course, where the two races are mixed up inextricably—the Dutch preponderating in numbers—the war was purely a civil conflict, taking on the technical character of a rebellion against the crown. There the British reprisals against the Boer sympathizers took on a severe form, for the Cape Dutch in arms were regarded as traitors without status as belligerents. A number of hangings of rebels took place to emphasize that policy. With this in mind Mr. Chamberlain's experience as he progressed from colony to colony can be better understood.

At Pretoria, the Boer deputations were civil, if glum; they were not disputatious or disposed to squeeze sunshine favors out of the Chamberlain cucumber. They seemed to agree in thinking that they were whipped, and they had no quarrels among themselves. Gen. Delarey was very polite to the colonial secretary, who also paid a visit to Gen. Cronje on his farm. The atmosphere changed for the worse at Bloemfontein. In Orange River colony a bitter feud exists between the Boers who followed Gen. De Wet loyally to the end and those who deserted to Roberts and Kitchener. The conference between Mr. Chamberlain and a deputation headed by Gen. De Wet and Judge Tertzog, was actually acrimonious. Mr. Chamberlain got into a long dispute with Judge Tertzog over a petition the latter had read and "re-buked" the Boer leaders severely for their alleged impudence in making charges reflecting on the honor of the government. After Mr. Chamberlain had freed his mind, there came, according to the London Chronicle's report, this incident:

Gen. De Wet then rose to speak, but Mr. Chamberlain motioned him to sit down. The general expressed regret that a speech from him was not welcome. It would come like mustard after meat. He then called upon Judge Tertzog to speak. When Gen. De Wet finally was allowed by Mr. Chamberlain to express himself, he declared that there was no co-operation possible so long as the colony was ruled by the men who had deserted the Boer cause. In its critical hour, he would not rest until he had caused, not an armed rebellion, but a rebellion of "agitation and discontent." It was in Grahamstown and Port Elizabeth, Cape Colony, somewhat later that Mr. Chamberlain gave some plain talk, telling the Dutch that an African republic was as dead as the ancient Babylon, that the government would stand by those who had been devoted to it. At the same time, he admitted that he had found in Cape Col-

ony "animosities which ought to be allowed to die, being intensified," while he warned the colony that he would be permanently injured if it did not succeed in effecting a reconciliation of the two white races.

It is very probable that in its effect on the race question, the Chamberlain tour has given courage to the British element of the population and has hardened the impression that the government will never yield any of the fruits of its victory in war. That it advanced the cause of reconciliation and race fusion is to be doubted. It is excellent advice to a conquered people to say "Be reasonable and accept the inevitable," but whether such advice comes effectively from a man like Mr. Chamberlain, who first took care to conquer before being reasonable and conciliatory himself, is another matter entirely. His tour at least has demonstrated that the race fusion will be much slower than he had hoped in his warlike days.

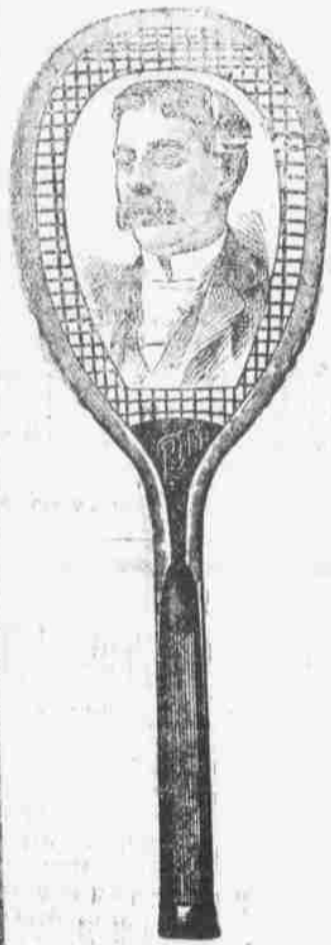

WANT FUTHER INFORMATION

THE PETITION FOR REPAYMENT OF JOHN A. CUMMINS \$5,000 FINE IN THE HOUSE THIS MORNING.

The claim of the Hon. J. A. Cummins for \$5,000 which he paid as a fine for misprision of treason came up in the House this morning on second reading of Kumalae's bill to appropriate the amount for Cummins. The Finance Committee report on the bill stated that it was not clear in stating the reason for which the appropriation was to be made, and recommended that it be returned to the introducer for correction.

Kumalae offered a preamble and moved that it be inserted before the enacting clause, stating that Cummins was the only one of the many who were fined who paid the fine. He was arrested and kept in prison, tried, found guilty and paid the fine.

Chillingworth said that his recollection was that Cummins had paid the fine under an agreement whereby he escaped imprisonment. Kanoho and Kumalae talked back and forth in Hawaiian. Kanoho enquiring as to how the bill happened to be drafted.

Pulaa proposed a special committee to investigate the claim and the proposition carried. Vice-Speaker Knudsen named Pulaa, Greenwell and Kumalae as the committee, to report to the House today.

Kumalae's preamble was as follows:

"Whereas the Honorable and aged John Adams Cummins was arrested by the Government of the Republic of Hawaii and confined in Oahu prison, was arraigned before a military commission or court martial of said Republic of Hawaii, and was charged with the crime of misprision of treason; and was convicted and sentenced to pay a fine of \$5,000, was confined in Oahu prison for a period of 30 days, did pay such fine of \$5,000 and was thereupon restored to liberty."

TODAY'S WORK IN THE HOUSE

THE ISSUE BETWEEN THE HOUSES ON THE COUNTY BILL IS NOW SQUARELY RAISED.

The House this morning received notice from the Senate of the upper body's refusal to concur in the House amendments to the county act, Senate Bill No. 1. No action was taken at once, the House proceeding with its regular order of business. The Senate also sent notice of refusal to concur in House amendments to Senate Bill No. 84, relating to criminal practice and procedure.

Nakaleka introduced a resolution to appropriate \$5,000 for a breakwater at the Kalaupapa leper settlement. It was adopted after a motion to table had been voted down.

A resolution by Vida to appropriate \$12,000 for the Coney estate, to reimburse the estate for lands taken for the Tantalus road, was referred to the Public Expenditures Committee.

Lewis introduced a resolution to appropriate \$3,000 for a second district magistrate at Hilo and \$2,400 for an assistant clerk and interpreter in the Fourth Circuit Court.

The following House bills came up on second reading and were referred to committees: An act to define the unlawful influencing of voters; an act relating to children remaining on streets after sunset; an act to regulate the employment of labor on public works; an act to provide for the publication of a volume of Estee's decision; an act to regulate the placing of electric wires in Waialuku and on other parts of Maui; an act creating a Territorial department of secret service; an act to provide for fire hydrants, etc., in Waialuku; an act to encourage a telephone system on Hawaii; an act to amend act 64 of the Laws of 1896. Bills sent from the Senate after final passage there passed first reading and Senate bills on second reading were referred to committees.

Senator Dickey's bill defining the legal holidays in the Territory passed second reading. The Senate Hilo railway franchise bill was referred to the Public Lands and Internal Improvements Committee.

AGAINST THE ORIENTALS

There was not much of particular interest in the Senate this morning. The last hour of the morning session was occupied with the consideration of the bill to amend act 101 of 1929. It was decided that the permits would have to be secured from the Superintendent of Public Works instead of the plumbing inspector. Some minor changes were made in the bill. The measure had not been concluded at the noon hour, when a recess until 2 p. m. was taken.

One of the first measures brought to the attention of the Senate was a petition from the secretary of the Honolulu Trades and Labor Council urging favorable action on the Hackman bill. The communication stated that the organization was in favor of the measure and claimed that the American and Hawaiian hackmen had more money invested in that line of business, than the Orientals, and deserved more consideration. The petition was tabled to be considered with the bill.

The resolutions adopted by the labor people at Hilo and which were presented to the Senate yesterday, were presented to the Senate this morning. The communication was tabled, to be considered with a bill which is to be introduced shortly along the lines suggested by the communication, which urges that some legislative action be taken to check the invasion of the mechanical trades by the Japanese.

The Long municipal bill was received and given first reading as was Bill No. 83 to provide for right of action for damages.

The bill to provide for the digest of the Hawaiian Supreme Court reports was introduced by Senator Cecil Brown. An appropriation of \$4,000 was asked. Fourteen volumes will be digested and the work will be sold for \$5.

The Senate was notified by Secretary Carter that Governor Dole had signed the bill relating to divorce, separation and marriage.

Favorable report was made by the Health and Education committee for a high school at Hilo. The report recommended that the original item be reduced from \$25,000 to \$18,000. A four room school house to cost \$6,000 with 5 special teachers at \$12,000 for the biennial period would in the opinion of the committee be all that Hawaii would require in the educational line. The report was adopted but subsequently the bill was reconsidered as no change had been made in the amount appropriated. This matter was reconsidered and the report will be taken up to be considered with the bill.

The health committee also reported favorably on the resolution to provide for a sewer for Kalihi. The cost would be \$21,443.20 and the committee recommended that \$12,000 be appropriated toward that purpose provided the trustees of Kamehameha would agree to appropriate the balance. The

Silva bankruptcy case was resumed this morning before Referee Rawlins, with a long cross-examination of Silva on the subject of his expenditures and receipts and the business of the grocery store he has been conducting on Beretania street, Gill and Farley appearing in opposition to the bankruptcy proceedings as representatives of Silva's divorced wife and several other creditors.

According to the testimony Silva did a large liquor business. Inquiries were made about several large purchases of intoxicating liquors, and it was finally admitted that the grocery got about \$400 worth of liquor a month, and over \$400 in one month. The liquor was sold in a small backroom. Silva has an internal revenue license, but no territorial license, to sell intoxicating liquors.

Silva was also questioned at great length regarding his income. He admitted expenditures of \$2,153.55, including about \$125 per month for his personal expenses, and cash receipts of \$7,448.50, which he said to be much more than was stated in the Circuit Court divorce proceedings.
