SOCIEDADE PORTUGUEZA DE SANTO ANTONIO BENEFICENTE DE HAWAII

RESOLUTION

The General Assembly of Sociedade Portuguesa de Santo Antonio Beneficente de Hawaii, in extraordinary session, duly convened on August 3, 1934, hereby resolves that the following amendments be made to its By-Laws:

First: That paragraph 3 of Article 1, Chapter XVI, is hereby amended to read as follows:

"3—Seventy-five cents (\$.75) a day during the period of ninety (90) days."

Second: Article 3 of Chapter XIV is hereby amended to read as follows:

"Article 3—If within the period of two years after the last date that he was sick, the member claims sick benefits, the Administrative Board shall take in consideration the date in which he last gave notice of conclusion of sickness, and, if between this date and the new notice there has not yet passed two years, the Board shall vote in favor of the member the sick benefits in the order that they would have been paid in case the member continued to be always sick until he receives the sum of \$1,110.00 from the General Fund, including sick benefits that he may have received during one or more periods of sickness during the time of his membership, whether he had been suspended or expelled and afterwards readmitted, not including, however, the additional benefit mentioned in Article 4 of this Chapter.

"When the member has completed receiving the

total amount of \$1,110.00 in sick benefits from the General Fund, the sick benefits by reason of sickness cease to be paid from the General Fund, but if the member under these circumstances desires to receive additional benefit during his illness, he can, after notifying the Administrative Board in this respect, receive monthly or once every three months, presenting for this purpose the certificates and medical proofs in accordance with the provisions of this Chapter, a benefit (which shall be also known as "beneficio") at the rate of 1% of his endowment allowance per month as an advancement on account of said endowment as prescribed in Chapter XVI and to which he would have a right at his death; conditional, however, that this advancement of endowment by reason of illness shall not exceed during the member's lifetime the limitation of two-thirds (2/3) of the endowment benefit for which he last subscribed as an effective member."

"If, however, the member outlives the receipt in benefit for illness in accordance with the provisions of this Chapter, of the total amount of two-thirds (2/3) of his endowment allowance, he, in case of illness not considered incurable, shall return to the right of receiving a sick benefit daily of fifty cents (\$.50) from the General Fund as long as he continues sick without being declared an invalid."

Third: This resolution shall take effect the day of its approval:

RESOLUTION

The General Assembly of the Sociedade Portuguesa de Santo Antonio Beneficente de Hawaii, in extraordinary session duly convened on November 19, 1934, by this means resolves that the following amendments be made to the By-Laws:

1. That Articles 3 and 5 of Chapter XVI are hereby amended to read respectively as follows:

"Article 3. On the occasion of the death of any member who has completed 30 days of membership from the date of the payment in full of his admission and diploma fees, as well as the payment of the dues of the first month of his admission, and is not suspended for nonpayment of dues of whatever nature or for any offense committed contrary to the by-laws of this Society, and who has not at any time received the death benefit mentioned in Article 4 of this Chapter, nor received any advances on account of sickness or pension, the Society shall pay to his heirs or legatees, in accordance with these by-laws, a death benefit equal to the amount he subscribed for, in accordance with the provisions of the preceding Article.

"Article 5. On the occasion of the death of any member who has completed 30 days of membership from the date of the payment in full of his admission and diploma fees, as well as the payment of the dues of the first month of his admission, and is not suspended for nonpayment of dues of whatever nature or for any penalty imposed on him in accordance with the by-laws of this Society, and who has at any time after April 1, 1910, received or been given the right to receive

a death benefit or advancement on account of the death of his wife, or advances on account of sickness or pension, the Society shall pay to his heirs or legatees, in accordance with these by-laws, the amount of the death benefit for which he subscribed less the advancement or advances which he received while he was living."

2. That Article 10 of Chapter XVII is hereby amended to read as follows:

"Article 10. On the death of any honorary member who has completed 30 days of membership after the payment in full of her admission and diploma fees, as well as the payment of the dues of the first month of her admission, and is not suspended for nonpayment of dues of whatever nature or for any penalty imposed on her in accordance with the by-laws of the Society, this Society shall pay to the heirs or legatees, in accordance with the provisions of this Chapter and the by-laws in this respect, a death benefit amounting to \$750.00, less whatever amount that may have been advanced to the said honorary member during her lifetime as sick benefit or pension."

3. This Resolution shall take effect on the date of its approval, thereby revoking all dispositions to the contrary.
