INAUGURATION PLANS ARE COMPLETED

CARTER WRITES OF COASTWISE SHIPPING LAWS

One of Governor Carter's last official documents is the following letter on the coastwise shipping law. This letter speaks for itself:

(Copy)

Aug. 12, 1907.

E. T. Chamberlain, Esq., Commissioner of Navigation, Department of Commerce and Labor, Washington, D. C.

Dear Sir:—Permit me to acknowledge receipt of yours of June 18th, with its enclosure of J. D. Spreckels & Bros. Company's letter, from San Francisco, under date of June 11th.

I cannot hope to compete with paid experts of corporations, who, as you are aware, have heretofore played so important a part in shaping our national legislation. It is but natural that they should fail to recognize the position of the common people and the demands that the public are now making, in contradistinction to corporate interests.

An administrative officer has often to meet perplexing questions concerning his duty. No one disputes that he is expected to enforce the laws, but every law is an abridgement of a private right as to some and the granting of privileges as to others. Thus its justice and permanency depends upon its usefulness to the majority.

Every rule has its exceptions, and a law in our country which is obnoxious to the people will not stand for any length of time, nor will they long tolerate its enforcement. An administrative officer often will enforce an obnoxious law in order to secure its early repeal. But we in Hawaii realize that the coastwise law has much of merit in it, and do not believe that your Department should enforce it in such a manner as to make it obnoxious, with a view to securing its repeal, for the lawmaking body, as I understand it, gave to the Secretary of Commerce and Labor the exclusive power and privilege of remitting such fines for violation of this Act as in his judgment he might think wise.

To show how impossible it is to strictly enforce a law of this nature, which does not take cognizance of varying conditions, I need only ask if your Department believes that, in the protection of Spreckels Brothers shipping interests, it was wrong for

you to consent to the British ship Restorer carrying supplies to the marines located on Midway Island to keep them from starving, after they had generously divided their stores and food supplies with the large number who were landed there from the stranded "Mongolia?" I need not mention the fact that it has already been recognized that Guam and Samoa should be exempted from the application of this law, it being impractical of application there.

Now, the public of Honolulu and this Territory, prior to annexation, enjoyed the passenger service of every steamer that stopped here. Thus commerce was enabled to grow because of the personal contact between buyer and seller, so essential to credit and trade. The application of the coastwise law to these islands, two thousand miles from the mainland, has in no way built up or fostered American shipping. Within the past year the Spreckels Brothers line itself, notwithstanding the encouragement of the coastwise law, has been obliged to withdraw all of its steamers but one. This, in conjunction with other losses, has deprived the people of Hawaii within the last year of over one-third of the already restricted accommodations which they have been forced to accept since annexation.

I have it on so high an authority as that of Mr. Schwerin, General Manager of the Pacific Mail Steamship Company, that the trade of Hawaii was immaterial to his Company. He stated in an interview lately in San Francisco that if he had to move a small coal pile from land of the Naval Reserve or pay ground rent for their coal storage (which is borne by all other steamship companies here) he would sooner cut out Honolulu from his service entirely.

For a long time every effort has been made by the people of Hawaii to force the Pacific Mail Company to recognize the local trade and permit a small portion of each steamer to be set aside definitely for the Honolulu trade, so that those who might be here, for business or other reasons, could be sure of accommodations, and not be subject to the inconvenience, as has repeatedly been the case, of

Hanalei Suffers Wash Out

(Special to the Bulletin) Hanalei, Kauai, Aug. 12.—On Saturday evening between the hours of 6 and 8:30 Hanalei and Wainiha was the center of great excitement. At about 6 o'clock it started to "pour" and it was about 8:30 p. m. before the rain ceased. During that time the rain gauge at Hanalei registered 8.1 inches. The next morning the gauge at the "Kauai Electric Co.'s" power house at Wainiha said 17 inches.

Sunday morning, as usual after most storms, was cloudless and bright, but the roads and bridges were gone. The big bridge at Wainiha was nowhere in sight, and one at Walkako, in the Hanalei valley, also went to sea. As to the road, in places there are traces where there once had been a road. The road between Hanalei and Wainiha is pretty well gone.

The Wainiha people suffered the loss of their bridge and the fine road built by the Kauai Electric Co., which has been washed out of existence. The Electric Co. also loses a few poles.

One or two rice planters have lost almost their entire crop. One has estimated his loss at \$2500.

Hanalei this year has had a rather wet time of it. Since the first the rainfall has been 106.92 inches.

CLAIM CARTER ADVISED FREAR TO "FIRE" ALL

If Chief Justice Frear had followed the advice given him by Governor Carter he would have made a clean sweep of all the department heads and instead of accepting the resignation of only Mr. Peters, who would not consent to retain the Attorney Generalship, would have fired the entire cabinet. That is the story at the Capitol today.

Among the heads of departments there is expressed much indignation at this action on Carter's part, which they denominate as ungrateful and treacherous. All the department heads have done their best to make the administration of Governor Carter successful and have succeeded in covering up as many of his bad breaks as possible. And as a reward for their loyalty he tries to have them all kicked out of office when he goes out. Perhaps Carter takes the view of the old savage chiefs who used to have large numbers of their friends and others sacrificed on their graves.

Those of the department heads who care to discuss the matter at all say that Carter in taking this action has

broken faith with them. Some of them demurred to his request that they take office under him, on the ground that they would be liable to be thrown out on his retirement and it would not be worth while to take the positions for two or four years and then have to get out and start in new at something else. But Carter told them that there was no reason why they should have to get out when he did. If they made good, they ought to be retained by his successor.

As a rule, it takes a man a good part of one term to get thoroughly familiar with the details of his office, and to let him out just as he is getting most efficient is regarded as a policy by which the public would be the losers.

Carter has spent considerable of his time out of the Territory during his administration of affairs and his cabinet have done their best to keep things moving. In view of the loyal support, they feel all the more hurt at the way he threw them down. They say there is no incentive for a man to do his best if he is to be kicked out at the end.

LOGAN WILL LOOK FOR LAYSAN ISLAND

Shipmasters Believe That Schlemmer's Isle Is Safe

"I am going to take the Laysan Island route," said Captain Stinson of the transport Logan this forenoon. "I don't know what became of the island, but if the schooner Luka had taken the regular course, Captain Oleson would surely have found it; that is if the island has not sunk."

Along the waterfront no stock is taken in the supposition that Laysan Island has really disappeared. It is generally believed that Captain Oleson missed the island by some error in his reckoning and passed it, a thing which he might quite easily do, as it can only be seen a very short distance off. That he found Oahu on his return is explained because this island is visible from quite a great distance. Numerous explanations of how the error in the reckoning could have occurred are being offered by the old salts, but they are all necessarily so technical as to be only intelligible to masters of the art of navigation.

ROW OVER DAM GOES TO SUPREME COURT

Territory Heavy Loser By Action Of Auditor Fisher

The new trouble over the Nuuanu dam will increase the cost of the work to the Territory, says Superintendent Holloway. The laborers will get their pay, although the matter will be carried to the Supreme Court by Mr. Holloway as soon as the Court is reorganized. It will be taken up on one count, that of the salary of B. F. Holloway, one of the engineers on the dam. His salary of \$175 was held up by Auditor Fisher, as well as the payrolls of the laborers. The laborers will get their pay, as Mr. Holloway states that he will turn the payrolls over to the contractor, Whitehouse, and let him pay the men and what other expenses have been incurred. This will cost the Territory considerably more than if the money were paid by the Territory directly, as Whitehouse will get his 15 per cent profit on the money he pays out. This would be saved if the Territory were allowed to pay out the money.

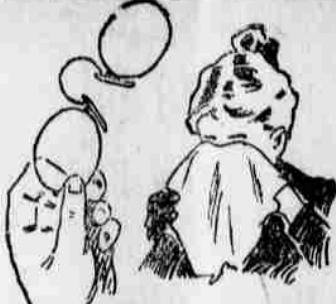

(Continued from Page 1) on a real counterfeiting plant, making real counterfeit money—in the office of the United States Marshal himself. The man is a Korean named Kim Bong Chuen, who was captured by Marshal Hendry on Hawaii recently. He admits that he is a counterfeiter and insists that he is the only real article of that brand in the islands. The authorities are inclined to take this with several large grains of salt. United States District Attorney Breckins intimated that he had spent some time in Missouri and would have to be shown.

He was shown. The Korean said he would show him how it was done. They took the man down to Wickman's jewelry store and let him demonstrate what he could do. He went to work and made his own tools, which were very simple, and with them turned out a counterfeiting plant that made the eyes of the authorities hang out. It was so simple it looked impossible. The whole affair could be put in one's pocket, yet the coin it turns out is so close an imitation of the genuine that there is no difficulty in passing it.

The nature of the metal used in the coins is still a mystery. Kim Bong Chuen calls it Korean calabash, but that doesn't help much. It has the proper weight and color but is off in its ring.

The Korean appears to be rather proud of his handwork but is evidently putting up a bluff about being the only operator, in the hope of saving the rest of the gang.

The capture of this man is the result of hard and persistent work on the part of the local Federal officials who have run him down.

Beyond that I have not as yet made up my mind."

GRUEL HUSBANDS BEAT THEIR WIVES

Divorce Court Calendar Clogged With Tales Of Cruelty

Complaining that her husband, Kyusuke Aikana, has during the entire period of their married life treated her in an extremely cruel and inhuman manner and has on many occasions threatened to take her life, Tsuno Aikana asks the court to grant her a decree of divorce. She alleges several instances when Kyusuke struck, beat and wounded her, and states that on last Wednesday he again assaulted her and after beating her with his fists, he got a carving knife and threatened to kill her with it. She believes that but for the interference of others present he would have taken her life on the spot. The man, libellant claims, has never provided for her support.

Miki Sakaguchi has a similar tale of abuse to relate in her libel of Katsuhel Sakaguchi, from whom she asks the court to divorce her. In addition to failing to provide for her maintenance, she says her husband on August 4, 1904, commenced a course of extreme and repeated cruelty toward her, and on the 10th and 20th days of last June beat, choked and bruised her and threatened to kill her, which she is afraid he will do.

Caroline Awa got quick action on her suit for divorce from John Awa. The libel was filed and the divorce granted yesterday morning, desertion being the ground of the action. The custody of the minor child was awarded to the libellant.

Kinoua Awana was also presented with a decree of divorce and granted the custody and control of her six minor children. She, too, alleged extreme cruelty as the ground for her suit, claiming that her husband, W. Awana, had beaten her and compelled her to earn the living for the family while he lived a life of idleness.

Judge De Bolt also separated Louise Keola from a husband who would not keep the flour barrel filled. She claimed that George Keola, the husband, whom she gets rid of, left her in want and dependent upon the charity of others.

GOVERNOR CARTER'S CONTRIBUTION.

One of the most valuable contribu-
tions Governor Carter makes to the
coastwise shipping law discussion is
his quotation from the statement
made by the manager of the Pacific
Mail line. Mr. Schwerin's assertion
that the Hawaiian section of his
steamship business is of no special
moment to him is a clear cut off-set
to the argument of P. C. Jones that
Honolulu is doing a great and good
friend a serious injury by even dis-
cussing the failure to give this port
satisfactory service.

The Schwerin statement is also a
very powerful argument for the local
steamer or steamers for this port.
It cannot be too often repeated, for
it is an every day living truth that
Honolulu and the Hawaiian Islands
play "second fiddle" in the consider-
ation of this and every other through
line, let that through line be Ameri-
can, British or Japanese.
Suspension of the coastwise ship-
ping laws is a relief.
Combination of freight interests
and financial interests to improve the
steamship service between Hawaii
and the mainland is a solution.
Governor Carter's letter would be
illuminated to quite an extent if
he were able to give out the letter
from the Spreckels interests to which
he refers. It is hardly probable,
however, that the Spreckels claimed
their local line with Hawaii is a los-
ing venture or ever has been.

THE ATTORNEY GENERALS.

Governor Frear loses a first class
Attorney General through the deci-
sion of Mr. Peters to retire and gain
a man who should make a most satis-
factory official, by the selection of
Mr. Hemenway to fill the vacancy.
Mr. Peters has handled the legal
department of the Territory in a
manner that has merited the con-
fidence and praise of his superior and
the people. He has looked after the
interests of his client—the Territory
of Hawaii—with loyalty and ability.
Mr. Hemenway, the incoming offi-
cial, has been successful in his prac-
tice and although this is his first ex-
perience as a prosecuting officer, his
reputation is such as to enable him
to start his work under most favor-
able circumstances and the kindly
feeling of the people. As one of Gov-
ernor Carter's legal advisers during
the sessions of the Legislature Mr.
Hemenway has had special opportu-
nity to keep in touch with the spirit
as well as the letter of recent laws.

LAYSAN ISLAND.

Either the skipper of the schooner
Luka was lost or Laysan Island has
sunk beneath the sea. The story
which Capt. Oleson brings to town
is either a seven days wonder or a
remarkably good yarn of the sea.
The Bulletin is very doubtful

learning that they have booked with
fifty or sixty other passengers desir-
ing to leave and that the steamer
can only take three or four addition-
al passengers at Honolulu, thus being
obliged to await another steamer
of American register, lose their time
and be greatly inconvenienced by the
delay, during which they often see a
British or Japanese passenger steam-
er arrive and depart. In fact, I may
say the agitation of this question was
started, not by residents of Hawaii,
but by visitors here, who claimed it
was the first time they had found
that being an American (and in an
American port) was a distinct dis-
advantage.

It cannot reasonably be argued
that the application of the coastwise
law was ever intended for a part
which had no rail communication
with other parts of America. As I
have already stated to you, in the de-
velopment of our country there have
been few features of more potency
that the free interchange and travel
of our people from one part of the
country to another. This has not
only made us homogeneous but has
brought about the immense trade be-
tween the various states and terri-
tories. It cannot be claimed that it
was the intention of Congress in this

passage of this Act to hamper or re-
strict this free interchange of our
commerce. The American drummer,
the wonder of the business world,
finds it most irritable to stop off
with his samples in Hawaii, expect-
ing to catch a steamer which he sees
scheduled to leave in a few days, and
then learns that he can only travel
on that vessel by the payment of a
fine of \$200.00. He cables his princi-
pal that his expenses go on and his
time is lost.
If during the eight years that this
law has been applied to Hawaii the
passenger service from these islands
to the mainland has been bettered or
increased because of this protection,
you would not find public-spirited
men in Hawaii opposing it. So far
as I am aware, there has not been a
murmur raised by the sugar planters
against the restriction to American
bottoms, though it costs them \$600-
000 a year—a tax practically of
\$4.00 per capita of our population.
Our people do not ask an exemption
for freight, but we do maintain com-
mon sense dictates that ordinary
judgment be used in the application
of our national laws.

I presume those who have money
invested in American ships will feel
that they are acting rightly and hu-
manely when, by insisting on its ap-
plication, they subject the local
naval authorities to keep one of
their sailors here for three weeks in
a dying condition, after his physi-
cian has stated that the only way to
save his life was to send him to the
Coast. The application of the naval
authorities for an exception had
been denied and no transport or other
American bottom would touch
here for that length of time, although
there have been two or more oppor-
tunities for placing him on an Eng-
lish vessel and thus saving his life
perhaps.

No community regrets more than
this the action of Congress in failing
to provide a subsidy, which would
probably have maintained the Spreck-
els Brothers steamers in service. But
in view of the fact that they have
been obliged to take their steamers
off, and the reputed statements of
the Pacific Mail Steamship Company's
officials that the passenger traffic
from Honolulu is a matter of utter
indifference to them and plays no
part in their calculations, as well as
other considerations, is not this Terri-
tory justified in demanding of the
Secretary of Commerce and Labor
that he use the discretion which
Congress has given him, and remit
all fines until such time as in his
judgment the service of American
steamers calling at this port war-
rants the application of the law in
its full rigor.

commander. Among them were Col-
onel Sam Parker and Wilder.
"I am glad and pleased to say that
the Manchuria is making much better
time than she used to," said Captain
Saunders. "Her engines are doing
splendid work and everything is in ex-
cellent condition."
The Manchuria brought a large list
of passengers for this port. Many of
them are island people who have been
on the mainland on business and
pleasure trips. Among the arrivals
was A. Garley of the Hawaiian Elec-
tric Co., who went away in the inter-
est of his company. Colonel C. W.
Ziegler also returned in the Manchuria
and reported prosperous conditions in
San Francisco. E. D. Tenney of Castle
& Cooke, accompanied by Mrs. Tenney
and family, also returned from the
mainland. Miss L. Lloyd, stenographer
of the Road Department, arrived in
best of health. She was surrounded by
her friends at the wharf. Mr. Y. Sui-
ten of New York branch of the Yoko-
hama Specie bank comes to become an
assistant manager of the local specie
bank. He was met at the wharf by
Mr. Akai.
Besides 250 tons of general cargo of
freight for the Orient the Manchuria
is taking back to the land of chrysan-
themum 112 deported Japanese from
San Francisco. Out of this number
are five women. They were all dis-
covered by the immigration officials at
the Mexican border. The majority of
them having resided in Texas and Ariz-
ona and being of the heat and the
small pay which they were getting, de-
cided to enter the United States; but
unexpected and contrary to their
dreams they found that Uncle Sam
was too quick for them. On examina-
tion before the Board of inquiry they
admitted that they violated the immi-
gration laws and accepted their de-
portation good naturedly. At the
Haskell wharf they attracted a good
deal of attention. Although they said
nothing, they were apparently anxious
to get into conversation with the shore
Japanese who gathered around. The
deported Japanese were very un-
tidy in their dress and hence the at-
traction. Besides the Japanese there
are five Russians and five Chinese on
the deported list.
The Manchuria will sail for the
Orient tomorrow morning at 10
o'clock, taking about twenty-eight
people from this port.
Dr. de Burrows, the Minister of
Education in the Philippines, arrived
in the Manchuria, as was expected. He
is going back to his post accompanied
by his wife and family. He came
ashore immediately after the Man-
churia docked.
At the recent burning of a stable in
the Potrero, San Francisco, thirty-one
horses that were haltered to their
mangers were burned to death.
The San Francisco police have un-
earthed a new slave ring in that city,
capturing fifteen newly arrived girls
in the rail.
G. H. Thell, who recently died in the
states, was noted as one of the great-
est detectives living.

PROMOTION COMMITTEE TO BE REORGANIZED

Chamber Of Commerce Will Hold Annual Meeting

The regular meeting of the Chamber of Commerce, which was to have taken place this afternoon, has been postponed until Friday afternoon at 3 o'clock owing to the fact that many of the members are going to the polo games.

The annual meeting of the Chamber will probably take place some time next week. It is generally believed in commercial circles that Jas. F. Morgan will be elected as its next president. As soon as the Chamber has organized for the coming year its president will appoint two members of the Promotion Committee, which will at this time be completely reorganized. The Merchants' Association will also, through its president, appoint two members of the committee, and these four members will themselves choose the fifth member. It is not known at this time whether any of the present members of the Promotion Committee will serve again. If Morgan is elected president of the Chamber of Commerce there will at least be one new member, as he will then not be able to serve any longer.

TRENT REPORTS ON COUNTY FINANCES

Treasurer Trent has prepared a report showing that the County had on hand August 1 \$21,588.08, while \$27,000 was in the bank at the County's credit on July 1. In addition to this balance the receipts of the County for the month amounted to \$27,983.11, the Territory paying over of this \$26,360.56.

The disbursements totaled \$33,395.65 as follows:

County Attorney, \$847.50; Auditor, 276.05; County Clerk, \$687.37; County Engineer, \$350.95; electric lights, \$1,372.34; Ewa road district, \$1524.01; Fire Department, \$4071.97; Garbage Department, \$1533.99; land, \$1584.85; Kapiolani Park, \$663.89; keepers of parks, \$263.10; Koolauloa road district, \$874.50; Koolauloa road district, \$337; Police Department, \$5582.98; police and fire alarm, \$243.48; Road Department, \$1160.56; Sheriff and Deputies, \$720; Treasurer, \$125; Waiakua road district, \$1206.85; Waiakua road district, \$300; road tax commissions, \$14.06; coroner's fees, \$58; County office rent, \$150; poundmasters, \$30; Supervisors' salaries, \$250, and witness fees, \$167.40.

Of the special road tax fund during July the Honolulu district was the only one to figure in the receipts column, turning in \$861. The disbursements in the various districts were: Honolulu, \$2670.32; Ewa and Waiakua, \$1440.30; Waiakua, \$2,409.29; Koolauloa, \$548.96, and Koolauloko, \$491.02. The total available balance in the County amounted on August 1 to \$26,815.35.

FILMS IN TIN TUBES

After considerable experimenting, Honolulu Photo-Supply Co. has proven conclusively that kodak films in tin tubes, hermetically sealed so as to exclude all air and moisture, will stand Hawaiian climatic conditions much better than films packed in pasteboard boxes. Acting in accordance with this knowledge they have ordered all films hereafter to be shipped to them in this manner. The first shipment has just been received and the films in tin tubes are now on sale.

Although there is an additional cost to the Honolulu Photo-Supply Co. for the tin tubes they have decided to sell the films at the same old prices.

The Honolulu Photo-Supply Co., has made numerous innovations in the methods of packing films and papers for this climate during the years they have been in business here, all of which have been to the advantage of local kodakers.

WARREN'S LOAD.

The San Francisco Evening Bulletin has the following to say regarding the Transport Warren which is now in this harbor:

"The Transport Warren sailed at noon today with the Fifty-Seventh Torpedo Company and fifteen army electricians. In her hold were tons of gun-cotton, nitroglycerine and dynamite, which will be used in planting mines in the harbors of Manila, Iloilo and Zamboanga. The mission of the company is along the lines of putting the Pacific ocean in a state of defense against any possible attack. The work will take several years to complete."

It is given out by Captain Warren that the Snark will sail from Bishop's wharf tomorrow afternoon at 4:30, destined for Hawaii. The London will visit with Dr. Goodhue while on the big island. When the Snark leaves Hawaii she will head for Christmas island.

The Examiner of August 6 has the following to say regarding Joy's big game:

OH, JOY!
Those of us who annex our three squares per diem by telling what has happened out at the ball park have fought religiously against using this expression. It was so obvious that any man who has any respect for his craft would hesitate before sending it to the composing room.

OH, JOY!
That's the only thing possible to say. Obvious or not, it fits the situation. For the fellow who wears this name with a prefix of Barney carried off the honors in yesterday afternoon's contest. His name coincidentally happens to voice the feelings of the San Francisco rosters. He is the cheapest pitcher in the league, Danny Long having bought him for \$125 more than a song. At the same time, however, he is the best man, from a boxoffice standpoint, of any slab artist in the entire organization.

After a week so disastrous that the Seals failed to gather the winning end of even one battle, Long sent in his low-priced man and won. For the Seals to win was a matter of surprise, at best. Shaughnessy then hit down to right and Esola all but scored. They slapped the Spaulding on this at the plate.

A pair of blanks was the lot of the Commuters in the first half of the eighth. When the Seals walked in to the bench, however, and stepped one by one out to meet Eli Cates face to face, it was quite a different tale. Spencer hammered the leather for two sacks, and roared there just a moment. He went to third on Wheeler's infield out, and then, on a very wild pitch by Cates, romped home.

BRITT OWES MUCH TO KELLY

The big man behind the gun was Spider Kelly, who seconded Jimmy Britt to the intense satisfaction of all his backers. If Britt had any desire to rush and floor Bat with a swat on the jaw Kelly discouraged him. "Fight carefully," was Kelly's slogan last night. Kelly's instructions were: "When Bat starts that in-fighting don't you make a move until he stops punching. You protect yourself, but just as soon as Nelson stops trying to get in them uppers you go to work and punch his bloody head off."

Kelly was afraid of Nelson at close range. After the battle the Spider stated that Britt fought right to orders, and he had only words of praise for his exhibition. Jimmy made one of the most remarkable fights in the history of the ring, chirped Kelly in the midst of a bunch of excited fans. "Look, see what he did," cried Kelly, swinging both arms in the air. I was satisfied he had the fight won, so I advised him to be content with out-punching him."

Kelly was dripping with perspiration when he left the ring. It was a question whether he or Britt was more tired. The Spider worked over Britt as he never worked over another fighter, and Jimmy owes a lot to his chief second.

Tommy Burns picked Britt to win. He bet some money on the short-end, and on the way to the fight he told Eddie Smith, the Oakland referee, that in his opinion Britt would win.

"Britt will stay away this time," said Burns, "and make his skill as a boxer count. Such a fight will win in a twenty-round go with the Dane. Britt can out-point him and get the decision, and he will do it, after the lesson he was taught at Colma."

As usual, Billy Nolan's methods have brought Nelson through with all the best of it from a money point of view. Although defeated, his extra 10 per cent gives him \$2,300 more than Jimmy Britt gets for outfighting him all the way through.

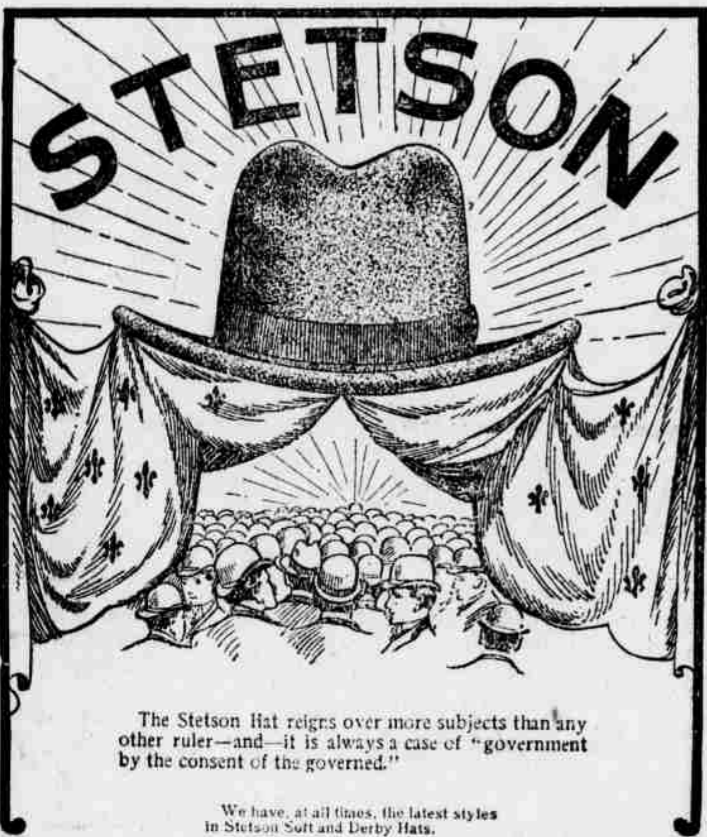
