ANCESTRY FROM RELOCATION CENTERS STOP RE WDC TWX NUMBER CS 1214 DATED 1 JAN 45
STOP IT IS REQUESTED THAT INSTRUCTIONS BE ISSUED TO COMMANDING OFFICERS OF ALL
MILITARY POLICE DETACHMENTS AT WAR RELOCATION CENTERS THAT PREVIOUS INSTRUCTIONS
CONTAINED IN TWX CS1214 ARE AMENDED AS FOLLOWS COLON IN ADDITION TO THOSE PERSONS
WHOSE NAMES APPEAR ON LIST OF PERSONS QUOTE CLEARED UNQUOTE BY THE WESTERN
DEFENSE COMD AND THOSE PERSONS OF JAPANESE ANCESTRY WHO HAVE BEEN GRANTED
EXEMPTIONS FROM ALL WESTERN DEFENSE COMD PROCLAMATIONS A LIST OF INDIVIDUALS
IN RELOCATION CENTERS WHO HAVE BEEN INDIVIDUALLY EXCLUDED AND WHOSE CASES
HAVE BEEN REVIEWED AND WHO MAY BE RELOCATED BY WAR RELOCATION AUTHORITY ANYWHERE
IN THE UNITED STATES OUTSIDE OF THE EXCLUSION AREAS OF THE WESTERN DEFENSE
COMD AND EASTERN DEFENSE COMD IS BEING FORWARDED TO THE MILITARY POLICE COMMANDERS
AT THE RELOCATION CENTERS STOP EFFECTIVE 21 JAN 45 THOSE PERSONS ON THIS LIST
MAY BE RELOCATED FROM CENTERS COMA PROVIDED THAT NON ENTER EXCLUSION ZONES STOP
ADDITIONAL LISTS WILL BE FURNISHED AS REVIEW OF CASES OF INDIVIDUAL EXCLUDERS
ARE COMPLETED UNQUOTE IT IS REQUESTED THAT A SIMILAR MESSAGE BE SENT TO CG
SEVENTH AND EIGHT SV COMDS APPLICABLE TO WAR RELOCATION AUTHORITY CENTERS IN
THEIR SERVICE COMDS END
