TO START A NEWSPAPER

MRS. THERESA WILCOX HAS A NEW SCHEME.

Wants to Run a Home Rule Paper of Her Own, Half English and Half Hawaiian.

Mrs. Theresa Wilcox is reported to be about to start a newspaper. She has watched Honolulu journalism, native and haole, and come to the conclusion that the city, in spite of its numerous publications, still lacks a newspaper of the right kind.

Theresa's paper will be half in English and half in Hawaiian. It will be an up-to-date English-Hawaiian journal, containing "all the news of the day, with bright intelligent comments by a corps of experienced writers."

The starter of the newspaper has not yet decided who will be editor. He will be a man familiar with Hawaiian affairs, and in strong sympathy with the sacred principles of Kuokoa Home Rule Republicana, and he will be expected to do heavy work for the party. Mrs. Wilcox has never tried journalism before, and she is enthusiastic about the new venture. She is delighted at the prospect of being the power behind the pencils and typewriters of a great daily.

The new paper will probably be called the "Home Rule Chronicle." There are now three native papers published in Honolulu. They are the Kuokoa, Lahui Hawaii, and the Aloha Aina.

TRIED TO JUMP THE DAIL

A. GRELCK CAUGHT ABOARD A VESSEL TODAY.

Would Have Sacrificed a \$300 Cash Bail—Another Former Brewery Employee Leaving at Same Time.

A. Grelick, the former employee of the Honolulu Brewery, who is under indictment by the grand jury for larceny of various kegs of beer, made an unsuccessful attempt today to jump \$300 cash bail. He was caught by the police and landed safely in jail, much to the satisfaction of F. M. Brooks, his attorney who nearly had heart failure when he learned how nearly he had lost about the \$300 of the bail which, as attorney, he had loaned his client.

Grelick tried to stow away on the German ship Sirene which left for Portland this morning. He went aboard her last night and he took his baggage along with him. Deputy Sheriff Chillingworth received the tip that a man answering the description of Grelick had gone aboard the Sirene and had probably stowed away. A trunk had also been sent aboard about the same time. Captain Flint was directed to make a careful search of the vessel this morning. He did so, and located Grelick, as well as another former employee of the brewery, who was named A. Roberts. Both were taken to the police station, where Grelick was surrendered by his bondsmen, while Roberts was charged with vagrancy. He will be held pending an investigation.

To his attorney, Grelick told quite a plausible story. He said that he had merely gone aboard the Sirene to aid Roberts to leave. Grelick had not intended to remain and fight the case to the bitter end. He had intended returning on the tug, after the ship had been towed out to sea. Brooks, whose tender heart is a matter of pride among his professional brethren, wept tears of regret to think that he had before doubted Grelick. For Brooks had had the worst case of "cold feet" on record when he was first told of Grelick's attempt to jump the cash bond.

If Brooks had not been so credulous however and inquired of the police, they would have informed him that instead of finding Grelick the model of uprightness sitting upon the poop deck of the Sirene, they had discovered him stowed away in the furthest corner of the forepeak, under a pile of canvas.

The police say that if Paddy Ryan and Pat Moore, two fellows who used to hang around the brewery, should still be in the city, their presence is desired by the officers as it is thought the two persons might be able to throw more light on the wholesale robbery of the brewery which has been going on since afternoon. Deputy Attorney General Cathcart made a motion in Judge Gear's court to have the bail raised to \$1,000. Grelick took the stand and swore that he had not had any intention of leaving the country. He had only gone to the vessel to see a friend off, intending to go out with him and come back with the tug.

SPECIAL ELECTION CALLED

GOVERNOR DOLE ISSUES A PROCLAMATION.

Successor to the Late J. Ewaldiko to Be Chosen, But May Never Occupy His Seat.

The governor has issued a proclamation calling a special election in the first district to elect a representative to take the place of the late J. Ewaldiko. The election is to take place on Monday, December 9. Though the man elected may never sit as a legislator, there is a good deal of interest in the election, and a lively campaign may be looked for. Unless Dole should at some time decide to call an extra or special session of the present legislature, the man to be elected will see his term expire without ever taking his seat.

The Home Rule Republicans have already decided to hold a convention at Hilo, for the purpose of selecting their candidate. Their executive committee met last night and decide that such a convention should be held. The Republican committee meets next Monday and will probably take some action regarding selecting a man to run. A. B. Leobenstein of Hilo has been mentioned as a probable candidate.

Governor Dole's proclamation is as follows: "Whereas, the Act to provide a Government for the Territory of Hawaii, requires that vacancies in the office of Representative, caused by death, shall be filled for the unexpired term at special elections, and that at least forty days before any election, the Governor shall issue an election proclamation, and now, therefore, in accordance herewith, I, Sanford B. Dole, Governor of the Territory of Hawaii, hereby give notice that a special election for a Representative of the Legislature of the Territory of Hawaii for the First Representative District, Island of Hawaii, for the unexpired term ending on the Tuesday next after the first day of November, 1901, made vacant by the death of J. Ewaldiko, will be held on Monday, December 9, A. D. 1901, in the First Representative District, Puna, Hilo and Hamakua, Island of Hawaii, between the hours of 8 o'clock a. m. and 5 o'clock p. m.

CAPT. TILLEY'S COSTLY JAG

ENORMOUS EXPENSE OF THE INVESTIGATION.

Fully \$50,000 Will be Paid to Send Two Vessels to Tutuila to Try Tilley Intoxication Charges.

There have been some expensive debauches in the history of the world. In fact, old Nero's Bacchanalian revels have painted more morals and adorned more tales than the memory of man recall, and the most notorious starting away booze, old Lucullus was a regular double riveted tank. Cleopatra, when thirsting for the love of Marc Anthony, is said to have had a very expensive trip too. History claims she dissipated a heart worth \$50,000 in a goblet of vinegar and quaffed the health of her martial lover.

Cleopatra may have had her \$50,000 drink, science to the contrary, Lucullus may have stored away wine of costly vintage, Nero may have gulped red wine until his gin-soaked skin burst, but even the drunken revels of those royal old Bohemians, pale before the costly jag which Commander B. F. Tilley, the governor of Tutuila is alleged to have enjoyed, and for which a court of inquiry may be convened.

It is more than likely that the inquiry into the charges of having been once under the influence of liquor and of conduct unbecoming an officer and a gentleman which certain missionaries in Tutuila are said to have filed with the Navy Department against Governor Tilley, will cost the United States government more than any other court-martial probably in history has done, and certainly more than any professional debauchee among the old Roman gluttons paid for his jags.

In the first place, Admiral Silas Casey, the commander of the Pacific Squadron, has been ordered to proceed to Pago Pago, and inquire into the charges against Governor Tilley, who has been relieved from that office however, pending the investigation. In the second place, the United States government will be ready to warrant, if the charges sufficient to warrant it, be submitted to a court-martial. In order that Admiral Casey may make his investigation, the battleship Wisconsin has been ordered to proceed from Bremerton on the Pacific Coast to the island of Tutuila, a distance of about 5,000 miles. In anticipation that it will be found necessary to convene the court-martial, the seven gentlemen who will compose that body, have been ordered to proceed on the Solace from San Francisco. In addition to the seven members of the court, one of whom is Rear Admiral Evans and the others six captains, there will be Captain Tilley and the judge advocate and various clerks who will accompany the vessel to Tutuila.

The idea of sending these vessels to Tutuila for the sole purpose of investigating the charges of intoxication against Tilley, is a huge joke from the police standpoint of jags. In the first place, in coming down here from Bremerton, the Wisconsin will use about 100 tons of coal. Here and Tutuila she will use at least a similar amount. From Tutuila, she is to go across the Pacific to Valparaiso, a distance of about 5,000 miles and from there she will cruise up the South American coast, she burns coal at the rate of about 100 tons a day. On the trip from the Coast to Tutuila, she will therefore use about 1800 tons of fuel. Coal costs on an average of \$3 a ton which will bring that item up to \$5,400. From Tutuila to Valparaiso, on the home trip, the vessel will require at least about the same amount, which means \$5,400 more. From Valparaiso back to the north Pacific she will use probably 800 to 900 tons more, so that by the time she is home she will have burned up well onto \$35,000 for fuel alone.

The Solace will burn about 60 tons a day under ordinary draft, and more, if forced. Estimating on the average of 60 tons, it will be seen that her coal consumption from San Francisco to Tutuila will be close onto 1060 tons, a cost of about \$3,180. From Tutuila she is to go to Manila and from Manila back home. This will be about 25 days additional runs so that her coal will foot up to the neighborhood of \$23,360. The daily maintenance of the vessel has also to be taken into consideration. Five hundred men on the Wisconsin have to be fed and several hundred on the Solace, so this part of the expenses will be quite large. Then there are the salaries to be figured. There are three Rear Admirals in the expedition. A Rear Admiral receives \$15.25 a day, six captains who are on the board receive \$12.50 a day, lieutenant commanders, \$9.70; senior lieutenants \$7.75; junior lieutenants, \$5; ensigns, \$4.20; warrant officers, \$5.30 and the average members of the crew, \$1.40.

The pay of the members of the court and various clerks will reach close onto \$2,500. More than this, most of the cost of the trip to Tutuila and return to the States, on one of the Spreckels line of vessels. The passage from Pago Pago will be about \$150 each, which will in round numbers, be about \$1500 to land them in San Francisco. Estimated up to the fact that because Captain Tilley is accused of having been intoxicated on one occasion, the United States government sends two ships to burn about \$58,360 for coal, about \$2000 more for additional expenses of the boats, and \$1,500 for steamship transportation to a private corporation. It is well that Commander Tilley is not accused to having been on a 30 day jag. It might have cost the government 30 times the present cost of investigation and at this rate a few more such investigations might bankrupt Uncle Sam.

It can, of course, be claimed in defence of those bringing the charge against Tilley, that the vessels would have to be maintained anyhow as the cost of the trip to Tutuila and return does not really amount to anything. On the other hand, it can well be said that had the charges not been made, the vessels would not have had to go to Tutuila and, in consequence, the trip represents an actual loss of at least about \$60,000 for coal and transportation.

DOCK MAY BE ENJOINED

CONTRACTORS CLAIM BOYD IS SUED CLOSE CONTRACT.

Injunction Likely to be Issued Stopping Cotton Brothers—No Bids Were Called For.

There is a possibility, if not a probability, that work on the new wharf which is being built by Cotton Brothers, at the Ewa end of the harbor for the accommodation of the big steamers which, contracted to Hackfeld and Company, will soon be coming to Honolulu, will be interfered with by an injunction brought at the instance of certain local contractors for government and public works.

The matter is one that involves a large amount of money, some \$150,000 to \$200,000, and consists of various kinds of work, dredging, pile driving and the different branches of wharf building.

The contractors who are murmuring at the present status of affairs are aggrieved because they claim not to have been allowed an opportunity of bidding on the whole or individual portions of the work.

It is said among them that the Government, represented by the Superintendent of Public Works, has in effect given Cotton Brothers a contract to build the wharf and has instructed them to proceed with the work without opening the deal for bids according to law. It is claimed that Hackfeld and Company are supplying the wherewithal for the labor and the lumber, the latter being already stacked on the banks of the Nuuanu stream. Cotton Brothers it is stated, will get a commission upon the total cost for directing the work and here it is claimed that money is being lost to the people of the Territory. Large amounts of money have been made on the coast by managing contractors getting a percentage on the pay roll, which is often artfully determined not to allow Cotton Brothers to secure such a juicy plum without the others having their due opportunity to try for it. In emergency cases, it is claimed, the Government may only give out work without bids to the amount of \$500. This matter, it is claimed is not an emergency case and the new ships will not be ready for docking in Honolulu for almost two years and Hackfeld and Company have several years yet to run on their lease of the railroad wharf. Neither of course, is the contract anywhere near the limit of \$500.

The contention is that Cotton Brothers have been allotted the direction of the building, and the profit thereon, out of favoritism and illegally. The firm supplying the sinews of money for the erection, are it is supposed depending on the next legislature to make an appropriation for the work, to get back the money they are advancing. But by that time the work will have been long completed without it is claimed the legal bids having been called for.

"Superintendent Boyd is at present absent from the city," said a prominent contractor this morning, "but when he comes back there will be several of us asking for an explanation of this disposal of so great an amount of the public funds without giving the citizens the right of gaining money on the lower sums always induced by public bids. The evasion of such a matter is distinctly illegal."

The law, as enacted by the last legislature, reads as follows. Act 4, Section 5. All and every expenditure for constructing or repairing public works amounting to \$500 and for furnishing material, provisions and other supplies, shall be awarded only upon public advertisement for tenders; and no public work, material or supplies shall be divided or parcelled out for the purpose of evading the provisions of this section. This section as it stands does not even except emergency cases and places the limit for them under the five hundred dollar mark.

A petition is being circulated protesting against the arbitrary practice and sham battles of the National Guard of the Territory being allowed to take place on Sundays and asking the Governor to countermand the proposed desecration of the Sabbath. No precedent for such action can it is stated be found in any other of the States or Territories.

Col. Jones says that Sunday is the only day the men can get away on their work, and that as they are not paid for the drill they ought not to lose a day's work on account of it. The last drill of the kind was held several years ago, at Remond Grove, on a Sunday, and there was no complaint then, says the colonel.

WAS NOT A TRUE SALMON

NEW SPECIMEN WILL BE SENT TO WASHINGTON.

Possessed None of the Regulation Characteristics—Not Classified in These Waters.

The strange variety of fish that was caught off Waikiki, by a native yesterday, and which created a great deal of interest by the naming of it a salmon, has been proved today by closer and expert examination to be sailing under false fins.

Some years ago an attempt was made to propagate salmon ova on the island of Kauai, but as far as is known without any satisfactory result. The salmon is a peculiar fish in many respects. In the winter it spawns in the fresh water running far up the rivers of colder climates to perform the initial rites and then disappearing into the sea again leaving no definite trail of migration. Hawaii probably proved too warm for breeding purposes in the case of the Kauai ova.

As at this time of year the average salmon is supposed to be performing family duties up north, it was surmised among fishy authorities that he must be a nomad, an outcast of his tribe, a confirmed fish bachelor or myogonist, or else his ova were mixed with a silvery spangled bride to spend their honeymoon in tropic seas.

All illusions were dispelled this morning when the formalin preserved remains were inspected by those who had caught the lovely salmon in many quarters of the globe and were well acquainted with the peculiarities of the species. The natives persist in calling it an Hawaiian salmon but the fish is undoubtedly not a member of the large salmon family. Still it is a new fish to these waters and its exact individuality will soon be determined as the specimen which is now residing with a sandy green red fish called kawalo, in a 3 per cent solution of formalin, will soon be sent to the Ichthyological Department at Washington by Market Inspector Berndt for classification.

CUSTOMS PROMOTIONS.

C. M. Neal has been promoted from night inspector to the office of discharging inspector. R. H. Bemrose, one of the inspectors, has been promoted to a clerkship in the appraiser's office.

STRIKES.

Of the whole number of strikes, 189, in Massachusetts last year, 16 were occasioned by questions relating to hours of labor alone; 28 to hours of labor and wages taken together; 90 related to wages alone, the remaining 61 being occasioned by a variety of causes; 53 succeeded; 10 partially succeeded; 25 were compromised; 14 satisfactorily adjusted; 74 failed, and four were pending at the close of the year; while with reference to nine the result of the contest was not stated. Expressed in percentage, 28.04 per cent. of the contests terminated successfully for the employees; 5.29 per cent succeeded partially, 13.23 per cent were compromised; 7.41 per cent failed; 21.2 per cent were pending at the close of the year, and in 47.76 per cent of the cases the result was not stated. There was more trouble in the boot and shoe industry than in any other trade, the number of strikes being 40.—New Bedford Republican Standard.

PRINCE CHUN.

Inasmuch as Prince Chun is returning by way of America, it may be just as well that people here should know that he makes a difficulty about paying his hotel bills, says the Boston Advertiser. When the hour arrived for taking his departure from the hotel at Basel, where he had spent three weeks that intervened between his arrival in Europe and his reception at Berlin, and which is known by the name of the Three Kings, it was found that he had no money to pay the bill, amounting to over \$5,000. As the hotel is situated on Swiss territory, the German government had no ground for interference, and as the Swiss boniface made difficulty about letting the baggage of the imperial mission go, the prince left with the proprietor a pair of superb diamond buttons, to remain in pledge until redeemed by the Chinese minister to the court of Berlin. As he left the hotel the prince is said to have remarked to the proprietor: "It is all very well, but I have given you a splendid advertisement."

A HERO.

The Royal Humane society of England has picked from among 700 men who had performed gallant deeds William Allen as the bravest man in England and has given him the gold medal for 1901. Allen's heroism was shown in rescuing three men from the inside of a tar-still, which was filled with deadly fumes. He made four trips into the jaws of death.

HOW TO PEEL ONIONS.

Although the fact of the pungent odor arising from the peeling of onions affecting the eyes is well known, the way to avoid these effects is not so generally recognized. The odor which affects the delicate membrane surrounding the eyes is due to a sulphurous oil, which volatilizes rapidly when the tissue of the vegetable is broken in any way. To avoid the effects of this vapor is easy if a small pared potato be stuck in the end of the knife with which the cutting is done. A chemical affinity attracts the fumes, and their presence is not manifested to the operator till the potato has reached a certain degree of saturation, when it can readily be replaced by another.

VERY CATCHING.

A London dispatch says that Lady Sybil Primrose, daughter of Lord Rosebery, is suffering from a very serious disfigurement in the form of a species of skin disease, which she is understood to have taken from a cat which she was in the habit of fondling and holding to her cheek, and which now turns out to have been suffering from some very catching and virulent skin malady.

FREAK WELL.

A well that furnishes two separate and distinct kinds of drinking water from the one opening is a freak of nature which the town of Lyons, Miss., a few miles south of Memphis, is now enjoying, says the Chicago Inter Ocean. One stream is said by experts to flow from an underground current having its source in Lake Michigan, while the other is identified by analysis and chemical analysis with the waters of Waukesha springs. The discovery of the two streams one a pure, clear, soft freestone, and the other a strong, sweet, chalybeate iron water, is a source of wonder to the natives. Both streams rush above the surface, the freestone to a height of 35 feet and the chalybeate 21 feet.

POOLOA REGATTA PLANS

THREE RACES, A JAUNT AND A JOLLIFICATION.

First Outing of the Hawaii Yacht Association to Prove a Success-Program of the Trip.

The first outing and regatta of the newly organized Hawaii Yacht Association will take place tomorrow and Sunday. The outing includes three races for all yachts, going down to Pearl Harbor, in Pearl Harbor, and returning. In these, yachts are given time allowance according to their class.

The races will be followed up and adjudged from one of the small gasoline launches belonging to the Young brothers. It was at first arranged to take down the Waterwitch but Herbert Young the only man qualified to run it being absent on Kauai, that idea was changed and the party that was to have gone down on her will go in the Clyti.

Members and guests of the club are advised to take along blankets and a mosquito net as there are plenty of mosquitoes around Puloa after sundown. Particulars will endeavor to obtain coats for everybody. Thoughtful men will also take along pajamas and towels with a nail or two from which to mend their raiment and the skelter netting.

Commodore Hobron has had printed tasteful programs of the regatta as a souvenir of the occasion of the first outing of the Hawaii Yacht Club.

The following are the courses and rules for the several races:

First race October 25. Course: From an imaginary line from lighthouse to pilot office down channel, keeping spar buoy on port hand; thence around buoy rounding same on port side; thence to Pearl Harbor, keeping twenty five feet from the flag stake on starboard hand; thence around shark pen finishing between committee boat and club flag on Puloa beach.

Yachts start on their respective courses as follows: Fourth class, 2:00 p. m.; third class, 2:10 p. m.; second class, 2:20 p. m.; first class, 2:30 p. m. The preparatory gun will be fired at 1:55 p. m. All races will be started by what is known as the "one-gun start." Before each race a gun will be fired five minutes before starting signal.

Yachts making the best corrected time in each class will receive a pennant. First and second class yachts may use topsails but not spinnakers or balloon jibs. On reaching Puloa yachts will come to anchor, the smaller classes anchoring near shark pen and the larger west of salt house.

At 6 o'clock a luau will be served to the yachtsmen and their guests, after which the entertainment committee will give the boys a feast of music and wit.

On Sunday morning October 27, colors will be hoisted at 8 a. m. Signals will be given from Commodore's flagship. Breakfast will be served ashore. At 9 a. m. yachts will "dress ship."

The first race will be the Ford's Island race: Course, between a line from committee boat to club flag on beach; thence up channel to middle loch, keeping first and second buoys on starboard hand, and stake on Waipio Point on port side; thence around Ford's Island, keeping island on starboard hand, keeping fifty feet outside of stakes on mauka end of the island and thence to starting point.

Races will commence at 10 a. m. Preparatory gun will be fired at 9:55. First second, third and fourth-class boats start in order given, with interval of ten minutes between classes. Prize, a pennant for yacht making best corrected time in each class. Same rules apply to racing sails in first and second class.

The last event will be the homeward race for commodore's cup. Course, from line between committee boat and club flag on shore; thence out Pearl Harbor channel, and thence up the coast, rounding bell buoy, keeping same on port hand, and finishing at spar buoy.

In this race all yachts participate, the boats receiving their respective time allowances at the start. This race will start at 2 p. m. and yachts will be started from the committee's boat by megaphone. Prize, a silver cup to the yacht arriving at finishing line first.

The races will be governed by the rules of this club, except as herein provided. Each yacht shall fly the club burgee at main topmast, and owner's private signal at main peak.

CUSTOMS COMMISSIONER.

Thaddeus S. Sharrett a member of the Board of General Appraisers has been commissioned by the President to go to China as the representative of the United States to readjust the Chinese customs service in accordance with the protocol lately signed with China by the representative of the powers. His exact duties are thus set out in his commission. He has "full and all authority for and in the name of the United States of America to meet and confer with any person or persons duly authorized by the government of China, by any government or governments having treaties with China, being invested with like powers and authority, and with him or them to agree on a plan for the conversion into specific duties, as far as possible and as soon as may be, of all ad valorem duties on imports into China in conformity with these provisions and these requirements and contained in the final protocol, signed by the diplomatic representatives of China and the powers at Peking on September 7, 1901 the same to be submitted to the President of the United States for approval."

Mr. Sharrett was expected to sail by the America Maru October 23.

BADGE FOR HENDRY.

The Elks are going to present United States Marshal E. R. Hendry with a handsome gold badge as marshal. It will be very much like the one he had before, only in place of the words "Chief Office Deputy Marshal" will be the words "United States Marshal."

MANCHURIA.

Very little is generally known about the conditions of Manchuria, but a recent report to the Department of State throws considerable light upon its value, and upon the conditions there. When the late general in command in Manchuria passed through here a week or so ago, he was asked how many troops were in Manchuria he evaded the question, and the natural inference was that it was much larger than he cared to state. The report to the State Department says:

"There is much exaggeration about the number of Russian troops in this region. The 90,000, which expanded to 100,000 so quickly in the imagination of journalists and theorists, may be safely cut down one-third. It is only necessary to recall the events of last summer—the way in which the great Siberian Railway was taxed to transport the troops actually forwarded, at a critical moment—to be assured that it was impossible to transport, feed, and maintain so large a force as is credited in Manchuria."

Manchuria has an area of 363,000 square miles and is one of the most fertile countries on the globe. There are no better crops in all Asia. The Manchus have barely scratched the surface and yet the business activity, the actual traffic, and the tangible results are a continual surprise. Well-informed persons—merchants, miners, officers—assert that it is richer in resources than any other part of China. The main roads leading south and north are said to be congested with the crowds of carts, people, and beasts of burden, all heavily laden, moving in the early winter. During the whole period of navigation, on the river from Niuchwang north, thousands of Chinese boats are continually plying. The volume of business done is estimated at from \$50,000,000 to \$100,000,000; and yet no part of the land is worked according to European methods, and only the least portion of it is cultivated. Millet, beans, wheat, hemp, indigo, and opium are the principal products cultivated.

Besides its agricultural possibilities the mineral wealth of Manchuria is very great. The area of the gold fields so far as at present explored extends 1,127 miles along the shores of the Argun and Amur rivers and 25 miles in land. There is no doubt as to the richness of these deposits. Several years ago, small parties of Russians illegally mining easily earned from \$20 to \$100 per man per day. And in these mining operations, so primitive is the work method, that at least half of the gold was overlooked. Enormous fortunes lie ready for the exploiter in time.

This fertile and rich country is now practically Russian territory for the protection of the railroad, where ever the Bear puts his paw, he never withdraws it. Gradually but surely Manchuria will be Russianized. Some extracts published last Monday in these columns from the edicts of the Russian Representative at Niuchwang showed with how strong a hand Russia was holding the commercial regulation of the new province.

As to the railway which the Russian troops have gone to protect it is not yet in good running order. It was hastily put together last year and the work so crudely done that in many places the rails were laid upon the bare ground. The line as at present projected is merely a make shift, however, for it is impracticable to finish it on the present line. The true line is, however, being carried on to completion. When the railway and its branch lines are completed, Manchuria will be really and truly a Russian province.

LABOR IN GERMANY.

The condition of the labor market in Germany is very gloomy, men are out of work, and cannot obtain work. This will mean a strong tide of immigration into the United States during the winter months and the early spring of next year.

The Berlin semi-monthly periodical *Der Arbeitsmarkt* (The Labor Market) furnishes facts and figures which show that there is a continuous scarcity of work in Germany. From the mining district and from the centers of the iron-working and machine-making regions, short hours, dismissals of hands, and the cutting down of wages are reported. In the month of July, 1900, when the depression of business in general was felt for the first time on the labor market, the decrease of employed laborers amounted to only 3 per cent, while in July of this year their already much reduced number has decreased by a further 5 per cent.

There is a marked increase in the number of men applying for work at the public labor offices. In July, 1900, for every 100 open places 122.2 applicants were counted; this year their numbers has run up to 160.9. The labor offices report an increased rush for places, particularly by metal workers and those employed in the building trade. The latter may hope for an improvement, at least in some places at the beginning of the autumnal building season, but for the iron workers the outlook is gloomy, indeed.

The German census, which started December 1, 1900, and has just been

finished, gives some interesting facts. There are 42 cities with a population between 10,000 and 100,000 each. In 1910 the German Empire had 24,537,000 inhabitants; in 1857, 26,114,000; and in 1890, 34,242,000. In the year 1910, Prussia had 13,709,000 inhabitants; in 1857, 21,300,000; and in 1900, 24,462,000. The enormous increase in the large cities of Germany is said to be due to the retrograde movement in agriculture, which has driven people from the country.

The end of the San Francisco strike is somewhat innocuous. The effort has done no good in any direction. The men who struck are still many hundreds of thousands of dollars, no one will ever be able to calculate exactly how much. The steamship trade of San Francisco received a very serious blow, and people in other sea ports of the Pacific coast, have reaped a harvest from the extraordinary conditions. Instead of holding on to what she had, the city of the Golden Gate has given her competitors a start which should never have been given. Lastly the strike has given a very serious blow to the exclusion act. California stood as a unit upon this question, it will certainly not stand as a unit now. The farmers, and many others are going to try to admit oriental labor. The San Francisco strike may have solved some of our own problems.

SEDITIONOUS SPEECH.

The New Bedford (Mass.) Republican Standard, which can hardly be accused of either "yellow" journalism or radicalism, has the following well poised consideration of the agitation for stringent laws to suppress inflammatory speech. It probably represents the sober thought of patriotic citizens who recognize that freedom of speech is too valuable a part of blood brought liberty to be parted with in panic.

The release of the Goldman woman by the Chicago police for lack of legal evidence against her is said to emphasize "one difficulty that will be encountered in the effort to stamp out anarchy." It is pointed out that "the attitude of this creature has been notoriously in defiance of law and order and government, and in subtle encouragement of criminal means to subvert them, and assassins are moved to point to her as the source of inspiration for their deeds." But the law does not touch her, or, as is said, "she is cunning enough in the propagation of her poisonous theories to keep within the law." So there is call for more stringent law.

Well and good; but what is to be done with other people who in defiance of law and order and government subtly encourage criminal means to subvert them? Not very long ago a southern clergyman spoke in this city in a sympathetic tone of the lynching practice as it had been exemplified in his own vicinity. Within five years the commendation of lynching at the south—and at the north, for that matter—has ranged from the mildly apologetic to the intensely vigorous. We have seen recently in a quiet country town of Massachusetts, "the best people" conniving at the commission of assault and battery in defiance of the law of the state on a man who was suspected of having expressed an unpopular and wholly unjustifiable opinion. An apparently respectable man, admitting that the proposed proceeding was wholly illegal, has in our hearing vociferously defended it. We have time and again heard in this city men whose standing is infinitely above that of Emma Goldman not merely excuse, but champion, the out-and-out purchase of votes for the purpose of carrying caucuses and elections, "in defiance of law and order and government and in subtle encouragement of criminal means to subvert them." If we are going to make laws to prevent Goldmans from counselling assassination of presidents, are we going to leave unmade laws to prevent ministers from counselling lynching, and the best citizens from counselling assault and battery, and leading men from counselling bribery at the ballot box? If, as is said, the law in the case of the anarchist-assassins is too lax, is it stringent enough in the case of the assassins of national honor and purity in other directions? While we are making laws against demoralizing talk we had better have the courage to be consistent and thorough.

Perhaps no recommendation of the grand jury is worthy of more serious consideration than that in relation to the commitment of persons to the insane asylum. Though no such cases have arisen here, so far as is known, in the State of New York where formerly persons could be committed on the certificate of two physicians, many cases, some of them of world wide celebrity, arose where sane persons were committed at the instance of designing relatives and others. Similar cases have arisen in England and in some of the other states where legal safeguards did not interfere. The greatest safeguards should be thrown around this class of cases. From the very nature of the charge the person charged is at a disadvantage. There should be adequate publicity given to all such commitments or trials for commitment. It seems as though the grand jury recommendation in the matter covered the ground, though a jury trial would be in consonance with the principles of constitutional liberty. The suggestion that one of the three examining physicians should be a specialist has in it the seeds of abuse, because there is no means except that of cross examination to determine whether a man is a specialist in any subject or not, but a jury trial in open court would afford this means.

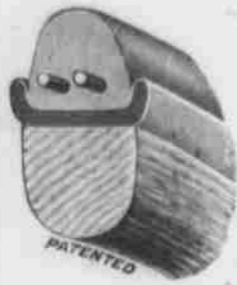

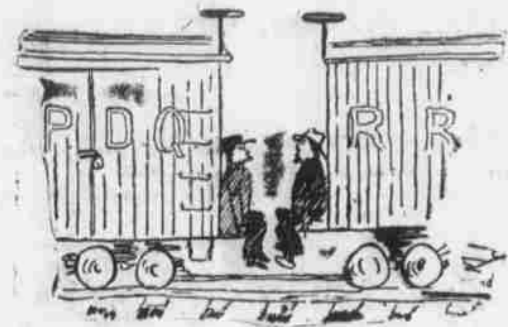

When alone quietly waited, and finally for the balance, because the vessels could have been changed in some other work, which is important and worth basking with. The idea of sending ten warships 5,000 miles because a commander has been charged with being intoxicated, sounds ridiculous, especially when the famous Schley court-martial will probably not cost the government more than a quarter of the coal and transportation which the Tilley expedition will do.

WILL BE FLOATING CAMP

PEARL HARBOR WORKMEN TO LIVE ON DREDGER.

Hulls of Dredger and Scows to be Built in Honolulu Harbor and Towed to Pearl Harbor.

Contractor Henry is chafing at the delay over the commencement of dredging operations at Pearl Harbor, caused by the non-arrival of the Nokomis, now twenty seven days out from Balakrishna which is bringing the lumber out of which the scows and dredger will be built.

The dredger hull and scows are to be built in Honolulu harbor and towed down to Pearl Harbor when completed. Contrary to general expectation, there will be no army of men employed in the work. All the labor is skilled and in all there will be little more than a score of men to work the dredger.

Instead of building a camp at Pearl Harbor as at first contemplated, Mr. Henry stated this morning that the camp would be a floating one, dining rooms and state rooms being built on the dredger itself for the accommodation of the men.

Gasoline will be the motive of the powerful engine employed in scooping up the sand that clogs the channel. The scows themselves will be of the variety technically known as the clam shell and orange peel scow, the first built in two and the second in four sections.

The dredger hull will be very strongly built to carry the powerful engine and resist the strain of the working machinery. The scows are specially built with an arrangement where the sand dredged up is dropped from the bottom of the craft to leeward of the channel. The work will be commenced as soon as the lumber arrives and meanwhile Mr. Henry and several skilled assistants on high pay are performing loading.

CAPT. JACK MYERS HERE

HONOLULU FAVORITE ON THE WISCONSIN.

Captain Myers of the Marine Corps is to Act as Judge Advocate of Tilley Court-martial.

There is a well known naval officer aboard the Wisconsin, one of the principal pets of Honolulu. He is "Jack" Myers, Captain of United States Marines, who is to officiate as Judge Advocate in case the court-martial is called today by Captain B. F. Tilley at Tutuila.

Myers first made the acquaintance of Honolulu in 1898, when he was aboard the cruiser Charleston. He was entertained along with other officers of the vessel, and during the course of being entertained, he drifted as naturally as a buoy on a water runs back to the sea. While there, he made the acquaintance of a cousin, whom he had never met before, Dr. Myers of this city.

From Honolulu the Charleston went to Guam, where Myers, who was then one of the best of marines, took part in the capture of that island. The cruiser reached Manila too late to aid Dewey in the destruction of the Spanish fleet, but it participated in the bombardment and capture of the city of Manila. Myers continued in the marine service in the Philippines, until the outbreak of the Boxer trouble in China last year, then he accompanied the Newark to Tien Tsin. He was the commander of the special detachment of marines which Captain McCalla wisely rushed into Peking to the aid of the legations, before the Boxers closed in around the foreigners.

It was well that McCalla sent the marines to the legations, and it was a wise choice he made in placing Myers at their head, for had it not been for the gallant conduct and work of the marines in repulsing the savage Boxers and Imperial Chinese troops, the Ministers and all others in the legations would have been massacred. Myers commanded the American marines and it was he, who was at the head of his troops when they repulsed the most desperate attack of the Chinese on the imprisoned legations one night. Myers was wounded in the leg by a spear and was forced to relinquish his post as he became quite ill. He passed through here last year on one of the Pacific liners and stopped a few hours, visiting Waikiki and familiar places. He was promoted to be captain for gallant services during the Peking siege.

He has been entertained by Honolulu people during his present visit here and recalls with much pleasure, the other delightful times he enjoyed on his previous visit.

JUDGE WILCOX KICKED.

Opposed to Using His Court as Collecting Agency.

A charge of compounding a felony may be brought against certain Chinese. This morning Judge Wilcox was to answer to the charge of embezzlement. It was charged that the defendant had absconded from Maui about a year ago with \$100, belonging to Lam Bong. The latter claimed he had entrusted this \$100 to Lui to be taken to a store from where it was to be forwarded to China. Instead of delivering the money, Lui skipped to Honolulu and proceeded to blow it in so it was claimed. Tom Fitch was employed by the defendant, while F. M. Brooks was engaged as special counsel to prosecute.

When the case was called, Attorney Brooks arose and said "May it please the court, my client says that he desires to drop this case, I was surprised when he so informed me, and do not approve of such conduct upon his part in dropping the case after it has been begun. He is here in court and can speak for himself."

The court did not relish the idea of such a conduct either, and hinted that action might be brought against the Chinese for compounding a felony. "Some people seem to think" added his honor, "that they can use this court for a collecting agency."

BISHOP AND HALLOWEEN.

A good story is told on the venerable Bishop Whipple. The scene is laid in St. Paul, and the story runs as follows: One evening in the fall, and after dark, as the bishop was walking along the street, he noticed a little fellow trying to ring the doorbell of a fine residence. He was too short to do any more than reach it, and although he stood on his tiptoes and stretched vigorously, no sound came from the bell. The kind-hearted prelate felt called upon to assist him, and so, ascending the steps, asked: "Shall I help you, my little man?" The boy intimated that such a course would be gratifying to him, and the bishop rang the bell. Thereupon the little fellow remarked: "Now, we'd better both run!" and decamped as rapidly as possible. It took the bishop just a moment to remember that it was Halloween and got around the corner about as rapidly as did the little boy.

MANY RECOMMENDATIONS

REPORT OF TERRITORIAL GRAND JURY.

Change in Method of Commitments in the Asylum is Needed—Too Many Trivial Investigations.

In the amount of work done and number of recommendations made the Territorial Grand Jury which was discharged yesterday after five weeks' service will probably hold the record for some time. Its long report was highly commended by Judge Gear, who suggested that as the jurors had served so excellently it might be well for the clerk to keep their names, so that they might be barged again next time. Among the comments and recommendations were the following after some severe criticism of poor accommodations and insanitary conditions at the asylum for insane:

"A magistrate, on the certificate of a single doctor of medicine, should not commit any person to the Insane Asylum, and in all cases the patient should be produced in court. And we would suggest that a commission of at least three doctors, one of whom shall be a specialist in nervous diseases, pass upon the merits of every proposed commitment before judgment be rendered in the case, and we further suggest that from time to time, a visiting commission of three well qualified physicians might well be appointed to visit the asylum to ascertain if all the inmates thereof were properly treated and rightly detained therein.

"We consider the practice of the police department being made to act as public administrators and having to take charge of and keep in their possession for an unlimited time large quantities of furniture, liquor, etc.

"We recommend that a receiving hospital be placed in the police station, in charge of competent surgeons, and that a regular ambulance be maintained for that purpose alone.

"We condemn the system of having misdemeanor, petty larceny and malicious mischief cases brought before the grand jury; they should be disposed of in the police court and would not keep a prisoner some six months awaiting a hearing.

"We heartily approve of the new police call system about to be put in and feel sure that it will be of great assistance to the department as well as a better protection to citizens.

"We would respectfully call the attention of the Federal grand jury to the fact that there is still a large amount of illicit distilling going on about Honolulu, and that although the attention of some of the Federal officers has been called to it by the police department, they have not seemed to pay any attention to the information. We also suggest to the judges of the police courts that they inflict more severe sentences in this class of people the limit of the law, we think vagrancy will diminish.

"The grand jury has seen fit to inquire into the practice under the old established regulation of the Board of Health which requires physical examination at least once a year by government physicians of all children in public and private schools, not provided with health certificates, in order to detect contagious and infectious diseases. While this rule undoubtedly acts as a safeguard to the public health, the grand jury finds upon investigation of the various methods under which it has been carried out on this and other islands and in the city of Honolulu that there is much in them to condemn. When it is known that the authority given to the physicians under this rule is without qualification or restrictions, so that boys and girls (sometimes entirely disabled) must submit to the requirements arbitrarily fixed by the respective physicians it will at once be apparent that positive rules of practice should be adopted in the premises, so that the proper sensibilities of parents and children and of teachers who are usually expected to be present at the examinations are not in any way ignored, nor even affected.

"The grand jury would, therefore recommend that the Board of Health hereafter employ women physicians exclusively in the annual physical examination of school girls and provide also that no physical examination be made by any physician of any children unless due notice thereof be first given to their parents or guardians.

"The grand jury would respectfully call the attention of your honor to the trivial character of many of the offenses examined into during its session, just closed, which included larceny cases where the amount of loss involved did not exceed fifteen cents in value or consisted perhaps of battered hat, an old calico dress, or a common rooster. It deems it just and proper that twenty business men should freely serve the community and preserve to every person suspected of the commission of an infamous crime the constitutional right of a secret investigation as to his probable guilt or innocence, but it submits to the candor of the court whether it be necessary and proper to compel grand jurors to inquire into the many petty offenses of daily occurrence which seem properly to be long within the jurisdiction of a police judge or a district magistrate and would recommend that the next legislature take proper action in the premises.

"The attention of the grand jury having been called to the practice of certifying in Territorial officials of paying to their subordinates and clerks amounts of salary less than the specific sums appropriated by the legislature for the respective positions filled by said employees, it is of the opinion that such practice should be condemned even though adopted in good faith and ostensibly for the purpose of curtailing expenditure of public money.

"In concluding its report the grand jury desires to express its appreciation of the ability, thoroughness, fairness, dignity and courtesy which have been the unfailing characteristics through-out its session of John W. Cathcart, the Deputy Attorney-General of this Territory, and would furthermore thank your honor for your kind efforts in our behalf in securing for our use the commodious and well ventilated room in which our long session has been held and we are confident that the privilege has not been abused and that the room is now in like good order and condition as when first entered by us.

"A list of all cases investigated by the grand jury, showing those in which true bills were found, and those in which bills of indictment were ignored

is hereto attached and made a part of this report.

Judge Gear styled the jury a grand grand jury and eulogized the work done by the sixteen and sincerely thanked them as judge of the court and stated that the newspapers would publish the report in full. The Judge also thanked them for the community at large and approved the suggestions of the jury as to the asylum and the matter of trivial offenses being brought before the jury, stating that the fault lay in the fact that the present punishment for such offenses did not fit the crime and by their high penalties called for indictment. The trouble was that the laws were not made according to the constitution of the United States and the matter should be altered at the next Legislature. The Judge asked them all to become missionaries to carry through a repeal or modification of the present law and seconded the jury's favorable opinion of Attorney General Cathcart's courtesy.

The jury were then dismissed for the remainder of the term.

MARRIED. McLAIN-MINTON—At the Catholic Cathedral, Honolulu, October 25, 1901, at 8:30 o'clock p. m., the Rt. Rev. Gulstan Robert, Bishop of Panapolis, officiating Miss Jennie McLain daughter of John McLain, to W. M. Minton, both of Honolulu.

Mr. Minton is well known in real estate circles in Honolulu, being at present connected with the Island Realty Company. He was for some time with Gear and Lansing and was responsible for placing most of the real estate sold by that firm. Mr. and Mrs. Minton will reside at the former's home on Young street which has lately been refitted for the reception of the bride and furnished in large measure with valuable Oriental curios, the results of several years of travel spent by Mr. Minton when purser of a prominent Oriental steamship line.

The bride, Miss McLain, is well known in the city and has been for some time a school teacher. Her family are Kamaoalas of Honolulu.

WAS IT PREMONITION? Words in McKinley's Last Great Speech.

In this great speech at the Buffalo Fair the phrase "our prosperity is exemplified in it" is appalling, aroused in the audience a shock of surprise, for there was plainly something in the President's mind that was not in entire accord with the scene—the glorious canopy of "light and blue" above, the magnificent palaces of art and industry around, and the almost countless thousands of alert, well-dressed, happy and confident people before him. Was it a presentiment, vague, but none the less imperiously real, of what was impending? If so, he alone felt it. The others went light-heartedly away all to homes of comfort, and not a few to pleasant villas by the seashore or in the mountains, to think over, in the serious moments that are part of the daily life, even in such retreats, what the President had said. And then—what a rude awakening! Literally, too, an awakening, for messengers by the ten of thousands were everywhere speeding through the night to summon back to the centers of national and business life the leaders of the people. Today, the great men of affairs in all the great cities are providing for the future, what ever it may be; and the keynote of national feeling is the same as when Garfield, afterwards himself President and himself murdered stood on the steps of the sub-Treasury in Wall street on the morning after the death of Lincoln, and began a noble oration with the words, "God reigns, and the Republic at Washington still lives."—Sydney Morning Herald.

THE SOUVENIR FEND. It is not surprising to hear that the souvenir fend is at Buffalo in full force "lifting" everything that is movable. The two palms between which President McKinley stood when he was shot have been stripped and the chair in which he was placed chipped and mutilated. Parker, the negro, who helped capture the assassin, has lost his buttons, necktie and hat, and is lucky in having some of his hair left.

BETWEEN TWO COURTS

QUEER STANDING OF SOME
INDICTMENTS.

Prisoners Who Will Have Had Two
Trials, Each Declared Void by One
Court.

Preparations are being made to take
an appeal to the United States Supreme
court from the decision given by Judge
Estee in the habeas corpus cases. At-
torney General Dole did not charge his
mind during his vacation, and he stated
this morning that the matter would be
taken up for a final decision.

"The question is a very important one
over which good lawyers differ," said
Dole, "and it ought to be finally decided
by the highest court. At present, we
have two contrary decisions by courts
here that have no jurisdiction over one
another."
The prisoners whose cases were ef-
fected by Judge Estee's decision were
all brought to the attention of the
Grand Jury that finished work yester-
day, with the exception of several
whose terms of imprisonment are so
nearly expired that it was not thought
worth while to give them new trials.
Many of the sentences that would have
been effected by the decision have al-
ready been served out. In one case no
evidence could be found, there being
no witnesses available, and a burglar
went free, as far as the rest of his sen-
tence was concerned.

In no case of an old offense did the
Grand Jury fail to find an indictment.
Seven prisoners who are serving long
terms for serious offenses, six of them
murder in the first degree and the
other burglary in the first degree, were
indicted by the Grand Jury, and their
cases will appear on the November cal-
endar of the First Circuit court.

The legal tangle is not over yet, how-
ever, for the Territorial Supreme court
holds that the old sentence was good. In
the event of a new conviction the ap-
peal would be to this court, and the
higher court would be compelled, it is
claimed, to knock out the new trials
on the ground of "twice in jeopardy."
With Estee issuing writs of habeas cor-
pus because the old convictions were
void, the Supreme Court issuing orders
because the new convictions would be
illegal, it appears that the chance for
the prisoners going free in the end is
very good.

Deputy Attorney General Cathcart
is preparing to try the cases and get new
convictions. What will be done when
the convictions are secured remains to
be seen.

UNFIT FOR DUTY.

Judge Estee on Jurors Who Avoid
Voting.

United States Judge Estee yesterday
administered a stern rebuke to some of
the members of the Federal Grand
Jury. The jury came into court for
instructions. Foreman Brown said
that he wanted to know if all the jurors
were obliged to vote on every question
that arose.
"That's what you are for, gentlemen,"
said Judge Estee. "That is what
jurors are for. The court in-
structs you that it is the duty of all
jurors to vote upon every matter that
is presented. The court will also say
that any man who for fear of its effect
on his business or social standing
wants to avoid a vote is unfit to be an
American juror. You may retire gen-
tlemen."
The jurors did retire, some of them
looking a bit crestfallen. People in the
court room said they could pick out the
men who had been objecting to vote.
Whether they wanted to avoid voting
because they were interested in the
proposition under discussion, or for
some other reason, was not stated by
Foreman Brown.

WILCOX CONGRATULATIONS.

Delegate Robert W. Wilcox under
date of Honolulu, September 25, 1901,
sent the following congratulatory mes-
sage to President Roosevelt:

"Dear Sir: I extend my warmest
greeting to you, and also the Hawaiian
people wishes me to convey to you the
same.
"I wish you success and prosperity in
your new position as Chief Executive
of the people of the United States as
well as the Hawaiian Islands."
"Therefore, I earnestly believe, your
term of office will be crowned with
prosperity. My candid prayer and wish
is that you will remain as President not
only for the unexpired term, but also
for the term of 1905-1909. God bless
you."

He has received the following from
Secretary George B. Cortelyou dated
Washington, October 8:

"My Dear Sir: The President re-
quests me to acknowledge the receipt
of your kind letter of the 25th ultimo,
and to assure you that your friendly
expressions and good wishes are sin-
cerely appreciated."

CHARGED WITH PERJURY.

Attorney Robertson, on behalf of the
government, sprung a sensation in the
tax court at last night's session, by
charging Ah In with fraud and perjury
in making false returns to income for
the year just passed. Ah In returned a
sworn statement of \$222 which small
amount raised suspicion, leading to the
examination of his books by an expert.
An income of \$1,112 for the year was re-
ported. The question of imposing the
penalty of 200 per cent addition to the
correct valuation has been taken un-
der advisement by the court.

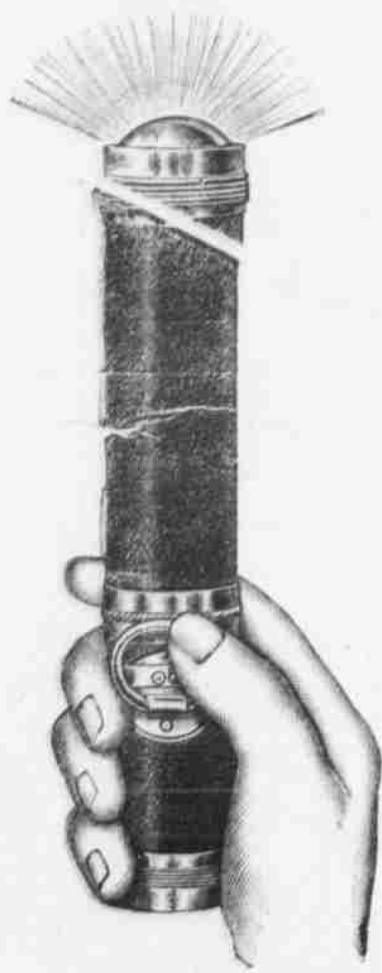

RAINING AT HAMAKUA

According to the latest advices from Hawaii brought this morning by the Mauna Loa, the rain has been falling steadily at Hamakua since last Sunday. Pursur W. Simerson reports that when the vessel left Kailua at 11 o'clock yesterday morning, the rainfall at Honokaa had amounted to 3 1/2 inches, and the storm was still in progress with indications of continuing. This news is confirmation of the reports brought by the Ke Au Hou in the week. At that time, the rainfall had amounted to about half an inch Sunday night, so the storm appears to have continued with a good average of half an inch daily. Pursur Simerson telephoned to Honokaa yesterday morning shortly before the Mauna Loa left Kailua. The storm had been general all over Hamakua and, moreover, had brought about the end of the terrible forest fires which have been consuming the forest lands of that district. In Kohala, the rain had also been very generous, the rainfall being at least 2 inches. At Honokaa, the grinding was stopped at the mill and the entire force put to work planting. Evidently this is what is now being done by all of the other plantations throughout the Hamakua district, for the managers propose to try and get the plantations on their feet as soon as possible. The Kaulani came along the Hamakua coast and arrived here yesterday afternoon. Captain Dower reports that all of the creeks and streams were running full, as the rain had evidently fallen very heavily in the mountains. Pursur Simerson stated that central at Honokaa reported the rain was still falling and that the indications were that it would continue.

MAY VISIT WISCONSIN. The battleship Wisconsin will probably finish coaling some time tomorrow morning. The officers have invited several friends aboard for the afternoon but no official reception day has been announced. It is doubtful if the vessel will be thrown open to the inspection of the public, although those who do go to the ship will probably be permitted to inspect her.
